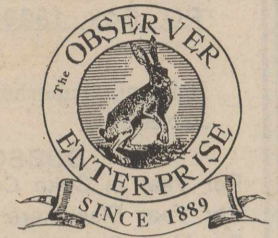

FB membership week set

County Judge Royce Lee has signed a proclamation designating February 7-11 as "Farm Bureau Membership Week" in Coke County.

The week is part of a statewide observance during which county Farm Bureaus will make a special effort to enroll new members, according to Bobby Roberts of Robert Lee, president of the Coke County Farm Bureau.

Mr. Roberts is also chairman of the membership committee which is responsible for membership acquisition and maintenance.

"The Texas Farm Bureau, with more than 293,000 member families, is influential in both state and national affairs on behalf of agriculture,"

the proclamation reads.

"Farm Bureau is a grass-roots organization. Its foundation is the county unit. There are 211 organized county Farm Bureaus in the state including the Coke County Farm Bureau," the proclamation states.

Bobby Roberts said the local county Farm Bureau has 740 member families and is seeking to exceed that figure in 1994.

He said that the Farm Bureau is a general farm organization that seeks to improve income and living conditions of farm and ranch families. It represents the farmer and rancher at the local county courthouse, in Austin, and in the nation's capital, Washington, D.C.

Roach

William Thomas Roach, age 80, passed away Saturday, January 29, 1994, at his residence in Robert Lee after a short illness.

Funeral service was held Tuesday, February 1, 1994, at 3:00 pm at the Robert Lee First United Methodist Church with the Rev. Bill Frisbee officiating. Masonic graveside rites followed in the Robert Lee Cemetery under the direction of Shaffer Funeral Home.

Bill Tom Roach was born March 11, 1913, on the Roach family farm in the Lane community in Hunt County, Texas. Bill Tom attended East Texas State University and was a member of the 1934 undefeated football team. He served as a football coach and schoolteacher in Robert Lee in 1937. He married Christine Glenn on December 24, 1939. His World War II duty took him to the South Pacific for three years; he served in the Navy Seabees. He then returned to his teaching field, serving as principal and teacher in the Robert Lee High School system.

In 1941, Pop and Christine bought the Red & White Store from W.J. Cumbie, Christine's grandfather who had owned the store since 1921. For 42 years, Bill Tom and Christine owned and operated Roach's Dry Goods.

Bill Tom was a 52 year member of the Hayrick Masonic Lodge, had actively participated in the Eastern Star and was a member of the First United Methodist Church.

Bill Tom was preceded in death by his wife, Christine, in 1986.

Survivors include two sons, Bill R. Roach, and wife, Diane, of Fort Worth; Glenn Roach and wife, Jan, of Lee, Florida; and a daughter, Cristie Bagwell and husband, Michael R., of Robert Lee. Grandchildren include Gabe and Glen Roach, Tom and Joe Roach, Stacey and Katie Roach, and Kirk and Tiffany Bagwell, and a great-grandchild, Kimberly Roach.

He also leaves behind a brother-in-law and sister-in-law, Horace and Mary Scott of Robert Lee; and a sister-in-law, Mildred Roach, and niece, Sydne Roach, of Celeste. He also leaves behind his companion and friend, Rudy Gloria.

Pallbearers were Donnie Robertson, John Jacobs, Bobby Boyd, Billy Wayne Roe, Bill Allen, and Larry Brock. Honorary pallbearers were members of the Hayrick

Masonic Lodge and Robert Vaughan.

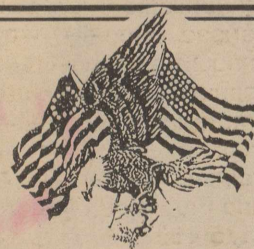

Bivins-Jenschke Engagement

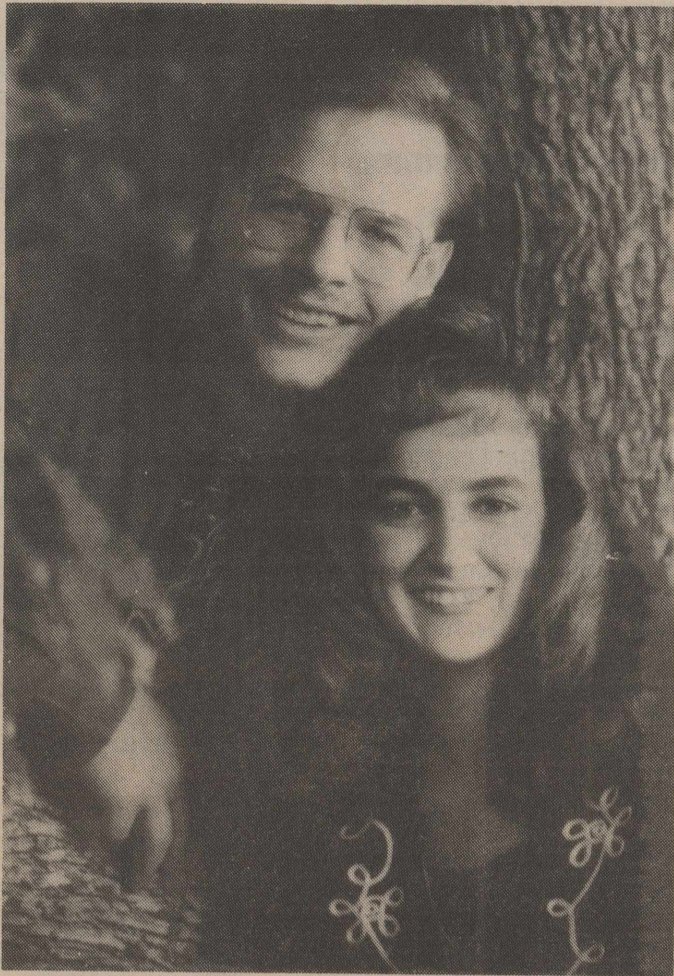

Pesticide dealers cautioned to record distribution

Agriculture Commissioner Rick Perry reminds pesticide dealers that under Texas pesticide laws and regulations dealers are responsible for documenting all federally restricted and state limited-use pesticides that they distribute. By law, "distribute" means offer for sale, hold for sale, sell, barter or supply.

"We've had some dealers who unload to customers right off the distributor's truck," Perry said. "People have been unsure about who is responsible for recording the distribution. The dealer has placed the order and is getting the money from the customer, so the dealer is responsible for record-keeping."

In addition to recording distribution and keeping it on file for two years, dealers can only distribute a restricted use or state-limited-use pesticide to a licensed or certified pesticide applicator. In Texas, dealers who distribute pesticides that are restricted under state and federal laws must be licensed by the Texas Department of Agriculture on an annual basis.

Commercial and non-commercial applicators must also be licensed annually, while private applicators must renew their licenses every five years.

Youth to show at Houston

Three FFA members and four 4-H members from Coke County will join other FFA and 4-H members from throughout Texas for showing competition at the upcoming Houston Livestock Show, Feb. 19 through March 6 at the Astrodome.

FFA members making the trip to Houston include: Danielle Parker of Bronte (one market barrow); Mike Pentecost of Robert Lee (one beef heifer); and James Tennison of Robert Lee (one market lamb and one market barrow). Jay Henderson, Agricultural Science teacher at Bronte and Jeff York, Agricultural Science teacher at Robert Lee are the advisors for these students. The 4-H members going to Houston led by County Extension Agent, Tommy Antilley, include: Casey Antilley of Robert Lee (one market steer); Andy Blair of Bronte (one market barrow); Kim Blair of Bronte (one market barrow); and Shea Kelton of Bronte (one market steer).

These FFA and 4-H exhibitors compete in one of two divisions of the Houston Livestock Show - the junior show division. The other division, the open show, attracts its exhibitors from the world's agricultural industry, who are primarily professional breeders and ranchers.

Entries in both the open and junior show combine with horse show entries to make Houston Livestock Show the world's largest.

Representing 878 Texas 4-H clubs and FFA chapters, the junior show is expected to draw more than 11,000 entries this year. A variety of animals are shown in the junior show division: market steers, market swine, market poultry, beef and dairy heifers, breeding sheep, goats, commercial steers and breeding rabbits.

The four market animal categories (steers, lambs, barrows, and poultry) represent

animals raised by the exhibitor as food sources. Top animals in each of these categories are eligible for their individual market auctions. Total money paid in 1993 at the four junior show auctions exceeded \$3.5 million.

"The most significant part of our livestock show is the junior show," said Steve Woodley, Houston Livestock Show and Rodeo manager. "It represents Texas youth and their commitment to education, discipline and agricultural development."

All net proceeds from the annual Houston Livestock Show and Rodeo provide funds for scholarships and research projects throughout the state. Since the Show's first scholarship was granted in 1957, the Show has presented more than 11,000 awards to Texas youth at a cost exceeding \$32 million.

The 1994 Houston Livestock Show and Rodeo begins with horse show competition, Wednesday, Feb. 16, followed by other livestock competition beginning Saturday, Feb. 19. The first rodeo performance will be held at 7 pm Saturday, Feb. 19. All events conclude March 6.

Ticket prices include admission to the horse show (excluding National Cutting Horse Association sponsored events), the livestock show, the carnival and the rodeo. Tickets can be purchased at all Ticketmaster outlets, including the Astrodome box office. Tickets also can be charged by phone 1-800-726-1313.

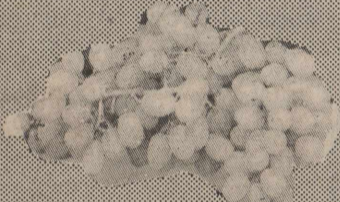

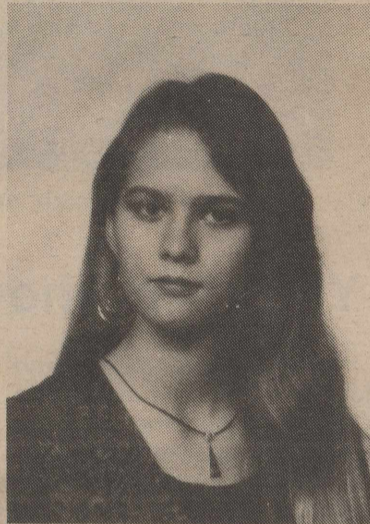

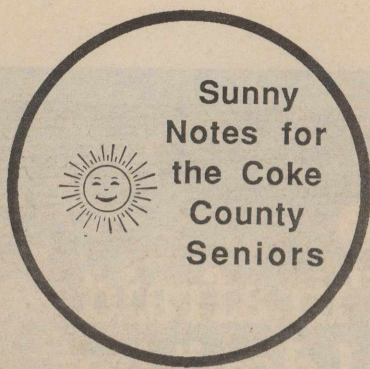

SS as proof of benefits

"If you're on direct deposit, you can use the cost-of-living letter you received from Social Security as proof of your benefit amount," said Franklin H. Upp, Social Security manager in San Angelo. People who have their Social Security checks sent to their bank received a cost-of-living adjustment (COLA) notice last month telling them that their new benefit rate will be effective January 1994. Upp said, this notice can be used when people need to prove the amount of their Social Security payments to the welfare office, a landlord, an energy company, or any other business or agency that provides a service or a subsidy that takes into account the amount of a person's Social Security check.

Upp indicated that some agencies and businesses requiring proof of Social Security payments send a verification form to the beneficiary for him or her to have completed by the Social Security Administration. "They should check with the organization that sent the form," Upp said, "to find out if the cost-of-living notice can be used instead. If it can, it would save a call and a trip to the Social Security office."

People who have their Social Security checks mailed to their home did not receive a personalized COLA letter from Social Security. Instead, they received a "stuffer" with their January Social Security check advising them of the COLA increase but not of their specific dollar amount. The stuffer cannot be used as proof of payment.

Postal Service

Recognizing the growing concern in society about disclosing new address information on battered individuals, the U. S. Postal Service is making two major changes in its mail forwarding system, Postmaster General Marvin Runyon announced today at the monthly Board of Governors business meeting.

"Clearly there are troubled individuals who could use our system of address changes for malicious purposes. I want to make sure that doesn't happen," said Runyon.

The first change alters postal regulations so that individuals can no longer walk into post offices and find out where another had moved. Currently, anyone can walk into the post office where an individual formerly lived and, after presenting the old address and paying a fee of \$3, receive the new address, Runyon explained.

In the second change, Runyon said the Postal Service will amend its mail forwarding system so that new address information of court order protection individuals such as battered women, is blocked from inclusion in its address correction services. The information however, would still be used for forwarding purposes.

In order to accomplish this, the Postal Service will develop special methods of "flagging" these particular addresses through new software programs and modified procedures. "We anticipate this alteration to the mail forwarding system will be finalized within six months," Runyon added.

FmHA moves to speed up loan processing

"Texas farmers applying for assistance from Farmers Home Administration (FmHA) will experience a breath of fresh air this year," George Ellis, FmHA Texas State Director, said today. "I have today taken action to delegate the full loan approval authority allowed under the Federal Regulations to FmHA County Offices in Texas," Ellis said.

This action means that FmHA Supervisors at the County level will be able to exercise loan approval authority up to the full County limit without prior reviews being required at other locations or even by FmHA officials at the same location. "As this new year begins, I feel this will be a real help to our farm customers, and I intend to pursue this type of change in the future, wherever I can," said Ellis.

FmHA County Supervisors were previously subject to a complicated system of reviews and re-reviews of loan applications in order to approve an FmHA loan. This system was instituted several years ago in order to insure fewer mistakes and more uniformity from County to County.

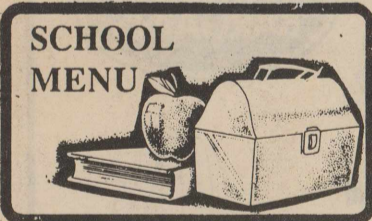
"I still intend to hold FmHA Supervisors to the same high standards as in the past, however, I am also dedicated to streamlining the process so that our farm customers will have funds available to them at the time they are needed," said Ellis. 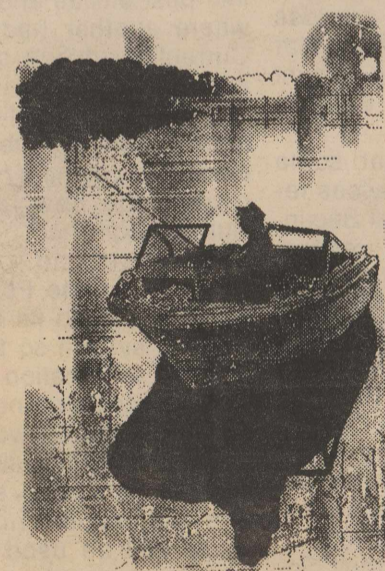

Living Wills

The Texas Hospital Association has distributed a public service campaign to Texas media promoting the use of advance directives, also known as living wills.

The campaign was developed by THA and Hank Moore of Read-Poland Associates of Houston. The long-term goals of the campaign are to educate the public about their option to accept or refuse medical treatment and to foster improved communication among the patient, family and attending physician. The message of the campaign is one of reassurance, explaining that the advance directives are positive health documents which should be considered by all adults.

Included in the campaign are four 30-second television spots; one spot is in both English and Spanish. Each spot features different age groups, illustrating the need for people of all ages to consider signing an advance directive. Print advertisements and a radio script also have been distributed.

Advance directives are used to direct medical care in the event a patient is unable to speak for himself. The Patient Self-Determination Act was passed in 1991 to improve patient knowledge about the right to accept or refuse medical treatment, and the patient's right to make advance decisions about the kind of medical care he/she wishes to receive.

Hospitals are required to inform adult patients upon admission about advance directives and durable power of attorney for health care documents.

In November, President Bill Clinton and Hillary Rodham Clinton announced their intention to complete their own advance directives concerning medical care.

The Texas Legislature also has taken steps to assist in the use of advance directives. A bill sponsored by Rep. Diane Delisi (R-Temple) was passed by the 73rd Legislature requiring the Texas Department of Public Safety to print on the back of each driver's license a space for a telephone number indicating where an advance directive has been filed.

Exercise to avoid health problems

Age is no excuse for avoiding exercise says an expert in physical conditioning at Baylor college of Medicine in Houston.

In fact, some common health problems related to aging can be reversed with simple exercise says Dr. Alan Herd, a professor of medicine at Baylor.

Simple activities, such as walking, can prevent and lessen the effects of heart disease, stiff joints and low energy.

"Walking is economical, easy and usually does not require a medical clearance," said Herd.

Herd also recommends "chair" exercises for people over age 65. He says a daily routine of these simple calisthenics can improve range of motion in most joints and make getting around easier.

"Chair exercises are easy and can be done at home," Herd said. "Either while seated or while standing with the hands on the chair back for support, slowly rotate and flex all the major joints and the torso."

Books about chair exercises are available at many book stores and libraries.

Other ways to work the joints while improving cardiovascular health and muscle tone are swimming and water aerobics.

Herd says exercise should be "stopped any time there is pain. Angina (chest pain) should be taken seriously, but does not necessarily mean there is a heart attack. If it occurs, stop the activity and stand or lean against something for a few minutes -- then call your doctor.

Many stressful exercises such as running, tennis or rowing can put a strain on the cardiovascular systems of people who do not exercise regularly. Anything other than a simple calisthenics, walking or chair exercises should be discussed with a physician.

Herd is living proof that exercise can benefit people of all ages. He is 62 years old and runs about 30 miles each week, a level of exercise he reached by gradually increasing his effort over many months.

"I know that most people my age have not exercised all their lives and cannot jump into a heavy workout schedule," Herd said. "Still, that is no excuse to put off exercise. Simple exercises will improve mobility, health and frame of mind in the elderly."

EPA Amendment

An amendment aimed at requiring the Environmental Protection Agency to provide a cost-benefit analysis on every regulation it publishes has been blocked by the House of Representatives Rules Committee. But people have an opportunity to turn the situation around, according to Bobby Roberts, president of the Coke-Sterling County Farm Bureau.

"Legislation which will give EPA Cabinet-level status will be one of the things considered when Congress returns. The Risk-Benefit amendment would make them stop and think before imposing excessive and costly regulations. It only makes good sense," Bobby said.

The amendment was added in the Senate, but disallowed in the House. Texas Farm Bureau is urging its members to write their congressmen and request opposition to the EPA Cabinet-level status bill (H. R. 3425) unless a vote is provided for by the House of Representatives on the Risk-Benefit Amendment.

Under a complicated procedure, Farm Bureau and others are asking that the Rule for H. R. 3425 be defeated, thereby forcing the Rules Committee to allow the House to vote on the Risk-Benefit Amendment.

"It is appropriate that the will of Congress be heard on this issue," Roberts added.

In addition to the risk-benefit effort, the legislation currently provides for a number of other policy directives. Specifically, it requires the establishment of a benefit assessment office for minority businesses.

"Our argument is that as long as other mandates are included, so should the Risk-Benefit Amendment for all regulations," the county Farm Bureau leader insisted.

Bobby Roberts said anyone concerned with the growth of burdensome and intrusive regulations should act quickly.

"Handwritten letters in your own words will be most effective when writing your Congressman," he said.

Is It Asthma?

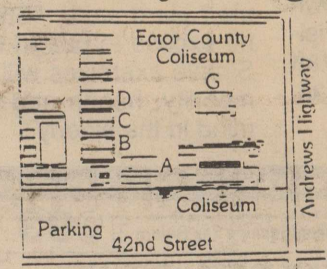

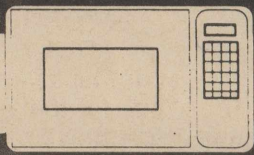

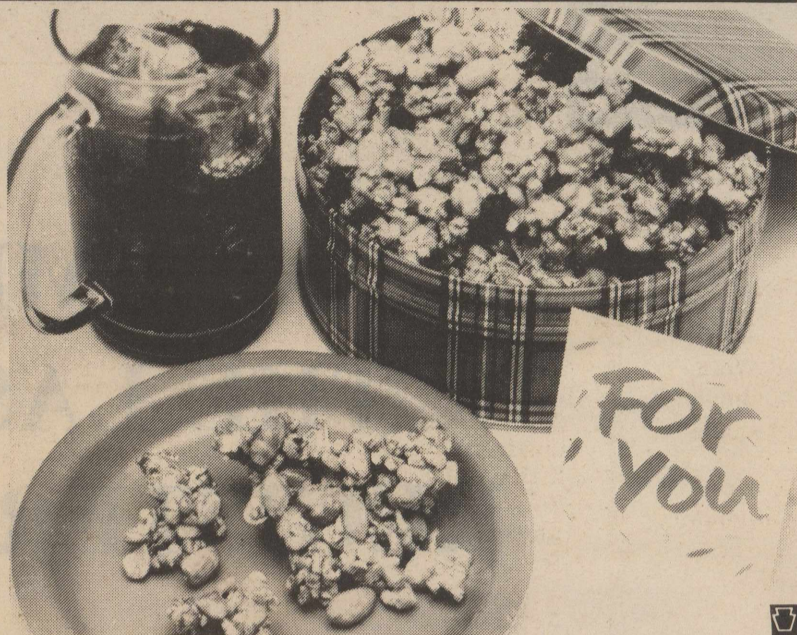

SNACKS TO SEND

the microwave way



(DM)— "We miss you." "For a study-break snack attack!" "For you - just because..." Whatever the reason, a snack package, delivered in person or sent through the mail, is one of the nicest ways to show how much you care for a special friend or family member.

Popcorn is always a favorite snack because it's easy to fix, especially with the microwave varieties available today. It also stores and travels well. With microwave recipes like Golden Caramel Corn and Jazzy Flavored Popcorn, an extra-special treat is simple and quick to prepare. Whirlpool Corporation home economists recommend sending it in an airtight food storage bag. Or choose a decorator tin that fits the occasion or season. Then you can send frequent refills!

GOLDEN CARAMEL CORN (3 quarts)

- 1 bag (3 to 3½ oz.) microwave popcorn, popped (2½ to 3 quarts)
- ½ cup dry roasted peanuts
- ¾ cup firmly packed brown sugar
- 6 tablespoons margarine or butter
- 3 tablespoons light corn syrup
- ¼ teaspoon baking soda
- ½ teaspoon vanilla flavoring

1. Combine popped corn, discarding unpopped kernels, and peanuts in large (4 quart) glass mixing bowl. Set aside.
2. Combine sugar, margarine and corn syrup in 1-quart glass measuring cup. Microwave at HIGH (100%) until margarine melts (about 1 minute).

3. Stir in soda and vanilla until mixture is foamy. Pour over popped corn and peanuts, mixing until evenly coated.
4. Microwave, uncovered, at HIGH for 4 minutes, stirring twice. Spread mixture on buttered jelly roll pan to cool. Store tightly covered.

NOTE: Mixture is very hot. Use hot pads.

JAZZY FLAVORED POPCORN

- 2 bags (3 to 3½ oz. each) microwave popcorn
- 1 package (1¼ oz.) dry cheese sauce mix
- OR
- 1 package (1½ oz.) dry mild taco seasoning mix

Pop corn. Pour into large bowl. Sprinkle with cheese sauce mix or taco seasoning mix. Toss and enjoy. Cool before storing in airtight container.

USING HOT PADS: It is important to remember that while microwaves do not heat glass or other microwaveable cookware, they can still become hot. The container often becomes heated by the food being cooked. Use hot pads.

...It's the Law in Texas

DPS RESPONDS
to Questions from Texas drivers
about the Safety Belt Law

Q. Who must use safety belts under this state law?

A. All drivers and front seat passengers are required to use them whenever they ride in safety belt-equipped cars or trucks of ¾-ton capacity and below.

Q. Can I be fined for failing to comply with this law?

A. Yes. Effective December 1, 1985, an offense is punishable by a fine of \$25 to \$50.

Q. Did the child safety seat law change?

A. No. Children under two years of age still must be secured in a federally-approved child safety seat system when they are riding in any seat equipped with a safety belt in a passenger car or light truck (¾-ton capacity and below). Children from two to four years of age must be secured by a safety belt or child safety seat system when riding in any seat equipped with a safety belt in a car or light truck.

Q. Who would be cited for a violation of the safety belt law?

A. If the unbelted person is under 15 years of age, the driver will receive the ticket. If an unbelted person is 15 or older, that person will receive the citation for the violation.

Q. Are any persons exempted from complying with this law?

A. Yes. The law does not apply to a person who possesses a written statement from a licensed physician stating that for medical reasons, the person is unable to wear safety belt. Also exempt are U.S. Postal Service employees when they are servicing postal boxes or performing duties for their agency requiring frequent entry and exit from vehicles.

Q. What if the safety belts have been taken out of the car?

A. If safety belt anchoring hardware came as original factory equipment on the car, the belts should be present and in use by front seat occupants riding in the vehicle.

Q. What about older cars and light trucks which came equipped with only lap belts or no safety belts at all?

A. If the older model vehicle did not come equipped with a shoulder strap like the newer models, use of the lap belts alone by front seat riders is permitted. Vehicles not originally equipped with safety belt anchorages are not required to have safety belts.

Q. Can I be cited if there are more people riding in the front seat than there are belts for?

A. No. The law states that each person occupying a seat equipped with a safety belt must be secured by the belt. As an example, if three persons are riding in the front seat and three belts are provided, all must be buckled in. If only two belts are provided, the two persons in the belted positions must be secured by the belts.

Q. Can residents of other states be cited for breaking this law?

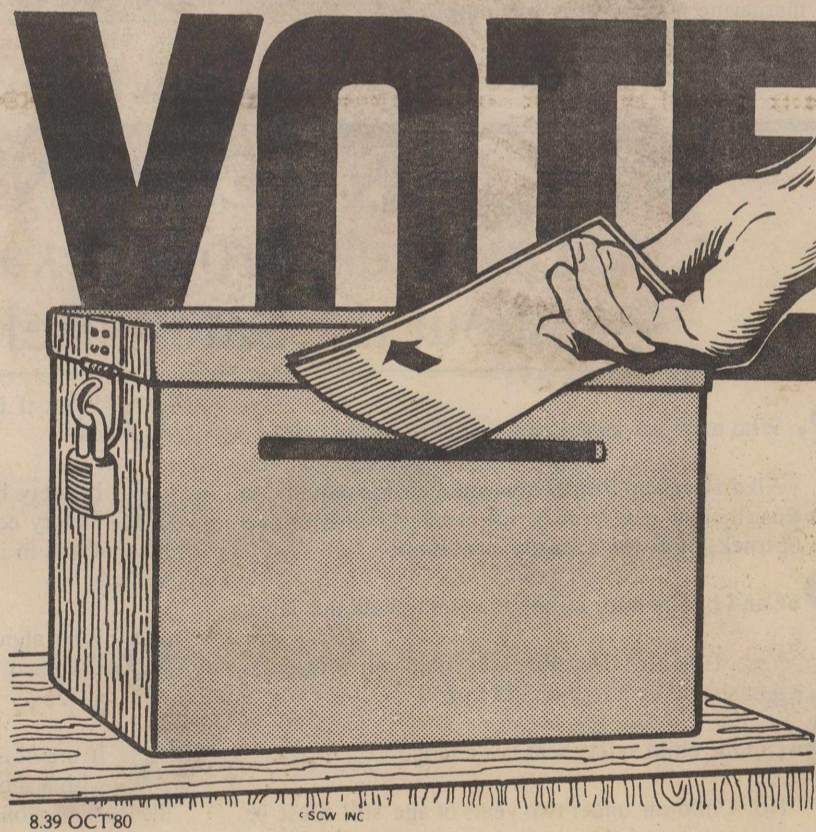
A. Yes. The statute applies to anyone riding in the front seat of the specified vehicles while they are being operated on roads, streets or highways of Texas.

Q. What if the belt doesn't fit?

A. Auto manufacturers have made belt extenders available for larger persons.
