## Thunderstorms produce tornado at Oak Creek Lake

tinued to rove the area at press-time Wednesday which have produced several confirmed tornado funnels. Monday's storm cells spawned a small twister shortly after 8 am in Eldorado with damage to several mobile homes, trees, and outbuildings but, luckily, no injuries.

Tuesday dawned cold and showery and weather reports from National Weather media channels began to warn at mid-morning of weather conditions, possibly with damaging hail, winds, or tornadoes to the west.

Shortly before 2 pm a tornado struck at Oak Creek Lake, near Blackwell. Damage was extensive to several homes, boat docks, storage buildings and large trees on the east side of the lake.

According to Deputy Jeff Barnes, about 10 homes sustained storm damage; two had extensive structural destruction, that of a Mrs. Eckert and the Grady Coulter home. He reported Mrs. Eckert was at home and heard the roar of the twister and took refuge in a bathroom. Coulter was also in his home when the storm took his roof off. The Larry Spivey home also received extensive damage when a

Strong thunderstorms con- large tree was uprooted and crashed on the house. Several power lines were down and left residents without power for several hours. Funnels are notorious for strange occurrences and Barnes said, "pavement from the surface of the dam crossing the lake to the east side was peeled back like an orange peel". Fortunately, no injuries resulted from the

Deputy Wayne McCutchen was also on hand at Oak Creek as he and Barnes surveyed the damage and offered assistance if needed.

As storm cells moved west to east two twisters were sighted in Glasscock County and a tank battery was struck by lightning in Sterling County, causing a fire that was allowed to burn itself out by volunteer firemen. Two funnels may have formed north of Sterling City. A small tornado formed near Wingate in Runnels County where thunderheads dumped 5 inches or more rain. Abilene and Taylor County received torrential rains, up to 7 inches in places.


Coke County received varying amount's during Tuesday's deluge, from 1.8 inches in the southwest to 3.90 in the north and east areas.

Several new members were seated on the governing panels of local taxing entities in Robert Lee elections last Saturday.

In the city balloting, the mayor's position was retained by Jackie Walker, who was unopposed, with 119 votes. Complete election totals included newcomer John Conley, 124 votes for an unexpired council term; two open positions for city alderman drew three new candidates - Donnie Devoll, 140; Kelly Nichols, 129; and Kenneth Green, 39.

Dianne Simpson, a new candidate, drew the most votes, 196, for the Robert Lee ISD board of trustees, while the other two vacancies will be filled by incumbent Beverly Burdett, 156, and Darrel Pitcock, a former board member, 128. Other candidates were Larry Hayes with 109 votes and Kim Hodge had 68 total.

Three vacancies existed on the board of directors for the West Coke County Hospital District. Another newcomer, Bill Carwile, was the top votegetter with 193, followed by incumbents Winton Milliff, 154, and Steve Whiteker with 131. Linda Arledge, longtime member of the board, had a 73 total.

Dear Editor,

We, the directors of the East Coke County Hospital District, realize that the community has entrusted us with the responsibility of planning for the future of the Bronte Nursing Home and the future of the elderly who reside in our community. We are very concerned that due to the small size of our facility that many of our sick, elderly citizens must be placed in other cities and nursing homes to meet their needs. Not only is it a hardship on the families who must travel to these other cities, but we are not fulfilling the basic responsibility that was set forth by the founders of the East Coke County Hospital District. The mission statement was to provide services to the needy inhabitants of the district.

The Board of Directors have intentionally kept private pay rates as low as possible, to benefit the self-paying patient. Many of our patients were and some still are, taxpayers to this hospital district.

We have received many comments from citizens in Bronte, about adding on to the nursing home. Many citizens have voiced concern about having to go elsewhere for nursing home care. But this takes money, alot of money, and we have hesitated simply because we knew it would have to come from the taxpayers. In order for the nursing home to meet its obligations now, a tax increase is inevitable. It is estimated that a 60-bed facility is the breakeven point!

The Bond of \$700,000 will be paid off in ten years. We feel that it is time to take the PLUNGE and ask the taxpayers to take the PLUNGE with


Williams, Burns, and Blair are seniors; Tavarez is a freshman, and Vincent is a junior.



# Breast-Feeding Update

Having a baby at a young age has long been considered some kind of protection against breast cancer. Now a study coordinated by researchers at the University of Wisconsin shows a relationship between breast-feeding and a reduced risk of breast cancer prior to menopause.

Dr. Polly Newcomb and her colleagues reported, in the New England Journal of Medicine (1-13), that women may reduce their risk of breast cancer before menopause twenty to thirty percent if they breast feed at least three to six months compared to women who did not breast-feed.

However, the study confirmed other separate risks for breast cancer including a family history of the disease, having no children and obesity. An accompanying editorial notes that while breast cancer in premenopausal women accounts for less than a quarter of all cases of breast cancer in the United States, the opportunity to reduce the risk should be welcome news, especially for young women. ©1992, Lyle Dean, Inc.
