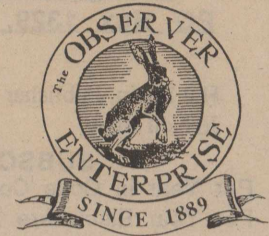

Juvenile facility contracts finalized

Legal documents joining Coke County with Wackenhut Corrections Corporation in the construction and operation of a female juvenile justice facility near Bronte were finalized Tuesday afternoon. Judge Lee and Commissioners Burns, Tidwell, Luckett, and Millican signed necessary contracts shortly after 3 pm at the county courthouse.

Present at the signing were Wayne H. Calabrese, Wackenhut vice-president, and Barney Knight, attorney for Biggerstaff, Heath, and Smiley.

A series of snags since the May 27 announcement by Texas Youth Commission of the Coke County selection for a model female offender facility has delayed plans to move forward. One of the

glitches included the necessary re-location of the site from the one mile west of Bronte on Hwy 158 to a 32 plus acre site one mile south of Bronte on Hwy 277.

The model unit, as directed by TYC, will include 75-100 beds for juvenile female offenders who will receive education, counseling, and alcohol and substance abuse treatment as needed to return to a normal life based on individual response and sentences. Payroll at the facility is a projected \$3.6 million with an employment of 80 people.

County and city officials, along with businessmen and citizens of both Robert Lee and Bronte, have worked long and hard since early in the year to bring about the location of the facility in the coun-

ty. This work has culminated in the completion Tuesday of the final paperwork.

According to County Judge Royce Lee, Dinosaur Construction Company of Glen Rose, Texas, has been awarded the contract for construction. Danny Butler, contractor, will begin preliminary dirt work and foundation preparation immediately. The race will be on at this point for the Texas Youth Commission mandated October 1, 1994 occupancy.

Coke Co. All Stars win big

The Coke County All Stars traveled to Carlsbad Tuesday night with one thing in mind - to win. The boys did just that - and in a big way; the final score was a whopping 20-7 victory for the team. They faced off against a good North Concho All Star team, but good defensive play, excellent pitching and some heavy hitting by the Coke County boys were just too much for the North Concho team to overcome.

The first inning told the story for the entire night with Coke County scoring 4 runs and holding the North Concho team scoreless. North Concho came back in the second to score 3 runs to Coke County's 2, making the score 6-3 going into the third. Excellent defensive play by both teams made for a scoreless third inning. North Concho scored the only run in the fourth and tensions were starting to mount as they pulled the score to within 2, but that was as close as it came all night.

The top of the fifth inning was a showcase for maturity and determination by the Coke County team. The team

had two outs and things were looking pretty grim for scoring opportunities when the heavy hitting started. Evidently no one told them that having two outs and no one on base was a "bad thing, man". The All Star team scored 8 runs before making the final out of the top of the fifth and then held North Concho to only one run to finish out the inning.

Correction

A mistake appeared in last week's newspaper account of the Special Session of the Coke County Commissioner's Court. The report stated that after the 16 year payout of the facility (in which the county would own the facility), the estimated minimum return would be \$73,000 per year. Fire consumes 3792 acres

Lightning striking to the ground in a sudden thunderstorm late Tuesday night must have made area firefighters cringe. They had finally breathed a collective sigh of relief on Sunday afternoon late, after a five-day battle of a stubborn range fire in southern Coke County. That fire began as a lightning strike between 5 and 6 am on the Jack Corley place Wednesday morning of last week. Before the mop-up, with probably a couple of hundred individual firefighters on the scene at one time or another, damages were estimated at over \$300,000. Coke County Commissioner James Tidwell, in whose precinct the fire raged, said the charred area covered 3,792 acres.

Tidwell observed that more damage would have occurred, given the high temperatures, wind velocity, and rough terrain, had it not been for the all-out help from surrounding fire departments and volunteers. Firefighter units from as far away as Menard responded to the range fire. Texas Forestry Service, Goodfellow Air Force Base, and countless other units were also on hand. Robert Lee, Bronte, and Blackwell spent long hours at the fire and were backed up by Tom Green County units and a unit from Lohn. He

could not praise firefighters enough and also had high praise for the Salvation Army unit from San Angelo who provided water and drinks for those working. Although the fire created grave losses he said it was gratifying to see people willing to come to the county's and property owner's defense when needed. It gave a feeling of old-fashioned unity, he said, not often demonstrated in this day and age.

Fortunately, no one was seriously injured during the five-day blaze. A Goodfellow firefighter suffered a rattlesnake bite and was taken to San Angelo where doctors treated and released him. The terrific heat, sometimes over 110 degrees, also caused problems of dehydration and heat exhaustion.

Much of the burned acreage was on large ranches, some leased by county ranchers; the Greenland suffered quite a loss, along with Jack Corley, Mitt Arrott, Jim Price, and others. Fences had to be cut in places to allow for the escape of cornered livestock; no losses have been reported. One deer camp accounted for the only structural loss.

Despite miles and miles of firebreaks, the fire reached southwest to within 3/4 of a mile of Highway 208.

To the people who oppose this the loudest, I challenge you! Where do you buy your groceries, your clothes, or medicine?

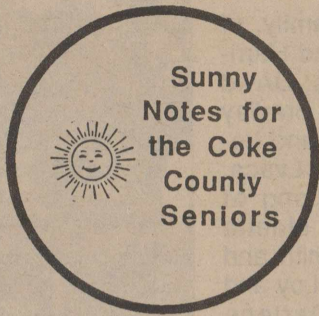

Calving difficulty in beef cattle

There are some common myths among beef producers that reducing dietary energy during late pregnancy will decrease fetal size resulting in improved calving ease, whereas increasing energy will increase fetal size leading to higher incidence of dystocia (calving problems). Generally speaking, research completed at the Meat Animal Research Center in Nebraska on thousands of head of various breeds of heifers show that lowering the energy allowance will decrease birth weights but will not significantly reduce dystocia. Increased dietary energy levels increased birth weights slightly but did not increase dystocia, in fact the incidence of calving difficulty was actually lower in the medium to high energy level fed heifers.

The same goes for concerns over the amount of protein fed during the last trimester of pregnancy. Again, research has found that heifers fed below normal amounts of protein had significantly lighter calves at birth and less calving problems but the heifers fed high amounts of protein gained more weight, had high condition scores at calving, maintained more body weight throughout the study and weaned significantly heavier calves. This plus other studies showed that levels of protein had very little or no affect on amount of dystocia.

inadequate levels of energy or protein of the young developing heifer can affect her subsequent calving performance. Restricting the energy level or protein level of weaned heifer calves during the first year can have a carry-over effect, resulting in decreased pre-calving pelvic area and increased dystocia. Young first calve heifers must have their energy protein levels met in order to ensure maturity and growth in the heifer and calf performance following calving. There has shown to be extremely little difference in calving difficulty with properly fed heifers and the benefits for the future far outweigh any chance of calving difficulties.

One other tip for calving first calf heifers would be the time of day they are fed. It has been shown that heifers or cows that are fed late in the day show a significantly less chance of calving during the night than cattle fed early in the day. By feeding late in the day, studies have shown that a large percentage of the heifers will calve during the daytime allowing producers to check them a little closer.

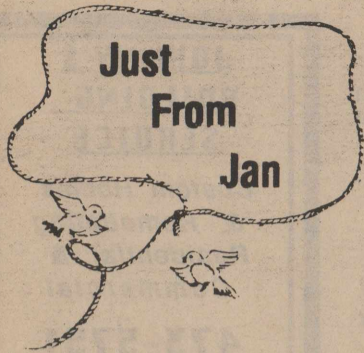

Exercise and weight management

Ingrained in our society is a belief that being overweight is caused by overeating. This belief is expressed in an endless array of calorie-restricted diets, diet books, chemical appetite suppressants and other weight loss aids. However, we know from experience that low-calorie diets alone rarely work.

Research shows that of those who are successful at losing weight, more than 95 percent will regain the weight lost within a year.

Exercise and physical activity go hand-in-hand with weight management. Why? What's so important about exercise? Here's a list of very good reasons to make exercise one of your lifestyle choices:

*The more calories your body burns, the more weight you can lose. Every time you make a choice to move rather than sit or lie around, you use more calories.

*If you exercise daily, a higher proportion of the weight you lose will come from fat deposits.

*Exercise has an effect on appetite. If you exercise hard before a meal, you will decrease your appetite.

*Physical activity speeds up your metabolism while you are exercising.

*As you lose weight, your body will feel firm because your muscles are toned.

*Your cardiovascular system will improve its ability to re-

spond to stress and exercise.

*Physical activity added to a dull routine will relieve some of the boredom and loneliness that can make you want to eat.

*You will be in a better mood and have more fun and enjoy life more.

It is a misconception that training causes body fat to turn into muscle and that when you stop training for a while the muscle turns back to fat. Muscle and fat cells are completely different, structurally and functionally. However, weight training can help you lose body fat by burning calories - a nonstop half-hour workout burns about 200 calories. In addition by building muscle you increase the rate at which your body burns calories (metabolic rate) since muscle is very active tissue that requires lots of energy. Thus, as you gain muscle through weight training, you may lose body fat if you maintain your normal calorie intake - a desirable change in body composition that will make you look trimmer whether or not you lose weight.

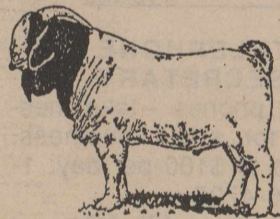

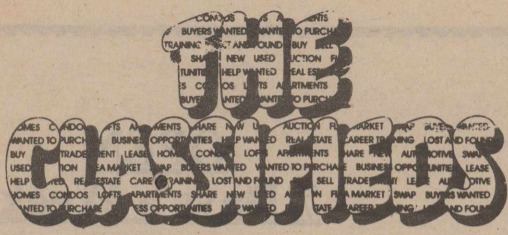

Again the July 4th Ice Cream and Fireworks Social was a big success. Almost one hundred attended the fireworks display.

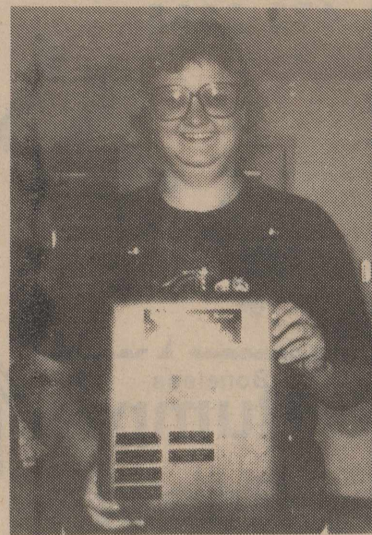

Spring Allergies?

Spring is in the air, but that is not all that is in the air. Bulbs may burst into bloom and birds may be singing, but grass and trees are also sending forth their pollen. Those are a few of the reasons spring is also the sneezin' season. Do not, however, be too quick to blame the budding spring for your sneezing and sniffles.

The University of Texas *Lifetime Health Letter* says only ten to twenty percent of us actually have allergies, although many more of us think we have. Dr. Richard Mabry, professor of otorhinolaryngology at the University of Texas Southern Medical Center at Dallas, says the first signs of a cold are the same as allergy symptoms—the sneezing, congestion, watery eyes and runny nose.

He says if nasal secretions are thick and colored, the problem is probably not an allergy, but may be a cold. If these symptoms last longer than a week, a sinus infection may be involved and require a doctor's attention.

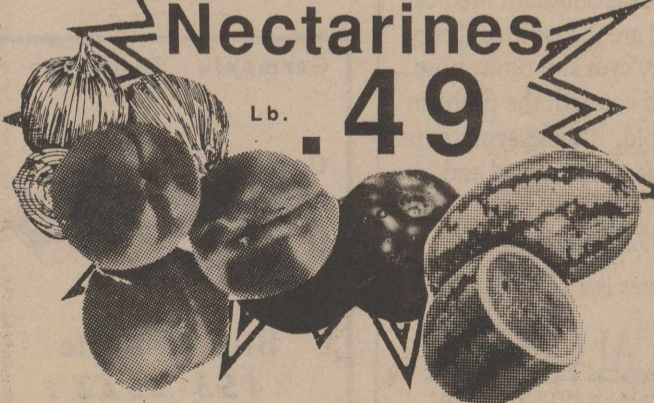
