A total of 127 characters from Coke County's history will be seen on stage. There are not quite that many doing the acting, because numerous people take more than one character to portray, making the actual cast a probable 110. They memorize, practice, and practice, and practice and love it!

Don't figure that is the total number working to give the audience a good show! Consider the narrator, the light and sound operators, the '64 Study Club members, Masonic Lodge and Eastern Star members and others who register people as they enter Twister Avenue to buy tickets; those who man the ticket booths, concession stand, the souvenir booth and Coca Cola truck, those who take tickets and programs; those who sell advertising for the program and who obtain publicity in publications over the country, on TV stations, and radio and help with poster distribution; those who write the original scenes, compose the songs, direct scenes and choir, gather props for actors to use, moved props on and off stage, and who try to keep children who are not in the cast from playing back stage and getting in the way.

RLVFD Equipment Needs Part One: Greg Fleming, Secretary/Treasurer

It is easy to be complacent about fire-fighting equipment as long as there are no fires. However, our current hot, dry spell and a couple of recent fires points out some deficiencies in the Robert Lee Volunteer Fire Department equipment inventory.

Specifically, these men and women are being asked to fight your fires in Central and West Coke County with trucks which are for the most part 20 to 30 years old.

The following is a list of the trucks used by the RLVFD:

1. 1963 Chevrolet pumper truck: has a 500 gallon tank with a 500 gallon per minute pump, owned by RLVFD;

2. 1969 Ford 2 ton, 900 gallon tank with a 250 gallon per minute pump, owned by RLVFD:

3. 1967 Dodge 10 ton, Detroit V-8 diesel engine, 5,000 gallon tank with a 600 gallon per minute pump, use provided by the Texas Forestry Service.

4. 1971 American General 2 1/2 ton, 6 wheel drive diesel, 1200 gallon tank with 250 gallon per minute pump, use provided by the Texas Forestry Service;

5. 1989 Ford Super Duty 1 1/2 ton, 600 gallon tank with a 250 gallon per minute pump,

owned by RLVFD.

The last three of these trucks are in good operating condition. The first two need replacement.

All of the trucks listed above can fight fires inside the Robert Lee City limits. All of these trucks but the 1963 Chevy pumper truck fight fires outside the city limits -- should you ever have a fire in town while the pumper truck was out of town, your insurance policy would not be liable for your damages. Thus, this truck NEVER leaves to fight out of town fires. A city pumper truck this old must be certified by the state yearly -- it barely was able to certify in its most recent test. Should this truck ever fail to re-certify, and we had no certified replacement, fire insurance rates for all structures in the city of Robert Lee would increase 2 1/2 times. The City of Robert Lee needs to replace this

The 1969 Ford has for years been our most useful and versatile piece of fire-fighting equipment. In fact, that's the problem now -- it has been

used hard for years and years, and it is worn out and undependable. For example, during the range fire a couple of weeks ago, it was the only truck still in town available to fight a structure fire in Edith: it was hard to start and when it finally made it to the fire there were problems getting the pump to work. Rural residents and property owners ought to especially be interested in replacing this truck because this type of vehicle can get to outof-town structure fires much quicker than the military-type vehicles provided by the Texas Forestry Service.





"I hear the train a comin', it's rolling through". . . . Coke County. These were the words that were sunf, to us, by the great Johnny Cash. But to me, these are the words that were secretly spoken in the terms of local and county politics in our county.

Let me begin, by saying, that I'm not accusing anyone of anything, unless they are guilty of the act! I would like to say I am not against the Women's Correctional Facility, it is the way in which this particular facility was brought to Coke County, that many citizens are concerned.

First of all, the word was spread that Coke County had a chance to host a female correctional facility. The facility was to hold 75-100 beds and employ approx. 80 people. Of course, all city and county officials rose to the occasion, saying what a great opportunity it was to hold such a facility in Coke County. With much travel, expense, work, and success, Coke County was selected as the host site over several other larger cities throughout Texas. Why Coke County?

I am proud to be from Coke County, proud to host such a facility, proud that it will "supposedly" boost the employment and economy. But I am not so proud of the fol-

First of all, it bothers me that the people of Coke County were solely dependent upon the mayors, judge, and commissioner's court of our county on any decisions concerning the type of facility, placement of facility, taxes to be incurred, etc...(We pay taxes, they should pay--the people should have a voice.)

Secondly, that citizens, located near the proposed sites were not given notice or any orientation of a possibility of the facility being located "next door" to the site and what to expect.

Third, it concerns me, that very few people have seen a proposed architectural drawing of the facility, specification of the facility, etc...

Fourth, that, city and county officials along with a select few, were the only people knowledgeable to the proposed sites.

Fifth, it seems to me, the present site of the facility, that is owned by an elected county official and that happens also to be on the committee. should not have been considered as a possible location for the facility.

Sixth, next we have the problem of the excess sewer water, which is being disposed of on the present site of the facility. This has been a "dump ground" for the sewer for several years. After completion of the facility at the present site, what will happen to the sewer water?

Seventh, it bothers me that the people that reside around, or own property around the proposed site, will realize a substantial reduction in their property value, but their various tax values will probably remain the same.

Eighth, it also bothers me, that the city and county officials, cannot inform the people that reside in the area of the location of the facility, of information and development of the facility.

Ninth, as in other situations that have happened around the country, it deeply concerns me that these elected officials, have not seemed to have any care or concern about the feelings of the majority of the citizens of Coke County, that elected them to these select positions.

Tenth, in closing, a synopsis of the overall concern of myself and numerous citizens of Coke County, is this facility could have been brought to Coke County in a sensible manner, could have been located at a site away from residential areas, and the people could have had a "voice" in

the matter.

I guess the saying "The Big Dog Always Gets The Bone", may be true in this situation, and the "little" people are always the ones that get hurt.

Alzheimer's Disease

The seven warning signs of Alzheimer's Disease are: 1) asking the same question over and over again; 2) repeating the same story, word for word, again and again; 3) forgetting how to cook, or how to make repairs, or how to play cards - activities that were previously done with ease and regularity; 4) losing one's ability to pay bills or balance one's checkbook; 5) getting lost in familiar surroundings, or misplacing household objects; 6) neglecting to bathe, or wearing the same clothes over and over again, while in-

sisting that they have taken a bath or that their clothes are still clean; 7) relying on somebody else, such as a spouse, to make decisions or answer questions they previously would handle themselves.

The purpose of this list is to alert the public to the early warning signs of one of the most devastating disorders affecting older people. If someone has several or even most of these symptoms, it does not mean that they definitely have the disease. It does mean that they should be thoroughly examined by a medical specialist trained in evaluating memory disorders, such as a neurologist or a psychiatrist, or by a comprehensive memory disorder clinic, with an entire team of experts knowledgeable about memory problems.

Morris McFadden, an officer in the Concho Valley Alzheimer's Support Group, will be at the Bronte Senior Center on Tuesday evening, July 26th at 7:00 p.m. to help shed some light on this disease. If you have a family member you think might have some of these symptoms, or if you just want to learn more about Alzheimers' you are welcome to come to the program. It is open to all ages, not just senior citizens.

HEALTH NOTES

Baseball & Softball Safety

Nearly five million American children take part in baseball and softball programs each season. Serious injuries are rare, but some safety concerns have been raised among parents. The American Academy of Pediatrics has issued new safety guidelines including use of safety equipment, such as batting helmets, rubber spikes and proper catcher's equipment-chest and neck protectors, helmet, and mask.

The guidelines also call for elimination of the on-deck circle, avoiding head-first slides by children under ten and use of breakaway bases to prevent sliding injuries. It would also limit pitching to prevent overuse injuries. The American Academy of Pediatrics Committee on Sports Medicine and Fitness says baseball and softball are generally safe, but chances of injuries, minor and serious, can be reduced by these preventive measures.
