## Wackenhut hosts interviews at Bronte

Parking spaces were scarce at the Bronte School Cafeteria and Library last week. The cause of all the commotion was the job and vendor fair for the new juvenile justice center being built just south of Bronte. Interviews were being held for prospective vendors and employees for the new facility, which is set to open in October.

Wackenhut Correction Corporation will operate the Coke County facility, and will employ approximately eighty at the new site.

Since all the applications have been submitted last weekend, the facility administration will screen the applications and begin selecting candidates for second interviews.

There were 46 vendor applications made on Thursday and Friday morning. Vendors from Abilene, Ballinger, Blackwell, Bronte, Robert Lee, San Angelo, and Winters made applications.

It was reported by Wackenhut that 450 persons were interviewed for working positions.

Applicants from all over Texas and other states were interviewed for jobs. There were applicants from the following cities: Abilene, Amarillo, Anson, Arlington, Austin,

Ballinger, Big Lake, Big Spring, Blackwell, Breckenridge, Bronte, Brownwood, Carlsbad, Christoval, Clyde, Colorado City, Columbus, Mississippi, Dunn, Eastland, Fort Stockton, Grape Creek, Hamilton, Hurst, Joplin, Missouri, Joshua, Junction, Kermit, Knickerbocker, Menard, Merkel, Mertzon, Midland, Miles, Monahans, and Muleshoe.

Also applying for positions were persons from Norton, Novice, Ovalo, Pecos, Robert Lee, Rowena, San Angelo, San Antonio, Sanderson, Santa Anna, Silver, Snyder, Stephenville, Sterling City, Sweetwater, Water Valley, Waxahachie, Wingate, and Winters.

Wackenhut manager Paul E. Bailey; Director of Start-up planning and Execution Mathew DenAdel; Erica Olson, the Coke County Juvenile Justice Center Administrator and many more from Wackenhut, state workers, and volunteers worked constantly during the interviewing days.

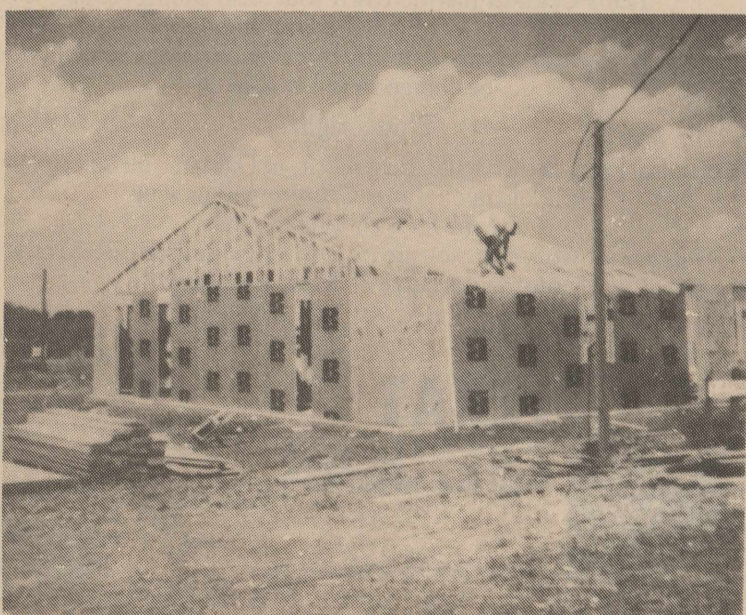
evening. "Kickoff the season" by bringing your lawn chairs and attending this special "beginning of school" event to support our school activities.

Funeral services for Dave King, 89, lifelong resident of the Edith community, were held Monday afternoon, August 8, at the Robert Lee Baptist Church. Burial followed in the Paint Creek Cemetery, not many miles from his birthplace. Officiants for the services were the Rev. Ray Aldridge, pastor of the Emmanuel Pentecostal Church and the Rev. Roy Epper, pastor of the Robert Lee Baptist Church.

He died at his ranch home at Edith Saturday, August 6, following a lengthy illness.

David (Dave) Oscar King was born November 19, 1904 at Edith, west of Robert Lee, to Sam and Anna Benson King. He was a stock farmer and a member of the the Emmanuel Pentecostal Church. He served as a Green Mountain School trustee and county trustee for fifty years; a director on the board of West Coke County Hospital; served several terms on the REA board in the late 40's and 50's; and had served as president, vice-president, and director for the Farm Bureau where he was an active member at the time of his death. Mr. King was a longtime Democratic Election Judge of the Green Mountain precinct #9 until his death.

His survivors include his wife, Vivian King, of Edith; three daughters and husbands, Gwen and Harry Anderson of Granite Shoals, Zona Mae and Dan Hall of Columbus, Ohio, and Joyce and Bobby Walker of Odessa; five stepsons, Carl Blair and Frank Blair, both of Bronte, Dwayne Blair of San Angelo, Wayne Blair of Pueblo, Colorado, and Dennis Blair of LaPryor; four stepdaughters, Madell Thomas of Arlington, Vivian Keel of San Angelo, Doris Akin of Richvale, California, and Eunice Wilkerson of Irving; one brother, R. The registration books made interesting reading. It is very gratifying to see how many local names appear every year, proving that citizens are really appreciative of the actors' and directors' efforts.

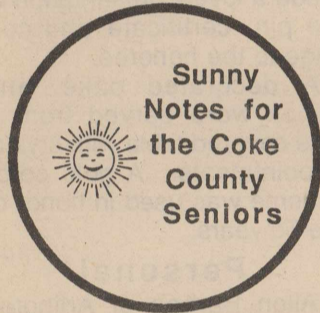

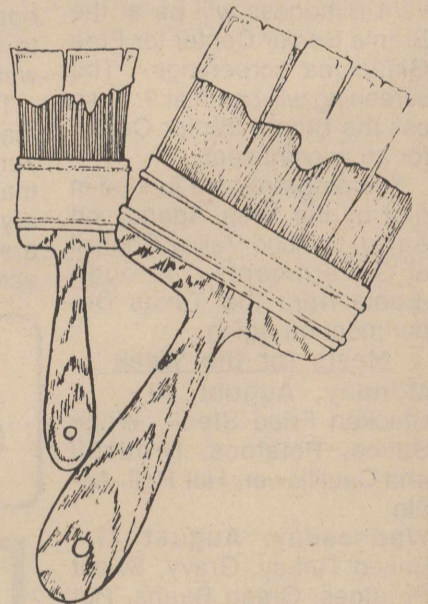

# HEALTH NOTES

## Dizziness

Among the top ten reasons people go to their doctor is dizziness. A common cause for dizziness is an inner-ear disorder, but surprising may be the finding that nearly half of those who complain of dizziness may have significant psychiatric problems.

A study, published in the *Archives of Internal Medicine*, by researchers at Johns Hopkins, the University of Washington, Seattle, and University of Texas at San Antonio, found that those without an inner-ear problem were much more likely to have major depression, panic disorder or somatization—which occurs when a person converts a mental state into a physical symptom.

Dr. Michael R. Clark and his colleagues say people whose dizziness is caused by emotional problems are every bit as incapacitated as someone with an inner-ear problem, but diagnosis may be more difficult and frustrating for both the patient and his or her doctor.

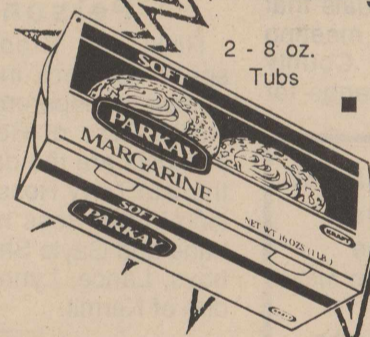
