Two candidates have officially filed as write-in candidates for the November 8, 1994 general election. Meeting those requirements as set forth in Texas election laws were Jackie Walker and Jack G. Moore.

Mrs. Walker will be a write-in candidate for county judge. She is currently the mayor for the city of Robert Lee. She is opposing Coke County Judge Royce Lee, still in his first term in that position. He was unopposed in the Democratic Primary in March, 1994 and his name will appear on the November ballot.

Jack G. Moore is now serving the unexpired term of former Peace Justice Gary Shaffer, Precinct 2, in Bronte. Moore will wage a write-in campaign for that justice of the peace position. Bruce Sonnenberg won the Democratic Primary in March, 1994 and will be on the November 8, 1994 ballot.

During her farewell speech, marking the end of her oneyear reign, at the coronation ceremony, Shelley recalled that cowboys had always been her heroes since she was young. Now these heroes have turned into friends during her travels which crossed Texas many times. As far as she is concerned the Miss Rodeo Texas honor has allowed her to "win her gold buckle" as a dream come true. She lived every girl's fantasy of travel, the spotlight, glamorous clothes. and meeting a lot of wonderful people.

According to Shelley, the long hours of travelling alone and being away from home afforded her a chance to think about life in a positive way, one being "the cowboy way". That philosophy has always meant right or wrong, with no gray areas.





The time has come! The event we all look forward to each year. Only one week 'til Robert Lee High School's Homecoming '94. The students at RLHS have been busy planning for this event.



Burn Risk

An estimated twenty-six thousand children and teens are hospitalized each year for fire and burn injuries. More than half involve children younger than five. A two-year study of children under five who needed hospital treatment for burns provided a closer look with a surprising finding—that eighty-eight percent of all burn cases involved children between six months and two years of age.

The study. conducted by the Centers for Disease Control and Prevention, showed a striking relationship between the risk of burns and the age at which children acquire the ability to reach, crawl, climb, and walk—too many times with precarious lack of control.

Scalding was the most common cause of burn injury. Drs. Paul Simon and Roy Baron say most burns were apparent accidents. but intentional abuse was suspected in almost twenty percent of the cases. They say parents need to be told of the particularly high risk of burns during late infancy and the early toddler period.

Small Grain Products

Hopefully, we will receive some rain soon and sow our small grain for winter forage and grain production. There are several important decisions to make before we sow our grain.

First, fertility is probably the most limiting factor besides moisture. The best source of information for fertility is a soil test, but if you have not taken one there are a few pointers on deciding how much fertilizer to use. For forage production small grains will use 70 lbs. of Nitrogen per ton of forage, 20-40 pounds of Phosporous, and 20-40 pounds of Potassium. For grain production it requires 2 lbs. of Nitrogen for each bushel of grain produced and 0.8 pounds of both Phosphorous and Potassium.

If grain is to be grazed, about 2/3's of the nitrogen needs to be applied at or near planting. If it is for grain production only, then 30-40% applied in fall and the rest in the spring. Fertility levels at or near emergence of small grain can genetically determine the future production of that crop. If the fertility is low at emergence or shortly thereafter, no amount of moisture can recover the loss of pre-deter-

mined production later.

Another key factor is what to sow. If you are going to strictly graze the grain out, there are several options to use. Beardless varieties such as Win-Tex, Russian, Wm-135, and Quantum 554, have performed very well in area tests. Also at maturity the lack of awns or breads on the grain allows livestock to more completely graze these varieties out. Also a producer can mix either varieties of early and late maturing grains or mix oats, rye, barley, or triticale with wheat to give increased forage production.
