## Tax Increase for Coke County

The Coke County Commissioner's Court approved the 1994-1995 county budget in a special session on September 16, 1994.

The adopted budget allows the effective rate plus 1.03% increase to become effective the beginning of the 1994-95 fiscal year, on the first day of October, 1994.

The new rate adopted will be as follows: General Fund-.386500 and Road and Bridge & lateral Road fund-.092081 for a total of .478581, compared to the 1994 respectively General Fund 1994 .35453 and Road and Bridge and Lateral Fund of .07955 for a 1994 tax rate of .43408.

This will mean a .044501 tax increase for Coke County.

## - Letter to the Editor -

Dear Editor,

Every now and then we need to take inventory of our assets and perhaps redirect our priorities.

During the past 38 years I have worked with people in counties and communities in the western half of Texas. I have not found one that I consider to have all the things to offer to its citizens that Coke County has.

Where can you find two small communities that have as many paved and curbed streets, nice county parks, community buildings, swimming pools, golf courses, and lighted ball parks as we have in Bronte and Robert Lee? These are an asset to our county, enhance the value of our property, and attract many out-of-town people.

Where can you find a small county with two schools that do a better job of educating our children? A high percentage of the graduates go to college and graduate to assume important jobs in the business world. Where do you find two schools in one county that consistently achieve state rankings in various athletic events?

We have two of the finest nursing homes to be found anywhere and the rates are far more reasonable than most.

All of the above mentioned facilities were built and supported by our own tax money. I hear comments and complaints about paying more taxes but our local taxes are

very reasonable compared to most other areas. If we wish to enjoy these improvements then we should expect to pay for them just as we do our own personal possessions. Local taxes are much more preferable than depending on state or federal assistance since we can control our own affairs.

Where can you find a small county that has more to offer in the way of businesses, restaurants, motels, banks, car dealerships, and two large lake recreational facilities? Both towns have the finest churches representing several different denominations. Can you walk in a business in a large town and buy goods on credit or write a check without having to show a handful of credentials? If the citizens of Coke County purchased their necessities from the local businesses, then that money would be put back into this community, new businesses could be attracted, and the increased income from local sales taxes could help contain the need for more local property taxes.

If there is one thing we seem to be short on right now, it is a positive attitude. Where is our sense of community pride? If you are going to use a hammer, BUILD SOMETHING. Seek the best, but be willing to pay for it in time, talent, and money. If there is a small county anywhere that has more to offer than we do, let me know. I haven't been there, yet.

## Horns make it three in a row over Roby

The Bronte Longhorns traveled up to Lion Country Friday night to challenge the Roby Lions. The Lions were confined to their cage most of the night and were certainly not allowed to play on the endzone. "Lion King" of the night was all 5'6", 135 pound Cory Robinson who gave Roby fits all night long. He had one interception, and almost had 2 others, caved in many Lion rib cages and kept feeding the Lion's running backs grass. Lion tamers for the evening were Darrel Sharp, Delvin Pierce, Todd Harrell, Phillip Ratliff, James Hambright, David Cason, David Wilson, Clint Brashear, Keith Treadaway, Cody Holland, Russel Vaughn, Kale

The Lions were allowed 93 yards rushing on 31 carries and 80 yards passing on 15 attempts. David Wilson and Cory had one interception each and the Horns recovered one fumble. The Horns played super defense and kept the Horns in the game.

Offensively the Horns were a little slow getting started. In the first half the Longhorns produced two first downs. The offensive line began to open huge holes in the Lion's defense and the Horns finished the evening with 213 yards on 42 carries. The Horns had no fumbles, but were cited for 85 yards on 9 penalties. Keith Treadaway had 3 punts for 37 yard average. Nicholas Arrott did another great job leading the Horns from his quarterback position. The Longhorns came away from Roby with a 13-0 victory

## Low Blood Pressure

She says the best definition of low blood pressure is a functional one-if you have symptoms from your low blood pressure, it is probably too

The first step in diagnosis is to determine whether the problem is in the heart and circulatory system or in the autonomic nervous system. Common fainting, such as standing in a hot, stuffy environment with an inadequate supply of blood to the brain, may not be life-threatening, but except for a very simple faint in an obvious situation, it is important to find the cause of fainting spells or dizziness before serious injury results from a fall or loss of balance. 1992. Coke County Game Warden Sparks Burdett will conduct a Hunter Education Training Course on two weekends in October. The course will take 10 hours and will be held at the county courthouse; it will be given in four 2 1/2 hour segments. Scheduled dates are Saturday and Sunday, October 8 and 9 and Saturday and Sunday, October 15 and 16. Saturday hours are 9:00 am-11:30 am. Sunday hours are 1:00-3:30 pm. To preregister for the course call 453-2887.

Every Texas hunter born on or after September 2, 1971 must successfully complete a Hunter Education Training Course. You must have proof of certification when hunting if you were born on or after September 2, 1971 (age 17 or older). It is not required to purchase a license. Minimum age to obtain certification is 12 years.

Hunters age 12-16 must successfully complete a hunter education course or be accompanied by a licensed hunter 17 or older. Hunters under 12 years of age must be accompanied by a licensed hunter. The cost of the required course if \$5.00.





Mr. Parsons urged his audience to report families who are known to qualify, and the Society will contact them. Folders with information concerning much more valuable help were given to club members.

AMERICAN CANCER SO-CIETY sponsors the "no smoking day" the third week in November annually. Parsons stressed that cigarettes are the greatest cancer causing agents in common use.





An ordinance levying ad valorem taxes for use and support of the municipal government of the city of Bronte for the 1994-95 fiscal year; providing for apportioning each levy for specific purposes; and providing when taxes shall become due and when same shall become delinquent if not paid.

Be it ordained by the city council of Bronte:

Section 1. That there is hereby levied and there shall be collected for the use and support of the municipal government of the City of Bronte, upon all property, real, personal and mixed, within the corporate limits of said City subject to taxation, a tax of \$.43 on each \$100.00 valuation of property, said tax being so levied and apportioned to the specific purposes here set forth:

For the maintenance and support of the general government (General Fund), \$.43 on each \$100.00 valuation of property.

Section 2. That taxes levied under this ordinance shall be due October 1, 1994, and if not paid on or before January 31, 1995, shall immediately become delinquent.

Section 3. All taxes shall

become a lien upon the property against which assessed, and the City assessor and collector of the City of Bronte is hereby authorized and empowered to enforce the collecion of such taxes according to the Constitution and laws of the State of Texas and ordinances of the City of Bronte shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest, and the interest and penalty collected from such delinquent taxes shall be apportioned to the General Fund of the City of Bronte. All delinquent taxes shall bear interest from the date of delinquency at the rate as prescribed by state law.

Section 4. That this ordinance shall take effect and be in force from and after its passage.





## Children and Competition

The expression "rat race" refers to the constant striving to achieve and get ahead. As adults, competition can be a motivating force in our careers and personal lives. Gearing up for school, many children will be involved in team sports. Team sports for children provide opportunities for teamwork, building self-esteem, physical activity and winning, as well as losing.

How parents deal with competition is important. Parents need to keep in mind how they want their children to compete in the future. Do they want them to be constantly striving to get ahead as adults, even at the expense of others, or do they want them to be cooperative and focus on working together in an effort in which all players benefit? These patterns are established early on in how they respond to their childhood successes and failures.

The old saying, "It is not whether you win or lose, but how you play the game", can be an important concept to reinforce as children compete. Oftentimes, the desire to win on the part of the team, the coach, and other parents, put tremendous stress on children. Specialists remind us that "Childhood sports should be fun. We need to remember that they are kids

and are developing their motor skills. Sports should be a learning experience, not an ordeal." Concentrate on the improvement and achievements of each game.

Parents can help children feel good about themselves and competition by keeping these simple things in mind:

\*Make sure to explore a variety of activities. Let children try out different activities to find one they feel good about. Specialization in a sport can come later in adolescence.

\*Make sure the sports program keeps in mind that the players are children. Avoid programs that abide by adult rules and regulations.

\*Remember that it is your child playing, not you. Do not compare your child's accomplishments to your past achievements. Help them to set their own goals, consistent with their skill level.

\*Most importantly, be positive and reinforce your child's achievement. The right attitude can make childhood sports a fun and positive experience.
