Candidates gear up for the stretch run

Political candidates are gearing up for the stretch run in their campaigns prior to the General Election on Tuesday, November 8.

Voters in various precincts of Coke County will see slightly different ballots to provide for commissioner candidates. James Arnold Tidwell and Billy Joe Luckett. Other county candidates on the ballots will be Chris Wyatt, county attorney; Royce Lee, county judge; Ettie Hubbard, District and County Clerk; Phelan Wrinkle, county treasurer; Joan Davis, Justice of the Peace, Precincts 1, 3, 9, and 10; and Bruce Sonnenberg, Justice of the Peace, Precincts 2, 4, and 5.

Stirring interest in the upcoming election are two official write-in candidates. Jackie Walker filed for the county judge position while Jack G. Moore is a candidate for Justice of the Peace, Pct. 2.

Early balloting counts are running unusually high. On Tuesday, County Clerk Ettie Hubbard said an even 100 voters had cast ballots in her office. Early voting continues through November 4 in the county clerk's office at the courthouse in Robert Lee.

On the state level, Democratic Governor Ann Richards and Republican George Bush are deadlocked in a hotly contested race for the governor's seat.

Locals are also awaiting the outcome of favorite son congressman Charles Stenholm's race, opposed by Republican Phil Boone. Republican U. S. Senator, Kay Bailey Hutchison is being challenged by Democrat Richard Fisher. State Senator Bill Sims, a democrat, is expected to finish strongly against his republican opponent, Hugh D. Shine.







It rained an inch west of and east of town, less south of town and 1.6 north of town.


The Robert Lee area received amounts ranging from .6 to 1.6.

Red Ribbon Week

In observance of Red Ribbon Week the following facts were presented to school students.

Facts concerning the use of alcohol, drugs, and cigarettes are almost unbelievable!

First - ALCOHOL - drunk driving is the number one killer of men and women in their teens and early twenties. Please remember on an average weekend night one of every ten drivers are DRUNK! Seventy-five percent of all child abuse deaths due to fire and suicides are results of alcohol use. One in four students live in a family in which someone is an alcoholic. About two out of every 5 people in the U.S. will be in an accident that is alcohol related during their lifetime. Alcohol accounts for approximately 97,500 deaths annually

DRUGS - as marijuana, crack, and all others are brain damaging and will appear years later in the human body or brain. Sniffing solvents or sprays can cause death. When using sprays be sure of good ventilation.

The most unbelievable fact humans completely ignore is the dangerous effect of cigarettes. There were 330,000 Americans who died in 1985 and there has been more averaged each year following as a result of smoking cigarettes. Nicotine, a drug in tobacco, is more addictive than crack or alcohol. Nine of ten persons who try smoking become addicted.

Cigarette smoke contains cyanide, a deadly poison.

Smoking is the number one preventable cause of death in the nation. More persons die from cigarette smoking and related illnesses then die from alcohol, traffic accidents, illicit drugs, murder, and suicide combined.

Deadline nears Congressman Charles W. Stenholm has announced that the deadline for applications to the United States Service Academies is just one month away.

Involvement in extracurricular acitivities, including school and community organizations and sports as well as full or part-time employment, is also in the applicant's favor.

The Congressman will be making nominations for appointments to the Air Force Academy at Colorado Springs, Colorado, the Military Academy at West Point, N. Y., the Naval Academy at Annapolis, MD, and the Merchant Marine Academy at Kings Point, N.Y. Each is a legal subdivision of state government organized by local agricultural landowners with the assistance of the Texas State Soil and Water Conservation Board. All conservation programs managed by the district are of a voluntary nature to the landowner or operator or other potential users of the SWCD's programs.

Elderly encouraged to get flu shots

With the approach of autumn, it's time for older Americans to take precautions against the pneumonia and flu epidemics that are on the horizon. The cost of both pneumonia vaccinations and flu shots is covered by Medicare Part B (Medical Insurance) for those age 65 or older.

The National Institute on Aging (NIA), American Lung Association, and the Department of Veterans Affairs have launched a coordinated campaign to encourage elderly people to be vaccinated this fall. Statistics show they are twice as likely as younger persons to get pneumonia. Only about 20% of those over age 65 have taken advantage of the availability of the pneumonia vaccine in the past, according to the NIA.

The Public Health Service recommends an annual flu shot for people over age 65, even if they are generally healthy. Typically, shots are given in the fall or winter. Medicare beneficiaries do not need a doctor's presciption or supervision to have this vaccination covered by Medicare Part B. And, beneficiaries do not pay a deductible or co-insurance amount.

Medicare Part B pays the reasonable approved amount for either shot. If the cost exceeds the approved amount, the beneficiary is responsible for the difference.

Generally, the cost will be paid if the vaccine is provided at a doctor's office or by a hospital, skilled nursing facility, home health agency, rural health clinic, federally qualified health center, outpatient physical therapy provider, a comprehensive outpatient rehabilitation facility, or health maintenance organization (HMO).

However, when Medicare beneficiaries get either vaccination at a community clinic that normally provides the shots free of charge to the public, the beneficiaries should not be charged just because they have Medicare coverage. Medicare Part B will not pay for these shots or for shots administered under a plan where the employer arranges to have free shots for all employees.

Medicare Part B pays for pneumonia and hepatitis B vaccinations when the beneficiary is in the hospital, even though the hospital stay is covered under Part A (Hospital Insurance). Flu shots now are paid for in the same way.

Mental Health in America

One in three adults in this country will have a diagnosable mental disorder during their lifetime. That assessment is in a report to congress by a committee of the Institute of Medicine. Dr. Robert J. Haggerty, of the University of Rochester and chair of the committee that wrote the report, says hardly a family in America is untouched by mental illness.

It is estimated that economic costs for alcohol abuse, drug abuse and other mental illnesses totaled more than three hundred billion dollars in 1990, but the committee estimates that the federal government spends only about twenty million dollars each year for research on rigorous intervention to prevent mental disorders.

Dr. Haggerty and his colleagues say the opportunities for preventing or delaying some mental disorders such as depression are abundant and, while billions could be saved in treatment and lost worker productivity, the real savings could be in human suffering and lost opportunity. © 1992, Lyle Dean, Inc.




