Saturday marks opening day of season

Saturday, November 5, marks the opening of the 1994-95 general gun hunting season. Turkey and deer may be taken November 5 through January 1. Four deer are allowed with a limit of two bucks. Four turkey may be taken during the season, either sex during the general season November 5 through January 1, and gobblers only during the Spring Season, April 8 through May 14.

Statewide quail season opened October 29 and runs through February 26. Daily bag limit is set at 15.

Wildlife biologists' predictions are poor for quail and average numbers for deer and

turkey. Late summer rains have hopefully arrived in time to support wildlife populations until a good number can be harvested. Drought conditions have threatened game with die-offs since late spring.

New for Coke County this season will be the antlerless only Muzzleloader special season January 7-15, 1995. No antlerless permit is required but a special \$10.00 Muzzleloader stamp is required. It must be attached to your Texas hunting license and signed across the face of the stamp. Included in the

special season are turkey and javelina.

Every hunter who buys a license should get the <u>free</u> hunting guides available where license and sporting goods are sold, and then read it from cover to cover.

Hunters are reminded to show respect for the land on which they are hunting and to practice gun safety and good sportsmanship. Report game violations to the game warden Sparks Burdett (453-2887) or by calling OPERATION GAME THIEF 1-800-792-GAME (4263).

Polls will be open on Tuesday, November 8 from 7:00 am until 7:00 pm. Polling locations on the west side of the county include Pct. 1 - Old Recreation Bldg.; Pct. 3 - Courthouse; Pct. 9 - Pecan Baptist Church; and Pct. 10 - Southside Church of Christ. Voters on the east side of

Coke County will cast ballots in Pct. 2 - Bronte City Hall; Pct. 4 - Tennyson Community Bldg., and Pct. 5 - Old Depot, Bronte.

On the General Election ballot are choices for the United States Senate; United States Representatives; Governor; Lieutentant Governor; Attorney General; Comptroller of Public Accounts; and State Treasurer as well as a number of other commissioners, judges, and justices. State senator and representative choices are on the ballot, along with Coke County candidates. Two county candidates, although not on the ballot, are legal write-in choic-

Pony Express rides again

On Tuesday morning November 1, the Coke County Roping Club made a "Pony Express" mail run between Bronte and Robert Lee post offices commemorating the Stageline and the people involved with the delivery of mail by the Butterfield Overland Mail and Passenger Stage that was established in 1858 and came through the heart of old Coke County.

The program consisted of music prelude by Bronte Longhorn Band; presentation of colors, Bronte 5th grade; the National Anthem, sung by postal worker Debbie Stilley; Invocation, Rev. Randy Johnson pastor of Central Baptist Church, Bronte; welcome by Mayor Martin Lee; remarks by Judge Royce Lee; introduction of stamps by Bronte 7th grade history class; dedication of stamps, John Howard, manager of Postal operations; Benediction Rev. Elmer Beck, pastor of First United Methodist Church Bronte.

Seventeen volunteers from the Robert Lee area participated in the "Pony Express" ride from Robert Lee to Bronte on Hwy. 158. The Robert Lee Stamp Club sold cachet envelopes with the **Butterfield Overland Station** Pictorial Cancellation and Pony Express mail stamp. The ride concluded in Bronte at the Post office at approximately 12:20 pm.

Obituaries -

Adams

Funeral services were held for S. E. "Skinny" Adams on Thursday, Nov. 3, at 2 pm at the Robert Lee Baptist Church. Interment followed in the Robert Lee Cemetery under the direction of Shaffer Funeral Home. The Rev. Roy Epperson officiated the services.

Skinny, 84, died in Shannon Medical Center in San Angelo Monday afternoon, October 31, following a sudden illness on Friday, October

He was born in Robert Lee February 14, 1910 to J. N. K. Adams and Martha Edward "Eddie" Swann. J. N. K. Adams was a merchant, president of McCallum Reed Company, a Robert Lee business that sold everything caskets, hardware, feed, horse tack, and groceries. Mrs. Adams was a music teacher. They reared their family on a stock farm just south of Robert Lee.

A tall, thin young man, Skinny went to San Angelo following schooling in Robert Lee, and worked with an abstract office and county government. He returned to Robert Lee and established an abstract office in 1928, not knowing he and his future wife would be abstractors for well over sixty years.

Skinny soon met a young school teacher who had come from San Angelo to teach. He and Elsie Pruitt were married in secret in Colorado City on a cold night, Dec. 10, 1932. They did not go public with the union for several days due to a school board rule that only single people could teach due to the depression, allowing more jobs.

The couple, like others during that time, worked at a number of things in addition to abstracting.

They ranched and stockfarmed, as well as operated the mail route between Robert Lee and the Silver community.

It was actually due to his connection of knowing everyone in the county that led to his being called later the "father of oil business in Coke County".

Clarence C. Pope, Sun Oil Company's West Texas landman, came to Coke County looking for just such a person. Skinny was instrumental in helping Pope secure a 20,000 acre block of leases at Silver which led to the oil

boom in the mid 40's. The first producing well was finalized on Allen Jameson property in December, 1946.

Skinny's association with oil companies led to oil leasing on his own. He and Elsie pursued their other interests, ranching and abstracting, during that period also.

Skinny and Elsie, along with their teenage son, Stanley, Jr., moved to San Angelo in 1949 where they busied themselves with abstract offices in San Angelo and Ballinger. The family also took an active part in San Angelo's civic affairs. Skinny helped form San Angelo's only semipro sport - a baseball team, the San Angelo Colts. He was a member of the Presbyterian Church, the Businessmen's Bible Class, the Downtown Rotary Club, the Suez Shrine Temple, the Elks Lodge, and the San Angelo Lions Club.

The Adams' returned to Robert Lee and opened their abstract office. He served as mayor of Robert Lee, was a member of the BCD, the Robert Lee - Silver Lions Club and member of the Eastern Star where he served as worthy patron.

The couple sold Adams Abstract in 1989 but Skinny remained interested in civic affairs and current events, in addition to his ranching, until the time of his death. Although he and Elsie were local nursing home residents, he continued to go to Rotary Club meetings, in San Angelo each Friday noon unitl his final illness.

Survivors include his wife, Elsie Adams of Robert Lee; one son, Stanley Adams, Jr., and his wife, Christie, of

Austin; three grandchildren, Naomi Adams of Austin, Stanley Adams, III, of Houston and Hazel Adams of Robert

He was preceded in death by one brother, Noel W. Adams, and two sisters, Naomi Powell Blanton and Dannie Carter.

One of the early Abilene volunteers for military duty at the beginning of World War II, Carl was a radar technician with the U.S. Navy, including duty on Midway Island, one of the keys to Allied victory in the Pacific. He had been a member of Veterans of Foreign Wars Post 2012 of Abilene for the past 50 years except for a time when his membership was not renewed while he was assigned to the Teague VA hospital in Temple.

Military honors were included in the Wednesday service at the family plot at Cedar Hill

Cemetery. After the War, he attended Dahlgren's carpentry school on the G. I. Bill and worked in that trade for more than 30 years, until he injured his back in a construction accident at a Mineral Wells School, when he diverted a falling beam to avoid injury to workers below.

Services were conducted by the Rev. Frank Estes, pastor of Bethel Temple Christian Center, who worked with Carl as a young man when Carl spent a number of years constructing churches with the Estes family.

Survivors inlcude his mother; sons Carl Lynn Brock of Anson and Gary Edward Brock of Mineral Wells; six grandchildren and three great-grandchildren; brothers Tom Pendergrast of Maxdale and Sam Pendergrast of Abilene; sister, Wanda Pendergrast Wright of Weatherford; and several nieces and nephews.



SC Eagles barely edge Horns in thriller

The Bronte Longhorns went west Friday night to test the Sterling City Eagles. The Horns gave the Eagles all they could handle before going down to defeat. Longhorns played perhaps their best game of the season, and had their opportunities to win the game but failed. The game was very costly for the Eagles when quarterback Philip Thomas broke his left forearm in two places requiring surgery. The Horn defense contained the Eagles not allowing long runs, holding them to short gains. The Eagles had 41 rushes for 174 yards while the Horns had 37 rushes for 173 yards. The Horns and the Eagles each had 144 yards passing. The Eagles had 17 first downs and the Horns had 16 first downs. The Longhorn offense was able to run and pass making it a very exciting evening. Leading ground gainers for the Horns were Brent Taylor with 7 carries for 43 yards; Russel Vaughn with 9 carries for 30 yards; Kale Beck with 10 carries for 27 yards; Keith Treadaway with 5 carries for 27 yards; Cory Robinson with 6 carries for 14 yards. The Horns punted one time for 33 yards and had 6 penalties for 37 yards. Both the offensive and defensive teams played an outstanding ball game, unfortunately, victory slipped right through their fingers. 1st Quarter

The Horns kicked off to the Eagles and they returned the ball to the 35 yard line. They could not move the ball on the ground but completed 2 passes for 26 and 25 yards. The Eagles scored on a nine yard run with 9:01 left in the 1st quarter.

The Eagles kicked off to the Horn's deep man Brent Taylor who ran to his right, handing off the ball to Clint Brashear on a reverse. Clint raced down the sideline to the Eagle 15 yard line before he was tackled. The Horns were not able to move the ball on four downs and the Eagles took over on their 10 yard line. The next Eagle drive stalled on a 4th and 12 and the Horns took over again. The Horns began to move the ball on short gainers; Nicholas Arrott went up with a defensive back

by Stover Taylor in his face and pulled in a 30 yard pass from Brent Taylor as the 1st quarter ended.

2nd Quarter

The Horns could not convert a fourth down and the Eagles took over. The Horns stopped the run on the series but a Eagle receiver got behind the Horns defensive secondary and scored on a 45 yard pass play. The PAT failed and the score was 13-0 with 6:05 left in the quarter. On this series of downs Taylor hit Jason Wilson for 17 yards, Cory Robinson ran for 15 yards and the Horns drove down to the 18 yard line facing 4th and 15 with .04 seconds left. Brent Taylor went back to pass and found Keith Treadawy in the corner of the endzone for an 18 yard completion and TD. Keith Treadaway carried the ball into the endzone for the 2 point conversion and the score was 13 to 8 at halftime.

3rd Quarter

The Horns started the 3rd quarter on their 20 yard line. Russel Vaughn picked up 20 yards, Taylor got 11 and 24 yards, Beck and Treadaway picked up 8 yards each. With the ball on the 6 yard line with 7:33 left in the quarter Taylor found Beck in the endzone for a 6 yard TD. The 2 point conversion was good and the Horns led 16 to 13. 





More About Fish

A growing list of researchers have written about the benefits of eating fish. Among the latest are Dr. Sirving Keli and his colleagues in the Netherlands. Their study of more than five hundred men from the Dutch town of Zutphen began in 1960. The latest follow-up suggests that those who ate more than two-thirds of an ounce of fish per day had a lower risk of stroke than men who ate less. Two-thirds of an ounce is not a lot of fish. It is about one-third of a normal adult serving.

The researchers wrote in the American Heart Association journal. Stroke, that evidence is mounting for the benefits of at least one serving of fish per week. They note that most strokes are caused by a blood clot in the brain, which may be reduced by the 'omega-3 fatty acids." the polyunsaturated fats found in fish. Their study also showed small amounts of fish were linked to a lower risk of death from heart disease, similar to findings in a number of other studies. . ©1992. Lyle Dean. Inc.






