Local voter turnout tallies 69 percent

Voter turnout in Coke County was tallied at 69% for Tuesday's General Election. A total of 1,442 persons cast ballots; 347 of those early voted.

Drawing the most interest locally were the only 2 contested races in Coke County. County Judge Royce Lee, who was in his first term in office, was defeated by write-in challenger Jackie Walker, mayor of Robert Lee, by a 744-565 total. On the east side of the county, Bruce Sonnenberg was defeated for Justice of the Peace, Pct. 2, position by Jack Moore, also a write-in candidate. Moore garnered 316 votes to Sonnenberg's 230.

Chris Wyatt, county attorney; Ettie Hubbard, county and district clerk; Phelan Wrinkle, county treasurer; county commissioners, Billy Joe Luckett and James Tidwell; and Joan Davis, Justice of the Peace, Pct. 1, were unopposed in the general election.

Coke County voters, traditionally Democratic, crossed party lines to cast a good number of Republican votes, as did a lot of Texans. Locals turned down Democratic Governer Ann Richards 558-824 in favor of Republican

George W. Bush. U.S. Senator Kay Bailey Hutchison was favored over Fisher by voters 876-456. Favorite son, Rep. Charles Stenholm, crushed Boone in Coke County 869-478. Texas Sen. Bill Sims topped Hugh Shine locally by a convincing margin, 968-378. Other races on the county ballot followed state voting trends, which in many cases repeated the anti-incumbent voting exercised across the nation to give the majority to the Republicans in both the house and senate.

According to Bob Wrinkle, chairman of WCCCD's Hunter's Appreciation BBQ, 872 persons signed the register at the door at the Rec Hall in Robert Lee. Several times only one in a large group signed as they entered the serving line, so a good number didn't get in the count. Everything went smoothly, he said, the food supply was about right and there was enough to feed everyone. The only glitch in the event was confusion over some carry-outs which will have to be resolved at a later date, before next year. He expressed appreciation for the tremendous help of volunteers and WCCCD members. Without them, the gigantic undertaking would not be possible, he said.



Mrs. Naizer can customize customers' items with embroidery or monograms or she can order items on which to create designs for customers.





Many parents are faced with problems and decisions each day concerning the issue of homework and schoolwork. Schoolwork and homework are two separate issues, yet they relate in many ways. Schoolwork is defined as any work that is completed at school, during the class period for which that particular subject was intended, while the teacher is there to offer explanations and help with understanding. Homework is an assignment made by the teacher intended to help that student practice what they learned that day and previously at school independently. Both are essential elements to learning; however, there is more involved than meets the eye.

The conscientious child who works independently and efficiently on homework usually needs no help. On the other hand, the child who procrastinates and does only the minimum on all assignments is the child who needs more intensive parental monitoring. Children with learning problems need more supervision. This child may prefer to avoid work thinking that it is a way to escape failure by not

The Department of Agriculture's Soil Conservation Service will soon take on a new identity as the Natural Resources Conservation Service as it streamlines its operations and takes on new program responsibilities. agency was authorized under the reorganization ordered October 20 by Agriculture Secretary Mike Espy

The new Natural Resources Conservation Service will continue to have responsibility for all the programs of the former Soil Conservation Service. In addition, several other programs have been transferred to it including the Wetland Reserve Program, the Waterbank Program, the Colorado River Basin Salinity Control Program, Farms for the Future Program, Forestry Incentive Program, and Great Plains Conservation Program.

"We are working to make this a smooth transition for our customers," said Paul Johnson, chief of the agency "And we will continue to build on 60 years of a unique relationship between federal government and this nation's private landowners as well as our conservation district and state agency partners. It's a relationship built on voluntary programs, technical assistance, and conservation costshare programs."

Johnson said farmers, ranchers, and other customers of the agency can continue to receive the same assistance they have found from the Soil Conservation Service during the transition

"Throughout this process, we will keep our customers and our employees well informed," said Johnson. "And we will stay connected to their ideas and concerns."

trying at all. Assistance must be provided for students with learning or study deficits. Before a child can develop a more responsible work ethic, the child will need the skills and believe the work can be accomplished. This requires effort, responsibility, and commitment, and as the child begins to achieve and becomes more competent and confident, he will require less supervision. A very important factor for all parents to consider is that monitoring a child closely is not without risks. If your child concludes that he/she is being constantly scrutinized, the child may become anxious, resentful, and resistant, or the child may become emotionally and academically dependent on the extra attention. The child becomes dependent if the parent takes ownership of the problems. This is very risky.

Parents should not be spectators in watching their child struggle in school. They can assume active and constructive roles in helping that child remove the barriers impeding their progress and success in school. The book I listed last week entitled 1001 Ways To Improve Your Child's Schoolwork by Lawrence J. Greene is an excellent resource for parents to obtain those skills needed to help children succeed. The Book is available through my office or at any bookstore.

"A" surrogates combat cancer

Vitamin A "surrogates" are the newest therapeutic force in the war against prostate cancer, according to a researcher at Baylor College of Medicine in Houston.

Using their own mouse model genetically programmed to develop prostate cancer, a team of Baylor scientists are testing synthetic Vitamin A-like agents known as retinoids thought to halt cancer growth by boosting the immune system's response to the disease.

"We have tested one promising retinoid that appears to suppress cancer progression," said Dr. Timothy Thompson, an associate professor or urology and cell biology at Baylor. "By testing a live animal model, we can tell if the drugs are effective and how they work."

Prostate cancer is the leading cause of cancer death in American men. Approximately 38,000 die from the disease each year. African-Americans have the highest

In recent years, retinoids have been used to treat acne and skin damaged from sun exposure. They have also been tested in people with other types of cancer such as lung and breast cancer.

Once the research team understands how retinoids work, Thompson says more effective tests in humans may be on the horizon.

"By applying new techniques in drug and gene therapy, we can see how prostate cancer is affected," he said. "How these therapies will be used in people remains to be seen."





. Employee or contractor?

Are you working for someone who doesn't withhold Social Security taxes from your salary? And does that person not withhold the taxes because he or she says you are an independent contractor, not an employee?

The Social Security Administration knows that some employers don't withhold Social Security taxes from their workers' salaries. This often happens with house-hold workers, beauticians and barbers, and other service occupations. The employer may mistakenly think the workers are actually independent contractors and responsible for their own taxes. Or, in some cases, employers pay their employees in cash so they can reduce business expenses by not making the matching contribution of Social Security taxes. While the employee may like being paid in cash, he/she should ask for a pay stub or voucher from the employer which shows that Social Security taxes have been withheld. Nonpayment of these taxes by the employer could deprive the worker of valuable Social Security pro-

Because Social Security benefits are based on how long you work and the amount of wages reported for you by your employer, it's important that your earnings are reported accurately and your Social Security taxes are paid. You never know when you may need Social Security. Each day that you work and don't have Social Security coverage, you are robbing yourself and your family of a valuable resource. If your wages aren't reported and you become disabled, you and your family could miss out on monthly Social Security disability benefits. If you die, your family could lose monthly survivors

benefits.

There are rules for determining whether a person should be considered an employee or an independent contractor. For example, an employee is hired, can be fired, receives employee benefits such as vacation time and sick leave, takes instructions from his or her employer, and is provided with tools and working materials. The employer sets your hours, determines your place of work and pays you by the hour, week, or month. What this means is that the employer controls or has the right to control how, when, and where the work is done.

An independent contractor. on the other hand, usually operates under the terms of an agreement or contract and doesn't receive employee benefits such as vacation time and sick leave. The contractor usually provides his or her own tools and work equipment, may set his or her working hours, have an opportunity to realize a profit or suffer a loss, and cannot be fired as long as he/she produces a result that measures up to contract specifications. If you need more information about the rules for determining whether a worker is an employee or an independent contractor, we suggest you contact your local Social Security office.


Regardless of whether you are an employee or an independent contractor, we also suggest that you check your earnings record at least every three years to make sure your earnings have been reported accurately. Just call Social Security's toll-free number, 1-800-772-1213, and ask to have a Request for a Personal Earnings and Benefit Estimate Statement form sent to you. You can expect to receive your statement about four weeks after we receive your completed request form.

Clean your cleaning tools

Cleaning with the right tools will help you do a better job. However, many of us use specific tools for special jobs, but never think about cleaning the tools that we clean with. Here are some storing and cleaning tips for:

*Brooms - For better service, a broom should never be stood or stored on its bristles. If your broom did not come with a ring for hanging, attach a screw eye through the top of the handle and loop a string through it. It is a good idea to occasionally wash the bristles with sudsy water, rinse with clean water and let it dry thoroughly before using.

*Mops (wet) - Mops used with cleaning compounds such as soaps and detergents usually need only to be rinsed thoroughly after each use. For rag mops, squeeze the water out and separate strands and then hang to dry. Sponge mops should be squeezed as dry as possible and hung in the shade to dry.

*Cellulose Sponges Sponges should be soaked carefully before using because they are brittle when dry. You should not use strong bleaches or strong solutions to soak them. Be sure to rinse after each use. To clean, use a mild solution of bleach, if necessary, but don't soak for long periods of time. Rinse carefully afterward.

*Dish towels - Wash towels

Safe holiday cooking tips

Don't go for the "quick thaw" and let bacteria gobble up your turkey this Thanksgiving, says an infectious disease expert at Baylor College of Medicine in Houston.

"Turkey and other poultry defrosted outside the refrigerator too long are prone to contamination with salmonella bacteria," said Dr. A. Clinton White Jr., an assistant professor of medicine at Baylor. "Once the turkey has thawed, it's important to cook it thoroughly to kill bacteria and avoid serious illness."

Salmonella poisoning is caused by bacteria that develop in raw or undercooked meats and other foods stored in a warm environment. When eaten, bacteria grow in the intestines, causing stomach pain, nausea, vomiting, diarrhea and dehydration.

"Over-the-counter anti-diarrheal medications can help soothe your stomach pain, but drink plenty of fluids to treat dehydration," White said. "If the symptoms worsen, see your doctor."

Other foods like eggs and shellfish can also pose a health risk.

If your holiday recipes call for eggs, be sure to purchase clean, uncracked eggs, and keep them refrigerated. Avoid serving raw or undercooked egg yolks, which increase the risk of infection.

People who enjoy eating raw shellfish, like oysters, over the holidays should be cautious, says White.

"Eating raw oysters is not a good idea, especially for people with liver disease, because it harbors cholera-like organisms called vibreos which cause life-threatening infections," he said.

White advises washing your hands before preparing foods to reduce bacteria transmis-

"You can contaminate the turkey with common bacteria that you carry on your skin," White said.

Here are more safe holiday cooking tips:

*Don't use the same knife you cut raw poultry with on other foods. Wash cutting boards, counter tops and cooking utensils with hot, soapy water.

*Avoid sampling rare beef or poultry.

*Check the temperature of your turkey with a cooking thermometer to make sure the turkey has been cooked thoroughly

*Thoroughly wash lettuce,

peeled potatoes, and other vegetables and fresh fruits.

*Throw away eggs kept for more than a month.

*Refrigerate leftovers immediately.

"The key is to be prudent when handling food," White said. "If you take precautions, you'll have a safe and enjoyable holiday."



Send your sinuses

to the slammer

If you're the victim of a throbbing headache, nasal congestion, aching teeth, or difficulty breathing through your nose, you'd probably like to send your sinuses to the slammer.

But could you prove beyond a reasonable doubt that your sinuses were the sole perpetrators of your misery?

Probably not. Dr. Fred Bressler of the Methodist Hospital in Houston says he often sees patients who are convinced their sinuses are to blame for their discomfort simply because they have no way of identifying several other possible suspects. However, further investigation usually turns up enough evidence to take appropriate action against the offender.

"You can't cure what you can't see," says Dr. Bressler. 'The only way to find the source of a patient's discomfort or irritation is to literally look up their nose."

Dr. Bressler says a sophisticated exam using an endoscope, a thin, lighted tube, helps pinpoint the problem. If surgery will be necessary, a cat scan of the sinuses should be done to provide the physician with a blueprint of how the nose is constructed.

"Sinus has become the catch word for a host of symptoms," says Dr. Bressler, "but in reality, there are other culprits which may produce similar symptoms. Allergies are the most common along the Texas Gulf Coast, and other nose problems, like swelling or a deviated septum, are also frequently the source of discomfort or difficulty breath-

If your nasal breathing function is not restored completely once those problems have been treated or ruled out, surgery may be the next logical step.

HEALTH NOTES

Did you forget the medicine chest during your spring house cleaning? Nicholas Popovich. head of Purdue University Department of Pharmacy Practice, says you should toss pills and other medications with expired dates or that you no longer use. He advises flushing medications down the toilet rather than putting them in wastebaskets where children and pets can get to them.

A ten-year study by the American Association of Poison Control Centers of child poisonings found that accidental use of medicines was responsible for most of the nearly five thousand child poisoning deaths. Professor Popovich says there is a better place to keep medicines than a medicine chest above the bathroom sink, because the warm, humid conditions may reduce the effectiveness of medicines. A kitchen cabinet shelf high enough to be out of reach of little ones and away from heat sources is a better place to store medications. 1992. Lyle Dean, Inc.
