# Local man meets star

Chuck Hart of Sun Valley, California recently gave his father-in-law, Raymond Smith, a call to come and visit with him on location at the filming of Streets of Laredo in South Texas. The local man went to the huge Moody Ranch between Del Rio and Eagle Pass Thursday, March 2nd and spent the day where the filming was being done for the made-for-TV movie. A western, the film will star James Garner and feature Sissy Spacek and Sam Shepard.

Smith's son-in-law is a stunt man for the producers. He is just getting back to work and is still recuperating from an accident which led to his having a pancreas transplant at Mayo Clinic.

Working with the stars is a family thing for Hart. His mother, Charlene Roberson, is a well-known makeup artist and hairdresser for several stars. She attends James Garner, as well as several other actresses and actors.

Mrs. Roberson was also on location for Streets of Laredo and she and Chuck Hart intro-

duced Smith to Garner. Smith described Garner as friendly and "down-home." Some of the younger actors commented they had expected Garner to exhibit "star status" but found him very helpful and gracious.

Garner told the group he was scheduled to speak to exclassmates in Oklahoma after his part of the filming was over and seemed more nervous about that than the current movie work.

Chuck Hart gave Smith a copy of a call sheet which is given to everyone on the set each morning. It indicates who will be in the takes that day, the props which will be needed, and the special effects of the day, such as wind, smoke, camp fire, and blood hits!!

Spacek and Shepard were not on call for Thursday. Filming mainly centered around Garner's character on the day Smith visited the set.

Hart and his mother were to return to California early this week to make preparations for a re-make by James Garner of the Rockford Files

The rest of the game was more of the same with Robert Lee advancing to the semi-final matchup against Midway. Aaron Hood was high point man in the win with 30 points. Eric Hood added 17, Lee Mc-Cown 15, Jeremy Vincent 9, Jason Wyatt 6, Bart Goodman 5, Jerrid Vincent 3, Jason Key 3, and Koby Howell 2. The Steers were up against Midway in the semi-final game held Saturday morning. Again, the first quarter was about as close as it was going to get with Robert Lee holding on to a 1 point lead going into the second quarter. The Steers held onto a 46-34 lead at halftime. Robert Lee came out gunning in the third and added 33 points to their lead. while holding a very confused Midway to only 14. The game ended with Robert Lee defeating Midway 98-77 to advance to the finals.

Hood tipped in 30, Lee Mc-Cown 14, Jeremy Vincent 8, Charles Hayes 6, Bart Goodman 4, and Koby Howell 1.

The final matchup was held Saturday evening with Robert Lee facing a strong Knox City team. The first half was nip and tuck with the lead changing as often as the West Texas weather. The first quarter ended in a 19-19 tie. Both teams hit good shots in the second quarter and the lead seesawed back and forth several times before the half ended with RL ahead 42-41. Strong defensive play and a good scoring drive in the third pulled the game out for the Steers as they held onto a 67-53 lead going into the fourth quarter. Midway couldn't get their feet under them in the final period and Robert Lee held on to win 79-69.

Lee McCown was high pointer with 30 points to his credit. Aaron Hood added 23 to the board, Eric Hood 15, Jeremy Vincent 11, and Charles Hayes 5.


During the Houston Stock Show Shea Kelton placed 6th in the Heavy Charolais and Casey Antilley had the 10th place Medium Hereford.

# **TDHS** Annual Report

The state spent a total of \$1,572,688 last year for major welfare programs in Coke County, according to David Maberry, Regional Administrator for the Texas Department of Human Services.

stamps worth Food \$238,835 were issued for the fiscal year which ended August 31, while Aide to Families with Dependent Children (AFDC) totaled \$40,493. Food stamps are funded entirely by the federal government, while the department determines eligibility of applicants and issues the food coupons.

The state and federal governments share in the cost of AFDC to families where needy children are deprived of support because of the absence or disability of one or both parents.

"Nursing home costs of approximately \$1,121,945 were paid for aged and disabled residents. Community Care for Aged and Disabled spent \$134,180 for Medicaid related services and \$35,262 for non-Medicaid related services," Mayberry said.



# Journey through a living cell
