



#### **RL** plans public hearing

The City of Robert Lee faces a two-pronged dilemma regarding its landfill. An open hearing will be held on August 1, 1995 at 7:00 pm at the County Courtroom.

Recent regulations will require an engineering study of the landfill site which will cost between \$10,000-\$25,000. The study will include gas and groundwater monitoring as well as a comprehensive plan for future use. The site must be in compliance with many of the regulations by October 9, 1995.

Should the site remain open for use, monthly monitoring and record-keeping will be required which will increase the cost of the landfill operation and an increase in monthly fees. Another garbage truck will have to be purchased at an estimated cost of \$30,000-\$50,000.

Two commercial waste haulers are available to handle municipal solid waste. Commercial haulers will make one residential pick-up per week and will provide dumpster pick-up to businesses.

The City is faced with the decision of funding the cost of implementing regulations, monitoring, and new equipment to keep the landfill open or contracting with a commercial hauler which will require that many county businesses and residents who currently handle their own hauling to the landfill to arrange for other service.


Because this decision will impact so many people, an open hearing will be held Tuesday, August 1, 1995 at 7:00 pm at the Coke County Courtroom.

## Treat lawns now for grubs

By treating now for white grubs, Texas homeowners can prevent unsightly dead patches from appearing in their lawns later in the season.


\*Now is the time to treat from mid-July through early August. After that time, the grubs will be too large to control. White grubs are the larvae of the ordinary brown June beetles, the nondescript, brown bugs that buzz around porch lamps at night. Though June beetles like porch lights, they avoid the sunlight during the day by burrowing in the soil. It's at this time the insect lays it eggs.

Throughout most of Texas, adult June beetles appear and begin to lay eggs in late May and early June. In July, the eggs hatch, and the larvae, though still tiny, begin feeding on grass roots.

The beetle does not restrict its egg laying to lawns. It also burrows into pastures. But in pastures, a few brown spots may not be a problem. Because the adult beetles are attracted to household lights, some lawns may be especially hard hit.

As the larvae grow and their feeding intensifies, they destroy grass roots. Without roots, the grass starves for moisture and dies.

In Texas, practically every home lawn probably has a few



white grubs. It's only at certain concentrations that the larvae begin killing enough grass to be noticeable. It's at this point that entomologists recommend using pesticides.

Homeowners can find out if they need to treat with a simple test: using a shovel, cut a foot-square section of sod about an inch deep and fold it back. The grubs should be easy to find if they are present. Look for small C-shaped grubs, white to cream color. If you count more than four in the square foot of exposed roots, then treatment is recommended. Size of the grubs will vary depending upon the time of year. During mid-July, the grubs should be from 1/8 to 1/4 inch long.

\*If you let them go, they will get as big around as your little finger. By then, it will be too late to treat. The treatment window is rather short. Mid-July is the best time, but homeowners may realize effective control up to early August.

It is recommended to use products that contain one of four active ingredients, diazinon, chlorpyrifos, carbaryl or bendiocarb.

Though diazinon has received some bad press lately, it is considered a safe product for the user and for the environment as long as label instructions are followed. Most of the problems occur when users exceed label rates or don't follow application instructions.

#### Farmers may be eligible for disaster loans

Tom Green and Coke County farmers and ranchers may be eligible for emergency loans to help cover losses they sustained as a result of the drought/late freeze or flood during 1994, according to Paul S. Cline, Consolidated Farm Service Agency County Supervisor.

Mr. Cline said that any farmer who was denied an emergency loan or discouraged from applying for a loan because he or she did not have crop insurance for the 1994 crop might be eligible for a loan since the crop insurance requirement for 1994 has been waived by the Agency.

"Any farmer or rancher in that category who is interested in a loan should visit the Consolidated Farm Service Agency county office as soon as possible," Mr. Cline said. "In any case, they must apply no later than 30 days from publication date. However, no applications may be accepted after the 8 month termination date for the particular disaster.





## Five reasons to contact SS

Social Security officials issued a reminder that people need to remember that there are at least five times when they should contact Social Security: \*to change your name when you get married; to get an application for a Social Security number; request for Earnings and Benefit Statement; \*if you notice an error on your earnings record; and \*if you need to apply or inquire about benefits because someone in your family dies, becomes disabled, reaches 62, develops permanent kidney failure, reaches 65 (to apply for Medicare even if he or she is not retiring).



#### Nutrition and Cancer prevention

The fact that absence of certain essential nutrients creates a predisposition to illness has been known for a long time. However, less understood has been the components of diet which are important in preventing chronic disease such as cancer.

The National Cancer Institute (NCI) is studying if certain "designer" foods high in ingredients naturally high in cancer - preventing substances can actually affect the relationship between cancer and diet. Diets high in fat appear to be connected to cancers of the breast, pancreas and colon/rectum.

Heavy alcohol consumption has been linked to higher incidence of cancers of the upper digestive tract and liver. These studies have also shown tha tfiber, vitamins A, C and E as well and many other substances also seem to have cancer-preventing properties.

Over the past decade more than 40 foods - mainly vegetables, grains, and fruits containing biologically active phytochemicals - have been

#### Athletes need pre-season checkup

High school athletes may be only "second string" without a pre-season checkup, says a sports medicine expert.

"Anyone involved in school athletics should have an annual history and exam as a necessary step for performing optimally," said Dr. Albert C. Hergenroeder, head of Adolescent Medicine and Sports Medicine, in the department of pediatrics at Baylor College of Medicine, and Texas Children's Hospital in Houston.

Hergenroeder says young athletes often will not admit to having problems related to exercise and sports. These include old and current in**by Jan Yanez** Coke County Ext. Agent

identified as having cancer preventive properties. Phytochemicals can interfere with and potentially block the biochemical pathways that lead to malignancy in animals. Phytochemicals can affect metabolic pathways associated with development of cancer by affecting the initiation and tumor-promotion phases.

The six foods at the top of this pyramid are at the center of the National Cancer Institute's Experimental Foods Program. On the top level of this triangle are garlic, cabbage, licorice, soybeans, ginger, carrots, celery, and parsnips. On the middle levels of the triangle are onions, tea, tumeric, citrus (such as orange, lemon, grapefruit), whole wheat, flax, brown rice, tomatoes, eggplant, peppers, and cruciferous vegetables (broccoli, cauliflower, and brussel sprouts). On the base level of the triangle are oats, mints, oregano, cucumber, rosemary, sage, potato, thyme, chives, cataloupe, basil, tarragon, barley, and berries.

Dietary supplements such as garlic pills do not offer the same benefits as the food counterparts.

So what can you do as a consumer to utilize the results of this research? Start following the U.S. Department of Agriculture Food Guide Pyramid and the American Cancer Association recommenda-

tions to increase servings to at least "5 A Day" of vegetables and fruits. Then you will be sure to eat many of the top 40 foods, which have been shown to display those cancer-prevention properties.

In the next few years, consumers will see more and more designer foods that contain even more of these phytochemicals.


#### Long receives award

Hergenroeder says that one study showed that one of the leading reasons for not participating in school sports was old, unrehabilitated injuries.

Hergenroeder says for the majority of healthy high school students, returning to school athletics or physical education courses is no problem.
