RL City Council meeting held

The Robert Lee City Council met in regular session on Monday, October 9. They conducted a review of the Curfew Ordinance. Mayor and Council members commended the City Law Enforcement Officer and Sheriff's department for their efforts. The following was reported by the City Law Enforcement Officer:

Before the Curfew went into effect, there were 13 M.I.Ps filed after midnight on juveniles and after 24 months of the curfew only 1 M.I.P. has been filed on a juvenile after 12:00 am.

There have been a total of 7 curfew violations in the last 24 months.

Only 1 major felony crime involving a juvenile was filed in the last 24 months.

Since the curfew has been enacted, there have been a total of 2 violations of State Law and 7 City Ordinance violations by juveniles after midnight. This compares with 24 cases involving State Law violations prior to the Curfew Ordinance.

This reflects an 83% decrease in the number of cases handled involving juveniles after midnight in the last 24 months.

Also on the agenda was discussion of a speeding ordinance on Loop 229. The City Council of Robert Lee adopted an ordinance reducing the speed limit on Loop 229 from the city limits to approximately 85 feet west of Washington Street. This change was prompted by concerns of the speed limit near the Nursing Home and the Housing Authority complex. The speed limit will be reduced from 50 mph to 40 mph.

Sims makes election annuncement

State Senator Bill Sims (D-Paint Rock) has, after much thought and deliberation over the past several months, decided not to seek reelection to the Senate. Senator Sims has served in the Texas Senate since 1983 and has represented 59 counties in Central and West Texas during this period.

In a statement to his colleagues, Sims said, "It has indeed been an honor to serve the people of Texas for almost fourteen years. I appreciate being given this opportunity and have always made a deliberate attempt -- conscience and traditional beliefs dictating -- to represent my constituents in a manner deserved by all of the people of Texas. There is some sorrow that accompanies my decision to not seek reelection, but I will leave with absolutely no regret because I am able to take with me fond memories, enduring friendships, and confidence that I have served the State of Texas honestly and to the best of my ability.

The Senator does plan to fulfill his current term which will end in January of 1997. During that time, he will continue to perform his senatorial duties which include participating in the interim studies assigned to the Natural Resources, Finance, and Criminal Justice committees, and representing his constituents and their interests.

SS number required for vehicle title

The Texas Department of Transportation (TxDOT) will soon require additional information on title applications for motor vehicles. Beginning November 1, Texans who request title transactions in counties using the Registration and Title System (RTS) must provide their social security number. RTS is an automated system that electronically links county tax offices to TxDOT Headquarters in Austin. The Coke County Tax Office uses RTS to process motor vehicle transactions.

The social security requirement is part of House Bill 1863, passed by the 74th Legislature; the bill addresses fraud prevention in public assistance programs. TxDOT is mandated to collect the social security numbers and make them accessible to other state agencies for the purpose of determining eligibility for those programs. Individuals who do not have a social security number, or are not eligible for one, must complete a statement before their title application is processed.

Questions concerning the new requirement should be directed to the Coke County Tax Office, or the nearest Vehicle Titles and Registration Division (VTR) office.

TxDOT is implementing RTS statewide, with completion expected by December The computerized system makes it possible for registration records to be updated within 48 hours, which is a major benefit to law enforcement. Customers will also receive their vehicle titles within five days of the date the title applications arrive at Tx-DOT headquarters.

The Steers had several players out for this game as they were healing up, hoping to be ready for District play against Bronte this week.


First Quarter
