### **FB** week proclaimed

County Judge Jackie Walker has signed a proclamation designating February 5 - 9 as "Farm Bureau Membership Week" in Coke County. The week is part of a statewide observance during which county Farm Bureaus will make a special effort to enroll new members, according to Bobby Roberts of Robert Lee, president of the Coke County Farm Bureau.

"The Texas Farm Bureau, with more than 300,000 member families, is influential in both state and national affairs on behalf of agriculture," the proclamation reads.

"Farm Bureau is a grass-

roots organization. Its foundation is the county unit. There are 211 organized county Farm Bureaus in the state, including the Coke County Farm Bureau," the proclamation states.

Bobby Roberts said the local county Farm Bureau has 747 member families and is seeking to exceed that figure in 1996.

He said that the Farm Bureau is a general farm organization that seeks to improve the income of farm and ranch families. The organization represents the farmer and rancher at the local level, in Austin, and in Washington, D.C.

### TxDOT offers project funding

The Texas Department of Transportation (TxDOT) will initiate a third call for project proposals under the Statewide Transportation Enhancement Program on January 24, 1996. This program ensures a dedicated source of revenue for important activities that fall outside the scope of traditional transportation operations. To be eligible for funding, activities must fall under one or more of the ten project categories listed below:

No information may be released about inmates of the Texas Department of Criminal Justice or about patients under protective custody.

The Texas Hospital Association recognizes the responsibility of hospitals to keep the public informed of their activities. However, pro-



#### Keeping healthy is easier than you may think

Americans spend approximately \$5 billion a year on their colds -- about \$3 billion on doctors' visits and \$2 billion on treatment. With an estimated 60 million days of school and 50 million days of work lost each year, colds also cost us some \$4 billion in lost wages and productivity.

Everyone has experienced the symptoms of a cold or flu -runny nose, watery eyes, headache, chills -- and chances are we've all unintentionally passed our germs to family and friends.

With the "cold and flu" season upon us, now is the time to take action against germs. Most people don't realize how quickly and easily germs can spread by living on dry surfaces (such as a toy) for several hours, and moist surfaces (like the bathroom sink) for up to three days. Anyone who touches these surfaces is at risk of getting sick.

According to The Soap and Detergent Association (SDA), "Good hygiene is the first line of defense in staying healthy. The best way to reduce the spread of infectious diseases is through frequent handwashing and regular cleaning of household surfaces. Using an antibacterial soap and a disinfectant provides an extra tecting a patient's privacy and maintaining confidentiality of health care information is of a paramount importance. A hospital may acknowledge an adult patient's presence and provide a one-word condition or status report without written consent. However, a patient has the right to request that no information be released, and the hospital must honor the patient's request.

The establishment of standards for release of health care information not only enhances patient protection, but also assures patient access to health care information.

degree of safety." SDA offers the following tips for staying healthy this winter:

\* Wash hands frequently. Wash before meals, after using the bathroom, and after coming into contact with someone who is sick. For extra protection, consider using an antibacterial soap.

\* Give colds the shoulder. Instead of using your hands, turn your head, lift your upper arm, then cough or sneeze into your shoulder.

\* Clean and disinfect wet or moist surfaces often. Bathroom countertops, faucets, and handles; toilet bowls, seats, and handles; door knobs, floors and diaper changing tables are germ havens.

\* Make sure the product does what you want it to do. Some cleaners disinfect and some do not; be sure to always read the label.

\* Launder cleaning cloths frequently. Cleaning cloths pick up germs from the surfaces they clean. Use liquid household bleach in the wash water, and always allow the cloths and sponges to dry thoroughly between uses.

\* Eliminate germ spreaders. Avoid sharing drinking glasses or eating utensils, coughing or sneezing into the telephone, chewing on a pencil, and leaving used tissues around.

Hospitals failing to comply with the provisions contained in S.B. 667 can be held liable, as well as be subject to administrative penalties and disciplinary action from the Texas Department of Health.

Although there is existing law concerning the confidentiality of mental health records, S.B. 667 contains specific standards for:

\* The disclosure of mental health records in certain court or administrative proceedings; \* The disclosure of mental health records in other than court or administrative hearings; and






#### Steers drop 2 in district play

#### Grant offered to RL student



#### Area lakes report

Conditions on Lake O.H. Ivie reached the excellent status for those after crappie this week. Lots of limits of crappie were caught. Using minnows and jigs and fishing in water 10-30 feet deep, anglers had good luck around the Concho Bridge, Colorado "12 Mile" Bridge, Kennedy Park Bluff, and the Observation Point Bluff.

Conditions for black bass were noted as "good" with a few keeper-size being reeled in along shorelines. Points are still holding the better fish in 10-25 feet of water. Plastic worms, spinner and crank baits, and slabs were best baits. Smallmouth bass were landed along rocky areas, points, ridges, and at the main body of the lake; in water 10-30 feet deep, crank baits and slabs brought good results.

Yellow catfish went for live baits mainly on trotlines up the Colorado and Concho River in water 10-30 feet deep. As for channel and blue catfish, white bass, and walleye, there were no catches reported.

For Monday, January 8, 1996, the lake's elevation was 1550.00; water temperature was 45.5 degrees Fahrenheit on the surface and 46.0 degrees Fahrenheit on the bottom. The main body of the

During the first of January, the temperature on Lake E.V. Spence was 31 degrees Fahrenheit.

Fishing results from Paint Creek Marina were as follows: Bill Barfield from Robert Lee reeled in a 12 lb. striper while trolling. Dan Townsend from San Angelo caught a 12 lb. 9 oz. striper on cut shad. Kelly Estes from Midland reeled in a 7.5 lb. black bass. David Miller from Odessa pulled in a 4 lb. black bass. DeDee Duncan from Midland landed a 12 lb. 10 oz. striper. Terry Brown of Odessa caught a 14 lb. striper on cut shad.

Stripers have been reeled in water 25-30 feet deep. Black bass have been slow and are being caught in brushy areas along the water's edge.

#### CRMWD fishing report

As of Monday, January 22, the surface temperature on Lake O.H. Ivie measured 47.0 degrees Fahrenheit while the bottom temperature was a little colder at 46.4 degrees Fahrenheit. Lake's elevation was 1549.94 feet, and the main body was clear and the upper-end was murky.

Although slowing some, crappie were still biting along brushy points and ridges, and the upper-end of creeks and rivers. The best depths were between 20 and 30 feet of water, and best baits were minnows and jigs.

Fishing conditions were fair to good for black bass. In water 12 to 15 inches deep, black bass are hitting along shorelines on spinners and crank baits; the larger fish are still hanging around the points in 20 to 40 feet of water, and were going mostly for slab baits. Along rocky points and ridges in water 20-30 feet deep, smallmouth bass were going for crank baits and slabs. Like the smallmouth, white bass conditions were listed as fair. The white bass were found in deeper water up the rivers and were hitting spoons, small spinners and

slabs.

Germs thrive and multiply in warm, moist places, such as hot tubs and heated pools. Rosen recommends that you:

\* Shower before entering the hot tub, and avoid sitting near hot tub jets.

\* Wear thongs in the shower, sauna and locker room and by the pool to minimize exposure to athlete's foot fungus.

\* Completely dry between toes after swimming or bathing.

\* Towel well after bathing, and wear cotton underwear. Underwear made from synthetic materials tends to trap moisture and heat.

#### Tattoo removal made easy

When it comes to tattoo removal, laser technology improvements make it easier to start the new year with a "clean slate".

"We have come a long way from the days when tattoos had to be surgically cut from the skin or scraped off," said Dr. Ted Rosen, professor of dermatology at Baylor College of Medicine in Houston. "Those techniques were often painful and left scars."

Laser removal of tattoos does not damage the skin and causes only minimal discomfort and slight bleeding. The laser's light is selective, passing through the skin and affecting only the tattoo dye.

"The laser emits energy that is absorbed by the ink which literally explodes into microscopic pieces," he said. "Scavenger cells gather up the pieces and digest and destroy them."

Rosen says the laser is so selective that it bypasses melanin, a natural skin pigment. "Removal is effective for light and dark skin," said Rosen, who is also chief of dermatology at the Houston Veterans Affairs Medical Center.

The technique works anywhere on the body and on most tattoo colors. Turquoise seems to be the only color that is hard to remove.

Professional tattoos generally take anywhere from four to ten treatments, and homemade tattoos require as little as one or two.

"The treatment is the same

ter how much the tattoo costs, Rosen says, the outline will become blurry and the color will spread and fade slightly.

Appearance, however, is not one of the main reasons people seek out laser removal.

"They often find they no longer have the same attraction to the tattoo whether it be the name of a person, a cult or a gang," Rosen said. "Others feel tattoos, particularly on their hands, do not go over well in job interviews."

Available in most major medical centers, the average cost is about \$1,200 to \$2,000 to remove professional tattoos and as little as \$300 to \$600 for homemade tattoos.

"Since it hurts less than getting the tattoo in the first place, there is quite a demand for removal," Rosen said.

# Bass population increasing at lvie

John A. Dennis, fisheries biologist with the Texas Parks & Wildlife Deprtment (TPWD) fisheries studies at Lake O.H. lvie have documented natural reproduction of smallmouth bass for the first time since the lake filled. Two 10 inch long smallmouth bass were collected by TPWD fisheries biologists in their fall electrofishing survey. Examination of their inner ear bones, which are used to determine the age of fish, revealed only 1 annular mark which indicates the two fish were spawned in the spring of 1994 and would be 1 1/2 years old. Smallmouth bass were stocked in lvie one time in the spring of 1990 and those stocked fish would now be 5 1/2 years old.

Smallmouth bass have proven to be a popular sportfish at O.H. Ivie Reservoir and the current lake record is 3.81 pounds caught in February of 1994. They are usually caught around rocky points in the main lake in the clear water. It is best to use small lures on light line, due to the clear water and preferences of the fish.

Smallmouth bass populations in West Texas have not been self-sustaining because of limited reproduction. Therefore, TPWD biologists are studying the 18 inch minimum length, 3 fish per day regulation to see if enough adult broodfish will be protected to allow a self sustaining fishable population to be maintained.





"Along with damaging citrus trees by causing young leaves and stems to curl and die prematurely, the brown citrus aphid is very effective at transmitting the citrus tristeza virus," Perry said.

The citrus tristeza virus comes in mild forms and severe forms. However, the severe form of the virus has not been detected in Texas.

In addition to the brown citrus aphid, the Asian strain of citrus canker also has been detected this year in Florida, so it is also essential that Texans avoid bringing back or accepting fruit from residential trees in Florida, Perry said. Citrus canker, an extremely virulent bacterial disease, was detected in a Miami residential area in September.

Brown citrus aphids were found initially in Fort Lauderdale during a routine inspection of fruit fly traps by a U.S. Department of Agriculture inspector. More brown citrus aphid populations have been found in several additional locations in the Fort Lauderdale and Miami areas. No commercial groves have been affected.

The Texas Department of Agriculture is intensifying its inspections at weight stations statewide to ensure that citrus plants and uncertified citrus from Florida is not imported into the state. If uncertified plants or citrus is found, they will be returned to Florida.

TDA, the U.S. Department of Agriculture and the citrus industry also conducted a cooperative survey last year of citrus trees in residential areas in Cameron, Hidalgo, and Willacy counties. More than 400 samples were taken, and no brown citrus aphids were found.

# Combatting calluses

"Don't be a 'bathroom surgeon," Dr. Jeffrey Ross warns athletes who shave calluses on their feet with a razor blade.

"If you cut deep enough to cause bleeding or lacerate the skin, the cut can become infected," said Ross, a sports medicine foot specialist at Baylor College of Medicine in Houston. "The infection could develop into localized cellulitis -- an inflammation of the connective tissue -- which can spread up the foot or to

### Aphids invade Florida fruit

Kenneth Arant

Agriculture Commissioner Rick Perry recently advised Texans who travel to Florida to avoid bringing back citrus plants, budsticks or any part of a citrus plant taken from residential areas following the November 3 detection of a very serious citrus pest - the brown citrus aphid - in Fort the bone."

Ross recommends having calluses trimmed by a skilled podiatrist, who can determine what's causing the callus and suggest ways to prevent recurrence.

Calluses build up on areas of the foot rubbing against shoes, often the result of structural imbalances, gait abormalities, hammertoes or other deformities, or "dropped" metatarsals -- the foot bones connecting to bones in the toes. In some cases, the problem can be solved simply by wearing better-fitting shoes or wrapping foam cushioning or other protective coverings around the affected toe. In other cases, the solution may require orthotic devices that elevate the metatarsals, or surgery to correct irregularly shaped bones.


