Candidates file for local elective posts

City of Robert Lee

Kelly Nichols has filed for the 2 year term of Mayor for the City of Robert Lee. The position has been held by John Conley, but he elected not to run for re-election to that post; he has filed for a 2 year term as council member. Donnie Devoll (I) has also filed for re-election to the council. At presstime no other candidates had filed for positions leaving all places uncontested. According to City Secretary Kay Torres, if all positions remain uncontested, an election will not be necessary.

City of Bronte

Three council member vacancies are up for grabs in Bronte, but at presstime only 2 had filed for those 2 year terms. Leslie Rolls (I) and James Lammers have filed for seats on the council. The mayor's position will also be

on the May ballot, but no one had filed for that position at presstime.

RL School Board

Two seats on the Robert Lee school board will expire and several candidates have filed for the 3 year terms. Mark Riley and William Burns, both incumbents, have filed for re-election. Steve Ebenstein, Manuel Abalos, and Harvey Wojtek have also filed to run for those posts.

Bronte School Board

Wayne Coalson (I), Bob Frazee, and David Scott have filed for candidacy to the Bronte School Board of Trustees. Two three year terms will be filled in that May election.

West Coke County Hospital Board

Three positions will be available on the Board of Directors at West Coke County Nursing

Home. At press time only two incumbents had filed for those posts. Winton Milliff and Bill Carwile will be on the ballot in May.

East Coke County Hospital Board

No information was available at presstime for the East Coke County Nursing Home filings.

Trappers Assoc. dues needed

Producers recently received notification of a change in the dues for the Trappers Association. For 1996, dues will be figured at the rate of five cents per acre per year. These dues can be sent to the County Trappers Association, Box 170, Robert Lee, Texas 76945. Dues are needed to maintain the county predator control program not only for livestock producers, but pet owners and wildlife survival also.

Players named All-West Texas

Several players from Coke County were named to The San Angelo Standard-Times mythical All-West Texas Team. Considering the size of Coke County, getting one player recognized as outstanding is difficult; but when the district Robert Lee and Bronte were in is also considered, the talent these young folks have displayed is truly amazing.

Shalon Waldrop of the Lady Steers was named to the Super Team for 1995. Shalon, the daughter of Riley and Donna Waldrop, averaged 19.3 points, and 10 rebounds to help lead the Ladies to an Area Championship this year. The junior was also named to 1996 All-West Texas Class 1-A basketball team.

Aaron Hood added the honor of being named to the All-West Texas Super Team to a long list of awards. Aaron, a senior for the Steers, averaged 23.5 points and 11.5 rebounds for the season. He was also named to the Class 1-A All-West Texas team. Aaron is the son of Bill and Rhonda Hood.

Bronte's Kim Hall averaged 21.2 points, 9 rebounds, and 3.3 assists for the year to earn a spot on the All-West Texas Team. Kim, a junior at BHS, is the daughter of Kerry and Donna Hall.

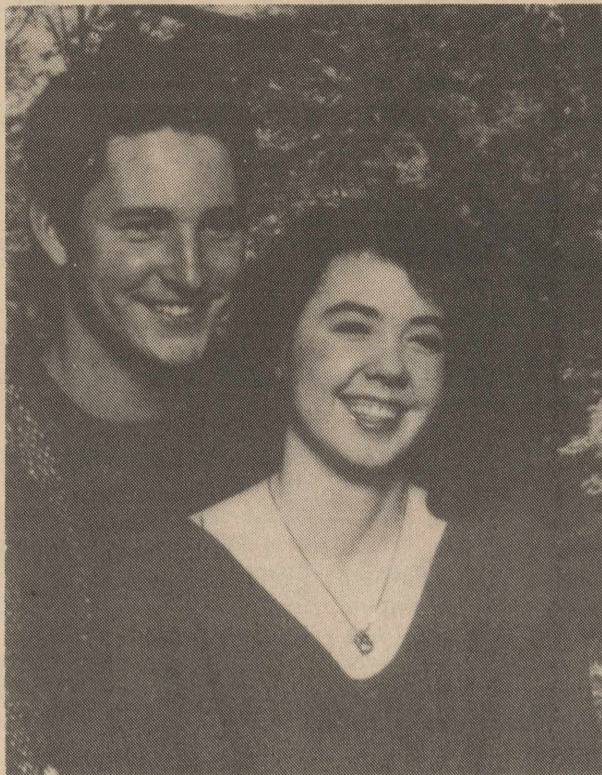
Owen Green, 78, of Oak Creek Lake, died Friday, March 15, 1996, at the Bronte Nursing Home in Bronte, Texas.
