

## Shamrock Clinic

to expand services Shamrock Clinic of Robert Lee will be offering a cardiology clinic to the residents of Coke and surrounding counties beginning Tuesday, February 25.

"We are pleased to be able to provide this new service,' George Zerucha, PA-C said. "After looking at data collected over this past year, there is a definite need for this cardiology clinic in our area."

Zerucha contacted San Angelo cardiologist Gene A. Sherrod, MD, of Shannon Regional Heart Center, and Dr. Sherrod agreed to come to the clinic on a monthly basis. "If the need is there, Dr. Sherrod will increase the number of monthly visits accordingly," Zerucha said.

The cardiology clinic is for people who have heart disease and are not presently under a physician's care, and for people with high blood pressure, chest pain or pressure, cholesterol problems, those with a family history of heart problems, and those who have been diagnosed with a heart murmur or any other cardiological problems.

Zerucha said the cardiology clinic is set up to evaluate, screen and, if need be, refer patients for further testing such as treadmills or echocardiograms.

In the future, the cardiology clinic will offer dietary counseling for persons with high cholesterol or known heart disease.

Be sure your Social Security number and name are correctly shown on the W-2 form (statement of earnings) your employer is required to give to workers before the end of January, Social Security manager, Franklin Upp announced.

"Compare the number and name shown on the W-2 with the information on your Social Security card. Report any discrepancies to your employer and local Social Security office right away. The name and number on your W-2 must match your Social Security record so that your earnings will be credited to the correct Social Security record," Upp said. "Call Social Security's toll-free number - 1-800-772-1213 - if you detect a problem with your name and number on your W-2."

Retirement, survivors, and disability benefits are based on an individual's earnings record. Uncreditied earnings could adversely affect your future eligibility for benefits, as well as your benefit amount.





#### Goat meat is the

"new" lean meat

The newest lean meat is probably as old as time itself, and a recent survey by Texas A&M University shows that retailers in the United States would put more into their meat cases if they had a steady supply.

Goat meat offers consumers a lowfat meat, according to Dr. Ernie Davis, agricultural economist with the Texas Agricultural Extension Service.

"It's a very tasty item," said Davis, who helped conduct the survey of wholesale meat distributors, chain restaurants, independent restaurants, chain food stores, and independent grocery stores.

These commercial retailers felt like they would be able to sell an estimated 4.8 million carcasses a year if supplied the meat.

Presently, there are about 800,000 meat goats in the United States and 700,000 of those are in Texas, according to Zane Willard of San Angelo, executive secretary of the Texas Sheep and Goat Raisers Association.

"Goat meat is the No. 1 consumed meat in the world," Willard said. It's also been consumed for centuries.

Federally-inspected plants processed 326,000 goats last year, about one-third of the total number of goats slaughtered in the nation. Most of the goat consumption in the United States is ethnic, and the slaughter is done at the farm level, Davis said. Much of the traditional Texas consumption is of cabrito, a young tender goat.

The next step in promoting goat meat as the newest lean meat is a series of consumer taste panels that will be conducted soon by Texas A&M.

Also, in-store advertising, on-site cooking demonstrations and recipes and price specials in grocery stores

would play an integral role in whether goat meat is widely accepted by consumers, Davis said. The main thrust of consumer acceptance would still entail working with chain restaurants, supplying them with recipes.

"We want to ensure that the goat-eating experience is very satisfactory to people. It wouldn't be something they would just take home and cook because it is low in fat. If it was cooked wrong, it wouldn't be a good experience for them."

Norman Kohls, a meat goat producer from Eldorado, thinks there is a future in that business.

'Everything you do in terms of marketing is supply and demand." Kohls said. "We don't meet demand here in the United States. If we can raise them, there is a market somewhere for them. And I think this thing is growing so fast it is the wave of the future."

There are many people who are either raising or poised to raise meat goats, Davis said.

"It's not a problem at all getting people interested in raising goats," he explained. "We've got a lot of producers out there right now. The problem is trying to coordinate those efforts where they're raising the right type of breed.

Goats are the oldest domesticated animal in the world, except for dogs. Every breed of goat -- even dairy -has been used as a meat goat at one time or another.

Davis said the most common meat breed -- the Spanish goat -- is so active and playful that it would be hard to raise it to the 100- to 110-pound live weight that would be needed for the mar-

able to increase the size to 110 pounds at one year of age and be able to furnish a plumper, fuller carcass to the industry. If you're going to case-ready cuts, you're going to have to furnish a larger, leaner cut."

One way to do this is to crossbreed goats, he said. Among those crosses being investigated are the crossing of traditional meat breeds with the large South African Boer goat.

Meat goats could be a lucrative option for West Texas sheep and goat producers who have lost governmental incentives, according to Dr. Frank Craddock, Extension sheep and goat specialist.

Additionally, Craddock feels goats may be a good option for East Texas landowners. Since goats are small animals, they can easily be raised on a little piece of land -- it takes only one to three acres for each goat, he said.

However, there are several considerations would-be producers need to keep in mind.

"Goats are a very active animal, and they like to travel and go through fences. They can find holes that most animals can't. Producers have to have good fencing."

Additionally, internal and external parasites and predators such as coyotes and wild dogs could be a problem, especially in the eastern part of the state, he said.

#### **Kids encouraged**

to play with food Fast food is healthy and it's on a roll.

Fourth and fifth grade students across the nation will learn the benefits of eating a variety of fruits and vegetables in the Lunch Box Derby a program challenging students to design, build and race model cars made completely out of fruits and vegetables.

The program, sponsored by the Washington Apple Commission, is intended to give kids a dietary tune-up by teaching them the size, shape, texture, tastes and nutritional value of fruits and vegetables.

"The derby promotes good nutrition, emphasizes teamwork and encourages children to be imaginative," said commission spokesman Jim Thomas. "The object of the exercise is to design a car which goes the farthest, not the fastest."

'It's important kids understand what makes a high-performance car body also makes a high-performance body. The derby reminds students in a creative way that eating fruits and veggies will help their bodies go the distance." Thomas said the commission is looking for classrooms willing to take the challenge, and the rules are fairly simple. Students divide into groups of four and make an inventory of available parts - fruits and vegetables of every variety. Each team designs their vehicle on paper, with the teacher slicing the food to make the necessary parts. The cars can be assembled using only three bamboo skewers, four toothpicks and a rubber band to hold it together. Teams then place their cars at the top of an eight-foot

flag. "Sometimes the cars run great," Thomas said. "Sometimes they turn into a tossed salad. That's what makes it fun to watch."



## Youth sports injuries

Sports may be hazardous to the health of our youth.

"Of the 30 million young people involved in organized sports, 10 percent of them will suffer a sports-related injury," said Dr. Albert Hergenroeder, head of adolescent and sports medicine at Baylor College of Medicine in Houston. According to Hergenroeder, many new injuries occur as a result of past injuries that are not detected or properly rehabilitated. Athletes often suffer loss of strength, flexibility, and endurance as a result of injuries that are ignored and not treated. "The best way to prevent injuries is to rehabilitate old injuries," he said. "In addition, watch for the 'stars.' An athlete who is successful at a high level is more likely to return to competition before he is fully recovered." Sports with the highest number of injuries include football, softball, gymnastics, and girls cross-country running

## **Extended** driver's licenses can save **Texans** money

Few Texans look forward to the prospect of getting a new driver's license -- and not just because they know they'll have to carry yet another unflattering photograph around for the next four years. The fact is that applying for a driver's license, or renewing one, is a time-consuming, irritating, and increasingly expensive hassle.

It's also an unnecessary one.

Modern technology has effectively eliminated the need for regularly updated driver's licenses. The Department of Public Safety (DPS) and the vast majority of local law enforcement agencies now use computer records to verify each Texas Motorist's license. Current licenses already employ both magnetic stripe and bar-code technology to allow officers to instantly check a driver's eligibility to operate a vehicle.

DPS processes 4.2 million new applications and renewal forms each year, issuing drivers temporary licenses until their "permanent" versions arrive in the mail weeks later. It costs \$1.2 million a year to mail new or renewed licenses to Texas motorists, an amount that will continue to rise as more youngsters reach the legal age and more folks move here from out-of-state.

All the elements are in place to offer Texans better customer service and taxpayer savings through extended driver's licenses, with required updates every 12 years -- free of charge.

The new system should feature an adjusted fee structure: \*\$85 for drivers aged 18 to

\*\$75 for those aged 25 to 34

\*\$60 for anyone between 35 and 44.

\*\$40 for drivers aged 45 to 49

\*\$20 for those aged 50 to 54.

\*\$16 for qualified drivers over the age of 55.

This new fee structure will save individual motorists a lot. For each age group, the extended license will be cheaper than the current \$16 charge for renewal every four years. For example, an 18year-old paying the \$85 fee will be covered for 42 years, as opposed to the \$168 he or she would owe over the same period under the present system.

Along with these extended driver's licenses, Texas should also offer the convenience of on-site issuance, which will also cut the costs of postage and processing. Immediately after applicants successfully complete their driving exams, they should receive their extended licenses. This will eliminate walk-in traffic and long lines in DPS offices, free up personnel for more urgent law enforcement matters, and save taxpayers \$487 million over the next five years.

The move toward extended driver's licenses is already evident in other states, especially Arizona, where licenses are valid until motorists turn 60, after which drivers are required to renew their licenses every five years. By late this summer, all Grand Canyon State drivers are expected to have extended licenses, a prospect that has proved popular among drivers and state troopers.

The time is right for Texas, too. Extended driver's licenses would be more efficient, just as secure, a whole lot cheaper for individual motorists, and far less expensive for Texas taxpayers overall.
