In the event of rain at service time, the meeting will be held in the basement of First United Methodist Church.


Rabies Clinic

Registration renewal notice receives new look

Texas motorists whose vehicle registrations expire in May will be among the first to see the state's new and improved registration renewal notice. The Texas Department of Transportation (TxDOT) has dramatically changed the form to make it more customer friendly and will begin distribution during the first week in April.

Gone is the multi-part card Texans have been getting since 1970. The new notice is a standardized 8 1/2" x 11" document, similar to a tax, utility, or credit card statement.

Some Texans have already seen a prototype of a new renewal notice. TxDOT showed the form to several focus groups and invited the state's 254 county tax assessor-collectors, who are TxDOT's statutory agents to give their input. An insert with a graphical explanation of the new form will be included with each renewal notice. Anyone with questions about the new renewal notice should contact the Coke County tax office at 915-453-2614.






TX Senate passes HMO bill

Health Maintenance Organizations (HMOs) will now be liable for their decisions made concerning patient care under Senate Bill 386, a bill which passed in the Senate on Monday, March 17. Currently, HMOs are protected under the law from being sued by an enrollee. However, cases have shown that decisions made by some HMOs have ended in critical, and sometimes fatal, circumstances because of denial of necessary treatments. SB 386 allows HMOs to be sued for medical malpractice if a health care

treatment decision adversely affects a patient's health. There was substantial opposition to the bill stemming from the fact that HMOs should not be making medical decisions nor should they be held responsible for circumstances resulting from advised procedures. Those in favor of the bill telt that the legislation was long overdue. "This bill is for Texans who are having to fight to get the health care that they have paid for for years," said the bill's author, Waco Senator David Sibley. "While there are a number of honorable HMOs operating in the marketplace, others seem more concerned with protecting their bottom line than protecting the health of their enrollees." There is an esti-mated 12 percent of Texans currently enrolled in some type of managed health care plan. If passed by the House and signed by the governor, the bill would take effect September 1, 1997.



Decorating Eggs

The egg's perfect shape has always inspired artists. It has been the palette for one of the most intriguing of folk art in many cultures.

There is literally no end to the creative possibilities for individual expression on an egg shell. Eggs can be painted or colored with crayons or felt tipped pens, turned into funny faces, topped with fantastic hats, trimmed with feathers or sequins or simply dyed in an endless variety of hues. However you decide to do it, decorating eggs is fun for grownups as well as for kids.

Eggs to be decorated may be either hard cooked or blown out of their shells. The hard cooked variety is a bit more sturdy for children to work with, while the blown shells are best if you are mak-

ing an egg tree or want to keep the eggs on display for considerable time. If eggs are to be dyed, washing in a mild detergent solution helps to remove the oil coating so that the color adheres more evenly.

Commercial egg dyes are available, especially at the Easter season. Food coloring works too, but why not try this unusual way to dye eggs with color you can produce by using natural materials. Eggs simmered in water to cover for 20 minutes with a teaspoon of vinegar and your choice of one of the following materials will produce a shade of natural colors. You will have to use

your own judgment about quantities. This is an art - not science!

Choose one of the following materials to dye your eggs: *Fresh oregano or mint will produce beige colored eggs. *Red cabbage leaves will produce blue colored eggs. *Strong coffee will produce brown colored eggs. *Walnut shells will produce buff colored eggs. *Spinach will produce greyish gold/pink eggs. *Carrot tops will produce greenish yellow eggs. *Yellow delicious apple peels will produce lavender colored eggs. *Onion skins will produce orange colored eggs. *Orange peels or thyme will produce yellow colored eggs. *Beet juice will produce red/purple colored eggs. Happy Easter!

Test Security: A Valid Concern

While they are not the only criteria, and certainly not the most primary piece of information utilized by college admissions personnel, standardized test scores are indeed an important component of a student's academic profile, and are taken seriously by those reviewing them. Students sometimes question the sense of so much weight being attached to a score that reflects one Saturday mornings' work, but in essence the score is a reflection of your academic preparation, and more significantly, is the one piece of information that puts all students on an equal footing. That is why they are called "standardized" tests, because all students in the nation (the world, really) are taking the same test. Other pieces of a student's record may be a little misleading - class rank, for instance. Two students can be equally bright and hard-working, but have very different class ranks based upon the number of students in their class, the competitiveness of their school, etc. (For instance, it would be much easier to be in the top quarter of a class of 800 where only 10% go on to college than in a class of 250 where 85% go on to college. However, students at these two schools have an equal chance to earn a 36 on the ACT.)

Because it is an "equal opportunity" reflection of a student's ability, colleges, the NCAA, and scholarship agencies count on ACT to construct a fair test, regulate the testing environment, and pursue any questionable test results or testing irregularities.

Test Security The Department is ACT's centralized resource for handling security related testing irregularities (situations in which test scores may have been achieved by means other than the independent efforts of the named examinee). Included are: copying from another examinee; gaining access to test questions or answers in advance; impersonating another examinee and writing the test for him/her (surrogate testing); tampering with an answer sheet or test booklet; and using prohibited testing aids such as dictionaries or scratch paper.

Test security is essential to ensuring that examinees have an equal opportunity to demonstrate their academic achievement and skills, and that examinees who do their own work are not unfairly disadvantaged by examinees who do not. Because testing irregularities compromise the integrity of test scores and are unfair to other test takers, ACT carefully investigates every potential testing irregularity.

In the cancellation statement printed in "Registering for the ACT Assessment" ACT informs examinees that it reserves the right to cancel test scores when there is reason to believe the scores are invalid. The examinee is notified as soon as a score review is begun and is invited to participate in answering the questions raised in the review.

ACT's primary concern is that test scores provide an accurate assessment of an examinee's academic achievement in the four test areas. If

test scores are canceled, only the examinee and the institutions that received official score reports from ACT are informed. The cancellation notice lists all the reasons that test scores can be canceled, including examinee illness, mistiming of the test, disturbances or irregularities at a test center, and at the examinee's request, but does not state the specific reason for cancellation in this particular instance. As you can see, ACT takes

test security seriously, and you should, too. Like being audited by the IRS, it is nothing to fear if you have followed the rules, but if someone tries to talk you into breaking them, please remember that safety nets are in place, and that being caught can be embarrassing at the very least, and ruin your chances for consideration by colleges at the very worst.

Avoid flying when ill

If you have an upper-respiratory infection plus fever and/or sinus-pressure pain, you may want to postpone trips by air, especially if you have high fever or sinus pain. Changes in cabin pressure can increase the severity of the infection in the sinuses and ears.

If the flight must be made, decongestants and/or nasal sprays can be used before takeoff and landing for short trips, said Dr. Wayne J. Riley, director of the Travel Medicine Service at Baylor College of Medicine in Houston.

For longer flights, also take oral decongestant medications for comfort during the flight.
