ASU sophomore Lee Mc-Cown is headed to the national track meet. Lee, a 1995 RLHS graduate, qualified for the Nationals Saturday, April 12 after two days of competition during the Angelo State Relays. McCown finished up the Elite Decathalon competition with 7,250 points, a personal record.

Lee set two personal records during the first day of the meet. One in the long jump and another in the 400 meters. He racked up 3,814 points on Friday and was well on his way to the 7,000 he needed to qualify for the nationals

outstanding posters will be honored as the year's Outstanding Class and presented a rotating trophy plaque with a space for engraving the class name and year.



Minutes were approved as corrected.

Kristy Roe reported that collections of taxes are currently at 95.74% or \$887,717.04. Mrs. Roe also informed court of some things her office does and what is involved. She will be visiting with the Bronte School Board and the City of Bronte regarding collection of taxes.

Discussion followed on the rentals of the recreation buildings and the condition of the buildings. We have completed quite a bit of work on the buildings. The commissioners plan to coat the roofs, in hope of stopping the leaks. New gutters will be installed. The need of infrastructure repairs is great and the commissioners are working as hard as they can to catch up. This is hindered by money and time,





WCCNH Eden Alternative takes flight

by Della Alexander As reported several weeks ago, the WCC Nursing Home has implemented a new concept in nursing home care called the Eden Alternative. This program creates a more humane living environment.

The program kicked off with four parakeets and two cats. The parakeets reside in pairs in the east and west lobbies. One of the cats chose to wander off to find other living accommodations but has since been replaced. Guidelines for the program state that the cats and dogs will know where they are welcome and find places to call home. One has only to walk down the hall and observe the true meaning of "cat nap" as a resident takes an afternoon nap and one of the cats is parked right next to or on top of the sleeping resident.


The main attraction to date is the bird aviary, which is located in the Activity Center. This glass enclosed case is home to a group of very active finches, two canaries, and a button quail. Activity in the aviary provides entertainment to visitors as well as residents. As word spreads around town, we even have people dropping by to see that "bird thing".

The bulk of the funds to purchase the aviary came from a generous donation by the WCC Nursing Home Auxiliary. Additional donations are being accepted from any individual or organization wanting to help pay for the aviary or to help with any part of the program.

Employees have willingly volunteered to take on the daily duties of the "animal housekeeping". Several residents have helped in locating just the right pets, get "good bargains" on pet housing and assisted with pet grooming.

Future plans indoors, include birds in the rooms of residents who wish to have them and the addition of a couple of dogs and another cat. Live plants are also being added as ivy takes root and funds become available to purchase hanging baskets and wall planters.

If you pass by the east side of the facility and see a large pile of dirt, watch it disappear as the ground is being prepared for a garden area. This



area will host both a flower and vegetable garden. The area is to be fenced in with the RLHS FFA students doing the fencing. Planning for this area includes a pond and water fall. All areas will be constructed with resident safety as the primary goal.

As author of this article, I am also an employee of the nursing home and will be the first to tell you I am not a pet lover. However, when I walk out my door and see a resi-

dent sitting in the lobby with the birds or walk by a room and observe a "cat nap", I am reminded that I only work here 40 hours of the 168 hours in a week; then I go home. This program is not for me. It is for the residents who are here all 168 hour per week because this is their home.

Any time you are out and about, feel free to drop in and experience for yourself the Eden Alternative.

Vacuuming with vigor

When it comes to vacuuming, it's almost safe to say that too much is never enough! Frequent vacuuming will not harm carpets and furnishings, but if ground-in soil is not removed, it can dull, discolor, and damage these textiles. Here are some guidelines for getting the most out of vacuuming efforts.

Keep in mind that an excessively soiled carpet can hold up to one pound of dirt in each square yard. That's a lot of dirt to create a lot of damage. If the choice is between a light vacuuming all over the room or a thorough vacuuming in heavily trafficked areas, choose the latter. Most of the damaging soils, oily or gritty particles collect where there is the most foot traffic. In a residential setting, heavily trafficked areas should be vacuumed once or twice a week. For areas that receive little traffic, once every two weeks may suffice. In the commercial setting, carpets should be vacuumed thoroughly at least three to five times per week. In high traffic areas, the carpet

To remove soil and improve the carpet's appearance, vacuum against the nap. Six or even eight strokes over the same area constitutes a heavy vacuuming. Three or four overlapping strokes equals a light vacuuming.

should be vacuumed nightly.

Vigilant maintenance will affect the vacuum cleaner's performance. Never let the dirt collection bag become more than half full. Otherwise, the suction power will be reduced and the vacuum will operate less efficiently. Cloth dirt collection bags should be turned inside out and brushed off at least every third emptying.

An upright vacuum with a beater bar is the best choice for a carpet. Adjust the bar's

height to match the pile height of the carpet. Carpets that have a high pile or are loosely textured may show shading marks that identify the vacuum's last pass. To create an even surface appearance, keep the final vacuuming strokes all in the same direction. A canister-sytle vacuum is preferable for upholstery, draperies, blinds and light dusting.

Freeze damage to wheat crops

The Canadian airmass that enveloped much of the state over the period from April 10 to 14, has caught much of our area wheat crops in a stage of growth that is vulnerable to very cold temperatures. When wheat is in a vegetative stage and is only growing leaves, it is usually quite hardy, and can take temperatures as low as -5° F without much injury from the freezing temperatures, although the level of damage will vary greatly with conditions such as drought, temperature and hardening, and other variables. The lateness of this Arctic front, coupled with a mild and wet winter that caused accelerated development of the wheat crop, has resulted in a considerable amount of damage to the Texas wheat crop.

Most of our wheat is at Feekes 10.0 to 10.5, or booted to headed, with a good deal at prebloom. When spring freezes occur, the less physiologically developed a wheat crop is, or indeed the less dveloped a tiller is on a given wheat plant, the more likely it is to survive. Reproductive tissue (the developing head) and the tissue immediately surrounding above ground nodes are the most susceptible tissue to freeze damage.

Damage to leaf tissue on wheat that has not yet jointed can appear serious, but usually does not affect yield to a great degree. This injury is most apparent as dried or dessicated leaves, usually the uppermost leaves. Frozen tissues often give off a distinct silage odor as they begin to decay in the field. In cases where wheat was tall and rank but not jointed, flash grazing or mowing will help remove damaged tissue and aide in growth of new leaves by letting sunlight in to newly developing leaves. Freeze injury is difficult to diagnose,

typically taking 5 days to a week before it is readily apparent which tissue is destroyed and which is normal.

Stem damage is difficult to assess. The area around the uppermost node or two nodes is most likely to be damaged. Apparent symptoms include discoloration (a light colored band), splitting, collapse of internodes, and enlarged, dark colored nodes. Results from stem injury vary with the level of injury to this tissue. In light cases of stem damage, wheat might stress a little quicker than uninjured wheat, and lodging may be a problem as the heads gain weight. In wheat with severely damaged stems, sudden dessication and lodging will occur as temperatures warm. Frozen stem tissue is soft and mushy with a "water soaked" appearance shortly after the freeze.

The developing spike or head has little tolerance to freezing temperatures. The most sensitive tissue to freezing weather is the anther or pollen sac. Anthers are normally lime green to yellow, with the color at boot being green and phasing towards yellow as the floret approaches bloom. If the anther is frozen, the floret is sterile. with resulting blank heads or portions of heads. The color of a frozen anther changes fairly rapidly from the greenyellow appearance to a brown, water soaked appearance, then to white as the tissue continues to degrade. In a healthy condition, anthers are plump and turgid. When frozen, they become shriveled and flaccid.

There is a substantial difference in age between tillers in young wheat (jointing and earlier). This difference in physiological age diminishes as wheat progresses towards bloom and grain fill. This age difference is very important in young wheat subjected to freeze injury. The main stem tiller is the first tiller to joint,

and in early jointing, the second, third, and subsequent tillers may still have growing points below the soil surface. where they are protected from a sudden, sharp freeze. In many instances where main stem tillers were lost to freeze. later tillers resulted in acceptable wheat yields. It is important when assessing wheat freeze injury to look at all tillers in a row segment to determine what fraction of the total number of viable tillers have survived, what is the potential head size and evaluate stem and vegetative tissue injury.

Banner turkey season expected

No excuses. For the first time in several years, all indicators point to what state wildlife officials predict should be an excellent spring turkey season in Texas.

"If you define a good hunt by the amount of gobbling activity, this spring ought to be a good one," offered Dr. Markus Peterson, turkey program leader for the Texas Parks and Wildlife Department (TPWD). "For the hunter who likes to call in birds, this is probably going to be one of the best seasons is quite awhile."

In nine East Texas counties, this spring will not only be the best season in quite awhile, it'll be the first season, as turkey and turkey hunting return to the Pineywoods after several generations. In addition to Red River County, which marks its third spring eastern turkey season, hunting will take place in Bowie, Cass, Marion, Harrison, Cherokee, Nacogdoches, Trinity, Jasper, and Newton counties. The spring eastern turkey season runs April 21-May 4 and is limited to shotgun only and one gobbler bag limit. Harvested turkeys must be checked at any of the 45 mandatory check stations set up in the counties having an open spring eastern turkey season.

Rio Grande turkey hunting season opened March 29 in South Texas and runs through May 4, and began in the remaining counties having a spring turkey season on April 4 and runs through May 11. In recent years, the number of hunters who participate in the spring turkey season

has stabilized at about 100,000. In addition to possessing a valid Texas hunting license, turkey hunters are required to purchase a Special Turkey Hunting Stamp. The annual bag limit on turkeys is four, and only gobblers may be harvested during the spring season.

According to Peterson, good fall and winter rainfall across much of the state has created ideal range conditions, which equates to increased turkey breeding activity. "The birds aren't going to be hungry due to the amount of available vegetation," he noted. "So, if you define a good hunt in the spring as having huge numbers of gobblers coming to bait, this won't be a red letter year, because the birds don't have to look to corn to survive."


Because this marks the first year that eastern turkeys will be hunted in the nine newly opened counties, hunters can expect to find some trophy class eastern gobblers, according to John Burk, TPWD eastern turkey program leader. "Because there will be higher proportion of older birds in the population, combined with excellent body conditions due to available food supplies, the serious turkey hunter has a golden opportunity to harvest a truly trophy class gobbler this year in any of the 10 East Texas counties."

Burk indicated the average gobbler harvested last year in Red River County weighed nearly 22 pounds and sported 10 1/2 inch beards, with inchlong spurs. "We had six birds with inch-and-a-half long spurs taken last year," said Burk. "To put that in perspective, the world record eastern turkey had two-inch spurs, so we've got some birds of a lifetime out there."
