

Howard attended school in Bronte. He served in the Army during Work War II in the Engineer Corp. He received the Asiatic-Pacific Theater Ribbon, the Philippine Liberation Ribbon, and the Good Conduct, and Victory medals. After the war, he returned to Bronte where he farmed, ranched, and served as Commissioner of Coke County for eighteen years until his retirement. While serving as County Commissioner, he made sure many improvements were made to county roads and bridges. During this time, the most important improvement for the residents of Bronte was the construction of the Park and Bronte City swimming pool.

Howard loved music and treasured his favorite instrument, his fiddle. As a young boy, he won numerous blue ribbons at the old fiddlers' contests. He always enjoyed entertaining family and friends because music was his favorite hobby and as he said many times, "Music is my life." He and his band played at country dances in Coke County and in numerous surrounding counties.

He was preceded in death by his first wife, Will Estelle Brock; two daughters, Patsy June and Judy Lynn Brock; Stockton, and John M. Jr. "Johnny" Brock of Las Vegas, Nevada; 14 step-grandchildren; and 5 step-great grandchildren.


Sheriff's report was approved.

Bills paid and meeting adjourned.


New Youth Minister Bronte First Baptist Church

Bronte chosen by **Texas Folklife** Resources

Twenty Texas towns will host a traditional musician for a week-long community-wide residency beginning in January, 1998. Working with Texas Folklife Resources, a statewide nonprofit cultural organization, each town will organize an intensive schedule of presentations to schools and community centers, workshops at local civic clubs, jam sessions with local musicians, and even private lessons. The purpose of the community residencies is twofold: 1) to underscore the importance of traditional music that is passed down from generation to generation and 2) to introduce smaller, mostly rural Texas communitites to presenting the arts.

The Community Residency Program will feature eminent traditional musicians such as fiddlers Johnny Gimble, Alvin Crow, and Valerie Ryals Bates, blues artists Carol Fran and Clarence Hollimon, singer and cowboy poet Buck Ramsey, and conjunto accordionists Santiago Jimenez and Mingo Saldivar.

The selected sites for the 1998 Community Residency include Anson, Bracketville, Bronte, Claude, Cotulla, Crockett, Cuero, Decatur, Del Rio, Falfurrias, Leakey, Mount Vernon, Palacios, Queen City, San Benito, and Yoakum County. In addition, four more towns will be chosen. The majority of these communities have populations of less than 5,000 and most have limited experience with public arts programs. Texas Folklife Resources is a nonprofit folk arts organization that presents and promotes the traditional arts of Texas. The statewide community residencies are made possible in part with funding from the National Endowment for the Arts Folk Arts Program and the Texas Commission on the Arts. 


The Bronte Lady Shorthorns 7th and 8th grade basketball teams fell to Robert Lee January 8, 1998.



Patience & Time are best cures

There's an old saying about colds: Left untreated, they last seven days; treated, they last a week. In other words, only time will cure a cold. Common cold symptoms, such as a fever, runny nose, and lethargy, are all signs your body is doing its job fighting the viral invader. Trying to suppress nature's healing process with over-the-counter (OTC) cold relief medications wil not speed recovery.

However, if you do choose to lessen a cold's unpleasant symptoms with medication, avoid a multi-symptom cold reliever. Few colds demand such a potpourri of pain relievers, decongestants, antihistamines, cough suppressants and expectorants. In fact, some multi-symptom ingredients can work against each other.

For a dry, persistent cough, use a cough suppressant. Use this only if the cough is interfering with sleep or if it's a hanging-on hack. Don't suppress a congested cough that's bringing up phlegm -the coughing helps keep mucus from settling in the lungs.

Treat headaches, muscular aches and fever with aspirin, acetaminophen, ibuprofen, or naproxen. Note: Aspirin is fine for adults, but never give it to children because of its association with Reye's Syndrome - a potentially deadly disease.

If a nose is stuffy, use a decongestant to shrink mucous membranes and open nasal passages. This allows the nose to run - a good thing because the outpouring fluid takes the virus with it.

For chest congestion or a painful cough, use an expectorant to loosen and thin contaminated secretions so they

are easier for the body to expel. Drinking lots of water or taking a steamy shower will do the same thing as an expectorant.

Remember, like prescription medications, OTCs can have serious adverse affects if improperly used or overused, whether intentionally or unintentionally. Before buying any medication, consult a pharmacist or physician.







IRS offers Texans more options

The beginning of a new year also signals the start of the annual federal tax filing season. More than 33 million North Texans are now fining tax packages in their mail boxes, a reminder that it's time to file their income tax forms again.

This year's tax forms look a lot like last year's form despite a huge number of tax law changes. For example, Form 1040 has just two new lines-one for the medical savings accounts deduction and the other for the adoption credit, both provisions resulting for 1996 legislation. Most of the changes in the Taxpayer Relief Act of 1997 will not start until 1998.

According to the IRS, most taxpayers file their taxes between the last few days of January through the first three weeks of February. That's the IRS' "peak filing period" "Once people receive their W-2 earnings statements from their employers, they usually don't waste any time in filing their annual tax return because they're expecting a tax refund." said Ellen Murphy, IRS North Texas acting district director. About seven out of every 10 North Texas taxpayers will receive tax refunds this year. For most people, the annual chore is an easy one. All the help they need is explained in their tax package.

If people still need help, they can call the IRS at 1-800-829-1040. The IRS has expanded its telephone hours to six days a week, sixteen

Texas Forest Service sells windbreak trees,

offers tips

A tree standing alone adds a certain aesthetic quality to rural living. But the systematic planting of trees and shrubs in a windbreak becomes a management tool that affects every aspect of a farm or ranch, says a Texas Forest Service official.

Now is the time for Coke County landowners to order windbreak seedlings produced by the Texas Forest Service West Texas Nursery in Lubbock, before preferred stock is sold out, says Robert Fewin, Texas Forest Service forester. The seedlings can be purchased through the Coke County Soil and Water Conservation District (SWCD).

Windbreaks protect the soil, increase land value and crop yields, and reduce livestock weight loss and mortality.

But producing a high performance windbreak requires more than just planting a line of trees, Fewin says.

Prior to planting a windbreak, Fewin states that it is essential to determine: the area or structure in need of protection; tree species adaptable to the planting region; and the planting dimensions of the break, be it a homestead, livestock, field or wildlife windbreak or a living snow fence.

A planting dimension, such as proper spacing, prevents crowding and reduces tree stress, which also decreases insect and disease susceptibility thus extending the life of the windbreak. Generally, each tree row should be planted 20 feet apart with 10 to 25 foot spacings between each tree within a row, Fewin says

When designing a windbreak, Fewin also recommends planting multiple rows of evergreens and deciduous trees and shrubs. The purpose of the windbreak dictates the number of rows required.

Each row within a multiple row windbreak serves as a backup in case one row is lost to pest damage or other conditions. Generally, insects and diseases are confined to a species. Also, within the multiple row structure a deciduous tree row will provide early protection. Deciduous trees are faster growing than evergreens, which are the backbone of multiple row windbreaks, Fewin states.

Specie diversity in a multiple row windbreak also enhances aesthetics with foliage that changes with the seasons (depending on the species).

A single row of trees may suffice for a period, but a multiple-row windbreak established with the recommended dimensions can serve a lifetime.

Heartburn What is Heartburn?


Heartburn (also known as acid indigestion) is a painful burning sensation at the base of the breastbone.

Although heartburn is not a major health threat, the pain can be so intense that it is mistaken for a heart attack. In fact, some experts estimate that as many as 70 percent of emergency room patients who believe they are having a heart attack are actually suffering from heartburn.

What Causes Heartburn?

Heartburn is caused by a backflow of stomach acids into the esophagus. When food is swallowed, it travels down a tube called the esophagus, and a valve (sphincter) at its bottom relaxes to allow the food to enter the stomach. This valve normally only allows food to move downward, but a drop in pressure in the lower esophagus or a weakening of the sphincter muscle can permit a backflow (reflux) of powerful stomach acids into the esophagus. This causes the burning sensation associated with heartburn.

Certain food or circumstances greatly increase the risk of heartburn. Overeating, consuming alcohol, cigarette smoking, and eating fatty or spicy foods can lead to acid indigestion. Pressure on the esophageal sphincter (usually from eating too much, exercising, bending over, or lying down after a large meal) can cause a drop in pressure in the esophagus that allows the stomach acid to flow back into it. A hiatel hernia, a disorder in which a portion of the stomach pushes up through the small opening in the diaphragm where the esophagus and stomach meet, also can allow a backflow of acids.


