Early voting in run-off slated for April 6-10

Early voting by personal appearance for the upcoming run-off election is set for April 6 through the 10 in the County Clerk's office at the courthouse in Robert Lee. The last day to apply for a mailin ballot is April 7, 1998. This election, to be held Tuesday, April 14, 1998, will decide two of Coke County's new commissioners.

In the race for Precinct 2 commissioner, Sid McGinnis will face Wayne McCutchen. In Precinct 4, David Rawlings will square off against Rick Styles.

Historically, voter turn-out in run-off elections has been low. However due to the importance of these races to the next commissioners' court, Coke County voters are urged to exercise their right to vote on Tuesday, April 14, 1998.



PAINKILLERS

How do painkillers work?

Opiates and opioids apparently work through specific receptors in the central nervous system. Aspirin and the other non-prescription drugs are thought to work by blocking the body's production of particular types of prostaglandins, hormone-like substances that are produced throughout the body.

Secondary Side Effects

The most common side effect of aspirin and the stronger nonsteroidal anti-inflammatories is gastrointestinal irritation. This can be minimized by taking them with meals or milk.


Acetaminophen does not cause as many intestinal side effects as aspirin, but it should be used with caution by persons who have liver or kidney disorders. The combination of aspirin and acetaminophen is especially damaging to the kidneys, as is heavy alcohol consumption and long-term acetaminophen use to the liver.

Codeine often causes nausea, dizziness, and constipation. A more serious problem, however, involves the tendency of codeine and other narcotic drugs to produce drowsiness. Thus, these agents should not be taken by anyone who must remain alert. In addition, narcotic drugs should never be taken in combination with alcohol, antihistamines, and other allergy or cold pills, anticonvulsants, tranquilizers, muscle relaxants, or any other agent that depresses the central nervous system. Narcotics increase the effects of these drugs on the brain, and a fatal overdose can result from their combined use.

The potentially addictive effect of opiates and other narcotic agents is the major drawback to their long-term use. However, overconcern

> about addiction has resulted in their underuse in the control of severe pain in a patient with terminal cancer.

Some painkillers have beneficial secondary effects. For example, lowdose aspirin may help prevent a heart attack or stroke by preventing clot formation. By the same token, aspirin can cause bleeding problems.





Falling interest rates boost

housing

Texas homes became more affordable to a wider population because the interest rate charged on home mortgage loans at the end of 1997 was the lowest it has been in two years.

The average rate on loans, both fixed and adjustable, closed in Texas during the last three months of 1997 was estimated to be 7.35 percent," says Jack C. Harris, a research economist for the Real Estate Texas A&M Center at "This rate University. compares to 7.6 percent paid one year ago and the most recent low point of 7.21 percent during the first quarter of 1996.

The Texas Housing Affordability Index, which indicate the adequacy of a median household income for purchasing a median-priced Texas home, rose to 1.48 in the fourth quarter.

"The index means that the median Texas income of \$38,000 was 48 percent higher than the amount needed to qualify for a mortgage to purchase a home selling for the median price of \$91,000 at prevailing market interest rates," says Harris.

Out of seven million Texas households, it is estimated that 66 percent can afford the median priced home, up from 63 percent last year.

"The improvement in the Index was caused solely by the lower interest rate," says Harris. "Affordability appears to have stimulated sales, as the number of homes sold through Texas Multiple Listing Services for the quarter was 7 percent higher than the number sold during the fourth quarter of 1996."

Child safety seats

Child safety seats really do work. Children, especially those under the age of 5, are vulnerable in collisions because of the size and shape of their bodies. Safety seats are designed to spread the forces of a crash over more of the body for front-facing toddlers, and cradle the fragile neck and back of rear-facing infants.

Child safety seats are the most effective occupant-protection devices used in motor vehicles today. If used correctly, they are 71 percent effective in reducing the need for hospitalization. Unfortunately, parents often do not know the basic who, what, when, where, why, and how of child safety seats.

Who should use a child safety seat? Texas law requires all children aged two and under be restrained in a child safety seat. Children 2-4 years of age are required to be in a child safety seat or in a seat belt.

A parent may ask what kind of safety seat should be used. All children should be restrained in a safety seat that is appropriate for age and weight, and also meets federal safety standards. Infants up to 20 pounds should ride facing the rear of the vehicle in infant-only or convertible seats. Children weighing about 20-40 pounds should

ride facing forward in convertible safety seats. Children who have outgrown their convertible seat should ride in a belt-positioning booster seat until adult belts fit them properly. Older children wear vehicle safety belts and keep the lap belt low and snug across the hips. The belt must not ride up over the abdomen, and the shoulder belt must not cross the face or front on the neck.

When should a child safety seat be used? Use a safety seat every time on every trip. Do not make the deadly mistake of using a car seat only on freeways or for long trips.

Lawn & Garden checklist for March

· Vegetables

Be sure to wait until all danger of a late freeze has passed before you set out tender transplants such as tomatoes, peppers and eggplant. In central and south Texas, there is an old gardener's tale which says once the mesquite trees have leafed out, there will not be any more

As you are setting out your spring transplants, try adding a slow release fertilizer to the bottom of each planting hole prior to setting in the new plant. This simple addition will slowly feed your plants all season long without burning their roots. It is also a good idea to put some compost around each transplant after it is set, spreading the compost several inches deep over the surface of the soil. Then water deeply, thoroughly soaking the soil to settle the new plants in the ground.

·Flowers and Herbs Make sure you leave the foliage on all your flowering bulbs until it dies back on its own, rather than cutting it off as soon as the flowers have faded. Cutting this foliage back too soon can have an adverse effect on next year's flowering, since the bulbs use the food made by the leaves in the spring for the production of future flowers.

Make sure you keep any container grown roses well watered. While these woody plants may not initially show the affects of overly dry soil as quickly as other more herbaceous flowers, they can be just as easily damaged if they do not receive regular supplies of moisture. As long as the soil in your containers is well-drained, soaking your container grown roses twice a week usually will not be too much.

If you are looking for a showy flowering annual to add to your garden, try planting Tithonia. Also know as Mexican sunflower, this outstanding plant is available from most garden centers as transplants or it may be grown from seed. Growing 5 to 6 feet tall, this interesting annual provides lots of bright reddish-orange daisy-like flowers all season long. With their long stems, these flowers are excellent as cut flowers. In addition to their striking floral display, Tithonia are also outstanding for attracting butterflies to your garden.

·Trees, Shrubs and Vines

This is the time to do any pruning on your roses which you may have missed last month. Naturally, you do not want to remove more than one-third of each rose you prune, with most antique roses needing much less in the way of trimming. Many of these plants only need to be shaped up, following the natural lines of each plant.

It is also important to keep your roses well watered, soaking them thoroughly once a week. One way to keep the soil around your roses evenly moist and weedfree is to first get all the weeds and grass out of the soil around your roses, then spread weed-block garden fabric (available in many garden and home improvement centers) over the soil around your roses, anchoring it down securely. Finally, spread a several-inch-thick layer of bark mulch over the fabric to produce a finished look to your rose garden.

· Lawns and Garden Design

Do not forget to water your lawn every week to 10 days this month if it does not rain regularly in your area. This is also a good time to get your mower tuned up for spring. Make sure the blade is ready for efficient cutting by replacing it or having it sharpened. It is also a good idea to change the oil, spark plug and tune your mower up

If your looking for a unique ground cover for sunny areas which receive little foot traffic, try planting Albus or creeping thyme. Growing 5 to 8 inches tall, these thymes grow steadily and remain green throughout the year. Prostrate rosemary is also a good ground cover, especially in hilly areas. If you prefer a flowering ground cover, try purple-flowering lantana for sunny sites or periwinkle in the shade.

•Fruits and Nuts If you have not cut out all the stems on your plum trees which have a jelly-like substance seeping out of them, now is the time to do so. Usually a sign of bacterial stem canker, these oozing spots

need to be trimmed out before your plum trees begin growing this spring.

If you did not fertilize your young pear trees last month, now is the time to do so. Do not give them more than 1 pound of a complete fertilizer, however, because too much food can encourage your pear trees to put on excessive vegetative which can, in turn, be susceptible to fire blight. It is usually not a good idea to feed your pear trees with slow release fertilizers, as these can also lead to the excessive vegetative growth which should be avoided.

The Social Security Administration investigates over 200,000 wage reporting errors annually. The Internal Revenue Service (IRS) can assess penalties for the employer if discrepancies in wage reports are not corrected.

Correct reporting insures that employees have the proper wage amounts credited to their Social Security records. These amounts are used in calculating the Social Security benefits payable to them and/or their families if the worker dies, becomes disabled or retires, and in determining the worker's eligibility for Medicare coverage.

Frequent errors include a misplaced digit in the Social Security number, failure to reflect a name change in the newly married and incorrect or misspelled names, particularly in the case of Hispanic surnames.
