Spring turkey season slated

Spring turkey season in Coke County and most of Texas begins Saturday, April 4, and runs through May 10. County hunters may have more success this year with the wily gobbler, due to the large hatch we experienced last year. According to Texas Parks and Wildlife (TPWD) officials, last year's hen/poult survey recorded the highest number of offspring produced in the past four or five years.

According to TPWD officials, "the spring hunting season should get off to a quick start because gobblers are starting to talk already, and range conditions are good." Although we might disagree somewhat with this assessment concerning our local range conditions (we have been short of moisture since July of 1997), there is no doubt that larger than average numbers of turkeys have been seen throughout the county. And, for those who are out and about very early in the morning, the unmistakable sound of turkeys gobbling has been in evidence of late.

Hunters are reminded that in addition to possessing a valid Texas hunting license, turkey hunters are required to purchase a Special Turkey Hunting Stamp. The spring season allows hunters to take gobblers only, with an annual bag limit of four.

Spring turkeys may be taken by any legal firearm, which includes rifles, pistols, and shotguns. Pellet guns and air rifles are not legal. Hunters may also use 22 caliber rimfire ammunition on turkeys, which is not allowed for use in deer hunting.

For those who don't think spring turkey hunting with a firearm is enough of a challenge already, they can raise the bar, so to speak, by hunting spring turkeys with a bow. Compound and recurve bows, in addition to crossbows, are also legal, if very

Early runoff voting to begin

Early voting for both Democratic and Republican parties will begin on Monday, April 6, in the county clerk's office. Balloting will continue during business hours through Thursday, April 9, for the Tuesday, April 14 runoff election. Coke County and District Clerk Ettie Hubbard, who is also the election administrator, will have a branch early voting site open in Bronte City Hall Wednesday, April 8, from 9 am to 1 pm for both parties. Applications for voting by mail must be received in the clerk's office by April 7.

Only voting precincts 2, 4, 5, and 10 will cast ballots in the Democratic runoff election to decide precinct commissioners of #2 and #4. Either Wayne McCutchen or Sid McGinnis will be elected Coke County Commissioner of Precinct 2. Rick Styles and David Rawlings are vying for Commissioner of Precinct 4.

Polling sites for the Democratic runoff election are Bronte City Hall, Precinct 2; Tennyson, Precinct 4; Old Depot, Precinct 5; and Robert Lee Southside Church of Christ, Precinct 10. Polls will

remain open from 7 am until 7 pm.

Although there will be no Democratic runoff election in the west Coke County precincts 1, 3, and 9, one polling site will be open for Republicans who have some statewide races to be decided by runoffs. The Republican runoff election will be in the Coke County Courthouse, 7 am to 7 pm, on April 14.

Mrs. Hubbard also advised that a vacancy now exists for the constable position, Precinct 2, created by the resignation of Keith Fletcher. That position will be filled in the general election on November 3. Candidates will be nominated for a place on the ballot by political parties. Selection by the Democratic party will be on April 7. Contact Patti Ivey, Democratic chairman or Kathy Pentecost. Republican chairman, to be considered for the nomination. Those who wish to file as an independent candidate must file intent by May 14, with County Judge Jackie Walker. Judge Walker will also take filings for write-in candidates for the November 3 election.


Paul

Walter William Paul was born September 3, 1911, at Walling, in Hill County, Texas, to Frederick and Marguerete Paul, both German immigrants. He was the eighth of ten children.

Walter passed from this life at 4:20 pm, March 29, 1998, at the age of 86 years and 7 months. Walter was raised on the family farm a few miles south of Jourdanton in Atascosa County, Texas. He was affectionately known to his south Texas friends and relatives as "Black" or "Blackie" and to his co-workers with Sun Oil Company as

W.W. started working for Sun Oil Company in Freer, Texas, in 1937. There he met and married Louise Young on March 15, 1941. Walter was drafted into the U.S. Army in May, 1941, and served until September of 1945. served in the 1st Platoon, Company D, of the 23rd Armored Combat Engineers of the 3rd Armored Division. He saw action in Normandy, The Battle of the Bulge, and throughout Germany. He earned the European Campaign Medal with 5 Bronze Campaign Stars as well as the Purple Heart.

Legislature passes new act

The first nationwide network of state and regional programs for birth defects research and prevention was established March 26, 1998, by a bipartisan act of Congress.

CC Library News

One of the more interesting, and best of all, FREE publications that comes to the Coke County Library is a newspaper called Elderhostel. In it are hundreds of opportunities for seniors for travel throughout the United States. This quarter's newsletter lists a course in Galveston with travel on the Intercoastal Canal - a five day trip for \$389. Three of the days are on a ship, two days in a condominium. Other Texas opportunities listed are programs in the Big Bend, coastal bird watching, and Mo Ranch in the Hill Country (7 days for \$410).

One of the programs takes place at Fort Clark Springs near Brackettville where participants stay in rock barracks (modernized) with meals, a golf course, tennis, and nature trails. In addition, programs on the making of "Lonesome Dove" and "The Alamo", the basics of golf, and the role of Fort Clark in the settlement of the Southwest are offered.

Sul Ross offers seniors a stay at the University with programs on Indians, forts, settlement, the Chihuahuan Desert, all with meals. Five day's cost is \$350.

Elderhostel is a non-profit educational organization and the programs are for those 55 and older. The programs listed above are available in Texas. Each of the other states lists hundreds of programs and lodging.

The next issue of Elderhostel will include travel opportunities in Canada. There will be an international issue as well.



Steers host track meet

The Robert Lee Steers and Lady Steers recently hosted their high school track meet. Out of a field of 10 teams, the Lady Steers came in 3rd place overall with 103 points while the Steers competed in a field of 9 and won their meet by accumulating 221 points.

In the field events B. Bolding threw 30'1 1/4" in the shot put to place 6th, and 91'0" in the discus to place 3rd. Dixie Simpson won the long jump with a distance of 15'5" and placed second in the triple jump with a 31'3 1/4". Winning first and second honors in the high jump were B. Bolding, 5'3"; and D. Dickey, 4'8", respectively.

Competing and placing third in the 800 meter relay with a time of 2:22.62 were Woods, Lockstedt, Bohannon, and DeLosSantos.

G. Torres placed 5th in the 3200 meter run by posting a time of 15:31.59

400 meter relay team D. Simpson, D. VanHuss, T. Copeland, and D. Dickey were 3rd with a time of 56.73.

Winner of the 800 meter dash was Deshira Dickey with the time of 1:04.66. Dixie Simpson placed 4th in the 200 meter dash posting a time of 29.24.

Pole vaulter Tony Bell won 1st place by vaulting 12'0", Brothers place 3rd with 11'0", and Curtis Bell, 6th with 9'6"





Storing Winter Clothes

Spring means warmer weather is coming and it is time to clean and store your winter clothing. Clean all items before storing. Even tiny spots of soil or food make the fabric more susceptible to staining, mildew and insect infestations. Launder washable items and garments, but avoid using laundry additives such as fabric softener and starch. Fabric softeners tend to yellow with age and starch attracts insects.

Reduce dry cleaning costs by having "dry clean only" garments cleaned, but not pressed. Store wool garments in moth repellent (balls, flakes or crystals), but avoid putting moth repellent in baby or children's cotton clothing.

Tailored and professional clothing should be stored on padded hangers protected in a cloth garment bag. Avoid storing garments in plastic whenever possible. Plastic garment bags and dry cleaner bags trap moisture during the humid summer season and sometimes cause garments to become yellowed and discol-The print from dry cleaner bags has been known to degrade onto garments leaving an ink stain.

If you do not have closet space available for winter gar-

ments, then stuff the sleeves and shoulders with tissue paper. Store in a tissue lined box. Choose large flat boxes so that the garments may be folded fewer times and are not crushed by the weight of other garments. Store the heaviest garments on the bottom and lighter weight garments on top.

Good places to store out-ofseason garments include the "far end" of a bedroom closet, under the bed, and the top shelves of a clothes closet. Avoid hot attics, damp basements, and damp garages, because mold and mildew grow in humid conditions. Also avoid storing good clothes next to the outside wall because outside walls tend to draw dampness with outside temperature fluctua-

COUNTRY AGENTS NEWS

Lawn & Garden Tips for April

Gardens: Gardeners across the state, except for in the upper and lower Rio Grande Valley, can plant corn now. If you love that "baby" corn you see in stores and gourmet restaurants, why not grow your own? Simply plant regular corn seed closer together (5 to 6 inches apart is perfect), then harvest the tiny ears when the silks first start emerging from the husks. Early Sunglow or Kandy Korn varieties produce good crops of baby corn.

As you water your garden, be sure to soak only the soil, not your plants, as wet leaves are more prone to fungal infections. A soaker or drip irrigation system is not only ideal for this type of watering, but is also a good way to give your plants the moisture they need while you do something else.

Trees: Newly established woody plants need to be watered once a week so their roots will not dry out. Since most container-grown plants. are watered frequently in the nurseries from which they come, it can cause severe damage if they are not routinely watered once they are planted. Just running your sprinkler system will not provide enough water for these

plants. Instead, they need to be watered individually with a hand-held hose so the soil around them can be thoroughly soaked.

Beginning the middle of April, spray your young (less than 5 to 6 years of age) pecan trees with zinc. Zinc sulfate or zinc nitrate should be mixed according to label directions, then sprayed on these young trees twice a week from the middle of the month until the first of August. Be sure not to get this spray on any other plants, as it can damage or even kill other specimens.

Lawns: This is the first time this year to feed your St. Augustine, Bermuda or Zoysia lawn. Whatever type of fertilizer you use, be sure to follow label directions very carefully. More is not better when it comes to fertilizing because too much food applied at once can severely damage or even kill your lawn. Be sure to thoroughly water you lawn after feeding it.

If you are putting in a new lawn and the soil in your area is acidic, you might want to consider planting Zoysia or Bermuda. They are more tolerant of acidic soil than St. Augustine or buffalo grass.

April is the earliest you will want to sow Bermuda seed,

as it needs warm soil and warm weather to germinate quickly and easily. Make sure your seed bed is free of weeds and other grasses and that it is as level as you can get it. Once you have sown the seed, be sure to water the seedbed at least once a day until the germination occurs. Allowing the soil to dry out can lead to the death of your new lawn before it even gets established.

That was a significant event that certainly started him on the road to fitness and achievement.

His racing chair has two large wheels in the rear and a smaller wheel well in front. For training, Jeremy will "push" through his neighborhood about five times a week, often going ten miles or more. Sometimes, a member of his family will accompany him on a bicycle, but will be hard pressed to keep up with him. Generally, he pushes alone. He goes to a local school track to do his speed workouts just like any serious competitor, lifts four times a week and still completes his schoolwork. When competing in a triathlon, he swims, uses a specially modified bike with a hand crank and switches to the racing chair for the push segment.

Jeremy has competed in the Australian Jr. Nationals and hopes to compete again in the 1999 Australian Jr. Nationals. His long range dream is to compete in the Para-Olympics in Athens, Greece, in 2004. Look for him to be there.





Tax filing - fast approaching

April 15, is fast approaching and it's time to prepare your tax return. The question is should you do it yourself, or is it time to hire a tax professional to do it for you?

The question can best be answered by you. If your return is reasonably simple, then you may want to do the return yourself. if your return is complex, then you have to decide how much time you are qilling to devote to reading the filling out forms and weigh that against hiring someone with the experience and expertise on the tax issued you face. If you decide to hire a tax preparer there a few things to keep in mind before choosing one that is right for you.

A certified public accountant (CPA) is someone who is certified by the State examing board as having met the requirements set by Texas law. CPAs are generally professional accounts, but that does not mean they all specialize in tax. If the person you are going to hire is a CPA, ask for their area of specialization.

An enrolled agent is someone who has passed a twoday examination given by the Internal Revenue Service. Enrolled agents generally specialize in tax issues and are empowered to represent taxpayers before all administrative levels of the IRS.

Many tax professionals are neither a CPA or enrolled agent, but that does not mean they are any less qualified to prepare your tax return. Many tax return preparers are very skilled and specialize in tax return preparation year-round. Some are tax planners, some are tax attorneys. But whatever their qualifications, only you can decide if their skills and experience meet your needs.

As you would do anytime you attempt to hire a service provider, try to go to a preparer you know or one that has a good reputation in your community. Ask friends or family members if they have someone they have used in the past. If you choose someone who does tax work on a part-time basis during the filing season, make sure they will be available to assist you if there is a problem with your return in the future. Remember, you are the one who is responsible for what is on your tax return, so always review it after it is completed. Question any items that are different from what you gave the preparer, and never sign a blank tax return or one that is prepared in pencil.

Generally, tax return preparers charge a flat fee or an hourly rate. Fees vary from preparer to preparer. Call around to get prices. Avoid preparers who guarantee a re-

fund or whose fee is based on the size of the refund. You should also never have the refund check sent to the preparer's address. A paid preparer must sign their name as the preparer of the tax return in the space provided on the lower right hand corner of the back page of the return.

Be sure your preparer gives you a copy of the completed tax return including his or her name as preparer. Put it in a safe place in case you need it at some later date.

Many tax professionals now offer electronic filing to their clients. Tax professionals who are accepted into the electronic filing program transmit tax return information over telephone lines to IRS computers. Fees for this service vary depending on the tax professional you choose and the specific services you request. You can prepare your won return and pay a professional only to transmit it. Or you can pay to have your return both prepared and transmitted. Whichever you choose, shop around for a tax professional who offers the services you need at an acceptable cost to you.

If you do hire a tax preparer, keep in contact throughout the year, not just a tax time. Good tax planning is a yearround process, and an experienced tax prepared can offer valuable tips throughout the

Although some law enforcement associations may claim to be raising money on behalf of the Texas Department of Public Safety, they are not affiliated with the agency. The DPS does not benefit from funds the groups and their professional telemarketers raise.

"Over the years, we have gotten numerous questions and complaints from Texas citizens regarding telephone solicitations by enforcement associations," said Col. Dudley M. Thomas, director of DPS. "The DPS does not solicit financial contributions from private citizens. We receive our funding from the Texas

Legislature."

The 75th Texas Legislature enacted a law that requires these organizations to clarify that they are not part of the DPS and prohibits them from implying that the money they raise will go to the DPS. In addition, solicitors cannot use names, symbols or statements that are similar to those used by the Texas Department of Public Safety or the Texas Rangers to confuse or mislead someone who is being asked to give money.

5. True: Even though high sodium and salt intake plays a key role in maintaining high blood pressure in some people, there is no easy way to determine who will benefit from eating less sodium and salt.

Also a high intake may limit how well certain high blood

Also, a high intake may limit how well certain high blood pressure medications work. Eating a diet with less sodium may help some people reduce their risk of developing high

may help some people reduce their risk of developing high blood pressure.

6. True: Eating fewer calories and exercising more is the best way to lose weight and keep it off. Weight control is a question of balance. You get calories from the food you eat. You burn off calories by exercising.

Cutting down on calories, especially from fat, is key to losing weight. Combining this with a regular exercise program not only can help in losing weight but also in maintaining the weight loss.

7. False: To cut calories, some people regularly skip meals and have no snacks or caloric drinks in between. If you do this, your body thinks that it is starving even if your intake of calories is not reduced to a very low amount.

Your body will try to save energy by slowing its metabolism, that is decreasing the rate at which it burns



calories.
8. True: Contrary to popular belief, foods high in complex carbohydrates (like pasta, rice, potatoes, breads, cereals, grains, dried beans and peas) are lower in calories than foods high in fat.
In addition, they are good sources of vitamins, minerals, and fiber. What adds a lot of calories to these foods is the addition of butter, rich sauces, whole milk, cheese, or cream, which are high in fat.
