

Tomes accepted to academy


George Tomes III of Bronte has been accepted to the Texas Academy of Mathematics and Science for the 1998 fall semester. He is the son of George and Cynthia Tomes.

TAMS is a two-year residential program at the University of North Texas that allows talented students to complete their freshman and sophomore years of college while earning their high school diplomas. Students enroll in the academy following their sophomore year in high school, live in a UNT residence hall and attend UNT classes with college students.

TAMS celebrates its 10th anniversary this year. Today, TAMS has more than 1,100 alumni, many of whom now have finished their bachelor's degrees at UNT, Stanford, Yale and other top universities. These bright young minds are taking their places among the country's foremost researchers, engineers, teachers and physicians.

Tomes recently completed his sophomore year in the Bronte ISD. He should be ready for his junior year of college when he graduates from TAMS in 2000.

The academy admits up to 200 new students each year. Selection is based on Scholastic Aptitude Test scores, academic records from seventh through 10th grades, an academy mathematics diagnostic test, a student essay, demonstrated interest in science and mathematics, teacher recommendations, a personal interview, and parental support and commitment.





· Preventable traffic deaths continue

Though most Texans know that seat belts save lives and despite a state law requiring their use, most Texans killed in car crashes were not buck-

Only about 40% of the 3,215 drivers and vehicle occupants killed on Texas roads in 1996 were buckled up, according to the Texas Department of Safety. During the first 10 months of 1997, a total of 2,408 persons were killed and of those, about 44% were buckled up. Included among the deaths over this combined 22-month period are 127 deaths of children under age 5; only about 39% of these children were restrained.

During Buckle Up Texas/Buckle Up America Week in May, Texas Governor George Bush issued a proclamation in Texas promoting the use of seat belts and child restraints as the way to save many lives and prevent injuries. "I urge all Texans to buckle up and make sure their children are properly restrained in their cars, "Governor Bush said in the proclamation. "Together we can reduce injuries and save precious lives."

For seat belts and child restraints to be effective, they have to not only be used, but used properly. The latest observational studies conducted in Texas show that one out of four Texans still do not buckle up, and restraint use is even

Texas Transportation restraint-use study of 14 Texas cities showed that 74.9% of drivers and front-seat occupants were buckled up, and only 63% of children under age 5 were restrained. Incorrect usage of child restraints is very high; as many as 9 out of 10 child safety seats are not installed correctly and/or not being used correctly.

Seat belts are about 45% effective in preventing crash fatalities. Child restraints reduce the risk of death by 71% for infants and 54% for toddlers. Seat belts help prevent crash fatalities by:

· Preventing ejection from the vehicle

· Contacting the body at the strongest parts of its structure (hip and shoulder bones)

· Spreading crash forces over a wide area of the body Allowing the body to more

slowly ride down the crash Studies also show a strong connection between parent and child restraint use. The National Highway Traffic Administration Safety (NHTSA) released results from a multi-state study this year that showed restraint use for young children was over 80% when their parents were buckled up too. But when parents were not buckled up, the corresponding restraint use for their children ranged form 11 to 56%.

New national goals have been established that call for 85% nationwide restraint use by the year 2000 and 90% restraint use by 2005. Initiatives are under way to help emphasize the message that seat belts save lives and increase seat belt use in Texas, including:



Recent research by Texas A&M University on the tenderness of seven popular retail cuts showed that five of them improved through planned aging by the super-market. That means consumers who have had a problem with tough beef can ask supermarket meat managers to purchase only properly aged beef to ensure optimum tenderness.

"Aging refers to holding beef at refrigerated temperatures for an extended period of time," said Jeff Savell PhD, section leader of the meat science section at Texas A&M. "The process allows natural enzymatic reactions to take place that maximize the tenderness of beef. In other words, aging makes beef bet-

The A&M study showed that cuts with the name round in fam, ribeyes, T-bones and





Previous studies have shown that beef gets from the packer to the retail meat case in an average of 17 days. That means some beef already has proper aging. However, other beef gets to the retail case in as few as three days. That's far too early for the enzymatic reactions that induce tenderness to occur.

"A customer who has high expectations about tenderness," Savell said, "generally will need a cut that has been





Watering during drought conditions

For our area, water is probably the most limiting nutrient that is required for green lawns and gardens. With the drought conditions we have been experiencing lately, this is becoming more true than usual. To get your garden and lawn off to a good start this spring, there are several tips on efficient watering that need to be considered.

When watering your lawns, especially if you are using Robert Lee water, it is important to give it a deep soaking watering rather than short frequent watering with

New mohair carpet concept introduced

Floor coverings are big business and the mohair industry wants a share of this lucrative market.

Earlier this year, Mohair Council of Americal officials atteded the annual "Surface Show" in Las Vegas to learn more about the carpet and floor coverings industry.

"We did not fully understand the carpet market, and it was an eye-opener for us," said council executive director Zane Willard. He and council president Lanny Leinweber of Mountain Home visited with a sentatives in Las Vegas. As a result, the council contacted 45 firms making floor coverings of natural fibers to interest them in using mohair and received 10 responses.

"It takes a big investment to introduce a new carpet concept," Willard said.

The council has been working with technologist Gerald Morrison of Dalton, Georgia, who makes carpetmanufacturing equipment. His expertise, along with new interest Atelier Carpets Inc. of Atlanta, could put another type of mohair carpet into the marketplace by early 1999.

According to carpet industry officals, 10 markets in the United States sell 80% of the high-end carpet. These markets include Dallas-Houston-Austin, San Francisco, Los Angeles, Chicago, New York, Boston, Washington, D.C., Miami, Philadelphia and Atlanta.

The council is in the process of working out an arrangement with the Atlanta firm to participate in the introduction of loop mohair carpet to the market.

"This firm has unique marketing abilities," Willard said. "They have experienced excellent growth the last several years, and we believe they have an impact."

The reason for this is to leach the salt content into the soil formation and not have it collecting over time in the top of the soil profile whereby the salt accumulation could damage the grass or garden. The soil should be wet from 4-6 inches deep for effective moisture retention. Water only when the top 1-2 inches of soil becomes dry as over watering can be just as detrimental to lawns as not having enough water. This is due to water logging which can cause suffocation of the grass due to lack of oxygen in the soil.

To water your garden for a good start up, again give the soil a deep soaking by running water down the furrows instead of light frequent sprinklings which can leave the salt residue on the plants.

Fertilizer for your lawn can also be very important especially during dry conditions. The proper rate of fertilizer to apply can only be determined precisely after a soil test has been run on your lawn. Applying more fertilizer than needed will cause a need for additional water and will cause excessive mowing. There is a new lawn fertility test that is inexpensive and can be obtained in the County Extension office at the courthouse. Fertilizing lawns should be or early May. Hopefi have had some rain time, but if we are still un, recommended to split the

fertilizer applications into two separate times. About half of the fertilizer should be applied and watered in sufficiently and wait two weeks to a month and then apply the rest. A general rule of thumb for fertilizer is to apply 3-4 pounds of actual nitrogen for 1,000 square feet of lawn area.

Social Security **Board of Trustees** announce Social Security solvent until 2032

Due in large measure to a growing economy, reduced unemployment and low inflation, Social Security's longrange projections have improved over the past year, the Social Security Board of Trustees reported in their 1998 annual report.

Although sustained high economic growth over the past year pushed back the depletion of the Social Security trust funds assets to 2032 rather than 2029 as forecast in Initially, the firm will intro- last year's report, the Trustees

Rubin said.

'Today's report confirms that the Social Security longterm financing problem is one of manageable proportions," Kenneth S. Apfel, Commissioner of Social Security, said. "Although there is no immediate financial crisis, the time to act is now in order to prevent a crisis from ever occuring.'

President Clinton has called for this year to be a year of national dialogue and has asked all Americans to get involved. In December, the President will convene a bipartisan White House Conference on Soical Security and begin bipartisan negotiations with congressional leaders early

"The President believes that this year of public discussion is essential to shaping a Social Security program for the future that provides a foundation of protection for all Americans and inspires public confidence," Apfel said.

The Trustees reported that income from payroll taxes will become insufficient to meet all Social Security obligation in 2013, a year later than forecast in last year's report. At that time it will be necessary to

begin using interest income to the trust funds. Beginning in 2021, it will be necessary to redeem trust fund assets to pay benefits until 2032 when the trust fund reserves will be exhausted and income going into the trust funds will provide money to pay only threefourths of benefits. Over the 75 year long-range forecast, the Trustees predicted the shortfall to be 2.19% of taable payroll rather than 2.23% as estimated last year.


"The health of both the Social Security and Medicare trust funds is important for the millions of Americans who depend on benefits. The longer solvency period is due primarily to legislative changes.
