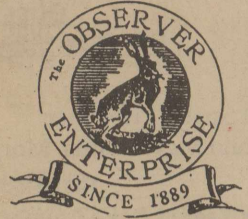

## Baptists honor Pastor Bivins

The Robert Lee Baptist Church has recently honored their pastor, Garry Bivins, for his accomplishments.

Pastor Bivins was called to pastor Robert Lee Baptist Church on April 6, 1997. In the next 18 months a God sized ministry has prevailed. At the end of 1997 there were 36 new members added to the church and nine baptisms.

So far in 1998, there have been 48 new members added and 24 baptisms, which is the most since 1956. Four senior citizens were baptized at the local swimming pool as they were not physically able to handle the steps to the baptism. One of these seniors was 87 years old.

The church had its highest attendance ever in February of this year, with 227 people.

Pastor Bivins married Marilyn Glenn in September of 1967, and was ordained in 1979 at First Baptist Church in Littlefield, Texas. He served as a bi-vocational pastor at Harriett for eight years, before coming to Robert Lee Baptist Church.

He is dedicated to the Lord and His work - to lead the lost

It is that taxing time of year again. Coke County property owners should look for tax statements to start showing up by the first of next week. The tax office encourages property owners to check the bills as soon as you receive them to make sure the records are correct. The sale or transfer of property during the year is not always reflected on the tax statement.

Verify that the property on the statement is everything you should be receiving a statement on. Failure to receive a bill does not excuse a property owner from paying the tax, or any penalty or interest for late payment. Prop-

erty tax bills are due upon receipt. Delinquent penalty and interest begins to accrue on February 1 if the tax is still unpaid by that date.

Taxpayers should make sure that any exemptions are applied to the correct property, and that special use valuations are applied to qualifying property (agricultural use, etc.). After verifying accuracy, to insure proper payment, statements should always be provided with payment. Taking a few minutes to check these items can save confusion and frustration, and help clear up any future problems with your property records.

**TSHL resolution disapproves Sunset proposal**

In their Seventh Legislative Session at the State Capitol recently, the Texas Silver-Haired Legislature voiced strong opposition to the Sunset Advisory Commission proposal to consolidate the functions of the Texas Department on Aging with the Texas Department of Human Services.

The Number One Priority Resolution recommended disapproval of the Sunset Plan. The Resolution was sponsored by Hazel Wright of Sherman.

Number Two Priority Resolution proposed the appointment of a Commissioner on Aging by the Governor of Texas. TSHL member Homer Lear of San Antonio submitted the Resolution, along with George Grimmer of Farmers Branch.

Other Resolutions receiving top priority included: Recommend lowering the authorized blood alcohol content for adults charged with drunk driving from 0.10 to 0.08. Raise the personal needs allowance of nursing home residents from \$30 to \$40 per month. Oppose the use of school voucher systems. Require a criminal background check on all persons applying for employment as a Home Health Provider. Prevent unauthorized phone billing. Oppose the deregulation of electric power. Provide protection from legal liabilities for citizen volunteers in Good Samaritan functions. Require

### Repositioning firefighters

Due to the recent increase in thunderstorm activity to the north and the continued high fire danger in the west Texas region, firefighters who were staged at Hamby Volunteer Fire Department have been repositioned at Decatur. Aircraft currently staged at the Abilene Regional Airport will remain in place. Resources at the airport include an air tanker, three helicopters and an air attack aircraft. Ronnie Hamm, Incident Commander for the Abilene Branch of the West Texas Zone, stated, "The present fire danger and drought conditions in the Abilene area have not changed. The continued cooperation and support of the public will be vital if fire prevention and suppression agencies are to keep fires at a minimum." Firefighters are not going home, and are still available for initial attack response to the Abilene area. If a concentration of fire activity develops in the Abilene area, firefighters will again be positioned in the Abilene or Hamby area. Firefighters at the Abilene Branch have responded to 90 wildfires that have burned 39,446 acres.

Since May 1st there have been 9,666 wildfires that have burned over 389,307 acres in Texas. The extreme wildfire danger alert will continue in western Texas until sufficient rainfall has been received to reduce the fire danger. A few days of rain won't have a profound effect on fuel moisture

caution to prevent wildfires, as each day brings us closer to the typically dry killing frost conditions of winter. Big fires start from a small spark.

**How you can help -** Please be extra careful with anything that can start a fire. Dispose of matches and smoking materials safely. Abide by the county burn bans that are in effect. Hunters are asked to check with local landowners and officials before building a campfire on private property. Avoid outdoor burning. Keep barbecue grills away from anything that can burn, stay near the grill, and keep children and pets away from it. Residents should clear leaves and other flammable material off roofs, and trim tree limbs so they don't hang over the roof. Reduce brush, weeds and other flammable vegetation at least 30 feet away from your home. Store firewood away from all structures. As the drought continues, water shortages will be experienced in many parts of Texas. Practice measures to conserve water, with the goal of reducing water use by 25 percent.

Bree Bolding, daughter of Bobby and Gayle Bolding, is a recipient of the Todd Moore Memorial Scholarship. She is attending McMurry University.

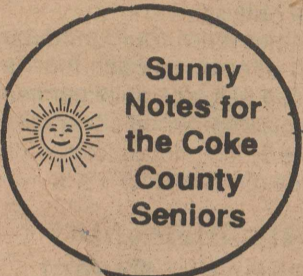

Five rules for ranch drought survival

The probability of a major drought occurring or the possible length of an already existing dry period are usually much discussed subjects by Texas ranchers. For the West/Central Texas rancher drought is a way of life. During the past seventy years the West Texas area has encountered drought conditions two out of every five years.

Rule number one is to constantly evaluate ranch forage supplies and strive to balance livestock numbers with forage availability. Reducing stocking rates during drought pays dividends in terms of less damage to desirable forage plants, more rapid range recovery following drought, reduced supplemental feeding costs and fewer losses of livestock to toxic plants.

When estimating future forage supplies care should be taken to not overestimate the probability of receiving rainfall. For example, a rancher near Brady, Texas has only a 50% chance of receiving 2.0 inch or greater rainfall in September. Near San Angelo this probability drops to 40%. Being aware of the above probabilities will help make stocking rate adjustments based on fact, not hope.

Rule number two is to manipulate the livestock mix to reduce drought risk. In general, breeding herds should constitute no more than 60% of the total carrying capacity of a ranch with the remainder of the stocking rate composed of held over yearlings or stocker type animals. When additional forage is available extra animals can be purchased to take advantage of the feed. If drought conditions occur and forage supplies are limiting, livestock numbers can be reduced by selling the stockers or yearlings first without destroying the integrity of the breeding herd. Accurate records of livestock performance should be maintained so that when it becomes necessary to reduce the breeding herd, the least desirable animals are culled first.

Rule number three is to supplement livestock to insure that proper nutritional requirements are being met. This is essential to prevent a reduction in reproductive rates and overall performance of livestock during drought. For example, phosphorous is

known to be deficient in most Texas range forage. This mineral should be provided year-long, free-choice to livestock as a 1:1 calcium:phosphorous mix. Phosphorous should be supplemented not only during drought years, but during the wet ones as well.

Vitamin A can also be expected to be limiting during drought conditions. This vitamin can be stored by livestock for a maximum of 90 days. When no green forage is available to livestock exceeding that length of time it should be supplemented.

Protein and energy can also be expected to be limiting during drought. To properly supplement these nutrients it is beneficial to utilize a forage testing program. The data obtained can then be used to establish what nutrients are limiting and in what quantity they should be supplemented. The result is an accurate supplemental feeding program that provides the required nutrients to each grazing animal while maintaining feeding costs at the lowest possible level. When supplemental feeding it should be remembered that pregnant females require a much higher nutritional level than animals simply maintaining themselves.

When the range becomes severely forage depleted, caution should be used that supplemental feeding does not evolve into maintenance feeding. If each grazing animal is not able to obtain his fill from the range forage, supplementing this fill will only serve to accelerate permanent range damage by providing livestock the energy to continue to graze any and all remaining forage. At this stage, the alternatives are to either sell animals, lease additional grazing land, move animals to alternative sources of feed, or use a complete or semi-drylot program to reduce grazing pressure on the remaining forage.

Rule number four is to be vigilant for potential poisonous plant problems during drought. The possible consumption of toxic plants during drought is increased due to reduced grazing selectivity by livestock. Such problems can be accelerated by livestock deficiencies of phosphorous or vitamin A which can greatly alter livestock grazing behavior.

Rule number five is to concentrate on other sources of income such as wildlife during drought. Harvesting wildlife

during drought can be good drought strategy in that it promotes a reduction in the incidence of starvation, and associated diseases, and will help maintain the remaining wildlife in a more desirable condition for recovery when drought breaks. All of the above is accomplished while also providing much needed cash flow for the ranch.

In summary, droughts are of common occurrence on rangelands, especially in West Texas. The rancher who plans for these droughts, maintains adequate forage reserves by properly balancing his livestock numbers to the forage supply and uses sound range management principles will not be forced into panic culling of livestock on a depressed market. He will also be able to significantly reduce the long-term adverse affects of drought on the rangeland forage.

The 20-second plan to food safety

What can you do in 20 seconds?

You can't run a mile. You can't mow a lawn. You can't even vacuum a room.

But you can sing "Happy Birthday" twice while you wash your hands, and when you're finished you're ready to handle food. And that could be the most important 20 seconds you spend in a day.

Unwashed hands are among the top 10 food safety mistakes made by consumers when preparing food. Washing hands before handling

food means clean hands, and, in turn, that means safe food.

September was National Food Safety Education Month, and Texas beef pro-

ducers joined Texas Gov. George Bush in the Texas Partnership for Food Safety. Together, they remind consumers that "keeping it clean" is the first step to food safety.

"By taking simple steps such as frequent hand washing, the rate of illness can be drastically reduced and lives can be saved," says Gov. Bush.

Here are all the keys to eliminating bacteria and their ability to cause illness from the Food Partnership for Food Safety Education:

- Wash hands in hot soapy water before preparing food and after using the bathroom, changing diapers and handling pets. For best results, consumers should use warm water to moisten hands and then apply soap. Rub hands together for 20 seconds - the time it takes to sing "Happy Birthday" twice - before rinsing thoroughly.

- Wash cutting boards, knives, utensils and counter tops in hot soapy water after preparing each food item and before going on to the next one.

- Use plastic or other non-porous cutting boards. Cutting boards should be run through the dishwasher or washed with hot soapy water after each use.

- Consider using paper towels to clean up kitchen surfaces. Or, if using cloth towels, consumers should wash them often in hot cycle of the washing machine.

Here are other ways to fight back against bacteria:

**Don't cross-contaminate.**

- Never place raw meat, poultry

- and seafood from other items in your grocery shopping and your refrigerator.

- Use a different cutting board for raw meat products.

- Never place cooked food

on a plate that previously held raw meat, poultry and seafood.

**Cook to proper temperatures.**

- Cook roasts and steaks to at least 145 degrees F or medium rare. Cook ground beef to at least 160 degrees F.

- Bring sauces, soups and gravy to a boil when reheating. Heat other leftovers to at least 165 degrees F.

**Refrigerate promptly.**

- Refrigerate or freeze perishables, prepared foods and leftovers within two hours or sooner.

- Never defrost food at room temperature. Thaw food in the refrigerator, under cold running water or in the microwave. Marinate foods in the refrigerator.

- Divide large amounts of leftovers into small, shallow containers for quick cooking in the refrigerator.

- Don't pack the refrigerator. Cool air must circulate to keep food safe.

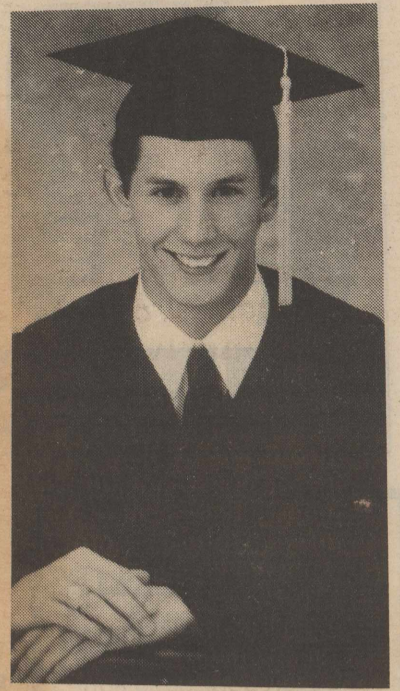

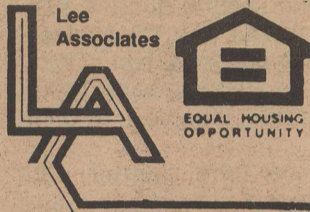

If a request is received, a separate notice, detailing the hearing, will be published at least 30 days in advance of the hearing. If a hearing is requested, anyone who submitted comments or a hearing request within the 30-day public notice period, will be notified of the scheduled hearing in writing, by the TNRCC. To verify whether a hearing will be held, if you did not submit comments or a hearing request, please call the Office of Public Assistance at (800) 687-4040 within 2-4 weeks of Sunday, November 1, 1998.

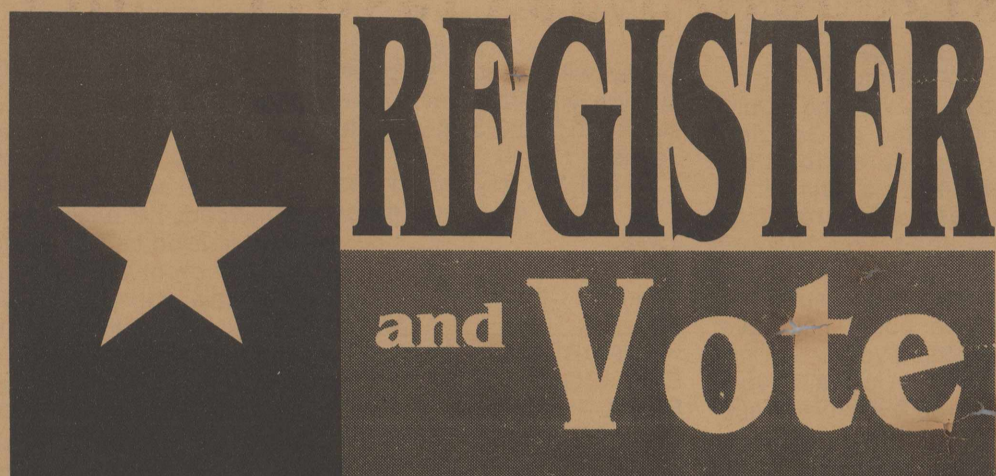
