Filing period ends for May 1st local elections

The filing period for the May 1st local elections ended March 17 for regular candidates and March 22 for write-in candidates.

In the City of Robert Lee election, the Mayor's office and three council seats will be up for the voters' decisions. Mayor Kelly Nichols has 1999. RL to get Alzheimer's Unit

The West Coke County Hospital District Board of Directors has approved the creation of an Alzheimer's Unit at the Robert Lee Care Center. This action was taken at the regular March Board meeting. Administrator, Roger Alexander, states that construction should start soon with a target of early summer for completion. Alexander also states that an application will be completed and forwarded to the Department of Human Services. When the application is approved, the Unit will be considered to be a Certified Alzheimer's Unit.

The regulations for a Certified Alzheimer's Unit are a little different than the regulations for a Nursing Facility. The main difference is the amount of training required for staff to work in a unit. Each staff member must have specific training in Alzheimer's Disease and in how to deal with a resident who has Alzheimer's. The challenges that a care giver faces when dealing with a person with Alzheimer's are very different than when a care giver deals with other residents.

Alzheimer's is one of several diseases called Dementia. It is possibly the most insidious one because it destroys brain cells and reduces short term memory. It can cause many behavioral changes in the afflicted person.

Citizens invited to Open Forum on community issues

by Tommy Antilley What are the issues and concerns that need to be addressed in Coke County to help the citizens and our total county in the years ahead? What can be done to assure a better quality of life and prosperity in the 21st century as we plan for the future?

Everyone interested in a better future for themselves, their family and their community is encouraged to participate in the Texas Community Futures Forum on March 29 at the Robert Lee Rec Hall beginning at 7 pm, said Tommy Antilley, county Extension agent. The Forum is being conducted in every county as a statewide effort of the Texas Agricultural Extension Service of the Texas A&M University System to bring together a diverse group of individuals, groups and organizations to identify issues and concerns. Once needs are identified, focus teams will be organized to develop specific plans of

"We want to get broadbased input into this process so that a plan can be developed for the future of each county and Texas as a whole," said Dr. Chester P. Fehlis of College Station, "by getting local, state and federal agencies and organizations to participate. Many of the needs and concerns of people can best be addressed through partnerships with other groups and organizations."

The Futures Forum process will help the Extension Service develop its long-range plan for the next four years -2000 to 2003, Fehlis said. However, he emphasized that the true goal is to facilitate the identification of common issues and define a process whereby these issues can be solved to create a better economic, environmental and social situation in communities across the state. He noted that participating agencies,

groups and organizations can better focus on issues and programs related to their missions and interests and the needs of the local people. "We view this as a partnership effort with all of us working together for the future of Texas," Fehlis said.

So, if you want to have a voice in the future of Coke County, be sure to attend the Futures Forum on March 29, said Antilley. This is your opportunity to help shape the future! We would ask that you contact the Coke County agricultural Extension office at 453-2461 by Friday, March 26 if you plan to attend.

Commissioners' Court Actions

The Coke County Commissioners Court met March 22nd. The meeting was called to order with the pledge to the flag and prayer led by County Attorney Lane Arthur.

The minutes were approved as presented.

Under open forum, County Attorney Lane Arthur discussed Senator Wentworth's bill regarding supplement to counties for the County Attorney's office. Mr. Arthur will report further on this at the next Court meeting.

Bronte Park Caretaker housing was discussed. A request was made to move a mobile home to the park. The Court tabled the item until further study could be made.

Fire Ban Resolution was presented to the Court, but after Judge Walker reported that Jim Allison, legal counsel for Texas Association of Counties said some legal problems were involved and he recommended counties not have the ban, but to encourage common sense, the Court did not pass the resolu-

The swimming pool rates were discussed at length and the following rates established for the 1999 season: Season Tickets: Individual, \$30; and Family Rate, \$120. Daily Rates: Children, \$1.50 and Adults \$3. Swimming parties (2 hours): \$40 plus the Lifeguard.

The Extension report was presented by Tommy Antilley and Jan Yanez.

Judge Moore presented prices on computers for his office and Judge Davis' office. Computers need replaced and new programs installed due to the Y2000. The Court approved the bid from US Tech for \$1628 for each of-

Blackwell Volunteer Fire Department requested help with their service. They stated that 35% of their fire runs were in Coke County and that 55% of the ambulance runs were in Coke County. In the past Coke County has not contributed any to the service. Due to the shortage of personnel in Bronte and the amount of service they give to Coke County, the Court felt the county should contribute. The county will pay the insurance until July 2000 and at that time they will address the situation again.

The Court approved Contractor Local Opportunity Plan, Policy Establishing Nondiscrimination Based on Handicap and Procedures for Enforcement of such Policy, and Proclamation of April as Fair Housing Month.

Line item transfer for Pct. 3 was approved. \$2000 from salaries will go to new equipment and \$3000 from salaries to equipment parts and repair.

Budget was amended to include the Library Grant. At

budget time this was an unknown project. This was a 100% grant for the purchase of computer and internet service for the Library.

Discussion followed on removal of front sidewalk and repair of the stand in the center of the sidewalk that was broken several years ago. Commissioners felt that they might be able to do part of the work and save money. They will do some research and report back later in order to put in next year's budget.

Resolution was passed to encourage the state to fund additional funds for Soil and Water Conservation Districts.

The Court discussed policy on reporting employee accidents. Policy was set to complete Accident Investigation Report within twenty-four hours after incident and to give to supervisor, who in turn will give to Treasurer's office to be put in personnel file. If incident becomes a worker's compensation claim, all of the records will be in place.

Discussion followed on methods to address the upcoming budget shortage.

The bills were approved to be paid.

The meeting adjourned.

Richards named board member for Texas Forts Trail

The Texas Historical Commission (THC) recently named Garland Richards to serve on the interim board for the agency's Texas Forts Trail pilot project, part of a regional heritage tourism program. Richards is owner of Fort Chadbourne.

The interim board will act as a decision-making entity in order to expedite the program strategies of the Texas Forts Trail pilot project. The group's first meeting took place Oct. 24 at the THC's official program launch held at Fort Con-

cho in San Angelo. At the launch, the Texas Travel Trails Program was introduced as a regional heritage tourism initiative and the Texas Forts Trail region was recognized as the first of 10 Texas territories to be developed and marketed as a tourism destination. This is expected to positively impact the local economy by stimulat-

Friday, March 26, 1999 Page 3 ing visitorship to cultural and historical attractions and advocating the benefits of historic preservation.

The board's first task will be to assist with the hiring of a regional coordinator for the Texas Forts Trail. The regional coordinator, with assistance from the THC, will be ultimately responsible for the successful development of the Texas Travel Trails Program in the Texas Forts Trail region.

"It is an honor to have been chosen to serve on the Texas Forts Trail pilot project interim board," said Richards. "The program will have a very positive economic and social impact on all the communities within the Texas Forts Trail region, and I am very glad to do my part to make it a success. Fort Chadbourne will be part of the region and with the Fort Chadbourne Foundation plans to enhance public access at Fort Chadbourne," Richards said, "I think our community will see a very positive economic impact."

The THC's new regional heritage tourism initiative, the Texas Travel Trails Program, utilizes 10 driving routes of scenic, cultural and historical interest based on the original travel trails system developed by the Texas Department of Transportation in 1968. A new brochure, produced by the THC, highlights the Texas Forts Trail region as a tourism destination and is available by calling the Abilene Chamber of Commerce at 800-727-7704 or the San Angelo Chamber of Commerce at 800-375-1206.

The Texas Historical Commission is the state agency for historic preservation. The agency administers a variety of programs to preserve the archeological, historical and cultural resources of Texas.



Honey by any other name

Honey comes in a wide range of varieties and forms. There are approximately 300 varieties of honey in the United States, which differ depending on the floral source the bees visit. Each floral source produces a uniquely flavored honey. Clover honey is the most widely available, but varieties like buckwheat, orange blossom and wildflower will give a subtle twist to recipes. In general, lighter colored honeys are milder in flavor, while darker colored honeys have a bolder taste.

Most honey in the United States is bought in liquid form. Creme or spun honey, which is finely crystallized honey, is also widely available. The crystallization is controlled during processing so that the honey will remain creamy and spreadable at room temperature. It's perfect for spreading on toast, muffins and much more. Comb honey is also available, usually at farmer market and health food stores.

Store honey at room temperature, never in the refrigerator. The counter top or pantry shelf is ideal. If honey turns cloudy or crystallizes, simply place the honey in a microwave container with the lid off and microwave it on high stirring every 30 seconds or until crystals dissolve. Be careful not to boil or scorch the honey.

Honey contains a wide complement of several essential vitamins and minerals,

including niacin, riboflavin, pantothenic acid, calcium, copper, iron, manganese, phosphorous, potassium, and zinc. While honey's vitamins and minerals are present in trace amounts only, the breadth of the array is important to many of today's health conscious consumers. One tablespoon of honey contains 60 calories, 17 grams of carbohydrates and no fat grams.

SA Genealogical and Historical Society to meet







For as little as 35-cents, the new Delivery Confirmation provides the date, time, and Zip Code delivery status of Priority Mail and Parcel Post. The service will be available nationwide on March 14.

"Delivery Confirmation is an outstanding value added service," said Postmaster Harrell Johnston. "The service is affordable, easy to use, and gives peace of mind to customers who need to know when their shipment arrived."

Delivering employees scan barcoded labels when delivery is made. Date and time data is stored in the scanner's memory to be later downloaded on postal host systems where it can be accessed by customers.

Customers receive information on the date and time of delivery and the Zip Code where delivery was made by calling 1-800-222-1811 or logging onto the Postal Service web site www.usps.com. Delivery information which includes attempted deliveries, forwarded or returned shipments is updated each evening.

Retail rates are 35-cents for Priority Mail and 60-cents for Parcel Post. Lower rates are available for customers who can send and receive Delivery Confirmation information electronically. For these customers, there is no additional charge for Priority Mail and a 25-cent charge for Parcel Select, Parcel Post, bound printed matter, special standard and library rates.

USDA releasing results of 18th CRP sign-up

by Congressman Charles Stenholm The U.S. Department of Agriculture (USDA) is now releasing the results of the 18th general sign-up of land into the Conservation Reserve Program (CRP), according to Congressman Charlie Stenholm. The sign-up was held from October 26 to December

11, 1998. Nationwide, the USDA received 90,000 offers totaling 7.1 million acres, and accepted 60,000 offers totaling nearly 5 million acres. Of this acreage, 57% had not previously been enrolled in the CRP.

"In Texas 655,121 acres were offered, with 554,800 accepted into CRP," said Stenholm. "This will bring total CRP acreage in Texas up to 3.9 million acres, as of October 1, 1999. The CRP acreage nationwide will total 31.2 million acres.

The cut-off on Environmental Benefits Index (EBI) scores were 245, as compared to 247 in the 16th sign-up.

"I have been assured that USDA will work with landowners who enrolled acreage last fall from the 16th sign-up, but have been unable to get a cover crop established because of continued dry conditions, to provide them with needed flexibility," said Stenholm.

Under the FEPP program, equipment acquired through the military is transferred to qualifying fire departments at no cost.

The passage of legislation minimizing liability to industrial companies that donate used firefighting equipment for volunteer fire department use has made additional equipment available, and more donations are likely. Companies interested in donating industrial fire equipment should contact the TFS Rural Fire Defense Section at 409-639-8130 for information on the Industrial Helping Hands program. The value of equipment received to date now exceeds \$4 million.

Volunteer fire departments may save money in another way. A self-insurance vehicle liability insurance pool also administered by the Texas Forest Service offers liability coverage for \$250 per vehicle, ambulances excluded.

Volunteer fire departments can also purchase firefighter clothing, hand tools and water handling accessories at discount prices through the Fire Safe program. Fire Safe sales to date exceed \$4.5 million, according to the state forestry



Wildflower hotline available

Motorists searching for the best wildflower locations along Texas highways now have help at their fingertips.

"The Texas Department of Transportation (TxDOT) began operating a wildflower hotline Feb. 25," according to Patsy Maddux, the San Angelo District's Public Information Officer. The toll-free hotline, 800-452-9292, will provide callers with automated information on the best locations for wildflowers along the 77,000-mile Texas highway system.

. The hotline information comes from TxDOT's maintenance employees around the state and includes wildflower information from cities, chambers of commerce and parks officials.

While finding the best wildflowers is as easy a picking up the phone, it is too early to predict the overall quality of this year's wildflowers, according to one wildflower expert.

"Wildflower plants are developing roots now," said Herb Neimann, TxDOT's director of landscape design. "We really need some rain soon across much of the state, or the flowers we get will be smaller than usual. We still have time, but the sooner the better."

Nature gets a helping hand each year from TxDOT maintenance employees, according to Neimann.
