Homestead exemption applications due April 30

Homeowners can reduce their property tax bills by taking advantage of homestead exemptions. Application forms are available at the Coke County Appraisal District office. Chief Appraiser Patsy Dunn informs homeowners that Texas law allows them to file a one-time application that reduces the taxable value of the home. A fee is not required to file for a homestead exemption. Property owners who have never received the general homestead exemption on their homes in which they were living on January 1, 1999, those who turn 65, and those who became disabled during 1998, must apply this year to receive exemptions for 1999. The deadline for filing applications is April 30.

The school tax exemption for those 65 or older provides a special property tax "ceiling"

for school taxes. Tax rates may change, but the tax will not be higher than the first year of qualification unless improvements are made to the homestead. Senior citizens may now transfer their tax ceilings to a new home.

If the homestead is located in a taxing unit that overlaps into two or more counties, the homeowner need only apply at one county appraisal district. That district will inform any other appraisal districts about the application.

Texas law provides several types of exemptions for homeowners. For school tax purposes, there is a \$15,000 general homestead exemption for all homeowners and an additional \$10,000 exemption for those 65 or older or disabled. Coke County, Robert Lee ISD, and Bronte ISD each offer a local-option exemption based on a percentage of a home's appraised value. Twenty percent of the value of each qualified homestead is exempted. The dollar amount of this exemption for any home must equal at least \$5,000. Coke County also gives a \$3,000 general homestead exemption on the portion of the county tax levied for farmto-market roads or flood control. East Coke County Hospital District grants an optional exemption on the home-




The four best scores of each round are used to determine team scores. In addition to the team honors, Dee Van Huss was awarded second medalist honors for her fine performance.






