### 16 year old drowns at Oak Creek Lake

The body of 16 year old
Jose Sanchez, Jr., of Bronte,
was pulled from Oak Creek
Lake about 7:00 pm on
Wednesday, August 4, 1999.
A Blackwell student and athlete, Sanchez had just finished football practice around
lunch on Wednesday, and
went to the lake to cool off.

He and three friends were swimming and diving off rocks near Rocky Point at Oak Creek Reservoir just south of Blackwell. At approximately 1:15 pm, his friends reported that he dove into the water, surfaced once, and then sank. His friends searched a short time in the murky water and called 9-1-1.

Sanchez' body had drifted from where he was last seen, and recovery was not made

### Area men to travel to Honduras on rebuilding mission

Several area men, including First Baptist Church - Bronte minister Morris Johnson, will be traveling to Honduras the week of August 14-21, 1999. Others making the trip include former RL residents Bobby Boone and Roy Epperson, both from Ballinger. They will be accompanied by Ballinger residents Joe Don Murman and Tony King; Tony Gruben of Paint Rock; Ken Barr of Rochelle; Larry Wester and Robert Cuellar, both of San Angelo; and Red Mullins of Brady.

The purpose of the trip, according to Epperson, Director of Missions for the Brady-Coleman; Runnels Baptist area, is to help rebuild homes destroyed by Hurricane Mitch.

Mitch hit Honduras in late October and early November 1998 with a fury. An estimated 6,500 were left dead, with up to 11,000 missing. Displaced and homeless people numbered as high as 1.5 million. Twenty percent of

the population of the country was left homeless as a result of the force of this hurricane.

Initially, a group of Texas Baptist men went into Honduras with a disaster relief unit to help with food and medicine. Epperson and a team of Baptist workers traveled to Honduras in late June to work a week on the project. Their goal is to rebuild 100 homes in 1999 and 2000.

# Commissioners publish minutes of court meetings

The Coke County Commissioners' Court met in a called session on July 6, with the four commissioners and county judge in attendance, along with Jo Nell Blair, deputy clerk.

Chief Appraiser Patsy Dunn addresses the court regarding concerns the court had in regard to mileage and the Appraisal District's proposed budget. She presented corrected copies of the budget and explained she had made an error in preparing the previous copy. Mrs. Dunn also gave the court copies of mileage records for each employee of the district.

A request was received from citizens on Lake Dam Road to reduce the speed limit from 35 miles per hour to 25 miles per hour. Motion passed to reduce speed limit.

Employee health insurance rates were discussed. County Treasurer Phelan Wrinkle and Judge Walker attended an insurance conference and explained some of the problems with the current system. Alternatives to the current carrier were discussed. Coke County has a high rate of claims, and the claim experience for the county has not been good. Motion passed to stay with the current carrier

WTRCA for the time being.

A lengthy budget workshop as held. Several topics were discussed, including the pros and cons of the Sheriff's Office applying for a grant from the Justice Department that would help pay the salary of a new deputy. After much discussion, the motion to approve the application for the grant was passed.

Judge Walker adjourned the meeting.

The Commissioners met in regular session on July 12, 1999. All commissioners and county judge were in attendance, along with County/District Clerk Mary Grim.

Minutes of the June 28 and July 6 meeting were approved.

In open forum, there were twenty-eight citizens present to discuss a county tax increase. The concensus of those present was that if taxes were to be raised, the court should consider cutting courthouse employees.

Judge Walker stated that West Texas Utilities will have a public hearing in August to discuss the utility line coming across the county.

Commissioner Rawlings asked that a thank you note be sent to Nolan County for their help on the Lake Dam Road.

### A Tribute to Sadye Chumley, Our Mother

Sadye Chumley, 104 years of age, passed away August 5, 1999, in the Robert Lee Care Center. Her passing leaves much sadness but many wonderful memories. She was born June 12, 1895, in the Divide Community to John Q. and Sally McCabe. Her actions at an early age indicated that she was destined to be a special person. At the age of five years she learned to read from the Bible as her Mother read to her, and was able to tease her sisters by reading their love letters and telling on them at the dinner table! Sadye finished the last grade of school offered at that time, the 9th grade, and attended Howard Payne College in Brownwood. She returned to Coke County where she took a test and received her Teacher's Certificate. The first year she taught in Stiles, Texas, and the next year the Wildcat Rural School in Coke County. Her parents often offered room and board to the the school teachers, and there she met Fern Chumley, who taught at the Chapman School on the Divide. Fern married Frank McCabe, Sadye's brother, and as a result of this association, Sadye met Mark Chumley, Fern's brother, and he and Sadye were married on August 12, 1916, in San Angelo, Tom Green County, Texas. She and Mark had three children: two daughters - Louise and Jo Marie, and one son - Derwood. Derwood died in 1922, and Mark passed away March 14, 1984, in Big Spring, Texas.

Our Mother's loving nature assured us that even though the world about us was in turmoil, our world with her was strong and stable. Her first love and Guide was the Lord Jesus, whom she served all of her life. For many years she taught a Sunday School Class both in Bronte and in Robert Lee. Always active in the Baptist Church, she loved WMU and mission work. We never heard our Mother ever condemn any person, always excusing any kind of behavior and treating everyone with loving kindness. Her ability to laugh at herself and see humor in any situation was one of the things about her that always amazed her family and friends.

She was a wonderful cook

and spent many hours preparing food for others and taking dishes to the church for those who were bereaved or celebrating happy events. She and Mark were always among the first to visit and take food when anyone became ill and passed away. Her specialty was homemade veast bread and fried fruit pies. Hundreds of loaves of bread were baked in Sadye's kitchen and taken to someone ill or in need. When her family came home for a visit, the first thing they looked for was a loaf of Sadye's bread and fried pies.

A wonderful seamstress, she made clothing for all her family as long as they were at home, and for her granddaughters as long as her hands were able to hold a needle and thread. She was always making blankets, pillows, and clothing for new babies. At the age of 95 years, she made a Cathedral Window quilt which was exhibited in the San Angelo Quilt Show in 1996.

Sadye's memory was so remarkable. She never forgot anyone she ever met - and especially the children and grandchildren of her friends and acquaintances. Even as late as this past year, many of us were asking her about Coke County history and families - and she always remembered them. The children from school would come to her and ask about their grandparents and great grandparents, and she was able to tell them about their families. Often times she would remember when and where they were married, and where they lived at many times in their life. Sadye and Mark always helped hold both local, state, and national elections in their precinct for many years. Her grasp of current events, both national and international, as well as political history, was remarkable, and she read her newspaper daily until she became ill last month.

When Sadye entered the nursing home on June 1, 1992, she had a tremendous adjustment to make. She was so independent it was very difficult to accept any assistance from others. I've been told that she was always pleasant to the nurses and staff, and thanked them each time they did anything for her. Her thought was always for others before herself, and

she loved her caretakers so much!





### Selective Service honors 100,000th Internet registrant

The Selective Service System (SSS) registered its 100,000th man via the Internet recently. At a ceremony this evening in San Antonio, Texas, 18 year old Derek Alan Gordon of Brooklyn, New York, was honored as the 100,000th man to register online since December 1998, when SSS began the pro-

"This is proof that Internet registration is a huge success, and growing," said Selective Service Director Gil Coronado. "In just over six months, 100,000 young men have registered using computers."

Derek Gordon, simply logged onto the Selective Service website http://www.sss.gov, keyed in some basic information, and instantly received his Selective Service registration number. Men can also register at any local post office by completing a simple card, or they may fill out and return a card they get in the mail. By law, men are required to register within 30 days of reaching age 18. Approximately 4,000 Internet registrations are received each week. Between 30,000 and 40,000 registrations cards arrive at the Selective Service Data Management Center in Illinois every week.

Derek Gordon was honored during Selective Service System's biennial training conference held this week in San "The emphasis is on being ready in case of a national emergency," Coronado stated. "After all, being ready is our mission." As part of the conference, Selective Service personnel--both employees and volunteers from across the country-gathered to discuss the latest procedures and share information on tasks they would have to perform in the event a draft were reinstituted.

Millions of young men have registered since registration was reinstated in 1980, but none have been drafted. The last draft ended

### Sept. 1 is deadline for THC sponsored preservation grants

The deadline for 2000 Texas Preservation Trust Fund (TPTF) grants is September 1, 1999. Last year, the Texas Historical Commission (THC) awarded approximately \$340,000 to assist organizations around the state in preserving significant historic landmarks. In 2000, the THC plans to award \$375,000. Applications are available from the THC.

The Texas Legislature created the TPTF, the only statewide grant program, to preserve endangered historic buildings and significant archeological sites. Earned interest and designated gifts from the pool of public and private monies are distributed as matching grants. The program provides up to one-third of the total project costs for acquiring, planning, and developing historic properties. ### Most banks prepared for Year 2000

Federal bank, thrift, and credit union regulators announced recently that 99% of federally insured financial institutions have completed testing of critical systems for Year 2000 readiness. In their announcement, the Board of Governors of the Federal Reserve System, the Federal Deposit Insurance Corporation, the National Credit Union Administration, the Office of the Comptroller of the Currency, and the Office of Thrift Supervision noted that most financial institutions are already using Year 2000 ready systems on a daily basis without problems.

Over the past two years, federally insured financial institutions have been identifying and overhauling systems that were not Year 2000 ready. At the same time, the regulatory agencies have been closely monitoring their efforts. As of June 30, 1999, the regulators had assigned a "Satisfactory" rating, the highest possible rating, to 99% of the federally insured financial institutions. This means the financial institutions are appropriately preparing for the Year 2000. The agencies are confident that, based on their reviews, financial institution customers

will be able to conduct business as usual both before and after January 1, 2000.

During each Year 2000 review, regulators look at the overall progress that an institution is making in its Year 2000 efforts, as well as its compliance with federally mandated requirements. Examiners check to see that financial institutions are performing any ongoing system renovation and testing that may be needed, establishing comprehensive contingency plans, mitigating any identified Year 2000 related business risk, and effectively informing their customers of their Year 2000 preparations.

The federal bank, thrift, and credit union regulators are closely supervising the few institutions that are lagging in the Year 2000 preparations. Regulators will increase and intensify their supervision of these institutions during the remaining five months to ensure that needed corrections are made by December 31, 1999.

### Letter to the Editor

During the past several months our county government has been undergoing some changes. This time of year is always a tough one with decisions regarding the budget being on the forefront of the minds of county officials. This year has been particularly rough. With the decline in oil prices and the sale and closing of one of the plants in the county, a steep decline in revenue made it necessary for some cuts in the budget to be made or an increase in taxes to be levied.

Citizens in the county have elected officials, the commissioners and the county judge, to make sure that tax dollars are being spent wisely. Most taxpayers assume that elected officials are doing the job they were sent to office to do in a wise and prudent manner. This year, this does not seem to be the case.

Cuts have been made with disregard to the effect they will have on the offices of the courthouse. Decisions regarding spending have been made recklessly and with little fore thought to the consequences. During the early part of the year, a rapidly sinking health insurance company was bailed out to the tune of \$35,000. This was done against the advice of the county auditor. At the same time cuts in the job force were being made, a decision to build new playground equipment in the Robert Lee park was approved. Also going against the advice of many, the commissioners' court elected to operated under a deficit budget. Most folks realize that once you dig a hole, it is very difficult to climb out. By operating under a deficit budget for one year, the county will be in financial

trouble for years to come. The state has a safeguard against the type of situation the county now finds itself in -the effective tax rate. The effective tax rate allows county governments to operate within the same perameters each year. With prudent spending decisions and careful financial planning, county governments can function in an efficient and effective manner year after year, without a huge tax increase.

While no one wants to pay higher taxes, very few of us want to see people lose their jobs and business sent to other counties. This is your county and your county dollars -- make it your business to see where your tax dollars are being spent. There is still time

to make your feelings known before the budget is adopted. Call your commissioner and county judge. A hearing to adopt the tax rate and new budget will be held in the commissioners' courtroom of the county courthouse September 20th. Plan to be there to make your feelings

7) Emphasize that you are concerned not with the car, but with the preciousness of your teenager's life.
