### Run-off elections set Tuesday

#### **Democratic Run-off**

County Democrats, along with others throughout the state, will be voting in a run-off election on Tuesday, April 11. The Democratic run-off election will focus on their candidate for the U.S. Senate, either Charles Gandy or Gene Kelly.

There will be two polling locations, according to Democratic county chair Patti Ivey. West Coke County (Precincts 1, 3, 9, & 10) will vote in the old Rec Hall in Robert Lee, and East Coke County (Precincts 2, 4, & 5) will vote at the Bronte City Hall. Polls will remain open from 7:00 am until 7:00 pm.

Voters are also reminded of another option, early voting, for both primaries. Early voting ends today, April 7, at the courthouse; so time is critical if you would like to early

vote.



## Robert Lee girls golf results



#### New yard care guide helps homeowners cut pollution and waste, and conserve water

Just in time for summer, the Texas Agricultural Extension Office is offering free copies of a new yard care guide that shows citizens how to cut pollution and waste, and conserve water. The new guide illustrates how to maintain a healthy yard and environment with a minimum of cost, work and waste

The guide, produced by the Texas Natural Resource Conservation Commission, follows a four-step plan-grass-cycling, mulching, composting (including worm composting), and green landscape design and yard care - called YardWise. To obtain a free copy of A Green Guide to Yard Care, contact the Coke County Extension Office at 453-2461, County Courthouse.

The guide is packed with how - to information, but it also explains the scientific principles behind these practices and the economic and environmental importance of using them.

The first three steps of YardWise - grasscycling, mulching and composting - are the basic tools for building up and protecting a healthy, fertile soil. Building on this foundation, the final step of "green yard care" is arranging and watering plants and managing pests so that the yard needs little or no chemical fertilization or pest control and releases little if any sediment or chemicals to pollute the environment.

At 25 pages, including a glossary, table of contents, diagrams and references to sources of more information, this guide is comprehensive and yet easy to use.

#### Ringworm, Just a fungal infection

Tinea is the name of a group of related fungal skin infections. Tinea pedis is the medical name for "athlete's foot"; tinea cruris is "jock itch"; tinea capitis is "ringworm" of the scalp; and tinea corporis is "ringworm" of the body and nails. These descriptive terms refer to the location of the infection and not which specific type of fungus is involved.

The classic features of tinea are itching, redness on the skin and a circular patchy lesion that spreads along its borders, at the same time clearing at the center. In time, it may appear as a ring or a series of rings around a clear center, hence the name "ringworm."

Ringworm is not a "worm" infection as the name suggests, but is a fungal infection caused by mold-like fungi. They live on the dead tissues on the skin and anything that grows from the skin, such as hair or nails. The source of the fungus is usually the soil, an animal (usually a cat, dog or rodent) or another person. Minor trauma to the skin, such as scratches, and poor skin

But if the disease is extensive, or the infection is deep-seated, anti fungal medication may be necessary.


