The Silver area didn't get slighted this time, as they reported up to 2.5 inches. Areas near Lake Spence and westward received from less than an inch up to about 1.5 inches.

Wherever you live in Coke County, it was wonderful. Residents on the east side of the county were seeing stock tanks go dry they had never seen dry before. Now most of those tanks are running around and brim level full.

Due to the drought, many area livestock producers have had to sell their stock. The benefits to these livestock producers are enormous.

Another major source of income in Coke County, our wildlife, just got a new start last weekend, as deer, turkey, and quail numbers at least have a chance for normal populations for next season.

The only bad news we can report with this storm system is that it didn't raise the lake level at Oak Creek but about a foot. Spence had received its lifesaving runoff a couple of months ago, but Oak Creek is still waiting.

4-H Leadership Lab/Camp to be held






The annual Fort Chadbourne Day is sponsored by the Bronte Chamber of Commerce and will be held Saturday, June 24, in Bronte, Texas.

Issuance of this Texas Pollutant Discharge **Elimination System (TPDES)** permit will replace the existing **TPDES Permit No. 00997** issued on July 23, 1999. adjacent to Oak Creek Reservoir, approximately ten miles north of the city of Bronte, Coke County, Texas. The effluent is discharged to Oak Creek Reservoir, thence to Oak Creek; thence to the Colorado River below E.V. Spence Reservoir in Segment No. 1426 of the Colorado River Basin. The unclassified receiving waters have high aquatic life use for Oak Creek Reservoir. The designated uses for Segment No. 1426 are high aquatic life use, contact recreation and public water supply. No significant degradation of high quality receiving waters is anticipated.






