These donations help the library add to the collection available to all patrons. The donated books also help create revenue for the library when they are sold.

### **RLISD Hires New** Superintendent

The new superintendent of schools for the Robert Lee Independent School District is Weldon Koepf. Mr. Koepf replaces Bill Hood, who retired this past year.

A native of Central Texas, Weldon grew up and was educated in the Bruceville-Eddy community. He borrowed money to attend Baylor University and worked part-time as a welder and a church music director to help pay expenses. He received a B.A. degree from Baylor in 1970, and began working as a junior high social studies teacher. Over the next several years, Mr. Koepf attended evening and summer classes to earn his Master's degree and the Texas Mid-Management (Principal's) Certificate.

In 1978, he was appointed to his first administrative position as Connally Junior High assistant principal in Waco, Texas. After five years he was appointed to his first principalship at Lakeview Elementary School in the Connally ISD. When that school was closed four years later as a result of elementary school reorganization, Mr. Koepf assumed the assistant principalship of Connally Junior High for two years and was then made principal of the same school in 1989. Throughout the 70's and 80's, he served as a parttime music director in several Baptist churches in the Waco

Weldon returned to school in 1992 to complete requirements for the Texas Superintendent Certificate at Tarleton University Stephenville, Texas. That same year he was appointed Special Administrative Assistant in Connally ISD. In 1993, he accepted the superintendency of Benjamin ISD in Knox County. After serving four years at Benjamin, in 1997 he became superintendent of Bryson ISD in Jack

The problem with the siren has been found. After the meeting, members relocated the siren switch to the new building.


The members discussed the fire in Bronte at El Ranchero. Ten firemen, truck 3 and the tanker answered the call for assistance.





**Big Country Wheat** Conference Picks August Date

The Big Country Wheat Conference is set for August 24 in the Abilene Civic Center in Abilene. Registration starts at 7:30 a.m. This year's program is designed to help wheat producers make management decisions for their 2000-2001 wheat crop. The conference is a joint effort of the Taylor County Wheat Task Force, and the Texas Agricultural Extension Service offices in Callahan, Shackelford, Jones, Fisher, Nolan, and Taylor counties. Four hours of CEU's will be given for the

The first part of the program features outlook information. Dr. Ernie Davis, Extension livestock economist at College Station, will start the program with his views on the stocker cattle market and what price trends to expect. Next, Dr. Mark Waller, Extension economist-grain marketing and policy at College Station, will speak on wheat supply and demand and price trends. George Bomar, TNRCC chief meteorologist of Austin, will discuss moisture expectations and weather patterns for the 2000-2001 crop. Dr. Ken Stokes, Extension economist-management at Stephenville, will round out the first session with a look at crop insurance options and updates.

After a mid-morning break, Vernon residents, Dr. David Worrall with Agripro, and Dr. Don Robinson, resident director of research with the Texas Agricultural Experiment Station, will discuss public versus private seed supplies. The next presentation will feature Dr. Bill Pinchak, Vernon experiment station range animal nutritionist, presenting cool season grazing and alterna-The morning's final segment is to be manned by Dr. Travis Miller, Extension agronomist at College Station. Miller will discuss seeding rates and wheat water use.

Following a catered lunch, Dr. Billy Warrick, Extension agronomist at San Angelo, will speak on wheat information available on the world wide web. Next, Dr. Todd Baughman, Vernon Extension agronomist, will discuss clear field systems of weed management in wheat. He is followed up by Dr. Roy Parker, Extension entomologist at Vernon, who will present information dealing with on-farm grain storage and control of insects in stored grain.

The final session will be devoted to a panel manned by producers who use no-till wheat cultural practices. Miller will lead the panel discussion. The day's program will conclude with industry updates and new developments.

In addition to the conference itself, there will also be industry-sponsored booths showcasing the latest tech-

nologies in wheat production. Registration is \$5.00 per person, if received by August

21. After that date, the cost will be \$15 per person. The registration includes lunch, breaks, and proceedings. Continuing education units from the Texas Department of Agriculture will be available. For registration information contact the Taylor County Extension Office at (915) 672-





Getting to School Safely

As summer gradually comes to an end, thoughts turn to getting children back to school. In an effort to increase the safety of all students traveling to and from school and school related activities, the National Highway Traffic Safety Administration (NHTSA) in conjunction with many partners is developing the "Getting to School Safely' program. The program will provide everyone involved in student travel, including parents, care givers, school administrators, teachers, police officers, crossing guards, and the many other community organizations concerned about student safety, the resources they need to improve the safety of students traveling to school.

Students are at much greater risk traveling to and from school than at any other time in their school day. During the 1997-98 school year about 800 children age five through 18 were killed while traveling to or from school. These students were traveling by passenger car, foot, bicycle and school bus.

There are many safety rules parents and care givers can teach their children about the different ways of getting to school safer.

Bicycle Safety

Make sure a bicycle is the proper size and is safely and properly maintained.

Buy a bike that is the right size, not one a child will "grow into." Oversize bikes are especially dangerous.

Always wear a bicycle hel-

A bicycle helmet should fit comfortably and securely. It should be worn level on the head (not tilted back on the crown or pulled low over the The helmet forehead). should not be able to be moved more than an inch in any direction.

Stand at least 5 giant steps (10 feet) away from the edge of the road.

Wait until the bus stops, the door opens, and the driver says it's okay before stepping onto the bus. When exiting the bus be careful that clothing with drawstrings and book bags with straps do not get caught in the handrail or door.

If it is necessary to cross the street in front of the bus, walk on the sidewalk or along the side of the road to a point at least five giant steps (10 feet) ahead of the bus before you cross. The bus driver and the student should be able to see each other. When you cross the street, stop at the edge of the bus and look LEFT-RIGHT-LEFT before crossing.

Never walk behind the

school bus.

If something is dropped beside or under the bus, tell the bus driver.
