Coke County Championship set for tonight in Robert Lee

by Hal Spain Talk about starting the season off with a bang! The Robert Lee Steers host the Bronte Longhorns at 8:00 pm tonight in the season opener for both teams.

This game has come to be known as the Coke County Championship, and in most cases has been played as a district contest later in the season with a lot on the line

Dove Season Opening

Dove season will open in Coke County (a part of the Central Zone of the TPW map) on Friday, Sept. 1 and will continue through Oct. 17. The second short season has been set for Dec. 26 through Jan. 19.

If you buy your license this week, you may want to be safe and buy the \$7 white-winged dove stamp since a good number of those birds have been sighted in our area. You would need that stamp anyway if you are fortunate enough to hunt in South Texas.

Hunting hours for the migratory birds are one-half hour before sunrise to sunset. Just to touch on a few points of law, bag limit is 15 birds; shotgun must be plugged to 3 shells; no hunting over baited areas, including deer feeders; and hunters cannot stir up doves with motor-driven vehicles. Complete regs are stated in the TPW Outdoor Annual, pages 69, 70, 71 and 72. These are free where license and sporting supplies are sold.

A district realignment by the UIL at the start of the 1998 season placed the two county teams in separate districts. That, however, has not decreased the intensity level of the players or the fans in this annual contest.

We talked with both head coaches of the two clubs this week, and got some insight into the 2000 season, and what each coach sees as the keys to a successful season for each club. Their responses seem to show several similarities between the two teams as they prepare for the upcoming season.

Bronte head coach Rocky Rawls indicated that pre-season workouts have gone well for the Horns. He praised the group as being "a hard-working bunch of kids" and indicated that they are trying some new things in their offensive and defensive sets, and "it's going to take a little while to come around." Concerning injuries, Coach Rawls said they had started out on a bad note, but "we are trying to make allowances for that (the injuries) with a total team effort."

Robert Lee head coach Ray Brown said that concerning pre-season, he felt the Steers were right on course following the Rising Star scrimmage, and "not as good as I would have liked" following the Cross Plains scrimmage. Concerning injuries, he stated that the Steers have had some little nagging injuries

with several illnesses being the major cause for concern right now.

Concerning the major strengths and weaknesses of the two clubs, Coach Rawls stated that one of the major strengths of the Horns is their past playoff experience and some strength in the skill positions. He viewed the Horns' major weakness as their depth.

Coach Brown cited a good number in skill positions back this season as one of the strengths of this year's Steer club, as well as some of the

He also thought that the positive attitude of his players was one of their most important keys to success for the upcoming season.

Keep Water handy.


Have someone with you to spot any fire that sparks ignite, so the fire can be caught while small.

Bronte Lady Longhorns


On Friday, August 25, the Bronte Lady Longhorns opened the San Angelo Central Tournament against Veribest. Bronte won 15-0,

Annual Sheep and Goat Field Day Set

By Tommy Antilley, County Extension Agent Make plans now to attend the Annual Sheep and Goat Field Day set for September 7 at the Texas A&M University Research and Extension Center. The Center is located north of San Angelo on U.S. Highway 7. Registration runs from 9:00-9:30 a.m.

The event focuses on current information of interest to the West Texas ranching community. This year's slate features subjects ranging from DNA sire fingerprinting to the Edwards Plateau Prescribed Burning Cooperative.

A five-stop tour from 9:30 a.m. to noon heads up the morning's activities. The stops include a look at DNA fingerprinting for sire determination by Dr. Dan Waldron and Andy Laughlin. Waldron is the Center's research geneticist and Laughlin is the state Extension sheep and goat assistant headquartered in San Angelo. Dr. Ed Huston, Dr. Chris Lupton and Wade Polk are scheduled to discuss the feasibility of producing extremely high quality lamb and wool at their stop. All three men are headquartered at the Center. Huston is the research range nutritionist, Lupton is head of the wool and mohair research effort, and Polk is the Extension risk management specialist.

The final two tour stops are "Livestock Supplementation with Cottonseed" manned by San Angelo-based feedlot nutritionist Dr. Millard Calhoun and "Edwards Plateau Prescribed Burning Cooperative" with Dr. Charles "Butch" Taylor, superintendent of the Sonora Research Station.

A catered "dutch treat" lunch is scheduled from noon to 1:30 p.m. at the Center. The afternoon opens in the Center auditorium with a formal presentation of Progressive Farmer Magazine's "Men of the Year in Texas Agriculture" to Drs. Allan McGinty,



Draft Regional Water Plan Complete

The draft water plan for the Region F Regional Water Planning Area has been completed and hearings will be held on September 5th in San Angelo and September 6th in Odessa to receive public comment, according to John Grant, Region F. Chairman.

The meetings will be conducted Tuesday, September 5, at 6:00 p.m. at the Texas A&M Research and Extension Center, 7887 U.S. Highway 87 North in San Angelo; and the next day, Wednesday, September 6, at 6:00 p.m. at the UTPB Center for Energy and Economic Diversification, 1400 North FM 1788 in Odessa. The hearings are one of the final steps in the development of a water plan for the future of the 32-county region.

"In June, 1997, Governor George Bush signed Senate Bill 1 into law, mandating that the Texas Water Development Board take the lead in development of a comprehensive state water plan," Grant said. The TWDB divided the state into 16 regional planning areas, and selected individuals in each representing different interest groups to actually prepare the plan for their region."

Grant said that the "bottom up" method recognizes that the people in each region, representing groups like municipalities, agriculture, small businesses, water districts, river authorities, utilities, industry and environmental groups are best equipped to understand the issues in their geographic area.

"Given the state's vulnerability to drought, and the fact that Texas' population is expected to almost double by the year 2050, water development, conservation and drought planning are essential to the state," Grant said. He noted that the plan is to be updated every five years.

Region F is composed of the counties of Andrews, Borden, Brown, Coke, Coleman, Concho, Crane, Crockett, Ector, Glasscock, Howard, Irion, Kimble, Loving, Martin, Mason, McCulloch, Menard, Midland, Mitchell, Pecos, Reagan, Reeves, Runnels, Schleicher, Scurry, Sterling, Sutton, Tom Green, Upton, Ward and Winkler.

"The Region F group has been meeting, working and conducting studies and public meetings since March of 1998 to compile a comprehensive overview of water supplies and plans for the wise use of those resources," Grant said. The group's tasks included

identifying and quantifying both available and potential water resources, projecting future water demand, identifying threats to natural resources and planning for development of water supplies and drought contingencies.

The chairman said that the two major Region F problems identified in the draft plan were the shortage of water available for irrigated agriculture in some of the counties, and regulations the Environmental Protection Agency may adopt pertaining to radio nuclei in public waters supplies that could eliminate the Hickory Aquifer as a regional water source.

"Radio nuclei is present in water from the aquifer, located primarily in McCulloch County", Grant said. "If the EPA rules are stringent, several communities in the area may be forced to discontinue municipal use of the water."

Grant said it is vital that the plan be as complete and correct as possible, since its recommendations will be a key component in both regional and state-wide water planning. The Texas Legislature will refer to the plan's recommendations when considering water issues and financial assistance, and the TWDB will use it in determining availability of low-interest loans to finance water supply projects.

The draft plan may be viewed in the county clerks' offices and public libraries in each of the counties, as well as on the internet at www.freese.com/senbill1/regi onf/index.htm. Grant said that oral and written comments from the hearings will be given consideration as the Region F plan is finalized.





Beef Cattle Browsing Supplement, Feed, or Sell?

As August ends, depending on location and management, some producers are about completely out of pasture while others still have considerable standing grass, though it's probably low quality. The last group can supplement, with some highprotein product to better utilize that forage. But since you can't supplement nothing, the first group must feed, or sell cattle. For this group, supplement alone simply won't work, especially products designed for low consumption, so you've got to buy hay or lease pasture, either of which may also require supplementation. For forage conditions between these two extremes. a medium protein-high energy supplement (such as breeder cubes or the equivalent) may be called for, but it'll take more pounds than with high protein supplements. Now, if you're out of pasture, will it pay to hold on and buy hay or lease grass? If you know when it'll rain and what cattle prices will do, you can answer that question.

Strategic Deworming What is the best strategy for deworming cows? How about diagnosing fecal egg counts to see if deworming is needed? Parasitologists at the Texas A&M Vet School say that's a waste of time. So when should you worm? Traditionally, the idea was to deworm in the spring right after grass came on, and maybe again in the fall. But the A&M parasitologists say that's often not the best strategy. It's been hot and very dry, so

there are no worms around to worry about, right? That may be true for the pasture, but not for the cow. Cows may have an infestation right now of brown stomach worms (Ostertagia, our most common harmful internal parasite) in an arrested or dormant stage of development. Such parasites will become active and harmful this fall. A summer treatment, with products effective against the arrested stage, should minimize future worm damage in animals and reduce pasture contamination. This provides the best opportunity to disrupt the life cycle of the parasites.

And Genes Are Bad For You, Right?

The "preferred" route requested will pass through Sterling, Coke, Tom Green, Concho, McCulloch, and Coleman Counties. DESCRIPTION OF LINE ROUTES

WTU is filling both a "preferred" route and "alternate" routes with the Commission. A description of these line routes follows:

PREFERRED ROUTE DESCRIPTION

Coke/ Mitchell County Line to Twin Buttes Switching Station - Segment A (Route 3) Segment A of the preferred transmission line route begins at the point where the Sterling/Coke county line intersects the southern boundary of Mitchell County, approximately 1.8 miles west of the Colorado River. The route proceeds south parallel to the Sterling/Coke county line, in Sterling County, for approximately 8.7 miles. From here the route turns southeast for approximately 1.2 miles, crossing into Coke County. The route then heads south-southeast, crosses State Highway (SH) 158 approximately 2 miles east of Mendenhall Lane, and proceeds for approximately 10.7 miles to a 90° bend in Walnut Road, northwest of the Divide Cemetery. From this point the route turns south for approximately 10.7 miles, during which it parallels at different distances the west side of Farm-to-Market Road (FM) 2034, to a point where it crosses U.S. Highway (U.S.) 87, approximately 1.5 miles northwest of its intersection with FM 2034, in Tom Green County. The route then heads southeast for approximately 1.7 miles and crosses FM 2034 just south of the Concho River. Turning further to the southeast, the route runs for approximately 1.0 mile, passes south of McLaughlin Mountain, and intersects an existing WTU transmission line. The route proceeds southeast, parallel to the existing transmission line, for approximately 17.7 miles (with a short segment leaving the existing transmission line to run along the south side of Turner Road for 2.1 miles), terminating at the proposed Twin Buttes Switching Station site. The switching station is located on Arden Road (FM 853), approximately 0.9 mile west of FM 2288.

Twin Buttes Switching Station to Red Creek Switching Station – Segment B (Route 8)
Segment B of the preferred transmission line route will utilize the same structures as Segment A for the first 5.6 miles northwest out of the proposed Twin Buttes Switching Station in Tom Green County. From this point, the proposed route heads northeast for approximately 3.1 miles to the North Concho River. From here, and for the next 2.8 miles, the route parallels a Colorado River Municipal Water District (CRMWD) water pipeline northeast and east to a point on the south side of U.S. 87 near its intersection with Grape Creek Road. The route then crosses U.S. 87, turns east for approximately 1.7 miles, and rejoins the CRMWD pipeline on the north side of U.S. 87. The route proceeds eastward approximately 3.4 miles before it crosses SH 208 near its intersection with Red Creek Road. The route continues along the pipeline south of Red Creek Rd. for approximately 4.0 miles before crossing U.S. 277, and continues eastward approximately 2.5 miles to a point west of the community of Harriet on the north side of U.S. 67. At this point the route makes a 90° turn to the south, crosses U.S. 67 and runs for approximately 1.0 mile to the existing Red Creek Switching Station, located on City Farm Rd., 1.3 miles south of Harriet.

Red Creek Switching Station to Coleman/ Brown County Line - Segment C (Route 12) Segment C of the preferred transmission line route exits the Red Creek Switching Station to the northeast for approximately 0.4 miles, parallel to an existing WTU transmission line. After crossing City Farm Rd., the route heads east for approximately 1.6 miles, turns northeast and runs approximately 1.0 mile, where it once again intersects the CRMWD water pipeline. From here the route parallels the pipeline east for approximately 10.1 miles, at which point the route leaves Tom Green County and enters Concho County. Along this segment of the pipeline in Tom Green County, the route crosses Douglas Loop twice (first, approximately 1.4 miles south of its intersection with U.S. 67 and then again approximately 1.0 mile east of the initial crossing); Mullins Crossing Road approximately 0.4 miles south of its intersection with Smith Road; FM 1692 approximately 1.0 mile south of its intersection with FM 1929; and Dairy Road approximately 1.4 miles south of its intersection with FM 1929. After entering Concho County, the route then heads southeast and east-southeast, paralleling a petroleum pipeline for approximately 11.8 miles. Along this section the route crosses FM 381 approximately 2.4 miles south of its intersection with FM 1929; and crosses FM 380 approximately 6.4 miles west of its intersection with U.S. 83 in Paint Rock. The route then turns back to the east and continues for approximately 16.9 miles, to a point along East Fork of Mustang Creek, south of O.H. Ivie Reservoir. Along this section the route crosses U.S. 83 about 4.2 miles south of Paint Rock and crosses FM 2134 about 2.8 miles north of Millersview. The route then turns slightly east/northeast before crossing Mustang Creek and runs for approximately 3.8 miles before crossing FM 503 after entering McCulloch County. This crossing is approximately 1.6 miles south of the community of Stacy. The route continues east-northeast for approximately 24.0 miles, crossing the Colorado River into Coleman County; crossing U.S. 283 just north of the community of Rockwood, crossing FM 2633 approximately 2.2 miles north of the community of Whon, and finally terminating at a point on the Coleman/Brown County line approximately 4.7 miles north of the Colorado River.

ALTERNATE ROUTE DESCRIPTIONS

Mitchell/Sterling County Line to Twin Buttes Switching Station-First Alternate Segment A (Route 1)

The first alternate for Segment A of the alternate transmission line route begins at a point on the Militchell/Sterling County Line, approximately 7.3 miles east of State Highway (SH) 163. From this starting point, the route runs due south for approximately 0.8 miles until it intersects a large water pipeline (aqueduct) right-of-way (ROW). The route turns southeast, running parallel to the pipeline for approximately 4.7 miles, until it reaches the Sterling/Coke county line. Here the route turns south again, paralleling the county line, in Sterling County, for approximately 5.7 miles. At this point, the route turns southeast for approximately 1.2 miles, crossing into Coke County. The route then heads south-southeast for approximately 3.1 miles, crosses SH 158 approximately 2 miles east of Mendenhall Lane, and proceeds for an additional 5.5 miles to a point along Walnut Creek near Shelving Rock Bluff. The route continues down the valley of Walnut Creek for approximately 1.9 miles to a point where it turns due south. Approximately 0.9 miles south of that point the route intersects Walnut Road and continues south parallel, and on the east side of the road, for approximately 4.7 miles. Where Walnut Road turns to the southwest, the route continues

south on the same heading for approximately 1.1 miles, where it crosses U.S. Highway (U.S.) & 7 approximately 0.6 miles southeast of its intersection with Walnut Road. The route continues south for approximately 2.6 miles, entering Tom Green County, crossing the North Concho River, and continuing to a point along an existing WTU transmission line. At this point the route turns southeast, paralleling the south side of the existing line, for approximately 2.4 miles, where it crosses Farm-to-Market Road (FM) 2034. The route continues southeast, passes south of McLaughlin Mountain, and continues to run parallel to the existing transmission line for approximately 18.6 miles (with a short detour away from the existing transmission line to run along the south side of Turner Road for 2.1 miles), terminating at the proposed Twin Buttes Switching Station site. The switching station site is located on Arden Road (FM 853), approximately 0.9 miles west of FM 2288, west of San Angelo.

Twin Buttes Switching Station to Red Creek Switching Station - Segment B (Route 7) Segment B of the alternate transmission line route will utilize the same structures as Segment A (Route 3, 1 or 4) for the first 5.6 miles northwest out of the proposed Twin Buttes Switching Station, in Tom Green County. From this point, the proposed route heads due north for approximately 3.2 miles continuing to utilize the same structures as Segment A (Route 4) if this alternate route is used, otherwise 3.2 miles of new structures are utilized, to a location approximately 0.5_ miles south of the North Concho River. At this point the route turns east and then north for approximately 1.3 miles, crossing the North Concho River. The route turns back to the east for approximately 1.0 mile, where it intersects an existing WTU transmission line approximately 300 yards southeast of the intersection of North Shore Drive and U.S. 87. The route then turns southeast, parallels the existing transmission line for approximately 1.0 mile to a point near the intersection of FM 2288 and North Shore Drive. From this point the route turns east-northeast and parallels a Colorado River Municipal Water District (CRMWD) water pipeline for approximately 2.0 miles to a point on the south side of U.S. 87 at its intersection with Grape Creek Road. The route then crosses U.S. 87, turns east for approximately 1.7 miles, and rejoins the CRMWD pipeline on the north side of U.S. 87, just north of it's intersection with Grape Creek Road. The route continues east, parallel to the south side of the CRMWD pipeline, for approximately 3.4 miles before it crosses SH 208 near its intersection with Red Creek Road, and then continues east along the pipeline south of-Red Creek Road for approximately 4.0 miles before crossing U.S. 277. From this point the route continues east approximately 2.5 miles to a point southwest of the community of Harriet, on the north side of U.S. 67. Here the route makes a 90 turn to the south, crosses U.S. 67 and runs for approximately 1.0 mile to the existing Red Creek Switching Station, located on City Farm Road, 1.3 miles south of Harriet.

Red Creek Switching Station to Coleman/Brown County Line - Segment C (Route 11) Segment C of the alternate transmission line route exits the Red Creek Switching Station to the northeast for approximately 0.4 miles, parallel to an existing WTU transmission line. After crossing City Farm Rd., the route heads east for approximately 1.6 miles, then turns northeast and runs approximately 1.0 mile, where it once again intersects the CRMWD water pipeline. From here the route parallels the pipeline east for approximately 10.1 miles, at which point the route leaves Tom Green County and enters Concho County. Along this segment of the pipeline in Tom Green County, the route crosses Douglas Loop twice (first, approximately 1.4 miles south of its intersection with U.S. 67 and then again approximately 1.0 mile east of the initial crossing); Mullin's Crossing Road approximately 0.4 miles south of its intersection with Smith Road; FM 1692 approximately 1.0 mile south of its intersection with FM 1929; and Dairy Road approximately 1.4 miles south of its intersection with FM 1929. After entering Concho County, the route continues east for approximately 1.1 miles, crossing FM 381 approximately 1.4 miles south of its intersection with FM 1929, and parallels the water pipeline for another 3.5 miles. At this point the route turns east-northeast, leaving the pipeline ROW, and extends for an additional 5.7 miles, where it crosses FM 1929, approximately 1.3 miles west of its intersection with U.S. 83. The route continues on this heading for approximately 1.3 miles, where it crosses U.S. 83 approximately 0.5 miles north of its intersection with FM 1929. Continuing on this course to the east-northeast the route covers another 2.0 miles, to a point just south of the Concho/Runnels County line. Here the route turns more to the northeast and, crossing into Runnels County, runs for approximately 4.7 miles to a point on the south side of County Road (CR) 129, just east of its intersection with CR 115. At this point the route turns back to the east for approximately 1.5 miles, paralleling the south side of CR 129, and crosses the Colorado River alongside the CR 129 bridge. After crossing the river, the route turns back to the north-northeast, crosses CR 129 approximately 0.7 miles from the bridge, and runs for approximately 2.9 miles, until it intersects a petroleum pipeline. Here the route turns east-northeast and parallels the pipeline ROW for approximately 5.8 miles before crossing into Coleman County, 5.4 miles south of Talpa. The route continues for approximately 7.6 miles, paralleling the pipeline ROW, until it intersects another pipeline about 1.0 mile southwest of Bead Mountain. At this point the route turns east-southeast and parallels the new pipeline ROW for approximately 2.9 miles, and crosses FM 503 about 1.8 miles south of Valera. The route continues along the pipeline ROW for approximately 4.0 miles, and crosses FM 1026 about 3.0 miles south of its intersection with U.S. 67. Continuing east, the route traverses another 3.1 miles, then crosses FM 2131 about 2.5 miles south of U.S. 67. From here, the route continues east-southeast, still parallel to the pipeline, for approximately 5.7 miles, where it crosses U.S. 283, about 3.1 miles south of its intersection with U.S. 67 in Santa Anna. The route then runs approximately 4.0 miles east along the pipeline ROW, crossing FM 1176 about 0.8 miles south of its intersection with FM 567. Finally the route runs east-southeast for an additional 3.7 miles and terminates on the Coleman/Brown county line, about 3.2 miles south of U.S. 67.

Coke/Mitchell County Line to Twin Buttes Switching Station - Second Alternate Segment

A (Route 4)

The second alternate for Segment A of the alternate transmission line route begins at a point where the Sterling/Coke county line intersects the southern boundary of Mitchell County, approximately 1.8 miles west of the Colorado River. The route proceeds south parallel to the Sterling/Coke county line, in Sterling County, for approximately 2.9 miles, where it intersects a water pipeline (aqueduct). At this point the route turns southeast, parallel to the pipeline, and enters Coke County. The route proceeds for approximately 4.8 miles, where it crosses Farm-to-Market Road (FM) 2742, about 0.7 miles from its intersection with FM 2059. In another 0.9 miles, the route crosses FM 2059, then continues to roughly parallel the road, first to the northeast, then south, then east, and then west for the next 8.6 miles, to the intersection of FM 2059 and State Highway (SH) 158. From here, the route crosses SH 158, intersects a petroleum pipeline ROW and proceeds southeast for approximately 2.7 miles. At this point, the route turns south and traverses approximately 2.8 miles to the top of a mesa, approximately 1.6 miles west of FM 2034. Here the route turns southwest and runs for approximately 2.3 miles, where it crosses FM 2034, 1.3 miles east of its intersection with Walnut Road, near the community of Divide. From this point, the route turns southeast and traverses approximately 7.3 miles to a point along the West Fork of Grape Creek, on the east side of March Road. The route then turns due south, crosses March Road, and extends for an additional 1.4 miles, where it enters Tom Green County. The route continues south for approximately 2.9 miles to a point about 0.6 miles northwest of the 90 bend in Walnut Grove Road, where the route turns southwest. The route heads southwest for only 0.7 miles before turning back to the south. The route runs south for approximately 3.2 miles, parallel to, but about 0.3-0.4 miles west of, Glass Road. At this point the route turns back to the southeast for approximately 0.7 miles, crosses Glass Road and parallels the east side of the road for approximately 0.5 miles, where it crosses U.S. Highway (U.S.) 87 approximately 2.2 miles southwest of the community of Carlsbad. Continuing south, the route runs for approximately 1.1 miles, where it crosses the North Concho River. From here the route continues south for approximate-ly 3.8 miles, where it intersects an existing WTU transmission line. At this point the route turns southeast and parallels the existing line for approximately 5.6 miles, terminating at the proposed Twin Buttes Switching Station site. The switching station site is located on Arden Road (FM 853), approximately 0.9 miles west of FM 2288, west of San Angelo.
