## Haskell Co. schools receive accountability

The initial accountability ratings are out, and once again Haskell County schools have proven they are among the best.

Haskell CISD, Rule ISD and Paint Creek ISD all earned a rating of Recognized. This is just another, in the consistently high ratings Haskell County schools have received throughout the years.

Compared to the 2009 TAKS results using the 2010 indicator definition, the 2010 statewide performance on the TAKS improved for all students and all student groups in each subject area

According to the Texas Education Agency's website, of the 1,237 Texas school districts, 239 are rated Exemplary, 597 are rated Recognized, 346 achieved the Academically Acceptable rating and 45 were rated Academically Unacceptable. These statistics include charter schools.

by meeting the absolute and eight grade dropout rate

Texas Projection Measure or TPM. The TPM, which was instituted for the 2009 ratings, has met with some controversy. However, Commissioner of Education, Robert Scott said, "Many schools and districts earned one of the top ratings by year."

The new standards require 80 percent of all students and each student group to pass the TAKS, compared to 75 percent in previous years. Also the district must achieve an 85 percent completion Districts earn their rating rate and an annual seventh

## Crime Stoppers helps citizens 'do the right thing'

Are you a responsible and effective member of your community? The majority of citizens would answer yes, or at least that they try to do what is right.

Fear, however, can sometimes keep people from "doing the right thing." Crime Stoppers provides a way for those with information concerning crimes to assist law enforcement agencies in the fight against crime, without fear of retribution.

In 1976, in Albuquerque, New Mexico, a young college student was shot to death during a robbery while working at a gas station. It appeared to law enforcement that the crime would go unsolved, since no witnesses came forward. According to the Crime Stoppers web site, Detective Greg MacAleese knew something really innovative would be necessary to encourage the public to get involved and help solve the murder.

He staged a re-enactment of the homicide and broadcast it on television, guaranteed anonymity for anyone who was willing to call him with information and put up a reward from his own pocket to encourage tips. Tips did come in and within seventytwo hours two men had been arrested for the murder and a string of other robberies.

MacAleese convinced the Albuquerque Police

of citizens to establish the first Crime Stoppers program. The idea caught on and Crime Stoppers programs were begun all over the nation. As of July 2010, Crime Stoppers worldwide statistics include 838,556 arrests made, 1,288,921 cases cleared and \$94,685,708 rewards paid out.

The Clear Fork Crime Stoppers, which received their state certification in Nov. 2007, serves Fisher, Jones, Haskell, Kent, Stonewall and Shackelford counties. Working from an office in the Haskell County Courthouse, Clear Fork Crime Stoppers has paid out over \$8000 in rewards for tips that have led to numerous arrests across these six counties. Over \$40,000 in stolen goods has also been recovered.

The CFCS is overseen by a coordinator and a volunteer board of directors representing each county. It has developed by-laws and operating procedures, has signed cooperative memorandums with area law enforcement, activated a toll free 24 hour tip line and received official certification and training from Texas Crime Stoppers.

The Crime Stoppers approach to solving the crime problem is three-fold. They rely on cooperation between the police, the media and the general community to

Department to allow a group provide information about crime and criminals. The key to its success is very likely the anonymity guaranteed to anyone providing tips, either through a phone call or on the web site. By offering cash rewards for information leading to an arrest, even the more reluctant callers are encouraged to provide information. Calls are accepted regarding any publicized request for information, such as "Crime of the Week."

While it is true, not everyone has important knowledge or information concerning a crime, we all can still be a part of the Clear Fork Crime Stoppers effort. Crime Stoppers is funded by private donations and fundraising. Since no tax dollars are involved, it is essential to the success of the program that citizens, businesses or other organizations answer the call for help with

### Attorney general files appeal to keep Texas' clean air program in place

AUSTIN — Texas challenging the U.S. Environmental Protection Agency's decision on July 15 to disapprove the state's flexible permits program.

Attorney General Greg Abbott on July 26 filed the state's petition for reconsideration with the U.S. Court of Appeals for the Fifth Circuit in New Orleans.

Texas' flexible permits program was created in 1994 "to incentivize grandfathered operations to voluntarily enter into the State's air permitting and environmental regulation program," according to the attorney general's office.

The Clean Air Act required the EPA to act on Texas' flexible permit program rules within one year, which would have been in 1995, Abbott said.

Facilities exempted because of their "grandfathered" status agreed to submit to state regulation because the program offered them operational flexibility.

In exchange for emissions regulations, participants were authorized to allocate emissions on a facilitywide basis rather than at each release point. Grandfathered facilities were operating before the state's permitting program began in 1971

Abbott said Section 101 of the Clean Air Act provides that air pollution prevention "is the primary responsibility of the States and local governments." And, Section 110 of the Act provides a similar admonishment to respect the states' authority, stipulating that "each State shall have the primary responsibility for assuring air quality within the entire geographic area comprising such State.

On July 29, Gov. Rick Perry said the EPA's action would lead to further mandates and regulations on Texas businesses and place Texas jobs at risk.

### Officials sign letter to delegation

Congress' contemplation of new laws to tighten oversight of drilling in the Gulf of Mexico -in light of the Deepwater Horizon oil spill — prompted a letter urging the Texas congressional delegation to fight against attempts at more federal regulation.

1. Do I need to fill out an application for each child? No. Complete one application to apply for free or reduce-price meals. Use one Free and Reduce-Price School Meals Application for all students in your household. We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to: Norma Rios, 1100 Union Avenue, Rule, Texas 79547.

2. Who can get free meals? Children in households receiving Supplemental Nutrition Assistance Program (SNAP) benefits (Formerly the Food Stamp Program) or TANF can get free meals regardless of your income. Your benefit letter from the Texas Health and Human Services Commission (HHSC) is your documentation for free meals. If you have not already received a letter from your school stating that your household is eligible for free meals, you may take your HHSC benefit letter to your child nutrition office to be certified for free meals. Call the school at **940-997-2521** if you have questions.

3. Should I fill out an application if I got a letter this school year saying my children are approved for free or reduced-price meals? In most cases no, however read the letter you got carefully and follow the instructions. Call the school at 940-997-2521 if you have questions. If your household does not receive SNAP or TANF, your children may still be eligible to receive free meals if your household income is less than the amounts listed on the federal Income Eligibility Guidelines. Please complete the application and submit it to your child nutrition office. Head Start students and most foster children may also qualify for free meals.

4. Can homeless, runaway and migrant children get free meals? Yes. If you have not been notified of free status under these categories, please call Rule ISD, David Parr, Homeless **Liaison** to see if your child(ren) qualify.

5. Who can get reduced price meals? Your children can get low cost meals if your household income is within the reduced-price limits on the Federal Income Chart, included in this application

6. I get WIC. Can my child(ren) get free meals? Children in households participating in WIC <u>may</u> be eligible for free or reduced-price meals. Please fill out an application.

7. Will the information I give be checked? Yes, we may ask you to send written proof.

8. If I don't qualify not, may I apply later? Yes. You may apply at any time during the school year if your household size goes up, income goes down, or if you start getting SNAP,

## TxDOT to hold public hearings

will host its second openhouse style public meeting to give citizens yet another opportunity to offer feedback on a long-range plan that provides the agency with a blueprint for the state's future transportation needs. TxDOT held the first series of meetings in May.

The agency's 25 districts will each host a meeting the first two weeks of August. The Abilene District's meeting is scheduled from 4 to 7 p.m. on Thurs., Aug. 12 at 1350 N. Arnold Blvd., Abilene.

Meeting dates and locations for the agency's http://www.txdot.gov/ public involvement/ transportation\_plan/public\_ involvement.htm Statewide Long-Range Transportation Plan 2035 are available on the TxDOT website.

The plan addresses future multi-modal transportation needs for Texas, including transit, rail, highways, bicycles and pedestrians. This statewide plan is also the basis for a number of other TxDOT planning efforts such as the Texas Rail Plan, the 2011-2015 Strategic Plan and corridor-related initiatives. In addition, the plan provides direction to make it easier for all of these different efforts also assures the state's goals are consistent with federal priorities and guidelines.

TxDOT spent the last six months analyzing system changes that have taken place in the last 20 years and, based on this information, the agency has forecast the needs.

The Abilene District of anticipated changes for the Texas Department of the next 25 years. Citizens Transportation (TxDOT) will have an opportunity to comment on this analysis at the August meetings.


