BISD is only local entity to hold May 4th election

The May 4 elections have been cancelled by all but one of the local entities due to unopposed races. These include East Coke County Hospital District, West Coke County Hospital District, the cities of Bronte and Robert Lee, and the Robert Lee Independent School District.

Two 3 year terms will be on the ballot for the Bronte Independent School District Board of Trustees. These offices are currently held by Jolene Henderson and David Scott. David Scott has filed for re-election. Past board member, Kendall Gibbs, will be on the ballot, along with Paul Williams.

Wednesday, April 17, was the first day voters could cast their ballots in this May 4 election. Early voting will continue through Tuesday, April 30, in the Superintendent's office at Bronte ISD.

East Coke County Hospital District has three 2 year terms expiring. These terms are currently held by Larry Robinson, Leon Brooks and Ed Cumbie. Incumbent Ed Cumbie will retain his seat and be joined on the Board by Billy Joe Luckett and Mark Duncan.

West Coke County Hospital District has three 2 year terms expiring - those held by Winton Milliff, Linda Burns and Patty Byrne. Joan Cantrell was the only person to file for an office.



Coke County has benefited greatly from the work done by the inmates housed at Carlsbad. County families have fed these workers in the past while they were helping with different projects in the county, and these families have enjoyed being of assistance to the good work that these inmates perform.

Captain Hubbard was in my office recently and related that we could no longer feed the inmates from our homes. This is a great disappointment to the inmates as well as the guards that travel with them. They looked forward to coming to Coke County because of our many good cooks.

I am enclosing a fax (to the newspaper) which details how much savings we have incurred by utilizing the inmates. During the month of March, the City of Robert Lee had 9 working hours with ten inmates and one staff (cost would have been \$615.87). The City of Bronte has 26 working hours with twenty seven inmates and three staff (cost of \$1642.68).

This is a wonderful program which has helped our community greatly. So when you see the inmates working in Coke County, think of all the tax dollars they are saving all of us as taxpayers.


Dear Editor,

Local ombudsmen recognized for NH residents service

Governor Rick Perry has proclaimed April 15, 2002, as Long-Term Care Ombudsman Day in Texas. Ombudsmen advocate for improved quality of life and care for nursing home residents. In the Concho Valley, 23 certified volunteers, 16 friend and family visitors, and the staff of the Area Agency on Aging Ombudsman program assists approximately 1500 residents, their friends and families, and staff in the 19 area nursing homes. Ombudsman services are free and confidential.

In fiscal year 2001, Ombudsmen program volunteers donated 2,855 hours of service to the program, resulting in 17,047 contacts with Concho Valley nursing home residents. Additionally, they handled 329 complaints, of which 323 complaints were substantiated and successfully resolved.

Those honored in Coke County as certified ombudsmen were Juanita Schnabel with the Robert Lee Care Center, and Glenda Fletcher with the Bronte Health and Rehab Center.


Proclamation of April as Fair Housing Month

Out of the Ordinary

by Jane Austin Bruckner As April is Women's History Month, it's a great opportunity to feature some of Coke County's early grandmothers whose grand and greatgrandchildren still live in the area. This story was written by banker Bill Allen about his grandmother Amelia Allen for Grandmother Stories from the Heart of Texas, Eakin Press, 2002

Amelia Caraway Allen by William H. Allen

My Mama Allen, born Amelia Boyce Caraway, was a popular school teacher and daughter of Wylie and Nannie Byrd Caraway, early settlers in the Hayrick community of Coke County. Amelia came as a child with her family from Gonzales, Texas to Tom Green County in 1883.

On June 5, 1902, she married Hawley Allen, son of James Monroe and Laura Hawley Allen. As newlyweds, they filed on a state land grant of four sections of land offered in Irion County and were required to live there for three years. Her husband worked for March Brothers Mercantile Store in San Angelo during the week; each Saturday night after work he rode a horse back thirty-two miles to be with his wife, returning in time for work Monday. Amelia lived in a tent by herself during this time, personally protected by a bulldog and her own ability to use her 45 Colt pistol.

In 1911, her husband was elected sheriff of Tom Green County, serving through 1921. In 1922 they moved to the Hayrick Ranch in Coke County, where he was elected sheriff of Coke County in 1923, serving through 1926. During his term in office he and Amelia and their three sons lived in the lower floor of the jailhouse in Robert Lee. Uncle H.C. used to jokingly say he was born in jail.

Amelia and the other Caraway children and cousin Wylie Byrd attended one of the first schools in Coke County (1885-86). They were taught by a Mr. Hall in a "one-room, wooden structure" on Mountain Creek, one mile west of Hayrick Mountain, and near the spot now occupied by the H. C. Allen stone ranch house. It was a four month, "subscription" school. Parents paid \$1.50 per month for each child. After one term, the school was moved two miles east to Sand Springs. There was a good spring at that site which furnished water for the school; also, a the country was settling up faster in that direction, and the move made it more convenient for a larger number of children. Mama Allen belonged to the First Baptist Church in San Angelo and later, Robert Lee Baptist Church, teaching the Ladies Sunday School class and joining the Women's Missionary Union. She was involved in Eastern Star and modeled honesty, integrity, loyalty, family pride, love, and dignity.

buying fabrics, patterns, gloves, and hats. This activity was not so pleasant for me, as I waited stoically to be "released" while my mother and Mama Allen tried on gloves and hats searching for the perfect "match".

Each morning as she arose, she put on the dress that she had worn the previous afternoon. After morning chores, lunch, and a nap, she would put on a fresh starched and ironed dress and be ready for visitors and grandfather's coming home. Even though the Allen men wore boots all week, she expected them to wear shoes on the Lord's Day. We knew she was the Queen of her home and we complied.

Cooking seemed second nature with her; so our family remembers the delicious family dinners and ample breakfasts. Well into her nineties, she continued cooking balanced meals using fresh vegetables and meats. I believe this was partly responsible for my grandparents' good health and long lives.

Her cranberry salad, a favorite of mine, was always served in a beautiful pressed glass bowl on Sundays. When that bowl was not in use it was on display in a glass-fronted china cabinet. She gave us the bowl and china cabinet when she no longer needed it, and the bowl still has its place of honor on our table.
