





RLISD welcomes new board member

The Robert Lee ISD Board of Trustees held its regular monthly board meeting on Tuesday, June 4 at 7 pm in the high school library. At the top of the agenda was the swearing in of newly appointed trustee Ron Hill. Mr. Hill was appointed to fill a vacancy for a one-year unexpired term. He will have to stand for election next May. Mr. Hill has lived in Robert Lee since 1994 and is Vice-President of Pioneer Gas Pipeline Company with offices in San Angelo.

The board also approved Food Service meal prices for next year. The only change in previous year prices was an increase in adult lunches from \$2.00 to \$2.25 as recommended by the Child Nutrition **Division of the Texas Education** Agency. Supt. Weldon Koepf also reported other results of a Child Nutrition Program audit conducted by TEA in April. He also reported that attempts to implement a Food Purchasing Coop for area schools could help bring down food service costs in the future.

Board members also reviewed the final draft of a **Community Networking Grant** Application that will be submitted to the Texas Technology Infrastructure Fund Board by June 7. If approved the grant would provide improved computer and Internet access to citizens of the Robert Lee community.

Robert Lee ISD Technology Coordinator Jerry Horn will administer the grant as a partnership between RLISD, Coke County, Coke County Library, Robert Lee Care Center, and the City of Robert Lee. The grant would provide a networked computer center at the location of each of the partner entities where local residents could access the Internet. Computer classes would also be taught at the school which would be open to community residents. Supt. Koepf explained that receiving the grant would require the school to provide 10% in matching funds over the three fiscal years that the grant would be operational. Trustees also reviewed a report of Elementary Library Services provided during the 2001-2002 school year. They also heard a report from Superintendent-elect Lindsey Wallace on progress on the search tor a new athletic director. Before adjourning, the board scheduled a special meeting on June 12 for the purpose of filling the position.



ASU Dinner Theater presents "The Fantasticks"





Laundry basics for the college bound

Doing your laundry for the first time? What gets washed with what? Too late to call home? You're the only one in the laundry room?

Hang on, help is here. You can take care of your clothes and save money by practicing good clothing management in your home, dorm or neighborhood laundry. Although the latest in washers, dryers and laundry products make cleaning easier, for good results, follow these basic procedures:

*Remove stains as soon as possible. Spots and stains are easier to remove if they are treated quickly. To remove a stain, use a blotting motion, do not rub the stain. Retreat stains that are not completely gone. Do not dry stained clothes in the dryer or the stains may become permanent. Bleach also helps to remove stains and improve cleaning power. Follow garment care instructions and bleach label directions for proper use. If there is any doubt, test the garment for colorfastness in an inconspicuous area.

*Read the care labels and follow instructions. Following the manufacturer's recommended instructions can mean the difference between a garment that lasts and one that can be ruined easily. Read the care labels in your garments. They contain care procedures recommended by the clothing manufacturer.

*Sort clothes before washing. Separate whites from colors and light colors from dark. Separate sturdy cottons from delicate and permanent press items. Separate lint-givers, such as sweatshirts, from lint-grabbers, such as corduroy and permanent press items. Finally, separate heavily soiled items from lightly soiled ones. As you separate clothes into loads, empty pockets and shake out cuffs. Close zippers and hooks. Repair any holes or tears so they don't grow in the wash.

won't be nearly as clean. For best results, items must circulate freely.

*Water temperature is an important factor in cleaning performance. For best results, use warm water (90-110 degrees F), for most loads, use hot water (130 degrees F and above) for whites and heavily soiled items, and cold water (80 degrees F or colder) for lightly soiled or brightly colored items.

*Choose a drying cycle that fits the care label instructions. Generally if clothes can be washed together they can be dried together. Shake the damp items to loosen them before putting them in the dryer. Set controls for "regular" if most of the load is made up of all-cotton fabric, or "permanent press" if the load contains man-made fibers or permanent press fabrics.

To avoid the unnecessary wrinkling, remove items from the dryer as soon as it shuts off. Do not overload the dryer. Keep lint filter clean. Air drying is recommended for some garments.

If you expect your clothes to last, you must take care of them. The appearance of clothing can be ruined during any of the steps outlined above. However, if you take time to care for and clean your clothes properly, you will save money.

AN ORDINANCE PROHIBITING THE DISCHARGE OR FIRING OF ANY RIFLE, PISTOL OR ANY **OTHER WEAPON DISCHARGED** BY THE IGNITION OF GUN POWDER OR ANY OTHER **EXPLOSIVE WITHIN ITS FIRING** CHAMBER, WITHIN THE CORPORATE LIMITS OF THE **CITY OF LIMITS OF THE CITY OF BRONTE, TEXAS, OR AN AREA** WITHIN ONE HUNDRED (100) FEET OF THE CITY LIMITS OF THE CITY OF BRONTE, TEXAS; PROVIDING A PENALTY; DECLARING THAT SAME CONSTITUTES A DANGER THROUGH PUBLIC HEALTH AND SAFETY OF THE CITY OF BRONTE, TEXAS. AND CONSTITUTES A NUISANCE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF **BRONTE, TEXAS:**

Section 1: This Ordinance shall not apply to:

(a) Law enforcement officials engaged in activities pursuant to their office or persons directed by them or under their supervision in connection with activities pursuant to their office.

(b) The use of a shotgun or shell shot used to repel or eliminate snakes, possums, skunks, rats, raccoons, armadillos and other wildlife that may pose a threat to property or humans.

Section 2: That no person or firm shall fire or discharge any rifle, pistol or weapon discharged by the ignition of gun powder or any other explosive within its firing chamber, within the corporate limits of the City of Bronte, Texas, or in an area within the extraterritorial Jurisdiction of the City where said area is within one hundred (100) feet of the city limits.

Dollars. Each such violation shall continue, or be permitted to continue, shall be deemed a separate offense.

Section 5: It shall be unlawful and an offense for any person to discharge a projectile from an air rifle, pellet gun or other instrument in which the projectile is propelled by compressed air in, upon, across or into a public street, alley or other public thoroughfare or across a property line within the City.

Section 7: The Ordinance shall become effective as of the 1st day of July, 2002.




