Fort Chadbourne was. established on October 28, 1852, by Companies A and K of the Eighth U.S. Infantry. It was named for 2nd Lt. Theodore Lincoln Chadbourne who was killed in the Battle of Resaca de la Palma in the Mexican War. The fort was officially abandoned in 1867 but was utilized by the military until

Garland Richards' great, great, great-grandfather came to Fort Chadbourne in 1874 to establish the O-D Ranch. The family has owned and operated the ranch from then until the present time.

Much work has been done in the restoration of the fort. All of the buildings have been completely stabilized. While two buildings are completely restored, the East Barrack building is under reconstruction. The donations from the 150th anniversary celebration will help the foundation build and install held windows, doors, and floors to the East Barracks building. Fort Chadbourne is located 12 miles north of Bronte on Hwy. 277. Turn into the entrance across from the Fort Chadbourne billboard.



The menu includes chopped BBQ sandwiches, chips, salad, and dessert. Take-out plates will be available.



An update on **West Nile Virus**

by Joan Davis Much has been said and written in the last few months about West Nile Virus. The most useful and common sense answers to the public's questions come from the Vector-Borne Infectious Disease Control, Texas State Health Dept., Texas Parks & Wildlife Department, or your veterinarian.

The mosquito-borne disease symptoms are flu-like in nature: headache, high fever, neck stiffness, swollen lymph glands, and muscle weakness.

Time from infection to onset of symptoms is 3-14 days, but about 20% of those who contract it will never know it in the less serious cases. Only a fraction of mosquitos are infected with WNV.

It is unrealistic to stay inside to avoid mosquitos. Chances

of a person being infected are small. If you are outdoors for a long-time period, wear a long-sleeved shirt, long pants, and apply a repellent high in DEET often. The highest chances of infections are in certain types of birds, horses, cats, bats, skunks, squirrels, and domestic rabbits. West Nile Virus is only transmitted by mosquitos. There is no evidence of getting it from an infected bird, animal, or human.

Since bird hunting has started, with other seasons upcoming, for safety's sake, use only fully-cooked meats from birds or animals. Wear gloves if you choose to in handling carcasses of any kind. This is probably a safe idea anyway because of rabies, wasting disease, or other viruses. Consuming game birds or animals is proven safe; no case of such evidence has ever been

Strategic culling due to drought

With the continued hot and dry conditions we are having, the long-range outlook for available forage in our area is bleak. With these type of conditions, our available forage or grass production is greatly reduced or, in some cases, almost nil. Even if we get some much needed rains in the next few weeks, the prospects of us growing a lot of tonnage is not great. Most of these drought stressed grasses will green up and shoot a tall single stem with the seed head on it that from a distance, looking across your pasture, you get the idea that there is lots of grass out there, but in reality, if you go out in the pasture and look straight down, we have not grown a lot of forage. A lot of our pastures have from 200-400 pounds of available forage for cattle per acre. If we use only about 1/2 of this forage and leave some for next years growth, we are only looking at 100-200 pounds per acre to be utilized. If a cow needs 20-25 pounds of grass per day, it will take about 40-45 acres per cow to run them only until March. If we get significant rains in the next few weeks, we are basically looking at the amount of forage that will be available for livestock from now until next spring. Reduced body condition in cattle is of great importance simply because what condition a cow is in now and going into winter not only determines what kind of calf she will have this spring and how big it will get, but can also determine the reproductive efficiency and productivity of that cow for the next year or more.

with this greatly reduced amount of forage we have or expect to have, there may become a time that we will have to cull our livestock to maximize the production of

our herds. A strategic plan for culling cows of at least immediate economic benefit and maximize production of remaining animals is as follows. Cull in the following order: (1) open fall-calving cows (2) dry spring and summer calving cows (3) open replacement heifers (4) shortbred fall/winter calving cows (5) bred replacement heifers (6) wet cows with poor teeth or other unsoundness (7) wet, historically poor producers (8) wet, open cows and heifers (9) wet, bred individuals in poor body condition, cows below body condition score 4 and heifers below body condition score 5 (10) wet, bred cows over 7 years of age (11) wet, bred first and second calf heifers (12) remaining wet, bred cows, 4-7 years old, as conditions require.

Culling of your herds that have taken years of selection and pride to build is no easy task, but sometimes conditions force us to do it. There is always some animals that can be culled for some reason or another. Another good rule of thumb is that if conditions get bad enough to feed your cows, don't hold onto low production animals or too many animals and wind up owing the bank for cows and the feed store for feed. As conditions worsen, take a load of cows to town and buy that much feed to save the






