Local woman killed in early morning accident

Sara Pitcock, 24, of Robert Lee died of injuries she sustained in a near head-on collision early Tuesday morning. Pitcock, a dental hygienist who commutes to work in San Angelo and Ballinger, was driving south on 208 about six miles from Robert Lee, when her vehicle apparently crossed the center median and collided with a north-bound four door Chevrolet pickup. Pitcock's vehicle burst into flames upon impact, and the passengers in the other vehicle were unable to rescue her.

The men in the Chevrolet pickup were enroute to Robert Lee to work on a carpentry job. The driver, 29year-old Austin Grantham, sustained head injuries and at least one broken leg. His brother, 31-year-old Shannon Grantham, Alfred Spencer, 46, and Robert Greathouse, 30, were also injured in the accident. All four were taken to Shannon Medical Center.

DPS trooper Scott Frasier, who investigated the accident, said that the dense early morning fog could have been the cause of the accident, but that the actual factors may never be known.

EMS teams from both Bronte and Robert Lee were dispatched to the site, along with members of the Robert Lee Volunteer Fire Department. After the flames were extinguished in one vehicle, the "Jaws of Life" from both Robert Lee and Bronte were used to extract the trapped driver of the Chevrolet pickup. The Coke County Sheriff's Department diverted traffic around the accident scene for about 3 1/2 hours as DPS officials were summoned to investigate the accident scene.

Mrs. Pitcock graduated from Midland Christian High School in 1996. She graduated from Midland College in 1998, and earned a degree in dental hygiene from Howard College in 2000. She was married to Robert Lee native Blake Pitcock on July 27, 2002.

A memorial service will be held in Midland on Thursday, Oct. 24, 10:00 am, at Fairmont Church of Christ, with services in Robert Lee that afternoon at 4:00 pm at the Robert Lee Baptist Church. Burial will be in the Robert Lee Cemetery.

Quail season will open in all counties statewide on Saturday, Oct. 26, 2002 and run through Sunday, Feb. 23, 2003. The general quail season bag limit is 15 birds. All species of quail may be included in the bag, except Mearn's quail, also known as Montezuma or Fool's quail, which has no open season and is protected.

Since quail are not migratory birds such as doves, hunters may unplug their shotguns and may hunt over baited areas such as deer feeders. Hunting hours are the same for quail as they are



Shannon adds blood service to AirMed 1

In an effort to augment emergency care provided to area trauma patients, Shannon AirMed 1 air ambulance service recently began carrying blood on board during flights. The readily accessible blood can enhance patient outcomes when received earlier in treatment.

"We are the only air ambulance service in West Texas to provide this type of on-board service" said Rod Gardner, director of Shannon AirMed 1.

Two units of O-negative blood provided by the Shannon Medical Center blood bank are carried on each flight. O-negative is a universal blood type that can be accepted by almost every patient, said Gardner. The blood is stored in a temperature-controlled environment while not in use and is carefully packed for transport in an approved container with special materials to maintain its temperature. Funds donated by Crockett County EMS and the Texas Department of Health Bureau of Emergency Management were used to purchase the equipment needed for blood storage.

Shannon Health will host its eighth annual Diabetes Update on Saturday, Nov. 9, at the San Angelo Convention Center.


The free program will help people with diabetes and their families learn more about the disease and how to manage it, said Carolyne Glass, RNC, CDE, program chair.



Safety tips for trick-or-treaters

One more door, one more stash of candy. Children masquerading as pirates, fairy princesses or dinosaurs take to the streets each Halloween in search of the best treats. **But Texas** Department of Health (TDH) safety experts urge that along with the preparations and decorations should come precautions to keep the evening safe as well as fun.

"Parents often are concerned about the safety of the treats children receive, and that's good," said Susan Warren, director of the TDH Safe Riders Program. "But many other types of injuries can be avoided if adults follow safety suggestions and if parents talk with their children about staying safe as they enjoy Halloween."

About four times as many children ages 5 to 14 are killed while walking on Halloween evening as compared with any other night of the year. "Many young children are not accustomed to walking after dark, and older children may be more interested in playing and getting treats than in watching out for traffic on Halloween," Warren said. "Plus drivers have difficulty seeing children, especially at night."

TDH offers these safety tips for children:

*Look left, right and left again for cars and trucks before crossing the street. Walk on sidewalks. If there is no sidewalk, walk on the left side of the road facing traffic.

*Don't cut across lawns or go through backyards, parks and alleys.

*Don't hide behind cars. Don't cross the street from between parked cars; go to a corner.

*Never accept rides from strangers. Do not take treats from a person in an auto.

*Use a flashlight when walking. Be sure it has fresh batteries.

*Wear light-colored costumes and put reflective strips on them. Be sure costumes are short enough so you will not trip.

*Wear comfortable shoes that fit. High heels or big floppy shoes are not safe for walking.

*Accompany trick-or-treaters under 12.

*Set a time for older children to be home. Know the route they will take.

*Never let a child go trickor-treating alone. Be sure at least two buddies go together.

*Have children eat dinner before they go out. They will be less likely to eat treats before they are checked.

*Remove breakable items or obstacles such as ladders, tools and toys from your yard.

*Keep jack-o-lanterns and lighted candles away from areas where costumes or paper decorations might touch the flame.

TDH offers this safety information for motorists:

*Slow down in residential, neighborhoods. Watch for children in the street or on medians and curbs.

*Enter and exit driveways slowly and carefully.

*If you are driving children around, be sure they get in and out of the car on the curb side, away from traffic.

*Do not wear a Halloween mask while driving.

"For added safety, parents

may want to have children only visit houses where they know the residents, and then only if the lights are on," Warren said.

She added that parents still need to check all treats. "Look at the wrapping carefully, and throw away anything that looks suspicious," Warren said. "Inspect the surface of fruit thoroughly for any punctures or holes. Wash fruit carefully and cut open before eating."

Be realistic, Warren advised. "Don't overestimate a child's safety skills."

Registered number of voters increase

The Texas Secretary of State's office has announced the official figure for the number of registered voters eligible for the November 5th general election. The certified number of voters is 12,569,738, meaning that 81% of Texans over the age of eighteen are now registered. This is an increase of 351,574 over the official tally for the March 12th primary election. By way of comparison, 12,365,235 Texans were registered to vote in the November 2000 general election. Between March and November of 2000, 752,474 new voters were added to the rolls. "I am delighted that eightyone percent of eligible Texans have made the decision to register to vote. Voting is both a privilege and a

responsibility, and I fervently e hope that Texans will now si follow through and take those th voter registration certificates k to the polls," said Secretary d Shea

Texas enjoys one of the highest rates of voter registration in the nation. The state pioneered motor-voter and instituted on-line access to printable registration applications, both aimed at increasing voter registration rates.

Early voting began on October 19th - October 21st, varying by county, and continues through November-1st. On Election Day, November 5th, polls will be open from 7 am to 7 pm.



We saw alot of whitewings this year and I finally saw my first group of Eurasian ringedneck doves last week. They're large and a brownish color with lots of white. You may take these doves here; they don't count on bag limits and you must leave one feathered wing.

The short season for dove hunting will start Dec. 26, 2002 and run through Jan. 05, 2003 with the same hunting regulations applying.




