




Also, January is National Book Blitz Month. To celebrate this event, visit the Coke County Library which is adding books daily to the collection.





Forest Service offers windbreak trees

Seedlings for conservation windbreaks are now available for order through the Coke County Soil and Water Conservation district (SWCD). Landowners in Coke County are encouraged to purchase the one-year-old seedlings before preferred stock is sold out.

Each year thousands of regionally adapted seedlings are grown from seed by the Texas Forest Service West Texas Nursery in Lubbock. agency's primary objective is to produce and sell quality seedlings at a price landowners can afford, allowing them to plant large quantities of trees for windbreaks, says Robert Fewin, Texas Forest Service forester, Lubbock.

"Windbreaks are trees and shrubs systematically planted adjacent to fields, homesteads, or feedlots as a barrier to reduce or redirect the wind," Fewin "They create permanent, natural protection and habitat for wildlife, reduce erosion, and increase land value and aesthetics." Available species for Coke County include afghan pine, austrian pine, arizona cypress, redcedar, pinyon pine, italian stone pine, amur honeysuckle, skunkbush sumac, shumard oak, green ash, russian olive, desert willow, lacebark elm, hackberry honeylocust, sand plum, fourwing saltbush, nanking cherry, flameleaf sumac, and osage orange.

Wildlife packets for habitat establishment also are available. Each of the four wildlife packets contain 100 bare-root trees and shrubs which cater specifically to the habitat needs of quail and pheasant, deer, turkey, or

Emergency farm loan applications being accepted

Applications for emergency farm loans for losses due to damages and losses caused by drought and excessive temperatures that occurred on various dates from January 1, 2002, and continuing, are being accepted at the Farm Service Agency (FSA) office located in Sweetwater.

Coke and Sterling Counties, as primary disaster counties, were recently declared eligible for FSA EM loss loans.

Farmers may be eligible for loans of up to 80 percent of their actual losses or the operating loan needed to continue in business or \$500,000.00, whichever is less. For farmers unable to obtain credit from private commercial lenders the interest is 3.75 percent.

As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FSA emergency loan. Farmers participating in the PIC or Federal Crop Insurance program will have to figure in proceeds from those programs in determining their loss

Applications for loans under this emergency designation will be accepted until June 23. 2003 but farmers should apply as soon as possible. Delays in applying could create backlogs in processing.

The FSA office in Sweetwater is open from 7:30 to 5:00 Monday through Friday.

Divorced wives don't sign away social security rights

by Fredi Franki Social Security Administration Anne was a battered wife. By the time she was 45, she had enough of her abusive husband and would do anything to get out of her 15 year marriage. As part of her divorce agreement, she signed a clause relinquishing her rights to her ex-husband's Social Security benefits.

That was 20 years ago and Social Security was just not on Anne's radar screen. But now she's pushing 65 and thinking about retiring. She's worked for years at several low-paying jobs, and her estimated Social Security check is only about \$800 a month. She stopped by our office and now she says she wishes she had never signed away her rights to her ex-husband's Social Security. She learned from friends that

But we had good news for her. She did not "sign away" her ex-husband's Social Security benefits. That clause the lawyers added to the divorce decree isn't worth the paper it's printed on. Federal law overrides anything that lawyers might add to divorce papers. And Social Security law says that because Anne was married for more than 10 years and because she never remarried, she is due some of her ex's Social Security.

She gets the same Social Security benefits as a currently married woman: anywhere from one-third to one-half of her ex's retirement benefits while he's still living, and up to 100 percent of it when he dies.

Anne was worried that her ex might get upset because she's taking away some of his retirement benefits. But we assured her she's not. Anything we pay to Anne will not reduce his benefits. And if he's remarried, anything we pay Anne does not reduce any benefits due his current wife. In other words, two or more women can draw full wife's or widow's benefits on the same man's record.

However, the benefits we pay on her ex-husband's record will be offset by her own retirement benefit. That means while her ex is still living, she won't get anything on his record because her own retirement benefit (\$800) is more than one-half of his (\$700). But if he dies before she does, we can augment her Social Security retirement check with the additional divorced widow's benefits she would be due. For example, if her ex-husband were to die this month, Anne would continue to get her \$800 retirement check and we'd supplement \$600 on his record to take her up to the \$1,400 divorced widow's rate.

Out of the Ordinary

Fort Worth pulled on its boots Saturday, and began its celebration of Western heritage as it does every January. In the forty degree moming it was estimated 110,000 people lined Main and Houston Streets as the Stock Show parade rolled through downtown led by Forth Worth Mayor Kenneth Barr riding horseback with members of the Fort Worth City Council. Following was Dallas Mayor Laura Miller sharing a wagon with Ben Tahmahkera, great-great-grandson of Quanah Parker, the last Comanche war chief. Then came the many floats and marching bands. And many horses. And steers. And mules. A total of 1345 animals marched through downtown. They were closely followed by four street cleaners, two trucks and a pair of dump trucks. More than 5,700 people filed into the Will Rogers Coliseum to watch competitors, dressed in thick brown leather chaps, dirt-stained black felt hats and silver spurs, sort and rope cattle and bust broncs.

Eight ranches competed in the Best of the West Ranch Rodeo, including the Bonds Ranch in Saginaw, the Spade Ranches in Lubbock and the Stuart Ranch in Caddo, OK. The winner was the Tongue River Ranch from Paducah. The ranch rodeo features "working cowboy" team events such as calf branding, stock sorting and wild cow milking. The ranch rodeo differs from the Stock Show's renowned Professional Rodeo Cowboys Association where individuals compete in steer wrestling and bull riding which begins its 17 day run.

The Stock Show, officially called The Southwestern Exposition and Livestock Show and Rodeo, goes back a hundred years and more, when Fort Worth was a Xanadu to

West Texans. It was where they came once a year to escape the dust and the drudgery and boiling sun. They put away their workday clothing and tools, and came to town. They came from other parts of the state, too. But Fort Worth was a refuge for West Texans. It was still a town then. A town with museums and art galleries and movie theaters. Malls came along later.

Art Chapman, writes in Fort Worth Star Telegram, he believes the Stock Show tells us how deeply we are rooted in our past and how far we have come from it. He believes Fort Worth has changed. It is bigger and more prosperous, drifting from its agricultural roots. Boots and blue jeans are wom with blazers. It is dangerously close to becoming a city, rather than a town. Chapman believes the Stock Show may just be the ballast that stops the frightening shift. It is an important job. Jerry Flemmons, a former Star-Telegram writer and lifelong Fort Worth advocate once wrote, "I can't think of Fort Worth as a city, a term with an austere and impersonal lawyering tone. Town has mythology in it and affection, a casual, almost languid, cadence, a presumption of refuge. A city is where a lot of people live; a town is where a lot of people live together and it is
