## Filing period ends for May 3, 2003 elections

March 19, 2003, was the last day to file for inclusion on the ballot for the May 3 local elections.

West Coke County Hospital District would have had two 2 year terms on the ballot. However, incumbents Judy Williams and Doug Wilkes were the only ones to file for the election. An election for this entity is no longer necessary.

East Coke County Hospital District will have two 2 year terms on the ballot. The terms of Jesse Sims and Keith Fletcher are expiring. Doris Sims and Alonso Robbins have filed for these seats. With no opposed races, the election may be cancelled. The city of Robert Lee will have to fill three council seats currently held by Johnny Carver, Nita Duncan, and Kenneth Green. Jayson Treadaway and Janie Munoz have filed for the election. The incumbents have also filed for re-election.

The city of Bronte will have to fill two 2 year council seats currently held

by Marty Boyd and Gerald Sandusky and one 1 year unexpired term, currently held by Martha Ratliff. All incumbents have filed for re-election. However, the filing deadline for the 1 year unexpired term is April 2. If no one else files for this position, the election may be cancelled.

Three 3 year terms will be on the ballot for the Bronte Independent School District Board of Trustees. Incumbents Wayne Coalson, Bob Frazee, and Jeff Schoenfield have filed for re-election. They will be joined on the ballot by Kenny White, Gary Acker and Paul Williams.

The Robert Lee Independent School District Board of Trustees would have had to decide on three 3 year terms. Incumbents Freda McCabe, Ron Hill, and Wes Washam were the only ones to file and therefore, the election has been cancelled.

Early voting for the May 3 election begins Wednesday, April 16, and continues through April 29.

## 915 area code to split April 5 - new to be 325

On April 5, 2003, area code 915 will split three ways. The split will add two new area codes to the area now served by area code 915. The 325 area code will serve residents in the eastern region, and 432 will serve the central region of the current 915 territory. Those in the western region will retain the 915 area code.

All of Coke County, including Bronte, Blackwell, Robert Lee, Silver, and Tennyson will be using the new 325 area code, along with San Angelo, Abilene, Snyder, Eden, Miles, Rowena, Sterling City, Water Valley,

Carlsbad, Mertzon, Ozona, Paint Rock, Sonora, Winters, Brownwood, Zephyr, Bangs, Coleman, Comanche, Gustine, Blanket, Goldthwaite, Brady, Kingsland, Mason, Llano, Tow, Junction, and London.

New area code 432 will cover Midland, Odessa, Seminole, Pecos, Fort Stockton, Fort Davis, Alpine, and Van Horn. El Paso, Dell City, and Fabens will retain the 915 area code.

Permissive dialing, which allows you to dial with seven or ten digits, will begin on April 5, 2003. Mandatory dialing, which requires you to dial the

area code and seven-digit phone number to place a call from one area code to another, will begin October 4, 2003.

To plan for the area code split, you are urged to start programming speed dial equipment, check security systems, confirm Internet dial-up numbers, reprogram fax machines, and update advertising, business cards, and stationery. Also, don't forget to notify family and friends of the new number in order to avoid any inconvenience. Another important point is to remember that 9-1-1 is still the number to call for emergency assistance.

### Robert Lee "City-Wide Spring Clean-Up"

The "City-wide Spring Clean-Up" event is scheduled for the first and second Saturdays of April. As always it is sponsored by the City of Robert Lee and Trashaway services. This clean-up allows residents of the city a chance to get rid of clutter from around their homes and businesses.

Residents with a Tuesday trash pick-up will be serviced on Saturday, April 5, 2003. Residents with a Friday trash pick-up will be

serviced on Saturday, April 12, 2003. Trucks will begin at 7:00 am.

Residents are encouraged to haul brush, tree limbs, shingles, bricks, and lumber materials to the City Landfill on Saturdays from 9:00 am to 12:00 noon.

Trashaway personnel will not pick up loads stacked on trailers, or household trash, tires, batteries, chemicals or wet paint. Please be available to help load anything over 50 pounds. If you have any questions please contact City Hall at 453-2831.

### Super H Grocery earns 4-Star Rating

Super H Grocery Store, owned and operated by Dave and Betty Hughes in Robert Lee, has been awarded a Four-Star Rating by the IGA System of locally owned grocery stores.

Super H was the only Four-Star store in the Lubbock-based Fleming Product Supply Center area, and one of only four stores in Texas to receive this rating. There were only three five-star stores in the United States.

IGA affiliated stores are located across the United States and in Australia,

England, Japan, China and other foreign countries.

The ten page assessment covers such areas as exterior (windows, entries, machines, appearance); the scanning system; store conditions; IGA brand promotion; produce preparation and sales; meat preparation and sales; dairy; frozen foods; back rooms; restrooms; pest control; video department and safety. Sanitation is a requirement in all areas of assessment. Dave Hughes said that the print-out of the assessment is about a half an inch thick.

The inspector who conducted the Super H assessment makes over 4,000 IGA inspections each year. Having a four-star rating assures shoppers of high quality goods and services.

Spring turkey season will open in Coke County on Saturday, April 5, and continue through May 11. Bag limit for that season is 4, depending on how many birds a hunter took in the fall season. As always, the spring hunt will be gobblers only.

Prospect for the hunting period is good. Fresh small green feed is plentiful, as well as late fall seeds, and water is available. Toms are together and good numbers are visible now. Most of the gobblers seen have been mature birds and appear to be large and in good shape.

**Coalition discusses pharmacy needs**

During the most recent meeting of the Coke County Alliance, pharmacy needs for Coke County were at the top of the list in the discussion. The Coalition was formed to find ways for prescriptions to be made available to Coke County citizens.

There is no pharmacy in Bronte, and with the impending closure of the Coke County Pharmacy in Robert Lee, many of Coke County citizens have expressed some concerns about how to get prescription services.

Pharmacies have been contacted in San Angelo to gather information about pharmacy service options for our citizens:

\* The Family Health Center of Bronte is proposing a plan for weekly delivery of prescriptions from Shannon Pharmacy.

\* East Coke County Hospital District has offered Bronte Health and Rehab Center to be a repository.

\* A Robert Lee resident has proposed assisting in delivery of prescriptions to Robert Lee from Walgreen Pharmacy.

\* Other pharmacies such as Medical Arts Pharmacy and Community Pharmacy have expressed interest in a prescription delivery plan.

County residents are encouraged to contact Mary Ann Choat, member of the Coke County Coalition, to express their pharmacy needs. The larger the number of participants in a pharmacy prescription delivery plan, the better chance of a reasonable delivery fee, or maybe a free delivery service could be offered. Please understand that the logistics have not yet been defined.



**Inmates to work at Bronte Cemetery**


The City of Bronte will have the inmates working at the cemetery two or three days, from April 1 - April 4.


## Steers track results



### Letter to the Editor

A California mother whose son is right now in Kuwait (or Iraq, by now), poised to knock Saddam's block off, wrote her son asking how he would feel if she joined other relatives of service members in an anti-war demonstration in Hollywood last month. After reading her son's response, she elected not to participate. The following is her son's response as it was printed in the Las Vegas Review Journal.

Dear Mom,

It's really your decision to march if you want to or not.

You are the one who has to decide if what we are doing out here is right or not. My opinion is not yours. I do, however, have things I would like for you and Grandma and everyone else at home to know.

I am a United States soldier. I was sworn to defend my country against all enemies, foreign and domestic. People may not agree with the things we are ordered to do. I would like to address those people by telling them that terrorism is not only a threat to us as Americans, but to many other innocent people in the world. What type of country would we be if we didn't defend the rights and freedoms of others, not because they're Americans, but how about just because they're human?

We live in a country where people feel secure with their daily lives. They do business as usual and don't worry about the thought of terrorism actually happening to them. The people of 9-11 thought the same thing. We now know that it can happen to anyone at any time. Yet as Americans we're afraid of losing our soldiers to defend our security. I can only speak for myself when I say that my life is an easy expense to ensure that my family and friends can live in peace. I strongly believe in what we are doing and wish you were here to see for yourselves the honor and privilege that American soldiers aboard this ship are feeling, knowing that we are going to be a part of something so strong and so meaningful to the safety of our loved ones. Then you would know what this potential war is about. We will stand tall in front of terrorism and defeat it.

We as soldiers are not afraid of what may happen. We are only afraid of Americans not being able to understand why we are here. I ask for your courage as Americans to be strong for us; I ask for your understanding in what we believe is right. I ask for

your support in what we are sworn to do: defend our country and the life of all. We will succeed in our task and will end the threat of terrorism in our back yard. We will also end the threat of terrorism in our neighbors'.

We have to remind ourselves of what this country stands for: life, liberty, and justice for all. In order to maintain those rights, we have to stop the threat of terrorism. I am proud to be here. I will be coming home, but not until I know that it is going to be safe for all Americans and for everyone I love. My family is first. My country is where they live. I will defend it.

### Get ready for tax time

Typically around this time of year, many individuals begin a scavenger hunt for all those financial documents they need to file their taxes. For the disorganized, that makes tax season a major undertaking.

Marked as a national event, Get Ready For Tax Time Month, is time to get your papers in order for filing taxes. As an extra measure, it's a good investment of time to update and organize your financial paperwork so tax time doesn't have to be so taxing the next time around.

Cyndi Seidler, author, columnist, and organizing expert, offers these tips in

organizing financial papers: \*Establish a "drop off" place for receipts. Empty receipts from pockets, purses, or shopping bags into this receipt holding place each day.

\*Do regular maintenance to process receipts. On a weekly or monthly basis, file the receipts into a categorized accordion file. If computerized, enter the expense receipts into your money management program, and then file the receipts away in an Expense Receipts file.

\*Set up finance files together in a filing cabinet or file drawer. Keep receipts, paid bills, credit card statements, bank statements, income records, and any other financial documents in clearly labeled files.

\*Don't keep what you don't need. Discard receipts that are not related to taxes, and toss ATM receipts after your bank statement balances.

\*Implement a paper management system to manage your flow of mail and financial papers. Set up stacking tray baskets to receive mail, hold pending papers, and to put papers in for filing. Use a vertical file holder for active files, like a "Bills to pay" file.

\*House your important, valuable documents safely. Store such documents as deeds and mortgage papers, birth and marriage certificates, insurance policies, legal agreements, essential investment records, tax returns, and property inventory in a fireproof box or safe deposit box.

\*Consider free tax assistance. IRS offers a tax help line at 800-829-1040. Many post offices and libraries carry the most widely requested forms and instructions.



## FINANCIAL FOCUS

### "Recovery Plan" can keep you moving toward financial goals

Over the past couple of years, we've had a long bear market and a period of low interest rates. Consequently, it's been tough for stockowners and income-oriented investors. If you fall into either of those groups - and most people do - you may be wondering what to do. You can't control market volatility or the movement of interest rates. But you can create a "recovery plan" that will allow you to make the best of your situation - and, in the process, make progress toward your financial goals.

What specifically can you do? Here are some suggestions.

#### Put your losses to work

Your investment losses are tax-deductible, to a point. You can use your capital losses to offset any capital gains you have, plus up to \$3,000 of other income, including earned income. So, for example, if you realized a \$1,000 capital gain this year from selling stocks or other appreciated investments, you could write off up to \$4,000 in losses. And you can carry forward any "excess" losses to future years.

#### Rebalance your portfolio

Your investment portfolio may have become "unbalanced" - and you might not even be aware that it happened. For example, if your stocks have declined sharply, then bonds or other fixed-income instruments may now make up a larger percentage of your portfolio's total value than you had originally intended. Consequently, you could be losing out on growth opportunities - which is why you'll need to rebalance your holdings to match your individual risk tolerance, goals, and time horizon. (Keep in mind that there may be tax consequences associated with one's rebalancing strategy).

#### Stabilize your investment income

What should you do with your bonds or certificates of deposit that mature when market interest rates are low? You could "park" the funds in a money market account until interest rates rise again, but that might take a while - and, in the meantime, you will have almost certainly missed out on some better opportunities. You may be better off

by building a "bond ladder". To create a bond ladder, you invest in an array of short, intermediate, and long-term high-quality bonds. When rates are rising, you use the proceeds from your maturing bonds to buy new bonds at the higher levels. When market rates are falling, you'll continue to benefit from the highest rates offered by your longer-term bonds. Over time, a well-structured bond ladder can help you stabilize the income you receive from your fixed income portfolio.

**Swap for quality** - Over the long term, high-quality investments - such as stocks of well-run companies with solid business plans - will reward investors more than investments that run "hot" and "cold". Look through your portfolio for opportunities to replace lower-quality investments for higher-quality ones that may now be attractively priced.

**Be a "tax-smart" investor** - Taxes can significantly erode your overall investment returns. That's why you need to look for tax-advantaged vehicles. Take full advantage of tax-deferred instruments, such as your 401(k) and traditional IRA. You can get tax-free earnings growth from a Roth IRA, provided you meet certain conditions. Depending on your tax bracket, you may also be able to benefit from municipal bonds, whose interest is exempt from federal income taxes, and may be exempt from state and local taxes as well. However, municipal bonds may incur the alternative minimum tax.

Clearly, you've got many opportunities to create a recovery plan that can help keep you on track toward your long-term financial goals. Start exploring these possibilities soon.

#### "Ranchers' Resources" short course offered

Texas Cooperative Extension is sponsoring a three-night "Ranchers Resources" short course series April 7, 14, and 21. The course sites are Abilene Auction (April 7), Ben Richey Boys Ranch (April 14), and the Sears Ranch (April 21).

A total of four Texas Department of Agriculture (TDA) continuing education units (CEUs) will be available for persons completing the series.

Gary Bomar, Taylor County Extension agent and a program coordinator, said the short course is designed to provide producers with the latest technical knowledge available. "We'll have everyone from feedlot operators to wildlife folks here to address just about any scenario a West Texas rancher could imagine," said Bomar. "We've tried hard to put together a quality program to really meet the

needs of our region's cattlemen. It'll be tough to find a program anywhere with as much practical information as this one offers. We're sure proud of the finished product"

The Abilene Auction located on Interstate 20 North will concentrate on marketing. Speakers and topics include a beef cattle outlook by Stan Bevers, Vernon-based Extension economist, and Randy Carson, Abilene Auction owner. Rex Bland, owner of Cal-Texas Feedyard at Trent, will join Carson for a quality and price live cattle evaluation session that will round out the evening.

The Ben Richey Boys Ranch, located on Loop 322, will feature Dr. Allan McGinty, Extension range specialist at San Angelo. He will offer a hands-on brush control demonstration entitled "Back to Basics of Range Herbicide Management."

April 1st is the last date for producers who want to sign up in the DCP program and select crop bases under option 4. After April 1st, the crop bases under option 4 will be deleted by the computer. The only crop bases left will be those under the old AMTA program, the 7 year program that just ended.

If you were not in the 7 year PFC program or you have increased your crop bases the last 4 years, April 1st is your last shot at saving those bases and using them in the DCP program.

For those only wishing to use option 1, which are the crop bases you had in AMTA, the final date for sign up is June 1st.
