The volunteer labor force is a requirement for the grants funds for the project.

growing response from teachers and students, the directors instituted a new award in 1995. The class with the most outstanding posters will be honored as the year's Outstanding Class and presented a rotating trophy plaque with a space for engraving the class name and year.

Mrs. Heather Lee's 6th grade was chosen Outstanding Class for 2002-2003. All the youngsters seemed to regard the award with enthusiasm and there was already talk among next year's Coke County 5th and 6th graders about plans to win the plaque for their class next time.

**ATTENTION PROPERTY OWNERS**  
 Property owners have certain rights that may reduce their property tax burden

**HOME OWNERS**  
 Persons who owned and lived in their home as their principal residence on January 1, 2003, may claim a residential homestead exemption. The filing of this document is necessary if the homeowner has changed homesteads since January 1, 2002, or has become eligible for additional exemptions since last year, or if the appraisal district has requested a new application. Homeowners may defer the portion of the tax on their residence homestead if the value of the home was raised more than 5% above the previous year. Although the tax collection is deferred, interest continues to run on the unpaid portion of tax at a rate of 8% per annum and the deferred tax remains a lien on the property. To apply for the deferral, the owner should contact Coke County Appraisal District.

**DISABLED PERSONS**  
 Persons who are disabled under Social Security law are entitled to additional exemptions on their residential homestead. Disabled applicants must apply with the appraisal district and furnish a determination letter from Social Security.

**PERSONS WHO ARE OVER 65 YEARS OF AGE**  
 Persons who are over 65 years of age may file for additional exemptions and a ceiling on school taxes for their residential homestead. They are also eligible to defer paying the tax, but the taxes continue to accrue during the deferral along with interest of 8% annually. No attempt will be made to force payment during the deferral period. Details and an application may be obtained from the appraisal district or the State Comptroller's Property Tax Division.

**DISABLED VETERANS**  
 Persons who have a service-connected disability and have been declared disabled by the Veterans Administration are eligible for additional exemptions on property they own. The declaration letter from VA is mailed annually, but the appraisal district needs a copy only in the first year of eligibility or if the percentage of disability changes.

**FARM AND RANCH OWNERS**  
 Farmers and ranchers may be entitled to receive an alternate method of appraisal determined by the productive income on the property. This method is available to farms and ranches raising crops or livestock or which are used as a wildlife habitat under State guidelines. An application for agricultural-use value and additional information is available from the appraisal district. Re-filing is necessary in the event of a change of use, or if requested to do so by the Chief Appraiser.

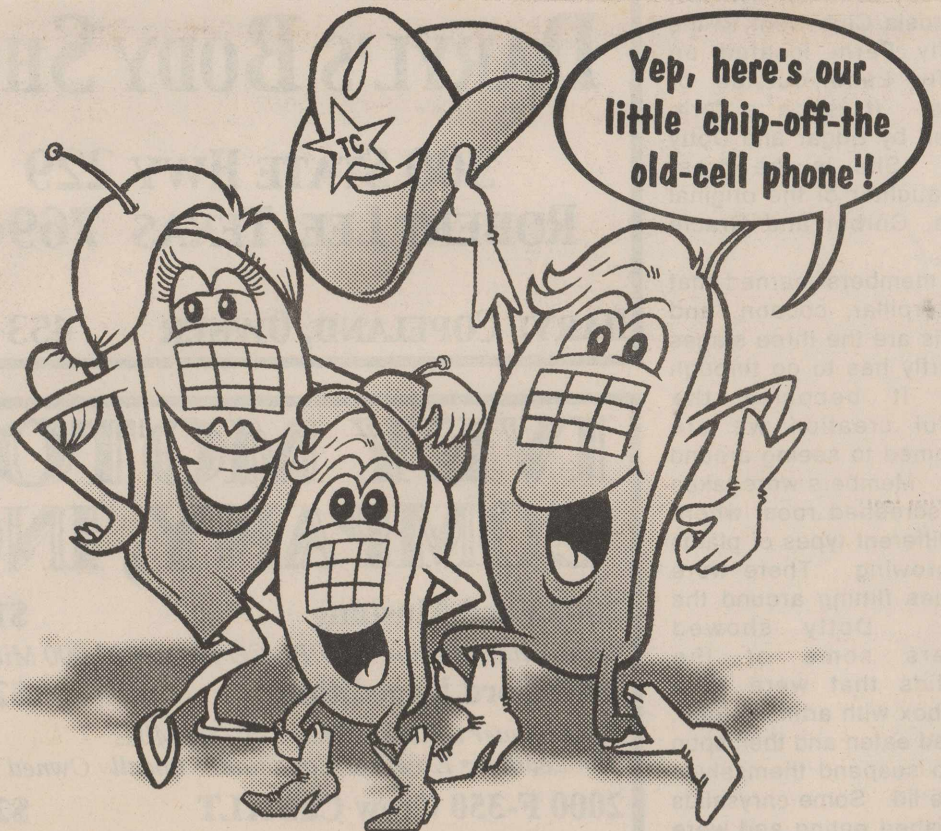
