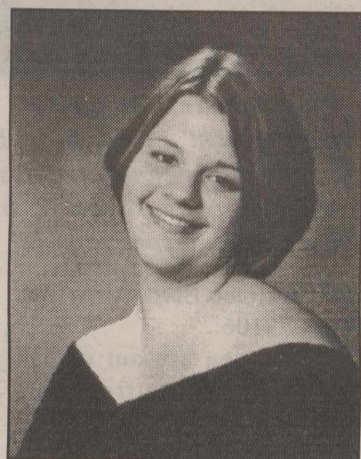
Ushers for the evening will include Ryan Martinez, Monica DeLaGarza, Blaine Dyess, and Justin Frazee.

The class will be honored with a Baccalaureate service this Sunday evening, May 23, 2004, at 7 pm in the auditorium of Bronte ISD.

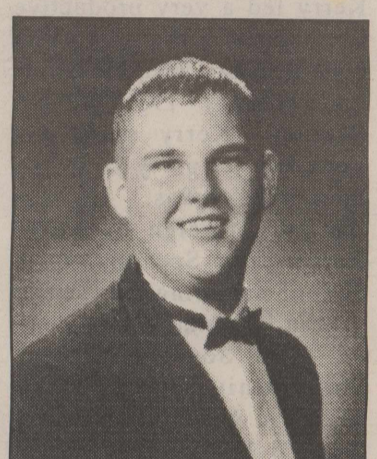
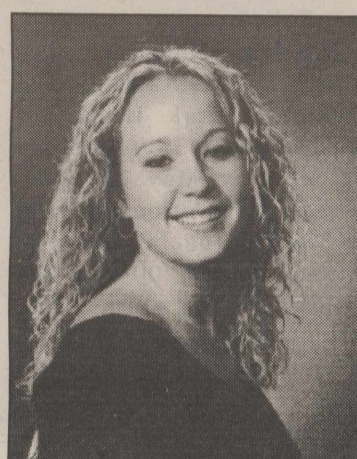

Local election results posted

Local elections were held this past Saturday, May 15. Opposed races in the county included the Robert Lee mayoral election, both school board elections, and the Bronte city council election.

The city of Robert Lee returned incumbent unopposed city council members Beth Prather (188 votes) and Bonita Copeland (167 votes) to their seats. Joe White, with 169 votes, defeated both Kenneth Green (36 votes) and Kimble

Middleton (8 votes) to become Robert Lee's new mayor.

Martha Ratliff (74 votes) and Charles Sonnenberg (102 votes) were returned to their seats on the Bronte City Council. They will be joined on the council by Scott Graves (78 votes). Incumbent Leslie Rolls received 57 votes. Mayor Martin Lee ran unopposed and was returned to office.

The city residents of Bronte also voted 105 to 1 to transfer \$85,000 from a 4A sales tax fund to be used for improvements to the swimming pool and city streets.

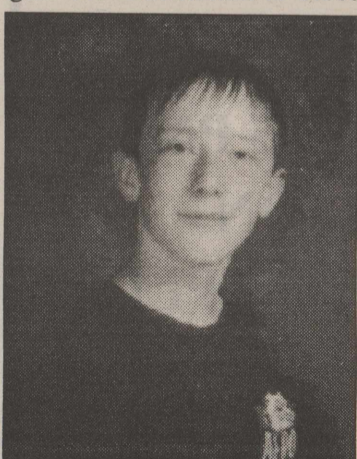
Bronte ISD had two vacancies to fill for full 3 year terms. Incumbents Terry Charles (130 votes) and Gary Acker (132 votes) were returned to the Board. Challenger Paul Williams received 65 votes.

Two three year terms on the Robert Lee ISD Board of Trustees were coming open. Incumbent Darrell Pitcock (100 votes) was defeated by Kevin Roe (164 votes) and Gayle Bolding (176 votes).

The county hospital districts, east and west, cancelled their elections due to no contested races.

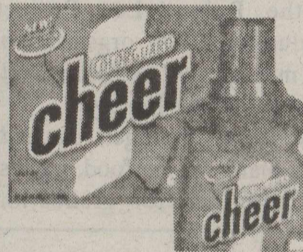

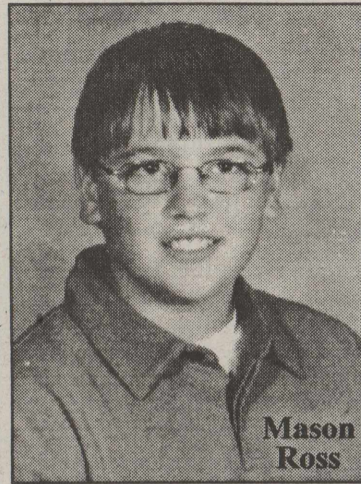
Mason Ross wins award

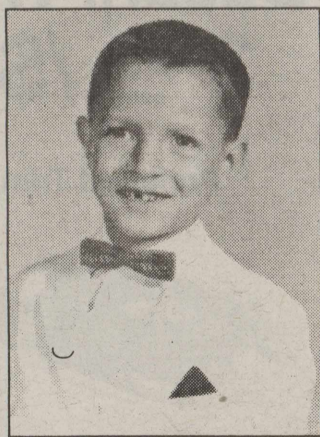

answer for continued outdoor watering to be available during the summer.

Two suggestions which are being considered to deter over-usage are: (1) to levy a fine of some significant amount if a citizen should be found watering outside the designated time-frame for outdoor watering. This would necessitate the assistance of a recognized enforcing agent.

The alternative to the "fine"

method would be: An excessive use charge applied to the water bills at the end of each month. A survey of how other cities handle "outside watering" is being conducted.

Please respond (in writing) what you believe to be the best solution to a difficult problem for your City Council to resolve. Citizen input is needed as soon as possible. Outdoor watering schedules and policy must be implemented soon.

Adding value to a calf crop pays regardless of the market

Adding value to a calf crop involves a bit of basic "cow-boyology," but is well worth the expense and effort. Husbandry practices common to large operators are often skipped by small operators. The result is dollars the producer should be getting, but isn't.

Most of these practices pay dividends every time, regardless of the market. Castrating bull calves in the No. 1 way to increase a male calf's market value. Most Texas producers sell their calves at 450 pounds or less to avoid having to do anything with the animals, but they usually forfeit considerable income by doing so. True, younger, lighter animals usually bring more per pound than older, heavier animals, but there's just not enough pounds there to maximize the animal's full market potential.

These younger calves are also

the most susceptible to getting sick. Castrate and dehorn those calves, even if you have to haul them to someone to have it done.

How much do buyers care whether or not they are castrated? Up to 450 pounds, they don't care. At 500 pounds they start caring and at 600 pounds they care quite a bit due to the added stress castration puts on an older animal. Dollar-wise, 500 pound un-castrated calves are usually docked \$3-5 dollars per 100 pounds. At 600 pounds, the penalty is closer to \$10-12 per 100 pounds. Horns on an older calf usually cost the seller about \$15 per head. It's the cow/calf producer's responsibility to castrate and dehorn his calves. Do it and pocket the money.

Bull calves gain faster than steers of the same class and size, but growth implants can change that ratio. Implants currently on the market cost \$1-1.25 per head. The added gain usually averages 20-30 pounds per head. Never implant bulls or the adverse effect on an intact male may cost the producer money.

Should you implant heifers you intend to keep? There's no incentive to implant replacement heifers. Does implanting affect a heifer's fertility? Researchers say 90 percent of the time there is no problem. If you are undecided whether or not you are going to keep or sell the heifer, go ahead and implant her for the 20 pounds or so gain you'll get.

Deworming nursing calves is nothing new, but few producers do it in this area. Timing is critical. May is the best time to deworm Texas calves because that's when moist, warm conditions make the parasites active and calves have the most potential for growth.

Deworming is as economical as implanting. Like implanting, it costs about a buck a head, and stacks up as much as 20-25 pounds per head advantage over non-dewormed calves.

Older cattle, cows and bulls benefit from an occasional worming, but across much of Texas it is best to allocate the dewormer to the calves and yearlings. They need it the most and will benefit from it the most.

Fly control is important, but frustrating. Misuse of pesticides has led to insect resistant to most products on the market. Producers using ear-tags should put one tag in both ears of every animal and remove them when they are no longer working. Tags should be rotated between an organophosphate tag and a type containing a pyrethroid to minimize resistance.

Cattle grub problems have increased in recent years. Treat with a pour-on or an injectable product in mid-summer.

Producers doctoring cattle for parasites should buy products which don't harm dung beetles. Research has found that the dung beetle contributes to pasture health and the reduction of parasites of cattle.

Vaccinations are more of an insurance policy than anything else. Check with a local veterinarian to find what is needed in a given area.

When a producer says "Yeah, they've had all their shots," 90 percent of the time that means they've only been vaccinated against blackleg. Leptospirosis is the most prevalent disease in Texas cow herds today. It, and a seven-way blackleg vaccine need to be in any good vaccination program of young cattle. Saving one calf will pay for an awful lot of vaccine at today's cattle prices.

Branding is another important practice most small operators skip. It is recommended to fire brand, since other methods are too easily botched.

Use a small, well-vented iron on the corners of the cow. Brand on the lower shoulder or upper hip away from the prime leather areas. There aren't many luxury car owners who would be happy sitting on a rafter-C brand or something similar every time they crawled into their car.

Do the numbers. Most of these practices will make you money every time. None are new, but many producers continually neglect them. If you can't do the husbandry yourself or don't have the facilities, haul the calves to someone who can process them for you. Chances are, you'll be happy you did, come sale day.

RLVFD news

He showed 2 films with segments on Electrical Burns, inju-

ries due to electricity, downed power lines, and downed power lines at a vehicle site. He spoke of the effects of current on the human body, electricity, and the do's and don'ts regarding high voltage and power at a structure fire.

Mr. Rosenquist gave a demonstration with a transformer, generator and a ladder, showing how electricity can burn through clothing, wet wood, leather gloves, electrical wires, and the human body. He answered the many questions the group asked. Everyone who attended felt it was very informative, and beneficial to the fire department.

Coke FSA announces soybean referendum

The U.S. Department of Agriculture will offer soybean producers the opportunity to request a referendum on the Soybean Promotion and Research Order May 3, 2004 through May 28, 2004. To be eligible to participate, producers must certify and provide documentation that shows that they produced soybeans and paid an assessment on soybeans during the period of January 1, 2002 through December 31, 2003. Producers may obtain a form to request a referendum from County FSA Offices either in person or by mail.

If you participated last year and want to participate in 2004, we encourage you to make an appointment and sign up. Signup will continue until June 1, 2004.

Keep in mind that if you cash lease a place, the FSA must have a copy of the cash lease on file before payments are made. For those producers wishing to sign a producer statement of the cash lease, they may do so but no payment can be made until after June 1, 2004.

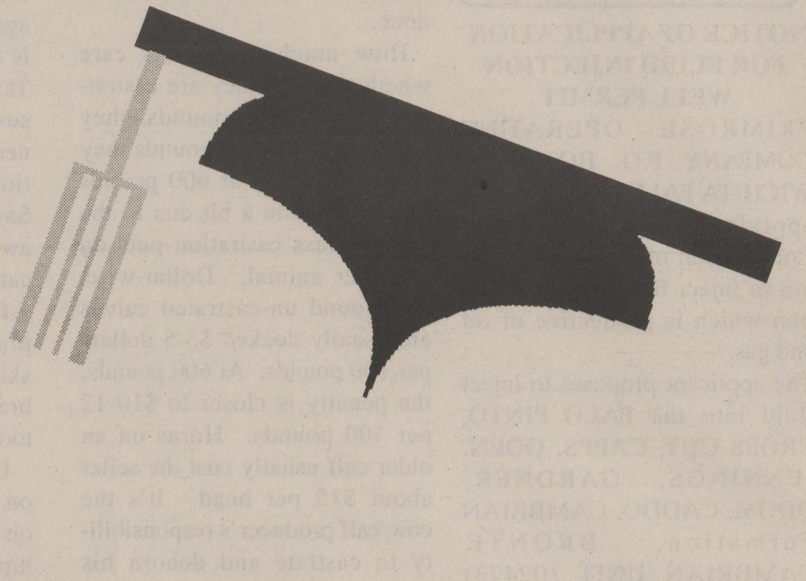
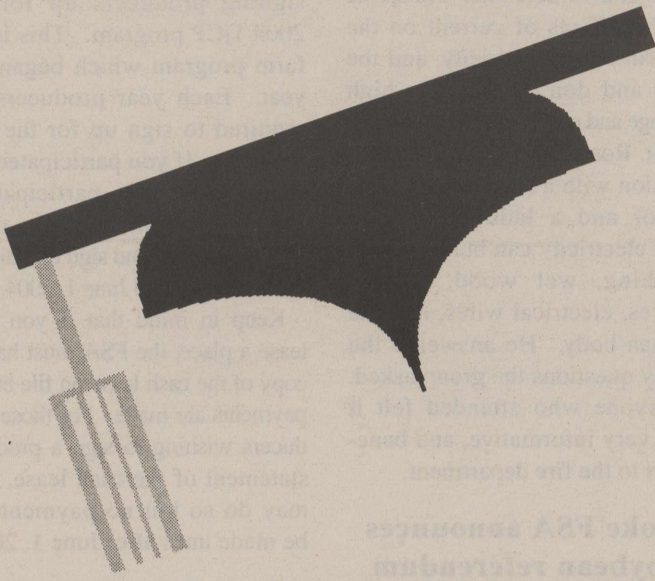
Call 453-2831, and speak to Office Personnel on an "as available" format; however, staff time will be limited because of other responsibilities which require their time.

Water conservation is the answer for continued outdoor watering to be available during the summer.

Two suggestions which are being considered to deter over-usage are: (1) to levy a fine of some significant amount if a citizen should be found watering outside the designated time-frame for outdoor watering. This would necessitate the assistance of a recognized enforcing agent.

The alternative to the "fine" method would be: An excessive use charge applied to the water bills at the end of each month. A survey of how other cities handle "outside watering" is being conducted.

Please respond (in writing) what you believe to be the best solution to a difficult problem for your City Council to resolve. Citizen input is needed as soon as possible. Outdoor watering schedules and policy must be implemented soon.
