Robert Lee Street Affair set for Oct. 2

The Fourth Annual Robert Lee Street Affair will bring fun, food, local folks and visitors out for a day of excitement and appreciation on Saturday, October 2, 2004.

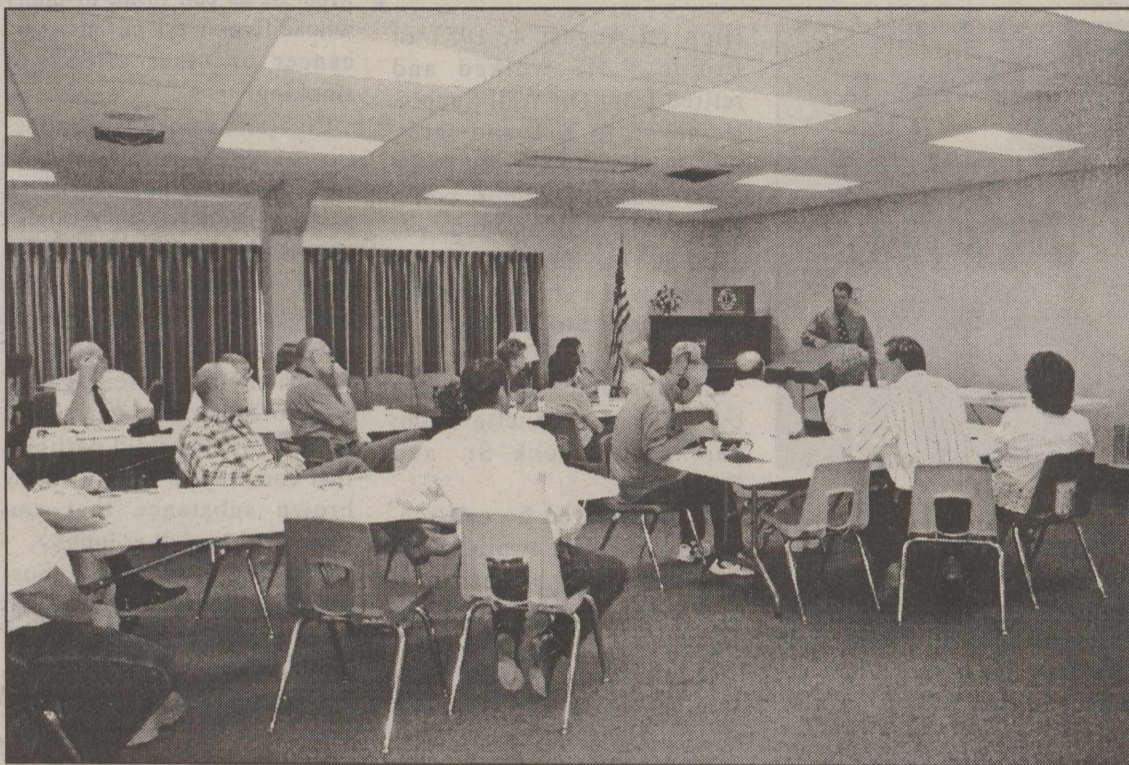
The popular Quilt Show will be held at Ivey Motors from 9 am to 3 pm on Saturday. Quilters are asked to check in on Friday, October 1, at 5 pm so that Nita Duncan, chairman, and committee can set up the displays. Quilters are asked not to show a quilt that was shown last year; however, quilts which have been in other shows are welcome. Categories are: Hand quilted; machine quilted; old quilts (at least 40 years old); quilted wall hangings; and junior quilts (made by anyone under age 18). There are 30 spaces for this year's event. Quilts should be picked up by 4 pm October 2. Any quilter is welcome to show. There is no entry fee. Ribbons and awards will be given in each category for first place.

Last year, the Duncans designed and made quilt

racks which allow the quilts to hang full length in a protected holder.

The 4th Annual Dessert Contest will also be held. Entry forms are available from May Williams, chairman, or Heather Williams, co-chairman, at 325-482-5252 (weekdays); 325-453-4572 (evenings); or Marilyn White (325-453-2026). Notification of entry will be appreciated by October 1, but will be accepted by 9 am on Saturday, October 2. Entries should be in covered disposable containers with a label. Label should show category and kind (i.e. Cake/Chocolate), but not the name.

The divisions are as follows: Adult: Cakes, Pies, and Cookies/Candy. One prize will be awarded in each category. Junior Division (any dessert is eligible): ages 5, 6, 7; Ages 8, 9, 10; and Ages 11, 12, 13. One prize will be awarded in each category, with winners announced at approximately 11 am. County officials from Sterling, Coke, Glasscock, Reagan, and Irion counties met at the Sterling County Community Center on August 24 to receive training on the new voting machines. Roger Tinnin with Hart Intercivic explains how to operate their electronic voting system to the group. The machines are called DRE's, short for direct recording electronics. According to Mary Grim, Coke County/District Clerk, the federal government is mandating the use of the DRE's by January 1, 2006. Mary indicated that the new machines will cost each county in the neighborhood of \$60,000 to incorporate their use. The DRE's are designed for the disabled, and the counties may be able to apply for up to \$24,000 from the federal government in grants which may help to defray some of the costs. The implementation of the new voting machines are leaving county commissioners' courts wondering where they are supposed to come up with the remainder of the costs for implementing the new voting system. The good news, according to Mrs. Grim, is that the new DRE's are very simple to operate and will be a good thing in the long run.

Nursing home administrator resigns position

Roger Alexander has resigned as administrator of the West Coke County Hospital District and Robert Lee Care Center. This latest action is effective immediately and comes as a direct result of the board of directors' decision "that no one be hired or terminated without the board's approval". The action by the board was taken at a regular board meeting held on August 24, 2004. It must also be noted that this action taken by the board was not listed on the agenda which was posted prior to the meeting, making the motion suspect as to its validity, according to state law.

This decision, according to Mr. Alexander, left he and his family "in legal jeopardy"

as to the penalties for non-performance of his job responsibilities. In a letter to the editor in this edition of *The Observer/Enterprise*, Mr. Alexander stated that "recent actions of the Board of Directors have created a very hostile environment that makes it almost impossible to properly carry out my duties." He also urged citizens to "continue to be involved in your care center and hospital district; so you can make informed choices and communicate them to whomever is in charge."

The nursing home is one of the largest employers in the county. What is even more important is that it is home to our loved ones and family. To date we have received no explanation from the board of directors for their actions. We would hope that this discussion would be forthcoming.

A smoking gun

We all know someone who has smoked and lived a long, healthy life. Although this is the exception, smoking is playing with a loaded gun. Most of us can think of many whose lives were cut short by cancer or other effects of smoking.

Cigarette smoke is a collection of over 4,000 chemicals; including 401 poisons, such as fingernail polish remover (acetone), cyanide (a rat poison), formaldehyde (an embalming fluid), and at least 63 distinct cancer-causing chemicals (carcinogens). It also contains tar, a conglomeration of solid particles that combine to form a sticky brown substance that can stain teeth and clog lungs.

Smoking is the single most important preventable cause of premature death in the United States. It is responsible for one out of every five deaths in the United States. On average, according to studies by the American Cancer Society, it is estimated that each cigarette takes seven to ten minutes from the smoker's life, and that does

not take into consideration innocent victims of secondary smoke.

About 87% of lung cancers are caused by smoking. Tobacco is the single biggest cause of cancer and accounts for more than half of all cancer deaths in smokers. Smoking is the main cause of chronic bronchitis and emphysema. Smoking is also associated with cancers of the mouth, pharynx, larynx,

esophagus, pancreas, uterine, cervix, kidney and bladder.

Smoking is also responsible for heart disease, lung disease and premature wrinkles. The use of tobacco products, including chewing tobacco, snuff and dip, is known to transfer the problematic chemicals into the body, weakening nearby cells before being carried by the blood to damage other parts of the body.

The Eden Bulldogs slipped past the Sterling City Eagles in the opening game of the season Friday night, 21-18. The Eagles scored three times, but the story of the game was the 239 yard rushing effort of Eden's Blaine Click.

Sterling City scored first on a 13-yard scoring pass from Cole Hord to Haven Martin in the first quarter. The extra point attempt failed. Eden responded with a 2-yard run by Blaine Click, with Chris Zepeda kicking the point after.

In the second quarter, the scoring all belonged to Eden, with a pass and a run, and the extra point kick for each, making the score 21-6 at halftime.

The Eagles came back strong in the second half, scoring once in each quarter, with quarterback Hord accounting for both with runs of 2 yards and 1 yard, respectively. Both extra point attempts were unsuccessful.

The Eagles had a chance late in the fourth to make a comeback, but Eden responded with just too much Blaine Click, and drove the ball to the 14 yard line before giving it back to the Eagles with just 2:14 left to play in the game.

The Eagles' next opponent is Irion County at home (Sterling City), with game time set for 8 pm Friday night.

The Sterling City Independent School District Board of Trustees met in a regular monthly meeting Thursday, August 26, at 7:00 pm in the O. T. Jones Auditorium boardroom. Those in attendance were: Trustees: Rosa Fuentes, Lonnie Horwood, David Aycock, Randy Hord, Tommy Wright, Jr., Cris Barber, and Pat Foster. Also in atten-

dance were: Superintendent Ronnie Krejci, Sharla Arp, Glenn Coles, Margaret Musick, Nancy Stevens, Louisa Arizola, Jacque Verastegui, and Joy Manning.

Minutes from the August 2, 2004 regular meeting and August 17, 2004, called meeting were approved as distributed.

The Board voted to amend the budget FYE August 31, 2004 for \$110,000.

The Board reviewed the local maintenance bills for August. The Board voted to pay the bills including those on the attachment.

Jacque Verastegui and Louisa Arizola addressed the Board expressing their disagreement with the consequences their sons had received because of their conduct at the Sterling City Kickoff on August 14, 2004.

The Board reviewed a letter of appreciation from Sonny Rios and family for the use of O.T. Jones Auditorium during Chief White-Eagle's funeral service.

Joy Manning, Sterling County Tax Assessor and Collector, made a presentation to the Board concerning the tax collections for the 2003-2004 school year. She reported that approximately 99.45% of the taxes for the District have been collected through the end of August.

Margaret Musick, Chairperson for the District Site-Based Committee, used a video presentation to discuss the Sterling City ISD District Improvement Plan for 2004-2005. The Board voted to approve the plan for the 2004-2005 school year.

Superintendent Ronnie Krejci reported that the administrative team would continue working on a policy

for student drug testing.

The Board conducted a hearing on the 2004-2005 budget. Superintendent Ronnie Krejci reviewed an analysis of the proposed official estimated budget.

The Board conducted a hearing on the proposed tax rate for the 2004-2005 school year. Superintendent Ronnie Krejci reviewed information regarding the proposed tax rate.

The Board voted to adopt the Sterling City ISD Official Estimated Budget (by Fund and Function) for FYE 8-31-05.

The Board voted to adopt the Ordinance Setting A Tax Rate of \$1.50 for Maintenance and Operation and \$0.00 for Interest and Sinking for the 2004-2005 school year.

Superintendent Ronnie Krejci reviewed the proposed agreement. The Board discussed options. The Board voted to approve the proposed agreement with Hunter Corral Associates.

Superintendent Ronnie Krejci reported that the District needs to purchase an estimated 360 units of WADA in order to equalize its wealth for the 2004-2005 school year. The Board voted to enter into Option 4 Agreements with Eden ISD and Wall ISD for the 2004-2005 school year.

The Board voted to enter into Executive Session at 9:28 pm. The Board reconvened in Open Session at 9:55 pm. No action was taken.

Superintendent Ronnie Krejci reported that he

intends to resume work on the Code of Conduct and Standard Operating Procedures for school board members.

The next regular school board meeting is scheduled for Monday, October 4, 2004 at 7:00 pm.

The Board voted to adjourn at 10:25 pm.

Volunteer training academy session set for September 21

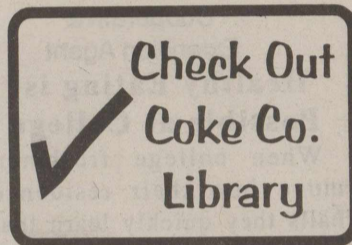
Just a reminder about Assault Victim Service's Fall 2004 Volunteer Training. New volunteer advocates will begin training next month on September 21, 2004.
