#### Local election filing begins Monday

Monday, February 7, 2005, is the first day a candidate may file an application for a place on the ballot for local elections to be held in May.

Applications for the city councils may be picked up at either City Hall. Filing deadline ends at 5:00 p.m. on March 7, 2005. The City of Robert Lee will be conducting an election for City Council positions for three (3) full-term members. Those members' terms expiring are: Nita Stovall-Duncan, Jayson Treadaway, and John Carver. The City of Bronte will be conducting an election for City Council positions for two (2) full-term and one (1) one-year due to a vacancy. Those members terms expiring are Gerald Sandusky and Elton Moore.

Robert Lee ISD will need to elect three trustees. The 3 year term of Mark Riley is expiring, as are the two 3 year unexpired terms with 2 years remaining currently held by Tom Sawyer, Jr., and Tod Reed.

Bronte ISD will elect two 3 year trustees. These offices are currently held by Kendall Gibbs and Scott Frasier.

Applications may be filed in the school administration offices.

Two 2 year terms currently held by Doris Sims and Alonzo Robbins are expiring in the East Coke County Hospital District. Filing will be held in the administration office of Bronte Health & Rehab Center.

West Coke County Hospital District will also need to elect two trustees for 2 year terms. These offices are currently held by Doug Wilkes and Judy Williams. Interested candidates may pick up and file their application in the administration office of Robert Lee Care Center.







## Coke Comme

by Hal Spain, Publisher I got an interesting call from a friend this past week, informing me of an ongoing problem we all need to be aware of. Roy Tinkler, who lives out toward Edith on Hwy. 158, called to let me know that his wife, Jennie Lee, had a close encounter with what will probably be determined to be a rabid bobcat. From what I can remember of the story, the bobcat came right in the yard and was attacking the barn cats and the family dog. In trying to protect the dog from the bobcat, Jennie Lee was scratched at least once on the leg.

The bobcat pursued the chase up until the time Jennie Lee entered the house, and the bobcat was still trying to get through the back door. After some time had passed, Roy was summoned, finally found his shotgun, and dispatched the bobcat.

The family loaded up and traveled all over San Angelo trying to get treatment, and Jennie Lee was finally given a series of rabies vaccine at Shannon Medical Center. cat were taken to Los

where the dog was treated.

Dr. Gary Hodges did the posting on the bobcat and sent the head, I suspect, to the Texas Veterinary Lab for rabies determination. Although the lab results are still not back, Dr. Hodges was quite sure that the bobcat was rabid for this reason. He indicated that he had never seen a bobcat brought in that had porcupine quills in his face that did not prove to be rabid.

If this was an isolated incident, it might not be such a problem. However, we have had several reported cases in the Bronte area, making this a countywide problem.

We are asking your continuing vigilance in reporting any animals which exhibit unusual behavior. I for one was one of those who thought that rabies was most generally prevalent during the summer months when range water sources dry up and infected animals start coming into town to water. Tinklers can testify that rabies is a continuing yearround problem.

Best of luck to Jennie Lee and her dog during their recuperation.







#### Texas Turf Tips Controlling Summer Annual Weeds--

Treatment Time is Near!

Summer annual weeds can by an eye-sore for all turfgrass sites. Weeds, in general, like to invade sites where turfgrass is weakened and where the overall density of the turf has been reduced. Therefore, maintaining a healthy, dense turf is the best approach for weed management. But, if you do have problems with these summer annual weeds, there are a number of products (preemergent herbicides) that can be used to control these pests.

Summer annuals like crabgrass, goosegrass, grassbur, and prostrate spurge germinate in the late winter/early spring season. They will survive into summer and then mature and die. These are plants that come back each year by seed. Control of these weeds can be accomplished, but one has to apply the correct pre-emergent herbicide at the proper time. In South Texas, applications may need to be made in late January/early February. In the northern sections of the

state, pre-emergence applications may be made in late February/early March. Hence, timing of the applications will depend on where live in Texas. Remember, we are controlling germinating seeds--so the pre-emergent needs to be put out prior to germination. Finally, please read the labels on all pesticides prior to application and calibrate your sprayer/spreader.

Calculating Surface Area in Your Landscape---Is it important?

Knowing how many square feet you have in your landscape is extremely important. It is the first step to take toward good environmental stewardship. Examples of times when you need this information include: applying a fertilizer, pesticide, topdressing material, irrigation water, and when purchasing seed, sod, sprigs or plugs during establishment of turfgrass.

In order to apply products in an appropriate manner with an environmentally friendly approach, one must take the time to measure and calculate the surface area of their site. It is an easy task to perform, it doesn't take a lot of time, and the calculations are relatively easy. In addition, you will normally only need to measure the site once. Record the information and save it. So, do the right thing and measure the surface area of your landscape. More importantly, use this value when applying products to your lawn! Encourage your friends to never again show up at the garden center to buy lawn care products without knowing the size of their lawn. They will thank you for it!!


#### Sawyer wins at Fort Worth





#### Backyard bird count slated Feb. 18-21

Participation is easy and every bird enthusiast in North America is encouraged to count the birds.

All you need is basic knowledge of bird identification and access to the Internet at home, a friend's house, local library, school, or anywhere you can get access to the Web. Website is http://www.birdsource.org/gb bc/index.html.

Here's what you do:

\*Count the birds in your backyard, local park, or other natural area on one or all four count days. You can count in as many different locations as you wish, just make sure to keep separate records and fill

The Observer/Enterprise Friday, February 4, 2005 Page 7 out a checklist for each area.

\*Watch the birds for at least 15 minutes on each day that you partipate. Recommended for watching is for a half-hour or more, so that you'll have a good sense of what birds are in your

\*How to count: Your data will be used by scientists to analyze bird populations, so it is very important that everyone count their birds in exactly the same way. On the day(s) that you count, watch your bird feeders or take a short walk (less than 1 mile) in your neighborhood or park.

For each kind (species) of bird that you see, keep track of the highest number of individuals that you observe at any one time. Use a "tally sheet" to help keep track of your counts. Your tally sheet should look something like the following:

\*House Finch - 3,5,3,1

\*High count = 5\*Blue Jay - 1,3,6,2

\*High count = 6

Be careful not to count the same bird over and over! Don't add another Blue Jay to your tally every time you see a Blue Jay at the feeder. You could be seeing the same individual again and again. If you record only the highest number of individual birds that you see in view at one

time, you're sure to never count the same bird more than once!

\*At the end of the day go to "Submit your bird checklist" on our GBBC web site. Fill out the questions about your location, local habitat, and count duration. Then enter your high counts for each species sighted on that day and location. You can submit one bird checklist for each day that you count or for each new area that you count in. For example:

\*If you count on four days at one location, you'd submit four different checklists.

\*If you count on four days at two different locations each day, submit eight checklists. And so on.

\*Problems getting access to the Internet? Many libraries, schools, bird clubs, and other community-based groups will be helping, too. If organiztions in your area are not already planning to help those without Internet access, you can help get something started!

\*Finally, after you've submitted you data, explore the web site. Check the results section to see other reports from your community, and what data come in from other areas. Have a look through the other pages, and find out other ways you can help

#### 2005 EQIP Sign-Up funding to end March 18

The USDA-Natural Resources Conservation Service (NRCS) in Texas announced that farmers and ranchers wishing to be considered for 2005 funding in the Environmental Quality Incentives Program (EQIP) should make sure they sign up by the close of business Friday, March 18, 2005.

EQIP was reauthorized in the 2002 Farm Bill to provide a voluntary conservation program for farmers and ranchers that promotes agricultural

production and environmental quality as compatible national goals. EQIP offers financial and technical help to assist eligible participants install or implement structural and/or management practices on eligible agricultural land.

In 2005, Texas will receive approximately \$64 million in EQIP financial assistance funds and approximately \$5.5 million in Ground and Surface Water EQIP funds.

"The funds will help farmers and ranchers improve the natural resources on private working lands in Texas," said Dr. Larry Butler, Texas NRCS State Conservationist. "They will be used to solve locally identified resource problems in each county and will also fund special statewide concerns recommended by the Texas State Technical Committee such as water quantity, water and air quality, wildlife habitat, and treatment of invasive species. This program offers cost share and incentives payments to producers applying approved conservation measures."

Butler explained, "Using national and state EQIP priorities, counties working through a Local Work Group chaired by the local Soil and

Water Conservation District recommended local resource concerns to be addressed, eligible practices, and costshare rates and/or incentive payments. This group also recommended cost-share rates for beginning farmers. In 2005, producers who meet the criteria as a Limited Resource Farmer or Rancher can receive 90 percent cost share for eligible practices. The group also recommended an application ranking process to prioritize applications


