More Coke County rainfall totals listed

by Hal Spain, Publisher As a result of our request for rainfall totals last week, we got a couple of responses from the areas we were needing to get a representative coverage of the county. The newest suspects

(rainkeepers, rainmen, gauge gatherers, meter measurers, or whatever name you would prescribe for these good volunteers) are Bruce and Fran Sonnenberg, longtime Bronte newspaper family members, and a new name for some of us, Pat Trevathan, who lives across from Mule Creek, 12 1/2 miles south of Bronte. I think Pat's totals for the first quarter of 2005 rang the bell for the most rainfall to date. In addition, Pat says Mule Creek is running now and has been since October. He also adds that there is not enough time in the day to mow all the weeds and grasses that this bountiful moisture has provided. Bruce and Fran's totals for the first quarter

are not too shabby, either, as both of these areas lead the totals for the year, so far. I would expect this trend to continue, with the east side of the county getting the most rainfall, with the area from the river south of Bronte to Maverick receiving the most rainfall during the year. It will be interesting to see how it turns out. Before I forget, the totals discussed above are included in the table below.

We don't want to end this week without some discussion of our bluebonnet activities in the county. 

CCSWCD Fish stocking program continues through May 6





A recent statewide survey shows an overwhelming majority of Texas registered voters support a school start date of September 1 or later and the majority also support school districts having the option to lengthen the school day and shorten the school year.

The Texas Interested Citizens Statewide Voter Opinion Survey, conducted by the Eppstein Group, found that 67 percent of the state's registered voters favor requiring all Texas public schools to begin their school years after Labor Day or during the first week in September.

Fifty-four percent of those polled favored allowing local school districts the option to lengthen the school day by 15 to 30 minutes to give students the option of a longer summer vacation or more flexibility with school breaks.

The survey also shows that Texas voters believe the quality of education in public schools is the single most important issue facing the state.

Tina Bruno, executive director of Texans for a Traditional School Year said she was not surprised to hear

1 or later school-start date. "Survey after survey shows Texans support a later school start date and do not support the trend in Texas to begin school early in August."

The majority of the 42,000 respondents to the web based school calendar survey sponsored by the School Start Date Task Force also supported a September 1 or later school start date, with the greatest number of respondents supporting a post-Labor Day school start.

A 1999 Texas Poll showed the majority of Texans supported a uniform school start date for alll Texas public schools and the majority thought the school year should begin around September 1, again with the greatest number of respondents supporting a post-Labor Day school start.

Currently, Texas law prohibits public schools from beginning instruction earlier than the week of August 21. However, the bill also allowed the Texas Education Agency to grant waivers to districts wishing to begin the school year earlier than law recommends.

The statewide telephone survey of 1001 randomly chosen Texas registered voters was conducted February 21-24, 2005. The survey has a margin of error of +/-3.2percent.



ORDINANCE #1138 REVISING AND AMENDING ORDINANCE⁻#1090 PASSED BY THE ROBERT LEE CITY **COUNCIL ON FEBRUARY** 22, 1999, ESTABLISHING A **NEW SCHEDULE OF RATES**

AND CHARGES FOR SERVICES RENDERED BY THE CITY'S WATERWORKS **SYSTEM**

WHEREAS, the cost of chemicals, materials, and utilities have increased to the point where the current schedule of rates is no longer sufficient to cover the increased cost, and

WHEREAS, the City Council seeks relief from this condition by an adjustment of its rates for services, and

WHEREAS, it now appears to the City Council that it is necessary and proper to prescribe a new schedule of rates or charges for services rendered by the City's Waterworks System;

WHEREAS, it is moved and seconded that said Ordinance be adopted;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF **ROBERT LEE AS FOLLOWS, TO-WIT:**

SECTION 1: That the rates or charges for the services furnished by the Waterworks System shall be amended as follows:

Service Charge of \$15.00 for disconnect/reconnect water due to non-payment of services.

Service Charge of \$10.00 for turning on/off water at customer's request during regular business hours.

A minimum charge of \$13.50 shall be charged with the maximum allowance of 3,000 gallons. Consumption of 4,000 and up to 9,000 gallons shall be charged \$1.75 per thousand gallons. Consumption of 10,000 gallons and thereafter shall be charged \$1.85 per thousand gallons.

Customers outside the city limits receiving water shall be charged a minimum charge of \$16.00 with the maximum allowance of \$3,000 gallons. Consumption of 4,000 and up to 9,000 gallons shall be charged \$1.75 per thousand gallons. Consumption of 10,000 gallons and thereafter shall be charged \$1.85 per thousand gallons.

Charges to the Coke County Water Supply Corporation and the Snead-Corbin Water Supply Contract shall be subject to the same increase imposed in the City. Section 1, as amended, becomes effective as of the May, 2005 billing. Section 6: This Ordinance will supercede any and all previous Ordinances regarding the rates of the Waterworks System of the City of Robert Lee. Section 7: By reason of the fact that the City Council considers the passage necessary for the economy and welfare of the Citizens of Robert Lee, it is hereby declared duly constituted by the City Council. 

Fort Chadbourne needs buttons


