Assuming that we all agree on that, let's ask ourselves a question. If we can talk this group into providing the leadership for getting the ball rolling on this consolidation topic, why shouldn't we utilize them? I would like to "challenge" this group to form a committee to lead the effort in discussing the feasibility of school consolidation. Said committee should be composed of school board members, administrative personnel, educators, businesspeople, parents, and others from throughout the county.

One issue we need to clarify. If this process proceeds,

voters in each district. The retired teachers group will only be responsible for initiating the discussion and hopefully moving the process along.

Earlier in the article I said something about discussing the need for consolidation; so we'd better address that next. Robert Lee's situation is perhaps the easiest to assess. Declining ADA (average daily attendance), which is the basis for how the money is passed out, along with some other issues concerning spending have put Robert Lee in a near-critical state of existence. This situation is not unique to Robert Lee, Bronte, or Coke County. Most all communities west of I-35 have suffered a population decline, mainly due to agricultural and petroleumrelated job losses. We are lucky in Coke County to have the hunting and fishing resources to help prop up our economy. Some communities have truly been devastated by this decline.

Bronte is in a little different situation with the added

income from the Coke County Juvenile Justice facility (their ADA counts toward Bronte's total). However, conditions at Bronte may not be as rosy as they might seem on the surface. What the legislature giveth, they can also taketh away; so these funds, plus the population levels at CCJJC, are not a guarantee, by any means. What is more important to the county is this: if Robert Lee decides they have to do something in the immediate future, and Bronte is not ready, Robert Lee may have to consolidate with some other school district like Water Valley or even Sterling City. If that should happen, it might be very difficult to consolidate within the county when that time should come.

One of the worst outcomes of this scenario is that Coke County kids might not be going to school in Coke County, and that is unacceptable to everyone involved.

The most beneficial aspect of consolidation is the fact Continued on Page 8

3 long blasts of the siren is the signal to take immediate shelter, preferably a sturdy building, storm cellar or interior room or hall. 1 long blast will signal the all clear.

The fire department utilizes the sirens, 2 blasts of the siren is a call for firemen to assemble at the station for a fire call or meeting.

### FSA taking signup for LAP

The Livestock Assistance Program (LAP) for 2003 in Coke County is in progress. The payment period is August 15, 2003 through November 26,

To sign up producers must furnish the livestock counts by weight for this time period. Livestock must have been owned for 90 days before they are eligible.

The Crop Disaster Program (CDP) signup is in progress for both Coke and Sterling County. This is for the 2003 or 2004 crop year. As of today there is no announced end to sign up. It is important to call ahead and make an appointment. We must have all of a producer's production records from crop insurance before we can sign you up. We have all the records on some producers and some we do not. Call ahead and find out if we have your records.

We are still taking signup for the farm program (DCP) for 2005. Producers are reminded that June 1, 2005 is the final date to be signed up. Producers may still sign up after this date but there will be a \$100.00 administrative fee charged per farm.

Because of the number of program signups going on at one time, it is VERY IMPORTANT that everyone make an appointment. Producers may come by the office or call (325) 453-2751 for additional information.

# **BISD** completes entry signs for community

Visitors, tourists and county favorites will enjoy a new introduction when they drive into Bronte from Highway 277 or from the Robert Lee Highway 158. Over the past two years the city of Bronte has been working together to create and design a slogan for the signs that will greet people when they enter town.

"Big Horns-Small Town-Great People" was the winning slogan for the city signs. High school students worked on a design for the signs. After a preliminary design was formulated, the students at CCJJC helped put the finishing touches on the signs. Lamar Advertising helped provide tips for graphic design to the students at the facility. A power-point presentation helped guide the students in finding the best representation for the billboards. The presentation and work with Lamar Advertising provided information for students at CCJJC to pursue careers in graphic arts while creating a visible benefit for the city and all visitors that enter Bronte. After making a few alterations and improving the picture, the graphic design was developed and processed. On May 18th, residents from CCJJC cleaned the area around the billboards so the signs could be hung. On May 26th, the new signs were hung by Lamar Advertising Company.

"It is amazing how many people contributed to this project," Michael Bohensky, principal at Coke County Juvenile Justice Center, commented. "When we first received the Title IV Service-Learning grant, this was a project that we wanted to help pursue. After two years of having input from just about everyone in the community, it is nice to see the finished project. It is also nice for the students at CCJJC to take a hand in something that makes them feel like positive contributors to the community. That is the meaning behind servicelearning.'

The students at CCJJC have contributed with many projects through the servicelearning program. Servicelearning students have prepared holiday baskets for the nursing home and have grown plants for the community. Projects from the program range from metal tables at the Bronte Park to little Easter bunnies for the nursing home. The students in the program also provided an open-house for the community at CCJJC on October 11th, 2004. This event provided a lunch and tour of the facility for the community. Each visitor was given a pumpkin for Halloween that had been painted by a student in service-learning.

Karena Prew, the current service-learning teacher, said "Attitudes have changed for many of the students toward people and community." One student in the service-learning program said, "The class has helped me work with people better."

Service-learning has worked at CCJJC because of the community involvement. The Chamber of Commerce for Bronte facilitated the sign-making project for the Annie Gill, community. former Chamber president, made the request for new city signs nearly two years ago and the project has been a collaboration of many people.

This summer CCJJC students will finish a three year project of writings and drawings compiled from students in the facility. The booklets will be available to the community at the end of June.

(Continued from Page 1) that all Coke County kids will grow up attending the same school, and the spirit of cooperation that will occur as a result. Imagine a unified Coke County pulling together for the betterment of the county, instead of the old Bronte - Robert Lee differences we continue to experience.

The next question is how to accomplish the consolidation. I'm sure there are better ideas than mine, but somebody has to suggest something so everybody else can poke holes in it. The people I talk with say not to bus the little ones in elementary school; so leave them alone and let them attend school right where they are. Now we get into the controversial portion of the proposal. I think, with their facilities, that Bronte is the logical choice for the high school. You can argue about that point all day, but at the end of the day, the facts will remain the same. That only leaves junior high, and I think you have to give those grades (possibly 6th, 7th, & 8th grades) to Robert Lee to make it as fair and equitable as is humanly possible. I think you would be surprised at how equitable this split would be in terms of total students enrolled in each school if this kind of consolidation is possible.

If we get that far along (and I haven't been run out of town), here are some more suggestions to make the transformation less traumatic. Let's take the varsity football team as an example. Play half the home games at Bronte, and half at Robert Lee. I even have a suggestion for the team mascot, as do many others, I imagine. Call the varsity squad the Coke County Corrientes, and you won't even have to



change the Steer and Longhorn logos up very much to match the new design.

Most important is the educational aspect of the change. This will help alleviate somewhat the problem of having seven kids in a freshman science class in Robert Lee, and eight others in the same class at Bronte.

This should result in a more efficient use of facilities and teachers.

What will make us more efficient and save money is also one of the negatives involved in the transition. Once we combine classes, we will need less teachers and administrative personnel. We will lose some teaching and administrative positions, and suffer a reduction of teaching families in the county, which will add to the loss of population, somewhat. There is always a downside when you have to make hard decisions, and this is a big one.

With the high costs of fuel, bussing and transportation costs are another negative to the new proposal. However, we bus kids from throughout the county and to ballgames and UIL competitions in all directions throughout the state already. I cannot imagine these costs going up astronomically, especially when you consider we will only be sending one bus to a particular competition instead of two, as we do now.

I know this is a very controversial subject. I also know I'm way off base with some of these suggestions, and I'm going to take some hits for some of them. As the old saying goes, what I know about the school business would fit in a thimble, and you'd still have room for your thumb. However, we need a starting place, and at least I've provided some ideas that everyone can shoot holes in.

Whatever we end up doing, we need some leadership, and we need it now. We don't have to make any long-term decisions right away. We just need to get the ball rolling, and if we get it rolling, maybe we can start it rolling downhill instead of the other direction.
