Robert Lee Street Affair puts best foot forward

Saturday's Robert Lee Street Affair hosted 60 booths, the RLISD Fall Festival, an air carnival, art show, quilt show, customized vehicle show, parade, bed race, dessert cook-off, Little Miss/Mister event, West Texas Cloggers, and a chicken roping.

An amazing job was done by volunteers working long hours to accommodate hundreds of visitors to Robert Lee and all for the purpose of showing off the town. Robert Lee put its best foot forward on Saturday. "Kickin Up Roses", Wildcat Mesquite and Taxidermy, This 'n That, and Ivey Motors all opened their doors for shows and shopping. Many businesses were out polishing windows and sweeping sidewalks the week before the Street Affair.

The Observer/Enterprise newspaper and bandstand area served as the center of activities with members of Driftwood, the local musician-restoration-investor group, coordinating announce-

ments with events and lending their equipment to entertainers throughout the day.

The art show chair, Charlotte McCabe Northcutt, presented a first place cash prize to Deone Roe of Robert Lee and a second place cash prize to Phyllis Poe of Bronte.

The first ever International Bed Race chaired by Susan Wellborn rivaled the Indy Speedway. Four entrants were judged by speed and creativity. Wheels fell off, occupants held on for dear life, human propellants broke into sweats, and the crowd cheered throughout the contest. The engineering expertise that produced the contestant beds was mind-boggling. Joe and Marilyn White served as judges which was an unenviable position given the creativity of the entrants. 

Coke County Veteran of C. B. I. Campaign, R.T. Caperton

After Pearl Harbor the Japanese overran the Philippines, French Indochina, Thailand and the Malay Peninsula overwhelming Brittish Singapore, seizing the oil in the Dutch East Indies. From Thailand Japan thrust into British Burma. Before Britain could mount a viable force, Japanese planes and troops began the battle of Rangoon December 23, 1941, which lasted 75 days. At that time, Americans, British, Dutch and Australians converged in Washington and formed the alliance "ABDA Command."

Churchill wanted China to stay in the war but he had concerns that well trained and equipped troops might be a threat later to British colonial possessions; primarily, Britain wanted to secure India. The . United States wanted to keep China fighting and use it as a springboard for an attack on the Japanese home islands. December 29, 1941, Roosevelt had his way and China became our ally and Generalissimo Chaing Kai - shek became Supreme Allied Commander of China.

China - Burma India Theater was set up and the theater quickly came to be called C.B.I. with headquarters split between the British in Delhi and the Chinese in Chungking. Joseph Warren "Vinegar Joe" Stillwell, a three - star general was an infantryman who believed that a ground war had to be won on the ground and an airforce would only "knock down a few Jap planes." Stillwell went to Asia as Senior American military representative. He was given several nearly impossible assignments. He was to oversee movement and allocating of Lend - Lease, serve as head of Chiang's staff and to train Chinese troops. Regarded as an outstanding tactician and an effective trainer of U.S. Army troops, he had spent 13 years in China and was fluent and literate in the Chinese language. He was tolerant of the Chinese but lacking in tact and patience. There was an apparently irreconcilable incompatibility of temperaments between Stillwell & Chaing Kai - shek. Chaing Kai - shek formed the opinion that American air power was needed to stop the Japanese who emed invincible. The fall of Burma left two major parts of the theater separated except by air. Cut off as the Japanese advanced, Stillwell decided to strike out for an airfield at Mytkyina. Moving in jeeps, trucks and a sedan with 114 people from nine countries, the roads gave out west of India. Hoping to find a train, he ordered his party to walk with what they could carry. When the railways were blocked by a wreck, there was one prospect, to walk to India. Leading his column in northern Burma, they walked an average of 11 hours a day. At the Uyo river their feet were so blistered they took to rafts until the bamboo poles gashed their hands and arms. With the morning coming, the pace had to advance. They covered 15, 17, to 21 miles a day reaching the Burma -India border on May 20, 1941, where an observer said Stillwell

looked like the wrath of God and cursed like a fallen angel. In 14 days the "boats in the mud" General had covered 140 miles. All of his party got to India following the old soldier who kept his promise to get them all out alive.

On Dec. 20, 1941, the Flying Tigers flew their first combat mission in China. They never had more than 55 planes and 70 pilots, they were daring in the air. So exalted was their reputation that many, including Chiang Kai - shek formed the opinion that American air power would defeat Japan. Actually, they did not compensate for losses in CBI as a whole.

The American leader of the Flying Tigers was Colonel Claire Lee Chennault. He was cut of much the same cloth as Stillwell, engaging, egocentric; a Louisianian of Hugenat descent. He was distantly related to Sam Houston and Robert E. Lee. Hunting and fishing had so weathered his skin that his pilots called him "Old Leatherface". Chennault was Stillwell's subordinate, he was an international hero who greatly influenced the conduct of the war in CBI.

Chennault retired from the service in 1937 when he was 47 years old and many of his superiors were glad, but the Chinese had invited him to come to China as an advisor. The Chinese Air Force had 500 planes in inventory and 91 fit for flight. He recruited 112 men from Army, Navy & Marine Corp. with Roosevelt's approval. They resigned to serve in China providing air defense in Western China and protecting con-

voys an the Burma Road. Once the United States was in the war, it would not support this "private air force". On July 4, 1942, the American "Volunteer Group" was reformed into regular Army Air Force with Brigadier General Claire Chennault in command.

Stillwell was planning the ground campaign in Burma, but he lacked finesse diplomatically. He proved to be no match for Chennault.

Despite allied squabbling, planning a Burma campaign continued. War material in China was never adequate. Neither Stillwell or Chennault were ever adequately supplied. To supply his army, Chiang Kai - shek had built a highway to Burma in 1937. The Japanese closed it in 1942. Stillwell described himself as impatient and vulgar. He was charged with building and opening the road. His chief engineer was Gen. Lewis Pick. In 1943, Pick told his troops, "The road is going to be built - mud, rain and malaria be damned!" Churchill felt the project was impossible.

He called it "an immense, laborious task, unlikely to be finished until the need for it has passed."

The old road going east 600 miles from Mang Yu in Burma to Kunming, China would be improved. A new 500 mile road would cut through the wilderness from Ledos to Mang Yu. Joining the two would provide an overland supply route from India to China and a path for a pipeline to fuel planes. 28,000 engineers and 35,000 natives worked more than two years on the Ledo - Burma Road. It was officially the Stilwell Road and in jest "Picks Pike" built at a cost of "a man a mile." Hundreds died of disease, accidents and Japanese attacks from snipers and planes. To keep China supplied during construction, Stillwell mounted an airlift from China to India over 14,000 foot peaks which claimed 607 supply planes. In total 13.5 million cubic yards of earth were moved to cut a road bed, enough dirt, reported the New York

Times, to build a wall ten feet high and three feet wide from New York to San Francisco!

Coke Countian R.T. Caperton was an American who served in one of the world's worst climates and most forbidden terrain in one of the greatest engineering feats of World War II. He has compelling memories of supplying fighting troops throughout the area as well as delivering animals, horses and mules, to the Chinese from Burma across the Himalayas to China. The job was hard and perilous.

Reaching their campsite along the Irrawaddi River in Burma, which is the largest river in Burma, and one of the largest in the world, being a quarter mile wide normally, after setting up camp for hundreds of men and corrals for hundreds of animals, a flood caused the river to overflow and flood camp. They had to start all over on higher ground. The monsoons could bring 30 inches of rain and last for weeks.

Although R.T. traveled throughout the surrounding areas, his headquarters was in Burma supporting the U.S., British and Chinese effort to defeat the occupying Japanese forces. He was commanding officer of a field depot in charge of supplying the Allied Forces with pack and remount animals. His command varied from 250 to 500 men including a veterinary company and a truck company. His commanding officer was the CBI Theater commander; therefore, he was given tremendous responsibility at a very early age. He received commendations for delivering animals into the battle zone in the best possible condition. He made numerous reconnaissance missions throughout the area, flew over 1,000 miles into southeast China, crossed the Himalayas (over "the hump") over

twenty - five times - checking troops for whom he was responsible and scouting ways to transport animals across the mountains. Twice he crossed the mountains on horseback and mule.

There were stories of passage around the world, riding trains across India, stories of warlords who ruled so much of that part of the world and stories of holy wars between so many diverse religions -Hindu, Buddhism, all the Chinese religions, Muslims from Pakistan, Afghanistan and India and tribal beliefs in the jungles. However, R.T. said he heard the Christian gospel preached by a tribesman in the jungle, accompanied by a hymn he had grown up with. Mothers tried to give starving babies into the soldiers' arms, there were great cruelties and unexpected kindness. They became global citizens with a comprehensive education of differences in the world and a better understanding of people who were nothing like Americans.





R.T. says one of his happiest moments was looking up and seeing Jay come out of the jungle, bandoleers across his chest, looking like Indiana Jones as they all did in pictures taken at the time



was while riding a mule into an area where elephants were working, having the mule, who had never seen an elephant, spot the elephants and take off running wildly.

One of R.T.'s longest walks was the evening when he followed a tiger who had been harassing the horses into a cane field. He had his Colt 45 at the ready, when he soon noticed that the cane had closed behind him and the tiger was nowhere to be seen, yet he knew the tiger knew where he was and his pistol was no defense against the tiger, it seemed like miles back out of that cane. They often saw tiger paw prints bigger than their hands, and the tigers' heads were bigger than their chests. Such prints caused a few to move their tent.

When a black trucking company was assigned to them, R.T. made it known that not one incident better happen involving prejudice or there would be hell to pay. Everyone lived together and ate together throughout the time the trucking company was there. Although segregation was still the norm to many of the soldiers, there was never any disagreement or incident of disrespect.

After serving from 1941 to 1946 he left active duty with the rank of Major, U.S. Army. As the Calvary had been mechanized in 1941, the Remount troops were the only mounted troops left in the army after 1943. R.T.'s troop was the last mounted troop in the Army at the end of the war.

Leaving the U.S. from Los Angeles around Australia to India, they would return home over the other half of the globe, through the Suez Canal to disembark in New York.

R.T. said that when the war ended, they broke camp, took care of the remaining animals and found their way back to civilization that he was sick and undernourished. When he reached India he was put in the hospital for a week before his scheduled ship was to leave Karachi (now Pakistan). In his determination to return home he slept with his gun under his pillow that week to ensure no one would stop his being on that ship. He just wanted to get back to Bronte. Of those left over 6 million of our men and women must have felt the same way.

R.T. said the hardest thing he did in the war was see his seventeen year old brother, Matt, leave from San Francisco shipping out to the Marianna Islands in the Pacific between the U.S. and Japan. R.T. was only 24 at the time, and had not left the States. He has said the next worst thing was writing letters to families to tell them someone would never come home.

Rueben Treavor (R.T.) Caperton was born to E.L. (Emmit) and Lillian Coleman Caperton on March 30, 1919 a half mile northwest of Cedar Mountain, three miles southwest of Bronte. He started to school in Clyde, Texas where his family lived for a time. He returned to Bronte after his first school year and was allowed to skip the second grade in Bronte. He worked on farms and ranches starting as a very young boy - plowing, threshing, doctoring and maintaining animals. He was riding a horse before he was old enough to work. After graduation from Bronte High School in 1936, R.T. graduated from Texas A&M University in 1941 with a BS in Animal Husbandry and Agriculture. With almost no financial support available to him, R.T. hitchhiked wherever he went and worked as a waiter in the commissary, Sbisa Hall, throughout his college years. He was promoted to headwaiter his senior year. The

and his animal and agriculture training would serve him well in the war to come. Due to the looming threat of war, the A&M class of 1941 was the first and only class to be commissioned into military service prior to receiving diplomas. This class included Frank Sayner of Bronte, one of R.T.'s best friends who went to El Reno with R.T., but was eventually shipped to the European Theater. Others from Bronte in classes behind 1941 were Tuny Glenn, Wink Kiker, Abe Caudle, Lewis Bridges and Ed Cumbie, all of whom went overseas or gave years of their lives to the war effort in the U.S.

R.T. was immediately stationed at Fort Reno in El Reno, Oklahoma, one of three U.S. Remount Depots. His troop was Troop A 253rd Remount Squadron. The U.S. Remount Service was a part of the Quartermaster Corp, which provided all supplies for the army. The Remount Service provided horses and pack animals to any part of the army needing these animals, including the Cavalry. One of the services furnished by the depot was stud service for horse breeding. Hard Tack, the sire of celebrity racehorse, Seabiscuit, was quartered at Ft. Reno.

During his stay at El Reno, R.T. married Zelma Slaughter of Robert Lee. Their first child was born there. Throughout this time R.T. crisscrossed the United States attending training schools in Virginia, Philadelphia, San Diego and others in preparation to embark overseas.

Although the war and anxiety about the future saddened the times, the men who were at Ft. Reno, many having been together through A&M and later serving overseas together, bonded in a special way. After the war those who came home had frequent reunions at the old fort, retelling their experiences riding horseback days on end along the North Canadian River at Ft. Reno and survival in a world they never imagined. To this day - 60 years later, R.T. receives phone calls from far and wide asking for the Captain or Cape. Their love and respect for each other has endured.

Following the war, R.T. taught agriculture classes in Coke County. Shortly thereafter, he, along with his father and brother, Matthew opened Caperton Chevrolet Company in Bronte. Over the years, he was a Chevrolet and/or Cadillac dealer in Bronte, Sterling City and Coleman. In later years, he entered into the Life and Health Insurance business and became the Area Manager for National Farm Life Insurance Company of Forth Worth. It reflects well on the character of a man who can sell to the people he counts as friends and lives among. He has always been active in the communities in which he lived. He served as the Mayor of Bronte, on the city councils of Bronte and Sterling City, on the school board of the Bronte ISD, and as President of the Coleman Chamber of Commerce. He is active in church membership and has served the First United Methodist Church in Bronte in various areas of leadership. He is a lifetime member of Lions International, a charter member of the Bronte Evening Lions Club and was awarded a certificate of membership for fifty years of service in 1997, as well as a certificate of appreciation for distinguished leadership and service in 2005. He was a member of the American Legion serving as Commander, a charter member and the first President of the West Texas A&M Club and is an active member of the Texas A&M Association of Former Students. He




