



Cooperative **Extension Agent** How to select a

pumpkin and pumpkin carving tips

Here are the basics to good pumpkin selections and carving.

#1 Go to your local pumpkin patch or pumpkin reseller. Don't go too early, since you want your pumpkin to be in good shape when Halloween arrives.

#2 Select a pumpkin that best suits you. For the stencils you buy at the store, bigger is better. If you think you want round features, you'll want a bigger pumpkin. For evil slitted features, try a tall narrow one.

#3 Pick up the pumpkin and examine it from all sides. Reject any pumpkins with blemishes such as white mildew, brown stains or wormholes.

#4 Pumpkins without bruises and cuts last longer (just like an apple).

#5 Examine the stem. If the pumpkin's stem is loose or has evidence of rotting don't buy it. Also, don't carry your pumpkin by the stem. They break easy!

#6 Knock on the pumpkin. It should sound hollow when

#7 If you're using your own design, try drawing it on a piece of paper first.

#8 If you're using your own knives remember to use STURDY knives and spoons. Ice cream scoops are great and so are ice picks.

#9 When you cut into the top, remember to make a special design to make it easier to put the top back on!

#10 Get all the guts out! Don't scoop your sides too thin. Create a nitch in the bottom for easy placement of a votive candle (put the votive candle in a glass jar it's safer and they last longer).

#11 Pumpkins usually only last around a week, give or take. This is because of of a carved pumpkin with a from drying out.

Stories of Coke County Veterans

Dad's Memories

By Donald Francis Pruitt I flew as the engineer in a B24 bomber in the 93rd bomb group, 328th squadron of the 2nd Air Division, 8th Army Air Corps, based in Norwich, England during World War II. We flew 30 missions before we were allowed to rotate home. Many, many people never made 30 missions, but we did without losing a single person.

On one mission, our plane got hit going over Zuider Zee, Holland, got one engine knocked out, and decided we couldn't make our mission, the rest of the squadron was going off and leaving us because we only had three engines, so we jettisoned our bombs, turned around, and called for an escort. The P-51s came and escorted us. When we got hit, we were at 32000 feet, and we began to lose altitude at the rate of 200 feet per minute. When we got low enough so that the air was thicker, our rate of altitude loss slowed to 100 feet per minute. We got over the North Sea, we discussed ditching, but we knew our survival rate was only about 17 minutes and then hypothermia would set in and we would freeze to death. So we decided we would ride the plane on in. Then another engine blew a cylinder and we had to feather that, so we only had two good engines. We were low enough now that we could see the whitecaps on the water, but we still hadn't jettisoned anything but the bombs. We still had that option, but we felt we wouldn't have to use it, because we began to see the shore and we thought, "I believe we're gonna make it". We could see there was a beach, where we could land if need be. But on top of the cliffs there was an air base that belonged to Britain. We weren't allowed to land there, but we didn't ask permission. We came so close to hitting the cliffs that when we cleared them, you could see the grass moving as our air "wake" caused it to wave in the wind we made. We couldn't have been more than 40 feet off the ground. And as we approached the air base and lined up with the runway, suddenly we could see another airplane taking off, coming right at us. My captain, named Dunlap, just moved over off the runway and set the plane down on the grass. The bomb bay doors were open, and we couldn't get them closed due to damage to the plane. I pushed the knob to bring the wheels down for landing, and checked to see if they locked. I couldn't tell, so I visually checked, but still couldn't tell. Three seconds later, we landed. To my (and our) great relief, the wheels had locked. The ground tore the bel-

ly of the plane to a heap of twisted metal because of the open bomb bay doors. So there was no exit to the bottom of the plane, and we all exited out the top of the plane. That let us out on the wing, and we ran down the wing and all of us just jumped off the wing getting out of that thing. It was dangerous, but at that moment our only thought was to get out with our lives. Fortunately, the plane did not catch fire.

The British met us and told us we weren't supposed to land there, that this was a top secret base. Since we had crash landed, they quickly put us in one of their planes and took us to our base in Norwich.

Another time our mission was Nuremberg. We approached our target and our bomb load wouldn't deploy. Try as I could, with what I had, pliers and screwdriver, I couldn't get the bombs to release, so we had to fly all the way back with them. They were the 2000 pound bombs, and you couldn't get the doors shut around them, so it created drag and used that much more fuel. They just gave you enough to get there and have an eyedropper full when you got back. So I was watching the fuel and determined we could make it across the channel but not back to Norwich to save our necks. I just sat and watched the gauge but didn't report to the captain, just sat and waited. We saw the white cliffs as we approached the English coastline. I slipped up to the cockpit and told the captain, "As soon as we clear those cliffs, you find us a place to set down, 'cause we don't have any gasoline." He said "What?", totally surprised. I repeated to him in almost a whisper, "We're out of gas!" So he found the nearest base (there were bases all over) and landed and taxied up to the hangar. We had 27 gallons left. This base gave us the gas we needed to get back to Norwich.

There were seven different times our plane was hit badly enough to abort our mission. It was my responsibility to see to it that we got home. Several times we had to land at a base not our own, but each time we made it back to Norwich. The last mission we flew, our 30th, they aborted, and everyone turned back for base except for us; we didn't get the transmission to abort. So we went on, dropped our bombs, and came back. The brass didn't believe we actually made the target and bombed it. But when the air reconnaissance came back, it proved we caused damage. We were the first lead crew in 7 months to make thirty missions, and we were allowed then to go home.

I attribute the fact that I got home in one piece to the grace-

of God and the prayers of my mother. She tells that she made a bargain with God that if He would let her boys come home alive, she would serve Him the rest of her life with all of her might. I am grateful to her for all her prayers and the prayers of everyone else in America at that time. Mama is now 101 and still serving the Lord with all her might.

The pair flew from Midland to New Mexico where their goal was to attend several days at the Albuquerque International Balloon Fiesta. On the first weekend, the fiesta featured 700 balloons, 900 pilots, and thousands of spectators. Highlight of the trip was a balloon ride high over the city and countryside.

Albuquerque has grown into a large city over the last few years and offers something for every interest. The friends took several side trips including a trip to the world's longest aerial tramway to Sandia Peak. Temperatures were in the low 40's at the peak. The tram held 45 passengers.

The travelers rented a car and drove to Santa Fe and on the Hyde Park Ski Resort to enjoy the mountains where the aspens were glorious with color.

Another enjoyable time was



artist Georgia O'Keeffe. They shoppped around the plaza and visited the several-hundred-yearold Loretta Chapel where the famous staircase was built later. The free-standing stairs were thought divine by the sisters and the priest because they had no means of support, contained no braces or nails. They could not get into the loft and were told by carpenters it was not possible. A man came out of the desert to the chapel and offered to construct the staircase with a few

the magnificent staircase and disappeared.

The two took a guided tour to the Sky City Pueblo of Acoma, a mesa settlement high atop a mountain, to protect inhabitants from invaders. It is the oldest inhabited settlement in the United States. Sixteen families now live on the mesa with no running water or electric power on top. A road now takes visitors up to the Pueblo village.

NOTICE TO TAXPAYER

Pursuant to Texas Transportation Code Chapter 258, the Commissioners Court of Coke County, Texas intends to consider the adoption of an official county road map.

The proposed official county road map will be available for viewing thirty days prior to the public meeting during regular business hours at the Coke County Courthouse in the District/Clerks Office.



October is National Breast Cancer **Awareness Month**

With the fall season now upon us, it is important to remember that October is National Breast Cancer Awareness Month. Today. breast cancer is the most common cancer among women in the United States and the second leading cause of cancer death among North American women, according to Jan Yanez, Family and Consumer Sciences Extension Agent in Coke and Sterling Counties. Unfortunately, many women with breast cancer do not even know that they have cancer until it is in its advanced stages. it is estimated that 1 in 8 women will be diagnosed with breast cancer in their lifetime, and 1 in 30 women will die of the

So what can we do to decrease our risk of dying of breast cancer? Early detection via health screenings, such as mammography, is an important step. Screening examinations can detect breast cancers early, before symptoms occur, which may make it easier to treat the disease. Screening involves getting mammograms, clinical breast exams, and self breast exams, which are optional. There are many factors in predicting the chances of survival of a woman who is diagnosed with breast cancer, but finding the cancer as early as possible greatly improves the likelihood that treatment will be effective.

When should women starting screening for breast cancer? If you are over 40 years old, you need a mammogram every year. A mammogram is an x-ray of the breast that usually involves two views, or pictures, of each breast. Mammograms help find lumps or growths that are too small for you or your health care provider to feel when

Additionally, women who are younger that 40 and have had breast cancer or breast problems or have a family history of breast cancer need a mammogram once a year.

A clinical breast examination is an examination of your breasts by a health professional, such as a doctor, nurse practitioner, nurse, or doctor's assistant. This exam is also known as a CBE. Clinical breast exams should be part of a periodic health exam, at least every three years for women in their 20s and 30s, and every year for women 40 and over. During your CBE, your health care provider may tell you how to perform a breast self-exam, or BSE. By regularly performing BSEs. you will learn how your breasts normally feel, and you will be able to report any changes in your breasts to your health professional as soon as you find them. a cancer. You may choose not to do BSEs, or you can just do them occasionally.

Remember, the most important screening tools we have are mammograms and clinical breast exams. To reduce your risks of dying from breast cancer, you need to follow the guidelines on when to get them. Taking charge of your health now can lead to a healthier tomor-Start by getting screened this month in recognition of National Breast Cancer Awareness Month.

Dove season ends October 30


By: Joan Davis Current dove season has about three weeks to run and will close on Oct. 30 in our Central Zone. It has been successful in some areas of the county where seed crops were planted or sunflowers were plentiful. A dry September helped the water hole hunting, but the season

hasn't lived expectations.

Javelina season opened Oct. 1 and ends Feb. 26, 2006. Limit is 2 per season.

Deer and turkey archery season lasts until Oct. 30. Heavy cover might work for or against for those hunts. They can't see you but you can't see them either. Turkeys are everywhere, particularly young birds.

It looks like the upcoming quail season may be the highlight of fall hunting, open Oct. 29 - Feb. 26, 2006. Daily bag limit is 15 birds statewide. We've not had to worry about killing too many birds locally for years. Now, if you drive around on country roads, quail are just running ahead of your vehicle with great numbers of small birds. I have seen more Bobwhites than Blues on this side of the county.



The Halloween Parade in downtown Robert Lee will begin Wednesday, October 26th at 10:00 am in front of the library. All Headstart students, all three to five year olds in Coke County, parents and caregivers are welcomed to trick-or-treat throughout the downtown area.
