### Conservationists of the Year

Grass covered rangeland, adequate water distribution for both wildlife and livestock, abundance of healthy wildlife, and quality, untamed, crossbred cows, such as Curly, Spot and Nancy are just a few factors that help label Kent and Juanette Gentry successful conservationists. Coke County SWCD is honored to recognize these two stewards of the land. The Gentrys established permanent residency in Coke County in 2001 after owning property here since 1989. They are very active members of the First United Methodist Church of Bronte, where Kent serves as Chairman of the Board of Trustees and Juanette serves with Kent on the Administrative Board. She serves on several other committees also.

The Gentrys ranching efforts began with a 270-acre tract. Abundant forage and good fences were two of the things that made this tract desirable. The Gentrys recognized prickly pear infesta- · Gentry on a job well done. tion and water distribution as potential problems. They give credit to a close friend and retired NRCS employee, Eddie Braswell, for introducing them to the Environmental Quality Incentives Program (EQIP). Their first EQIP contract helped with aerial treatment of mesquite and prickly pear and water distribution. An 80% kill on both pear and mesquite coupled with two troughs and 2972 feet of pipeline were the beginning of the Gentrys successful conservation efforts. The Gentry's purchased additional adjoining and surrounding property to supplement their original tract. Unfortunately, these additional acres had been neglected over the years. Brush management targeting cedar and mesquite, followed by Range Planting, were the first steps in rehabilitation of these new acres. A mix of bluestems, wilman lovegrass, blackwell switchgrass, indiangrass, sideoats and green sprangletop proved to be a good combination for the sandy loam soils. Across the ranch, the Gentrys have planted over 100 red oak, live oak and pecan trees both for beautification and to benefit wildlife. Other improvements completed with no government assistance include mechanical treatment of juniper; individual plant treatment of yucca and brush choked fence lines, silt removal in ponds, and installation of more than

The Gentrys, working with NRCS, developed a brush management plan incorporating travel ways and cover for wildlife. While large amounts of mesquite and juniper were removed, areas bordering creeks and draws, along with hillside slopes where attrac-

# Don't get hit with a penalty! "Render" your taxable property by April 16th.

A "rendition" is a report to the appraisal district that lists all the taxable property you owned or controlled on January 1st of this year.

### Who must file a rendition?

You must file a rendition if you own tangible personal property that is used to produce income such as the inventory and equipment used by a business. If you render late, don't render or file an incomplete or false rendition, a 10% to 50% penalty may be imposed.

### Are there any advantages to you?

The advantages of filing a rendition are:

You give your opinion of your property's value. The appraisal district must notify you in writing of any value change and explain how you can protest that value to the appraisal review board.

You record your correct mailing address so your tax bills will go to the right address. If your bill is mailed to the wrong address, the law still holds you responsible for paying your taxes on time or paying extra charges for late payments.

You can also file a "report of decreased value" to notify the appraisal district of significant depreciation of the value of your property in 2006. The district will look at your property before assigning a value in 2007.

### When is the deadline to file?

The last day for filing 2007 renditions is April 16. You can get an automatic extension to May 15 if you ask for it in writing on or before the April 16 deadline. The chief appraiser may grant an additional 15 days after May 15 for an owner who shows good cause in writing.

# "Productivity appraisal" may lower the property taxes on your farm, ranch or timberland!

Texas law allows farmers, ranchers and timber growers to pay property taxes based upon the "production value" of their land rather than on market value. This "productivity appraisal" means qualified land is taxed based on its ability to produce crops, livestock or timber - not on its value on the real estate market. And it can mean substantial property tax savings.

### When is the application deadline?

If your land has never had a productivity appraisal or you are a new owner, you must apply to your local appraisal district by April 30 to take advantage of this benefit on your 2007 property taxes. You may get up to 60 extra days if you have good reason and ask for it by April 30. If you miss this deadline, you may still be able to apply, but you will pay a penalty. Check with your appraisal district office.

### Do I need to reapply annually?

If your land already receives agricultural or timber productivity appraisal, you normally do not need to reapply unless the chief appraiser requires you to do so. If a new application is required, the appraisal district will notify you

# A variety of homestead exemptions could lower your property taxes!

A homestead exemption lowers the property taxes on your home by lowering its taxable value. If your home is valued at \$50,000 and you receive a \$15,000 homestead exemption, your home will be taxed as if it were worth \$35,000.

Who qualifies for an exemption?

Anyone who owns a home on January 1 and uses it as a primary residence on that date is entitled to a \$15,000 homestead exemption to lower school taxes this year...and it doesn't matter if your home is a house, condominium or mobile home. Counties, cities and special taxing districts may also offer homestead exemptions.

Are other exemptions available?

If you are disabled - or if you're 65 years or old or older you are entitled to an additional \$10,000 school tax exemption on your home. And if you qualify for the over-65 or disabled exemption, you're also entitled to a permanent, locked-in "ceiling" on the school property taxes on your home. (The county, city or junior college may adopt a tax ceiling to lock in 2006 taxes as the highest amount for 65 and older or disabled homeowners.) The over-65 homeowner's school tax ceiling transfers to the surviving spouse, if the spouse is 55 years of age or older at the time of death and lives in and owns the home. The age 65 or older homeowners (or their surviving spouses 55 years of age or older) also may transfer the percentage of school tax paid. based on their former home's school tax ceiling, to a new

Do I have to apply each year?

No. If you had a homestead exemption on your home in 2006, you won't need to reapply for 2007 unless your chief appraiser requires it. However, if you haven't received an exemption on your present home - or if you've moved to a new home - you'll need to file for an exemption for 2007. If you are 65 this year, you may file for the age 65 or older exemption up to one year after the date you turned 65. And if you become disabled, you need to file for the disabled person's exemption.
