



### **Check Out Coke County** Library

From the Southwest Educational Developmental Laboratory comes the following description of reading:

Right now as you read this passage, your occipital cortex is processing the information you are encounteringthe words, the letters, and the features of the letters; your neocortex is processing the meaning of the text you're reading, the words, the sentences and the big picture and relating this to what you already know. Meanwhile, your temporal lobe is processing all of the "sounds" associated with reading. Even though you're reading silently, the areas of the brain that process speech sounds are working as though you were listening to someone speak.

All of the above actions can be documented with a MRI or a PET scan. Never let it be said that reading is "passive." Reading is a workout.


#### Family Fun for Everyone with TMRC








