



Preparing for a Smooth Digital Television Transition

On Thursday, February 7, an AMBER Alert message flashed across TVs all over Texas, as the Emergency Alert System (EAS) broadcast information on a 5year old Austin boy who had just been abducted. Thanks to the swift action of authorities and implementation of the AMBER Alert system, the boy was safely recovered thirteen hours later and returned to his family. For more than 40 years, variations of the EAS have worked in concert with radio and television broadcasters, cable companies, and satellite providers to inform the public of emergencies. Today, it warns citizens about severe weather hazards, helps mobilize communities to search for and recover kidnapped children, and enables the government to immediately address the nation in the event of a national emergency.

One year from now, on February 17, 2009, the nation's full power broadcasters (large TV stations covering multiple cities) will switch from an analog to a digital broadcasting format. This change will dramatically enhance the clarity of television broadcasts, resulting in less interference, sound. Postpone major purchases (car, vacation, new clothes) and trim smaller expenses: Avoid restaurants and cook at home; cancel cable TV; wear a sweater and turn down the thermostat - there are hundreds of ways to save money.

Have a rainy-day fund you could live off for at least three months.

Curtail retirement savings. If you're still employed but fear the worst, this may be the one and only time it makes sense to temporarily halt your 401(k) plan contributions. You may need that money to survive the next few months and early 401(k) withdrawals come with steep penalties. Besides, you may be able to make a lumpsum contribution later if it was a false alarm. Consult a financial professional about your particular situation and if you don't know one, www.plannersearch.org is a good place to start your search.

Ask about severance benefits. If you're laid off, find out what benefits are available. Many employers offer severance pay or help with COBRA health insurance premiums; however, they have no legal obligation to do so. (Continued on next page)

Many companies also provide outplacement counseling, which may include professional assistance with resume writing, interview skills and job searches, or even office equipment usage.

If your company doesn't offer outplacement, visit www.careeronestop.org, a U.S. Department of Laborsponsored website featuring career resources and connections to local career centers that provide employment and training opportunities. AARP also has a comprehensive guide to surviving job loss, including discussions about age discrimination and employee

(www.aarp.org/money/career s/jobloss).

Apply for unemployment benefits. If you become unemployed and meet certain eligibility requirements, you qualify unemployment insurance while looking for a new job. www.servicelocator.org/OWS Links.asp for details.

Polish your resume. You may be competing against hundreds of other job applicants, so make sure your resume stands out from the crowd. It should accurately reflect your accomplishments and show potential employers you have the experience and qualifications they seek. Use concise, strong language and an organized appearance. It's a good idea to update your resume regularly, especially after a promotion or changed frequently with either soap job responsibilities.

Alert your network. Let family and friends know you're looking; they may sneezes; know about opportunities or spread the word on your behalf. Seek out networking events sponsored by the Chamber of Commerce, local colleges, trade associations

or other business and social organizations volunteer work.

Track job-search expenses. If you itemize income tax deductions, many job-searchrelated expenses are deductible, including resumes, business cards, phone calls, unreimbursed job interview trips and career counseling.

Flu Vaccine, Personal Precautions Offer Protection

With flu classified as widespread in the state for the last two weeks, Texas Department of State Health Services (DSHS) officials are reminding people to take precautions to reduce the risk of getting and spreading the viral illness.

According to health officials, getting a flu vaccination is one of the best ways to prevent getting and spreading the illness. Vaccination is recommended for people ages 6 months and older. Flu vaccines are available in shot and nasal spray forms. Only healthy people ages 2 through 49 years who are not pregnant may receive the spray form.

DSHS health officials offer the following additional precautions:

- Wash your hands and water or an alcoholbased hand sanitizer;
- * Cover your coughs and Stay home if you're sick.

The Texas flu season typically runs October through March.

The flu vaccine, which takes about two weeks to become fully effective, can be given at any time during this period. People wanting the flu vaccine should call their health care provider, local public health department, 2-1-1 or check online at www.211Texas.org about availability.

Flu is not a reportable condition in Texas, but DSHS relies on reports from a surveillance network to

classify flu activity in the state. The widespread classification applies when there are increases in flu-like illnesses and recent laboratory-confirmed flu cases in at least half of the state's regions.
