Preliminary figures from Texas Forest Service officials indicate that the Silver fire covered between 20,000 and 30,000 acres between Silver and Robert Lee. There were some homes which were lost. Scalping Your Lawn -Should You Do It?

There are usually pros and cons to every decision you make in life-even scalping your lawn. Scalping is defined as the removal of an excessive quantity of leaf tissue at any one mowing, resulting in a stubby brown appearance due to exposed stems, stolons, crowns, dead leaves and even bare soil. While scalping is not normally recommended for the warm season turfgrasses during the active growing season or prior to winter dormancy, it can be a beneficial cultural practice in late win-

ter to early spring. Benefits from early season scalping prior to green-up include: earlier spring green-up, control of some winter annual broadleaf weeds, and removal of some debris that could contribute to thatch accumulation. Scalping during the growing season will cause undue stress or potential injury to the turfgrass plants.

A more appropriate time to scalp warm season grass lawns is just prior to spring greenup. Drop your mower cutting height down to 1/2 - 1 inch and begin mowing. It is an excellent practice to remove old, dead plant material and to expose the soil to sunlight to warm the soil for quicker lawn green-up. Scalping too early

may injure the turfgrass by stolons and crowns to frost or extremely low temperatures. If delayed until the grass is actively growing, scalping will result in turf stress and shock the grass plant to the point that it slows growth until it can recover. Take caution to not overdo scalping on lawns with heavy thatch-especially on St. Augustine grass. If the active stolons (runners) are located in the upper portion of the thatch, scalping may cause a tremendous amount of damage to these vital plant parts and result in turf injury and even death.

Scalping creates a good bit of debris so it will be necessary to haul off all the old, dead plant material that is removed during the scalping the calculations and process. However, do not bag this material and send it to the landfill. Landfills are bad. You just need to take not appropriate sites for disposing of yard waste. your own compost pile or make mistakes? It's Time to Sharpen Mower Blades!

Spring green-up will be here before you know it. So it is time to drag the old lawnmower out of the garage and get it ready for your lawn. One practice that is sometimes ignored, but extremely important, is sharpening your mower

Dull blades will not only cause your lawn to look unattractive, but can also place undue stress on your lawn. Leaf tips become splintered and ragged, which leaves a straw colored appearance. These jaggededged leaf tips are entry points for small insects and disease pathogens, which can cause damage to your turf. So, pull the blades off the mower each month or so and give them a good sharpening. If they are in terrible shape, replace them-you'll be impressed with the results! If this is something that you do not feel comfortable doing yourself, then take your mower blades to a repair shop and have a professional do it for you. Your lawn will show its appreciation by an improved appearance. It will be healthier too!

Spreader and Sprayer Calibration

Do you apply fertilizers, compost, or pesticides to your lawn? If so, having your equipment clean, calibrated and "ready to go" is drawing near. Applications of these products normally occur during the growing

season, so it is important and exposing plant parts such as timely to have your equipment calibrated prior to the first use of the season.

Calibration of spreaders and sprayers is a relatively simple task. It doesn't take a lot of time, but is essential in order to apply products in measured amounts and in an environmentally safe manner. So take the time to calibrate your equipment - it's good for your lawn and our environment! Reverse mortgages can help seniors

By Jason Alderman More and more seniors unable to keep up with escalating living expenses have begun exploring reverse mortgages, where they draw equity from their paid-off homes and continue living there with no monthly payments.

Although reverse mortgages make sense for some people - especially those on fixed incomes who want to remain in their homes as long as possible - they have complex rules and hefty upfront costs, so look carefully before you leap.

Keep these considerations in mind:

You may qualify for a reverse mortgage at age 62 if you've paid off your home and it's your primary residence. The loan amount is determined by a formula based on your home's appraised value, your age, current interest rates, mortgage insurance and applicable fees. Generally, the older you are and the more valuable your home, the greater the available loan.

Unlike regular home equity loans/lines of credit, where you make monthly payments to repay the money you've borrowed, with reverse mortgages you don't need to

repay until you move out permanently, sell the property or die. You or your heirs must then repay the borrowed amount or sell the house. Any leftover money goes to you or your estate.

Other key differences from regular home equity loans/lines of credit: Reverse mortgages have no minimum income requirements; the repayment amount never exceeds the home's sale value, so you're never liable for more than you originally borrowed as with a traditional mortgage when the home's value decreases.

You can take the money as a lump sum, a line of credit, fixed monthly payments or any combination. And because it's a loan, it's not considered taxable income so Social Security and Medicare benefits usually aren't impacted.

Observe these cautions,

* Reverse mortgage fees are quite high (up to 5 percent of the loan's value), so also consider other alternatives such as a home equity loan or line of credit, downsizing homes or selling your home and renting.

* Reverse mortgages are a better deal over a longer

period of time, so if you plan to move in a few years they're probably not your best solution.

* Because you continue to own the home, you're responsible for any homeowner's fees, property taxes, insurance and repairs. Failure to meet those obligations could ultimately result in loan cancellation or even foreclosure.

* The longer you carry a reverse mortgage, the more it will decrease your home equity, so the inheritance you leave behind will be smaller. However, weigh that and living in your own home against the expense and possible inconvenience of moving into assisted living.

Be sure to consult a financial professional before applying for a reverse mortgage; if you don't know one, www.plannersearch.org is a good place to start your search. Note that federally insured reverse mortgages require you to meet with an approved independent counselor before applying for one.

Private Property Owners' Bill of Rights

It is a good bet if something is mentioned twice – if repeated – it is most likely a significant issue, especially when it is referenced twice in the United States Constitution.

"No person shall be...deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation."

- Amendment V, U.S.
Constitution

"No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law..."

- Amendment XIV, U.S.
Constitution

The right to own and use private property is one of the most important human rights and the cornerstone for economic prosperity. That is why our founders guaranteed it in the Constitution and listed property in the same category and with the same prominence as life...and...liberty.

The framers of our Constitution had the foresight to comprehend there are times when private property is needed for public use, but they went to great lengths to ensure the generations who followed would understand the sanctity of the ownership and protection of private property.

It is critical we never allow an entity or government the ability to trample on this basic right to own what is below our feet. Just as we intuitively defend and protect life and liberty, we must once again prioritize the protection of private property ownership. Nowhere has the need for this elevation been manifested more than in the transportation policies of our great state.

To say Texas is growing is an understatement. We picked up two seats in Congress after the last cen-

In recognition of this core ideology that has led us to prosperity, we hold these truths to be self-evident:

• Taking property from one private owner and giving it to another private owner is wrong.

• Taking private property for commercial purposes is wrong.

• Failing to provide landowners proper access is wrong.

• Failing to connect cities, towns and existing roadways to new routes is wrong.

• Not using every effort to follow the footprint of existing roadways to minimize the disruption of farm, ranch, timber and wildlife habitat is wrong.

Texas farmers and ranchers recognize the importance of an efficient transportation system. They depend on it for their livelihood. But those who work the land know the right to own property is mandatory for the preservation of life and liberty.

After all, the grand patriots who signed the Constitution were farmers too.





My Response to a Slanderous Mailout

It was stated the sheriff spends \$20,000 per year on gasoline from Town and Country. The Sheriff's budget per year for vehicle maintenance is \$22,000. This is used, not only for gasoline, but vehicle repairs, oil changes, tires, flats and any equipment needed for all <u>five</u> vehicles. Where the gasoline is purchased is up to each officer and usually he buys it on whatever side of the county he is stationed on. Town and Country in Bronte and Allsup's in Robert Lee are multimillion dollar businesses but they both bring needed tax revenue to the county and both towns.

Fact #3 - Comment on the Drug Task Force

It was stated that I would not allow the task force to come into Coke County. All I can say is this is totally a lie. I am a member/director of the West Central Texas Interlocal Crime Task Force, out of Abilene, Texas. If you really want the truth, call them and simply ask, and the contract is on file at the courthouse.

Fact #4 - Managing My Office

It was stated that I haven't managed my office in three years and I am seldom in the courthouse like the other elected officials. It really amazes me where you people come up with this information. I will be the first to admit that there were several months that I was not at work each and every day and most of the time partial days while recovering from back surgery. I can't believe who ever gave you this information left out the fact I worked for a little over a year with three ruptured disks before having a spinal fusion in July of 2007.

Fact #5 - Firing of a Deputy


