As to other effects to the economy, the funds generated from the prison are not expected to benefit the Bronte Independent School District, as in the past with the juvenile facility. The exception to this is if some of the adult inmates choose to obtain their GED. In those instances, the BISD will have employees to assist in their education, and the school district will benefit from state support for their education.

Also on the positive side, the facility will go on the tax rolls with a beginning appraisal of \$5.7 million empty. This will benefit the BISD, Coke County, ECCHD, and the Kickapoo Water District with a little extra tax revenue. Also, when the facility becomes operational,

the appraisal for the prison should balloon to a much larger figure, thereby benefiting the taxing districts even more.





Agri-Plex Ag Day Slated for March 20 in Ballinger

The 2008 Agri-Plex Ag Day is set for March 20 at Ballinger High School. The biennial event is coordinated by the Texas AgriLife Extension Service with support from area agribusinesses and trade show exhibitors.

The program highlights agricultural and consumer issues facing rural Texans, according to event organizers.

Activities will include a trade show of about 30 commercial exhibits, which opens concurrently, with registration at 9 am. There will be a health fair from 8:30 am to noon in the junior high school gym. A womens program will take place in the school's home economics department from 9 am to 3 pm. A mens program will take place in the school auditorium from 9 am to 3 pm and there will be a youth program from 1 pm until 3 pm in the junior high gym.

All sessions will break from 11:30 am to 12:20 pm for a combined awards program in the auditorium followed by a complimentary meal. Todd Staples, Texas Commissioner of Agriculture, is the scheduled keynote speaker.

Easter Egg Safety

If you're planning an Easter egg hunt or cooking eggs, USDA has important advice to help you keep your family safe from food borne illness throughout the Spring celebrations.

"Eggs play a key role in the Easter holiday, "Hardcooked eggs for Easter celebration should be prepared with care."

If you plan to eat the Easter eggs you decorate, be sure to use only food grade dye. (Some people make two sets of eggs - one for decorating and hiding, another for eating. Others use plastic eggs for hiding.) For an Easter egg hunt, avoid cracking the egg shells. If the shells crack then bacteria could enter and contaminate the egg inside. Also, hide eggs in places that are protected from dirt, pets and other bacteria sources and

but we got 40 more than our keep hard -cooked eggs chilled in the refrigerator until just before the hunt. The total time for hiding and hunting eggs should be no more than two hours. Then be sure to refrigerate the "found" eggs right away until you eat them. Eggs found hours later or the next day should be thrown out not eaten!

> When shell eggs are hardcooked, the protective coating is washed away, leaving open pores in the shell where harmful bacteria could enter. Be sure to refrigerate eggs within two hours of cooking and use them within a week. Check your refrigerator temperature with an appliance thermometer and adjust the refrigerator temperature to 40°F (Fahrenheit) or below.

> For egg safety - to stay healthy and avoid food borne illness - USDA advises: Always buy eggs from a refrigerated case. Choose eggs with clean, uncracked shells. Buy eggs before the "Sell-By" or "EXP" (expiration) date on

Take eggs straight home from the grocery store and refrigerate them right away. Check to be sure your refrigerator is set at 40°F or below. Don't take eggs out of the carton to put them in the refrigerator - the carton protects them. Keep the eggs in the coldest part of the refrigerator - not on the door. Raw shell eggs in the carton can stay in your refrigerator for three to five weeks from the purchase date. Although the "Sell-By" date might pass during that time, the eggs are still safe to use. (The date is not required by federal law, but some states may require it.) Always wash your hands with warm water and soap before and after handling raw eggs. To avoid cross-contamination, you should also wash forks, knives, spoons and all counters and other surfaces that touch the eggs with hot water and soap. Don't keep raw or cooked eggs out of the refrigerator more than two hours. Egg dishes such as deviled eggs or egg salad should be used within 3 to 4 days.

The Robert Lee Care Center was empty for the first time in 58 years. The February 25, 2008 wild fire in northern Coke County caused County Judge Roy Blair to order the evacuation of the town of Robert Lee. The Robert Lee Care Center was notified of the Mandatory evacuation about 6:30 pm and by 8:30 pm all residents had been transferred to either, Bronte Health and Rehab in Bronte, Runnels County Rehab and Nursing Center in Ballinger or Ballinger Health and Rehab in Ballinger.

The speed of this evacuation is due in large part to the dedicated staff of Robert Lee Care Center and the many volunteers who showed up to assist with the evacuation. Both staff and volunteers worked together to accomplish the evacuation. They all put the interest and safety of the residents first before themselves or their own families.

Instrumental in the evacuation were two hospital board members, Thunderbird Rural Transportation based in Robert Lee and Bronte, West Coke County Volunteer Ambulance Service, RLISD school bus, and the Runnels County Rehab and Nursing Center van as well as several family members. There were many other volunteers who helped load residents, and gather belongings.

The wonderful staff and administration at Bronte Health and Rehab in Bronte, Runnels County Rehab and Nursing Center in Balleiger, and Ballinger Rehab and Nursing Center in Ballinger, went above the call of duty to house these residents overnight.

As soon as the news was out about the evacuation, we received calls from these facilities as well as Baptist Memorial, Sagecrest, and Winters, offering to house our residents. Many other calls were received from around the area offering assistance.

It is a great comfort that these Care Centers are willing to help the elderly of West Texas when the need arises.

Coke County Food Pantry

The Coke County Food Pantry is located at 714 Washington Street in Robert Lee, Texas and is sponsored by the Coke County Ministerial Alliance. It is funded entirely on donations. The items that are available have been donated by citizens of Coke County or purchased at the Concho Valley Food Bank in San Angelo or local stores with donated funds.

In the past year a total of 2463 citizens of Coke County have been served. Many of those are regular shoppers and sign in each week and some are there only a few times just to get through a job lay-off or an illness that resulted in a loss of wages for a short period of time. There have been 1209 families served with 200 of those being children and 754 being senior citizens (65 or older).

The Thunderbird Bus is available for residents in Bronte. If you wish to shop at the Food Pantry go to the Depot and the Bus will pick up at 2:30pm and bring you to Robert Lee. When all who rode the bus have finished shopping the Bus will go back to Bronte.

At the Pantry one member from each family is allowed to shop with only three shoppers in the Pantry at one time. Each new shopper is given a paper grocery sack at their first visit and is expected to bring it back each week as they return to shop. Each shopper is allowed one bag of groceries - this can be an assortment of canned items, dried beans, pasta, juice, canned milk, boxed food (cake mix, macaroni and cheese, boxed or bagged rice, cereal, etc). Some products are limited

more than others due to supply. Fresh fruits and vegetables as well as bread and bakery items (when available) are put into a separate plastic sack and are limited depending on availability. The amount and choice are different each week. At times there is nothing more than bread and sweets and other times there are fresh vegetables and fruits. We welcome produce from local gardens and will make arrangements to receive any delivery. If you have questions regarding delivery of items call 453-2026 or 453-2164

The Coke County Food Pantry is open weekly on Wednesday from 2 pm to 4 pm. Each Tuesday morning Fred and Mary Williams volunteer their time to go to the Concho Valley Food Bank in San Angelo to pick up groceries. They are back to Robert Lee by 10:30 am and are met at the Food Pantry by other volunteers who help to unload and get the Food Pantry ready for the next day shoppers. It takes a lot of time from 6 to 10 volunteers to keep the Coke County Food Pantry in operation but it is a small price to pay for the help given to those in

Save money on medications

By Jason Alderman Between skyrocketing prescription drug prices, rising insurance copayments and an aging population, it's not surprising more and more people are having difficulty paying for their medications.

If that sounds like you or someone you know, here are a few money-saving tips:

Go generic. Unlike generic cereal or soup, where quality varies, generic drugs by law must conform to strict Food and Drug Administration guidelines for quality, strength, purity and stability. Generics usually cost a fraction of brand-name counterparts, and many insurance plans assign them significantly lower copayments. Ask your doctor or pharmacist if generic equivalents exist for your medications.

Bulk up. Many insurers encourage ordering routinely taken drugs in larger

have the same copayment as a 30- or 60-day supply. Multiply that by several drugs over a year and savings could really add up.

Shop around. Because prices often vary widely, call or check Websites of several pharmacies, including online-only chains, to find the best deal. Two cautions: In addition to your doctor, make sure at least one pharmacist is aware of all medications you take (including over-the-counter) to prevent accidental drug interactions; and use only online pharmacies certified by the National Association of Boards of Pharmacy (http://vipps.nabp.net/verify.

Pill splitting. Many drugs come in double-dosage tablets that cost close to or the same as a lower dosage. By splitting the larger dosage in half, you essentially get two doses for the price of one. Caution: Many pills should never be split, including time-release and coated medications, so always ask your doctor or pharmacist first.

Drug assistance programs. Most pharmaceutical companies offer patient assistance programs (PAPs) that provide uninsured and low-income people access to prescription drugs they couldn't otherwise afford. There's lots of paperwork, but you can save hundreds or thousands of dollars if you meet their eligibility requirements.

Ask your doctor, pharmacist or health clinic how to proceed, or visit Partnership for Prescription Assistance enrollment information on over medication costs.

Medicare. Medicare beneficiaries can sign up for Medicare Part D. which provides prescription drug coverage through dozens of plans offered by private insurers. Monthly premiums, copayment amounts, out-of-pocket limits and drugs covered under the plans vary considerably, so you'll need to be very careful when choosing the best plan for your situation. Read the information www.medicare.gov/pdphome.asp for guidance on choosing the right plan. Another good resource is AARP's comprehensive guide to Medicare www.aarp.org/health/medicare.

Note that extra assistance with premium payments is available to low-income people. And, unless you turn 65 or otherwise become eligible for Medicare during the year (for example, through a qualifying disability), you'll need to wait for next year's open enrollment period in mid-November to join.

Tax advantages. If your employer offers a health care flexible spending account (FSA), sign up. You can use pretax dollars to pay for prescription and over-thecounter medications, as well as other healthcare-related expenses, reducing your taxable income and thereby lowering your taxes substantially. Seafood Is A Safer Catch

Than Most Think

Each week seems to bring news that something else is bad for us. Food that's pronounced healthy one day is deemed dangerous the next.

When it comes to consumer perception of seafood safety, for instance, all is not going swimmingly.

In a recent survey conducted by the University of Maryland's Center for Food Nutrition and Agriculture Policy, consumers listed tuna, salmon and shrimp as the fish with the highest levels of mercury. But when the question was reversed -- which fish had the lowest levels of mercury? -- the responses were identical: tuna, salmon and shrimp.

"On one hand, we want pregnant women to eat fish, as there are plenty of benefits to the fetus in terms of cognitive development and other factors," said university researcher Maureen Storey, "But on the other hand, there is confusion about the risks, so there are a lot of conflicting messages that have been misunderstood."

For the record, the fish containing highest levels of mercury are large predatory fish, the most popularly eaten being shark, swordfish, and tilefish.

Storey was among various experts describing the escalating communication dilemma surrounding seafood that is posing a risk of its own -- turning people away from one of the most nutritious foods.

"There may be some risk in consumption of fish, but there's a bigger risk in not consuming fish at all," Storey said.

In some parts of the country this appears to be more prevalent than in

others. For instance, this scenario is playing out in Indiana, where seafood intake already is lower than on the East and West Coasts, according to Charles Santerre, a food toxicology expert with the Institute of Food Technologists and professor at Purdue University.

"We're starting to realize in Indiana that the risk of not getting enough fish -- and their benefits such as omega-3 fatty acids -- is greater than any risks that fish may pose," he said.

"Many physicians are not well versed in the true risks. They're telling their pregnant patients to simply not eat fish and that's just very bad advice."

Despite recommendations from the American Heart Association that fish should be consumed at least two times per week, only 17 percent of those surveyed reported eating fish that often. Only 24 percent said they ate fish a couple of times a

By comparison, in the United States annual per capita consumption of poultry is 86 pounds, beef is 66 pounds, and fish consumption is a mere 16 pounds, reported Barbara Blackistone, of the National Fisheries Institute.

"Fish is really the poster child of food safety, but we simply don't eat that much compared to other meats, and confusion about safety plays a big role in that," Blackistone said.

When the media reports Environmental Protection Agency reference doses for mercury contamination, headlines tend to paint a worstcase scenario without telling the whole story, Blackistone added.

"Based on EPA reference dose figures, thousands of babies appear to be at risk from mercury contamination, and that's what the media looks at, but they forget that the reference dose has a 10-fold safety factor?" Otherwise stated, EPA levels are purposefully set 10 times lower to help ensure people attain nowhere near harmful exposure.

Maryland's CFNAP Web site, www.realmercuryfacts.org, publishes a Web site to help people sort through seafood safety facts.

"The safety information coming from the FDA (Food and Drug Administration) and the EPA can be so complex; but this helps to sort it all out," Storey said.

Preserving Your Family's Precious Photos And Documents

We all want our precious photos, documents and news clippings to last a lifetime, if not longer.

Preserving your family's priceless memories and keepsakes needn't be expensive, especially if you know how to store them.

Linda Angle Miller, college archivist at Roanoke College in Salem, Virginia, offers these helpful preservation tips that are easy and cheap:

"Keep your documents and photos, especially color photos, out of direct sun and away from florescent lighting. The same UV rays that give us wrinkles make photos fade," she says.

Besides insects and mice, the deadliest elements to documents and photos are light, heat and humidity. Simply by storing photos and papers in "cool" areas, you are already on your way to preserving life's treasures.

Also, avoid basements, garages and cellars, since humidity can cause mold.

"Tapes and glues generally have acids in them that discolor the paper and make them deteriorate. Tapes may repair tears but will yellow the paper," says Roanoke

College's Miller.

Using ink and markers can be a bad idea, since they can bleed through documents and photos, so be careful!

These simple mistakes even have been made by the federal government. One U.S. Secretary of the Treasury had his office staff glue all his newspaper clippings into a notebook with rubber cement. Over the years, the glue dried and no longer kept many of the clippings in place and caused discoloration on many others. Precious history damaged!

The acids in paper are certain products preserve your documents -such as archival or "acid free" papers, folders and boxes.

When preserving photographs, black and white ones are more stable than color, which begin fading from the time they are printed.

Some simple suggestions that Miller stresses are: use Kodak and Fuji papers for long-term preservation; avoid ink jet prints since they can run and get wet; and use an archival mat when placing photos in a glass frame to avoid damaging adhesion.

also is a good idea as long as they do not become scratched or warped. If this happens, then your photos are no longer accessible. And remember, in the future you will have to reformat when CDs become obsolete due to whatever comes next in the technology wave.

It's never too early to begin properly storing photos. Those pictures of your newborn child all too quickly become images of days gone by, so don't let www.bbb.org.

Think of it this way -- if a moment is worth capturing on film or in a document, it's worth saving well.

What To Do If You Become A Credit Card Fraud Victim

Even if your credit card never leaves your pocket you could become a fraud victim.

The Better Business Bureau (BBB) urges consumers to keep close watch on credit and debit card statements. If your card is stolen or fraudulent charged, here's what to do:

Contact the issuer. Most what cause it to deteriorate have 24-hour fraud and theft and become brittle, but there hotlines. Your maximum liability is \$50 per card; once available that will help you you report a card loss or theft, you have no further responsibility for unauthorized charges. If the fraud involves the card number, but not the card, you have no liability for unauthorized use. If an ATM or debit card is lost or stolen, the amount you could lose depends on how quickly you alert the issuer.

File a report with the local police and get a copy for the card issuer and the credit reporting bureaus, and file reports with the Federal Trade Commission online www.consumer.gov/sentinel.

Contact the credit reporting bureaus -- Equifax, Experian, Scanning photos onto CDs and TransUnion. They can have accounts frozen, preventing new credit lines from being opened.

Follow up calls with letters outlining the problem and when you alerted the card issuer and credit bureaus to it. Consumers can receive a free copy of their credit report with all three bureaus. Keep a close eye on card statements, bank accounts, and credit reports well into the future.




